

Buckle Up, Phone Down “Retweet to Win”

Official Rules

No Purchase Necessary

Open Only to Legal Missouri Residents ages 15 and over.

The Buckle Up, Phone Down- Retweet to Win begins on February 1st, 2018 and ends on February 23rd, 2018 (the “Contest Period”). The Contest is sponsored by the Missouri Highways and Transportation Commission and the Missouri Department of Transportation (“Sponsors”). The Contest is administered by Bucket Media, Inc. (“Administrator”) and the winner will be selected using random.org. This promotion is in no way sponsored, endorsed or administered by, or associated with, Twitter. You are providing your information to the Missouri Highways and Transportation Commission and the Missouri Department of Transportation and not to Twitter. The information you provide will not be shared or sold by the Sponsors.

Eligibility: Retweet to Win participation is open to anyone but contest entry is limited to legal residents of Missouri who, as of the time of entry, are fifteen (15) years old and older. Entrants under the age of eighteen (18) must have parental or legal guardian consent before entering the contest. For entrants under eighteen (18), an entry may be deemed invalid if such entrant does not have parent or legal guardian consent to enter. The Sponsors may request entrants under eighteen (18) to have a parent or guardian sign a consent form to participate in this contest, and if the completed consent form is not received by the Sponsors, such entry will be deemed invalid. Entrants must have a valid Twitter account through the end of the contest period. The entrant’s Twitter account must be made “Public” to be considered to win. Employees and their immediate families, including household members, of the Sponsors are not eligible to enter.

How to Enter: NO PURCHASE NECESSARY. Contest void where prohibited. To enter, retweet the selected contest tweet through Twitter containing the Buckle Up Phone Down video. After retweeting, the entrant must follow or be following the @SaveMOLives Twitter account to be considered eligible. The retweet entry period will be from Thursday, February 1, 2018 through 11:59 p.m. CST Friday, February 23, 2018. Only one entry per person. A link to the official rules will be posted to the @SaveMOLives Twitter page. The Sponsors reserve the right to hide any tweet content using the selected Retweet to Win tweet that they deem inappropriate in nature. Sponsors also reserve the right to hide any comments that they deem inappropriate in nature. Content or comments may be deemed inappropriate for any of the following reasons including but not limited to; foul language, lewdness, threats of violence, illegal activity, hate speech, libel, misleading information, plagiarism, spam, nudity etc. No responsibility can be accepted for entries not received for whatever reason. All entries must be received by February 23, 2018 at 11:59 p.m. CST. Entries received past the submission period deadline will not be accepted.

Conditions of Entry: Incomplete entries will not be accepted. All entries in the Contest become the sole property of the Sponsors, and no legal rights of any kind to such entries shall be retained by the submitting entrants. By participating, entrants agree to these Official Rules, including all eligibility requirements. transmissions, omission, interruption, deletion, defect, line failures of any telephone network, computer equipment, software, inability to access any website or online service or any other error or malfunction. User must have and maintain a Twitter account through the notification period. It is free to create a Twitter. An account can be created by going to the following website www.twitter.com.

Prizes: The prize will be awarded at random by the software of random.org from all entries received and verified by Administrator. The prize awarded is two (2) tickets to the Southeastern Conference Men's Basketball Tournament at Scottrade Center in St. Louis. By accepting the prize, winner consents to the Sponsor's use of name, city of residence, and image for promotional purposes, including online announcements, without additional compensation, except where prohibited by law. All federal, state and local taxes are the sole responsibility of the winner. No prize substitution, cash substitution, or assignment or transfer of prize is permitted. Odds of winning depend upon the number of entries received.

Prize Notification: The winner will be notified via the Twitter account they used to submit their entry through Direct Message. The winner must be following the SaveMOLives Twitter account in order to view the Direct Message.
