

Lady Jane's Haircuts for Men Flatbed Field Goal Official Contest Rules

These Contest rules are specific to the above Contest conducted by Entercom Portland, LLC d/b/a KFXX-FM (the "**Station**"). Except to the extent specifically set forth below with respect to this specific Contest, the Stations' general contest rules apply to this Contest as well. A copy of these specific Contest rules and the Station's general contest rules are available at the Station's studio at 0700 SW Bancroft Street, Portland, OR 97239 during regular business hours and on the Station's websites at www.1080thefan.com/rules. To the extent that the general contest rules differ from these rules, these rules will govern and control with respect to this Contest.

How to Enter and How to Win

1. No purchase is necessary to enter or win "Lady Jane's Haircuts for Men Flatbed Field Goal" contest (the "**Contest**").
2. To enter, must be eighteen (18) years of age or older, a legal resident of Oregon or Southwest Washington, and be present on September 14, 2018 between approximately 11:00am (PT) and 1:00pm (PT) at Lady Jane's Haircuts for Men, 4550 NE Cornell Rd. Hillsboro, OR, 97124 (the "**Event**"). The following classes of people are INELIGIBLE to enter, participate or win any prize under the terms of this contract:
 - a. **Current or former professional or semi-professional soccer or football players;**
 - b. **Current or former high school or collegiate soccer football players who have competed at that level within the past six (6) years;**
 - c. **Current soccer or football coaches who are coaching at the high school level or higher.**
3. To enter, attend the Event on September 14, 2018, obtain and fully complete an entry blank made available prior to the start of the Grand Prize Event, while supplies last. Deposit the completed entry blank into the registration box available by 1:00pm (PT) on September 14, 2018. **Maximum of one (1) entry per person during the Event.**
4. Up to, but in no event more than one (1) entrant will be selected to participate in the Grand Prize Event as follows (the "**Finalist**"):
 - a. At approximately 1:01pm (PT) on September 14, 2018, one (1) entrant will be randomly selected by the Station from among all eligible entries received. The selected entrant name will be announced on-site, and the selected entrant must be present at the time of such announcement to participate. The selected entrant must come forward within two (2) minutes of his or her name being announced, or he or she will be disqualified and an alternate entrant will be selected and announced. Once an entrant comes forward within two (2) minutes of his or her name being announced on-site and confirms his or her identity, positively indicates that he or she is willing and able to participate in the Grand Prize Event, he or she will become the "**Finalist**".

5. If the selected Finalist does not meet the eligibility requirements, does not wish to participate in the Grand Prize Event, or is unable or unwilling to attend the Grand Prize Event in person, he or she will be disqualified and an alternate Finalist will then be randomly selected from all remaining eligible entries received, and notified per the procedures outlined above, time permitting. Only the Finalist who is selected and notified by Station will be eligible to participate in the Grand Prize Event. All other entrants are ineligible. Finalist selection and participation is non-transferable. No other individual may participate on behalf of a selected Finalist. Decisions of judges in the selection of Finalists, and all matters related to this Contest are final.
6. Selected Finalist must be present for the “**Grand Prize Event**” at approximately 1:01pm (PT) on September 14, 2018 at Lady Jane’s Haircuts for Men, 4550 NE Cornell Rd. Hillsboro OR, 97124. If the Finalist fails to appear by the required deadline as stated by Station, he or she will be disqualified, and will not receive any alternate Grand Prize Winning Kick Attempts, participation, prize award, prize substitution or compensation of any kind. Difficulties with getting to the Event to enter or participate in the Contest are not the responsibility of Station.
7. Station reserves the right, in their sole discretion to randomly select a replacement Finalist for any disqualified Finalist from any remaining eligible entries received. **NOTWITHSTANDING THE FOREGOING, THERE WILL UP TO, BUT IN NO EVENT MORE THAN ONE (1) FINALIST ENTITLED TO PARTICIPATE IN THE GRAND PRIZE EVENT ON SEPTEMBER 14, 2018.**

How to Win

8. **IN ORDER TO PARTICIPATE IN THE GRAND PRIZE EVENT, FINALIST MUST BE PRESENT ON SEPTEMBER 14, 2018. AT LADY JANE’S HAIRCUTS FOR MEN. 4550 NE CORNELL RD., HILLSBORO, OR, 97124.** Finalist will be required to provide valid US or state government issued photo identification and sign an Entercom liability and publicity release agreement “as is” in order to be properly “checked in” and to further participate in this Contest.
9. The Finalist must be properly and timely checked in and will have an opportunity to participate in the Grand Prize Event on September 14, 2018 and participate in the Flatbed Field Goal Contest (see below). **Finalist participation is non-transferable. No other individual may participate on behalf of a selected Finalist. THERE IS NO GUARANTEE THAT THE GRAND PRIZE WILL ACTUALLY BE AWARDED IN THIS CONTEST.**
10. **The following requirements shall apply to the Finalist selected during the Grand Prize Contest, in regards to their actual “Grand Prize Winning Kick Attempt” :**
 - **Video** – The Grand Prize Winning Kick Attempt must be recorded on video by the Station Administrator. Any attempt that is not captured on video for any reason, or any Finalist that attempts the Grand Prize Winning Kick

Attempt prior to being notified by the Administrator to proceed, shall be disqualified and ineligible to receive any prize.

- **No Practice** – Selected Finalists **may NOT attempt any practice or warm-up kicks in any manner** from any distance prior to their Grand Prize Winning Kick Attempt.
- **Signed Affidavit** – Immediately prior to their Grand Prize Winning Kick Attempt, the Finalist must complete and sign the provided affidavit of eligibility, verifying their agreement to the Official Rules and verification of eligibility requirements.
- **Football:** The Finalist must use the standard football provided by Station. No substitute or alternate Football may be used by the Finalist.
- **Distance** – The Finalist will have one (1) opportunity to successfully complete the Grand Prize Winning Kick Attempt from a minimum distance as designated by the Station Administrator at the Grand Prize Event. The exact distance shall be disclosed immediately prior to the Contest, and shall not be announced in advance to prevent practice. Finalist is NOT allowed any practice or warm-up attempts from any distance, prior to their Grand Prize Winning Kick Attempt.
- **Vehicle:** The designated Contest vehicle will be parked perpendicular to the Finalist for the Grand Prize Winning Kick Attempt.
- **Kick (No Tee)** – The football must be held by an individual on the ground, using a simulated holding device, or punted by the Contestant. **The Grand Prize Winning Kick Attempt may not be initiated off of a tee.**
- **Football Kick:** In order to be considered a successful Grand Prize Winning Kick Attempt, the football must enter the truck bed on the fly. A kicked ball that bounces, deflects or otherwise comes in contact with any object, person or surface (other than any part of the truck itself) prior to entering the truck bed is automatically disqualified and is not eligible to be a winning attempt. The ball must land, come to rest and stay inside the truck bed to be considered a winning attempt. The ball may not bounce into or out of the truck bed. **A kicked ball that makes initial contact with the inside surface of the truck bed, then subsequently bounces out of the truck bed and makes contact with any object, person, surface (*other than any part of the truck itself*) will NOT be considered a winning Grand Prize Winning Kick Attempt.**
- **Grand Prize:** In the event an eligible Finalist successfully completes the Grand Prize Winning Kick Attempt, on their one (1) and only attempt, that Contestant will be eligible to claim the Grand Prize, subject to approval and verification of compliance with these Official Rules.
- **Finalist shall have a maximum of one (1) Grand Prize Winning Kick Attempt, regardless of its outcome. If the Finalist misses or miss kicks the football during Grand Prize Winning Kick Attempt, he or she shall be considered to have completed their Grand Prize Winning Kick Attempt, and shall not receive any alternate attempts, regardless of the quality or outcome of their initial attempt.**

- The Grand Prize Winning Kick Attempt must occur in the presence of the appointed Contest Administrator and may NOT COMMENCE UNTIL THE ADMINISTRATOR GIVES EACH FINALIST AN OKAY TO KICK THE FOOTBALL. Any attempt not in the presence of the Contest Administrator and designated non-participating witness, that occurs prior to the Contest Administrator giving the OKAY to or that is not video recorded for any reason will be disqualified and is not eligible for the Grand Prize and such Finalist will NOT be given another opportunity to attempt Grand Prize Winning Kick Attempt.
11. By entering and by participating in this Contest, all Contestants acknowledge that they will be, and hereby grant their consent to being video recorded before, during and after the Contest (including, without limitation, signing required forms) in association with this Contest. Contestants may also be required to sign a release form relieving the Station and Sponsors from any and all liability with respect to participation in this Contest and/or the receipt and/or use of the prize, an affidavit of eligibility, sign-in sheet, acknowledgement of receipt of these Contest rules, and/or a publicity release. Refusal to sign any of these documents by the deadline required by Station will result in automatic disqualification.
 12. **In the event there is no Grand Prize Winning Kick Attempt by the eligible Finalist, then the Grand Prize will NOT be awarded.**
 13. The odds of winning the Grand Prize by successfully completing the Flatbed Field Goal Grand Prize Winning Kick Attempt are dependent upon the skill of selected Finalist.
 14. Finalist must strictly follow all instructions and directions given by Station personnel at the Grand Prize Event. Failure to do so may result in immediate disqualification, as determined in the sole discretion of Station personnel.

Prize(s)

15. **Grand Prize:** In the event that the Finalist successfully completes the Grand Prize Kick Requirements, the Finalist shall be eligible to claim the Grand Prize, subject to approval and verification of compliance with these official rules. A maximum of up to one (1) Grand Prize will be awarded. Grand Prize is: a check made out to the Grand Prize winner in the amount of \$10,000.
 - a. **In the event there is no Grand Prize Winning Kick Attempt by the Finalist, then the Grand Prize will NOT be awarded.**
 - b. **If the Grand Prize is awarded, and after all paperwork is completed and returned within the designated time period, the Station will notify the Grand Prize winner by telephone about when the Grand Prize can be claimed at Station.**
19. Grand Prize winner, if any, will be required to sign one or more affidavits and/or liability release agreements before the prize is awarded. Failure to do so by the

deadline required by Station or Sponsor will result in automatic forfeiture of any prize in this Contest. In the event that a Prize Winner is disqualified, for any reason, at any time, the Grand Prize will not be re-awarded.

20. In addition to verification of eligibility, the potential Grand Prize winner(s), if any, shall not be entitled to any prize in this Contest unless he/she provides Station with the following within three (3) business days of winning:
- a. Contestant Information: Name, address, phone number and photocopy of a government issued photo identification card of the actual person/winner who completed the prize winning requirements;
 - b. W-9 Form: Completed and signed by the winner.

Contest Administrator and Sponsors

21. The Contest administrator of this Contest is Entercom Portland, LLC, 0700 SW Bancroft Street, Portland, OR 97239. The sponsors of this Contest are Entercom Portland, LLC and Lady Jane's Haircuts for Men.

Other Rules Specific to this Contest

22. In addition to the eligibility restrictions set forth in the Station's general contest rules, employees (including, without limitation, part-time or temporary employees) of Entercom Portland, LLC, Million Dollar Media, LLC, and their respective parent entities, subsidiaries, affiliated companies and advertising and promotion agencies at any time during the applicable Contest and the immediate family (i.e., current and ex-spouses, parents, grandparents, children, grandchildren, and siblings and in-laws and steps in any of the foregoing categories and their respective spouses) and other household members (i.e., roommates, housemates, significant others, and partners of each legally residing at the same address) are NOT eligible to enter and/or to win this Contest.

By entering this Contest, entrants understand and agree that Station will be videotaping and/or audiotape such entrant's participation, appearance and/or performance in connection with this Contest (before, during or after the Contest) and that Station will own any such audio and/or video and shall be free to utilize such materials in any way it sees fit during or after the Contest with no compensation to the entrants, including without limitation posting any such audio and/or videos on its website or social media site or submitting it for Contest verification purposes to a third party.
