- (3) The applicant is a domestic limited liability company licensee for the water power project, designated as Project No. 2712 in the records of FERC. The current license was issued on April 20, 1998.
- (4) The amendments of license proposed herein are necessary to implement provisions of the Lower Penobscot River Multiparty Settlement Agreement ("MPA").
- (5)(i) The statutory or regulatory requirements of the state(s) in which the Project would be located that affect the Project as proposed with respect to bed and banks and the appropriation, diversion, and use of water for power purposes, and with respect to the right to engage in the business of developing, transmitting, and distributing power and in any other business necessary to accomplish the purposes of the license under the Federal Power Act, are:
 - (a) The Mill Act 38 M.R.S.A. § 651 et seq.

The Mill Act was first enacted by the Maine Legislature as Chapter 45 of the Public Laws of 1821. To a great extent, it was patterned after the Massachusetts Mill Act enacted there in 1714.

The rights and liabilities of riparian landowners with respect to the erection and maintenance on their own land of water mills and dams upon and across any non-navigable stream are set forth in 38 M.R.S.A. § 651 et seq. A complete history of this legislation appears in the case of Brown v DeNormandie, 123 Maine 539 (1924).

Section 651 of the Mill Act provides:

Any man may on his own land erect and maintain a watermill and dams to raise water for working it, upon and across any stream not navigable; or, for the purpose of propelling mills or machinery, may cut a canal and erect walls and embankments upon his own land, not exceeding one mile in length, and thereby divert from its natural

channel the water of any stream not navigable, upon the terms and conditions and subject to the regulations hereinafter expressed.

The Mill Act also contains extensive provisions for the method by which compensation for damages arising from flowage caused by a mill dam are to be determined and recovered.

It is settled law in Maine that a hydroelectric generating plant is a water mill within the meaning of the Mill Act, Gillmore v Central Maine Power, 127 Maine 522 (1929); that the Mill Act is constitutional, Brown v DeNormandie, 123 Maine 535 (1924); and that the part of a stream above tidewater is not navigable under the Mill Act, Opinion of Justices, 118 Maine 503 (1919) and Veazie v Dwinel, 50 Maine 470 (1862).

- (b) P.L. 92-500 Section 401 as amended Water Quality Certification. The Maine Department of Environmental Protection has been delegated authority to issue Water Quality Certification under Section 401 of the Clean Water Act.
- (5)(ii) The steps which the applicant has taken or plans to take to comply with each of the laws cited above are:
 - (a) Under the Mill Act, no approval of any state agency is required to continue to use water for the Stillwater Hydroelectric Project.
 - (b) PPL Maine has applied to the Maine Department of Environmental Protection for amendment of the Water Quality Certification (WQC) for the Stillwater Project. Refer to Exhibit E - Appendix E-A of this Amendment Application for documentation of the WQC Application.

(6) The following exhibits are filed within and are hereby made a part of this application:

Exhibit A - Project Description and Mode of Operation

Exhibit E - Environmental Report

Exhibit F - Project Design Drawings

Exhibit G - Project Maps

This application is being submitted in accordance with the provisions of Section IV of the MPA. The MPA is a comprehensive settlement agreement among the licensee, the Penobscot Indian Nation, the U.S. Department of the Interior, various agencies of the State of Maine, and a number of conservation groups. As discussed in greater detail in the Explanatory Statement concurrently herewith in this and other project dockets, implementation of the MPA and the companion "Comprehensive Settlement Agreement Between The Penobscot Indian Nation, PPL Maine, LLC, and the Bureau of Indian Affairs of the Department of the Interior" presents the opportunity to resolve all fish passage, energy generation, and Tribal issues associated with licensee's Penobscot River Basin hydroelectric projects and therefore is clearly in the public interest.

Section IV of the MPA will require the concurrent filing with the Commission of a number of requests and applications, including this application. These various requests and applications (Phase 1 Requests), if granted by the Commission without alteration or change that materially prejudices any party to the MPA, will permit the parties to proceed to the subsequent phases of the MPA and thus realize the full public interest benefits contemplated by the MPA. Because of the various rights and interests implicated by the Phase 1 Requests, all of those requests are interrelated and mutually dependent. Consequently, and as discussed in more detail in the above-referenced Explanatory Statement, if the Commission does not grant this application and all the other Phase 1 Requests without alteration or change that materially prejudices any party to the MPA, all of the Phase 1 Requests, including this application, will be withdrawn pursuant to 18 C.F.R. § 385.216.

A draft of this Application was distributed on February 17, 2004 to agencies and stakeholders. Comments received have been addressed in this final Application, and copies of all correspondence are provided in Appendix ES-A of this Executive Summary. In recognition that this Application is consistent with, and is the initial step towards implementation of the MPA, all agencies and stakeholders consulted support this Application and the accompanying request for a waiver of the three-stage consultation process (see Appendix ES-A).

Description of Requested Modifications

<u>Headpond increase</u> – In order to enhance generation output as proposed in the MPA, PPL Maine proposes to increase the normal impoundment level at the Stillwater Hydroelectric project by one-foot, from 93.65 (NGVD) to 94.65. This will result in approximately 965 MWH of additional generation annually.

This increase in impoundment elevation will be accomplished by simply adding one foot of height to the existing flashboard system and adding flashboards to the non-overflow sections of the dam as necessary to maintain flood flow discharge capacity while allowing the normal headpond elevation increase. Specifically, when the flashboard system is replaced after approval of the amendment request, PPL Maine will utilize boards that are one-foot taller than the existing boards (depending on dam section) currently erected on top of the dam's permanent crest or which will raise sections to the new impoundment level, as needed. The modified flashboard system will be designed to fail with one foot of overtopping to match the current system failure point. The present flashboard system is designed to fail with two feet of overtopping. The flood flow discharge capacity will not be reduced since flood flows occur after the boards have already failed. Additionally, the flashboards will fail at a lower flow.

Minimum Flow Modification – In order to enhance generation output as proposed in the MPA, PPL Maine proposes to modify the minimum bypass flow requirements at the Stillwater Hydroelectric Project by reducing from 40 cfs to 20 cfs the release to the west bypassed channel and by reducing from 155 cfs to 50 cfs the release to the east bypassed channel. This will result in approximately 723 MWh of additional generation annually.

This change in the minimum bypass flows will be accomplished by reducing the "openings" in the flashboard system on the main dam, and the section of dam above the east channel bypass, to allow passage of the modified flows on a continuous basis. Specifically, PPL Maine will adjust

Article 402 of the license, as amended June 29, 2001 (95 FERC ¶ 62,292), specifies flows of 40 cfs and 155 cfs in these channels.

the openings in the flashboards to provide for 20 cfs from the west channel (1.6 foot opening in the flashboards) and 50 cfs from the east channel (4.4 foot opening in the flashboards). It should be noted that these openings will allow the necessary releases when the headpond is up to one-foot lower than normal full pond elevation (as allowed for by Article 401), and the new openings are calculated at the requested modified normal full pond elevation of 94.65 feet NGVD. In addition, PPL Maine will continue to provide and monitor the releases through its Minimum Flow Monitoring Plan, as approved by Commission Order dated February 17, 1999.

These modified flows reflect the interim minimum bypass flows required by the Water Quality Certification included in the Commission's April 20, 1998 Order Issuing License.

<u>Fish Passage</u> – In order to implement the MPA, PPL Maine agrees to the modification of various articles for purposes of incorporation into the license those requirements consistent with the Department of Interior (DOI) modified fishway prescriptions dated June 2004, as specified in Attachment A of the MPA, as set forth below (four revised license articles).

Contingent Mitigation – In order to fully mitigate for any potential habitat impacts associated with the requested modifications and modifications at other projects, parties to the MPA developed a Contingent Mitigation Fund (CMF) (Attachment B to MPA), whereby it was agreed that the impacts will be fully mitigated by removal of the Veazie (FERC No. 2403) and Great Works (FERC No. 2312) dams. If those dams are not removed, then the MPA provides for the establishment of the CMF and requires PPL Maine to make monetary payments in certain circumstances, as specified in Attachment B to the MPA, to the CMF to fully mitigate for the habitat impacts. PPL Maine proposes to add the article set forth below requiring PPL Maine to comply with Attachment B.

Specific License Article Amendments and Additions

To implement these modifications, PPL Maine requests that the Commission make the following changes to the Project's April 20, 1998 Order Issuing License for the Stillwater Hydroelectric Project as amended by the June 29, 2001 Order Amending License and November 6, 2003 Order Approving Revised Exhibit F:

<u>Paragraph (B)(1)</u>: Exhibit G — The following revised Exhibit G maps should be approved and made part of this license:

Paragraph B(2)(a): Revised project descriptions as follows:

A main concrete gravity dam, totaling about 1,720 feet long, with a maximum height of 22 feet at crest elevation 91.65 feet National Geodetic Vertical Datum (NGVD), consisting of 13 sections: a non-overflow section, totaling 63 feet long, which serves as an abutment and wingwall, containing a 6-foot-wide unused stoplog sluice gate; a 381-foot-long primary spillway section, with a maximum height of 22 feet at a crest elevation of 91.65 feet NGVD, topped with 3-foot-high pin-supported flashboards; an 85-foot-long by 2-foot-wide by 2.5-foot-high leveling concrete course topped with 1.67 foot-high pin-supported flashboards; a 43-foot-long concrete sill section on top of a ledge island topped with 0.65-foot-high pin-supported flashboards; a 174-foot-long ogee section, with varying heights from 4 to 20 feet, topped with 3-foot-high pin-supported flashboards; a 52-foot-long ogee section, with a maximum height of 9 feet, topped with a concrete curb, 15 inches wide by 25 inches high, topped with 1.80-foot-high pin-supported flashboards; an 89-foot-long spillway section, with an average height of 6 feet topped with 1.05-foot-high pin-supported flashboards; a 42-foot-long

spillway section, with a maximum height of 8 feet, topped with 0.85- to 3.8-foothigh pin-supported flashboards; an 89.5-foothigh pin-supported flashboards; a 187-foothigh pin-supported flashboards;

Paragraph B (2)(c): Change to reflect current data and new elevations as follows:

c) An impoundment, about three miles long, having a surface area of about 191 acres (AC); a gross storage capacity of approximately 1,910 acre-feet (AF); a negligible useable storage capacity; a normal headwater surface elevation of about 94.65 feet NGVD; and a normal tailwater surface elevation of about 73.65 feet NGVD.

<u>Paragraph (B)(2)(d)</u>: Exhibit A reference - Change the reference from the existing Table A-1 to incorporate the changes and additions in the modified Table A-1, as submitted herein.

Article 401: Change the reference in the first paragraph thereof to "normal full pond elevation of 93.65 feet NGVD" to "normal full pond elevation of 94.65 feet NGVD".

Article 402: Change the reference to minimum flows required by the article (as modified by the Commission's Order dated June 29, 2001 (95 FERC 62,292)) from "a permanent minimum flow of 40 cubic feet per second (cfs) into the west bypassed channel and a permanent flow of 155 cfs into the east bypassed channel" to "a permanent minimum flow of 20 cubic feet per second (cfs) into the west bypassed channel and a permanent flow of 50 cfs into the east bypassed channel".

Article 406: Delete the existing Article 406 in its entirety and add the following new Article 406 in lieu thereof (for fish passage under MPA and DOI modified fishway prescriptions):

Article 406: The licensee shall install and operate permanent downstream fish passage facilities at the Stillwater Project. Fishways shall be maintained and operated to maximize fish passage effectiveness throughout fish migration period(s) as defined below. The downstream migration period is defined as April 1 to June 30 and November 1 to December 15 for Atlantic salmon, July 1 to December 31 for American shad and alewife, August to December 31 for blueback herring, and August 15 to November 15 (or other time periods determined when adequate information is available, and during any spring run that may occur) for American eel. Downstream facilities are to operate whenever generation occurs during the downstream migration period. The Licensee shall keep the fishways in proper order and shall keep fishway areas clear of trash, logs, and material that would hinder passage. Anticipated maintenance shall be performed in sufficient time before a migratory period such that fishways can be tested and inspected and will operate effectively prior to and during the migratory periods.

Fishway maintenance and operational plans (including schedules) for all fish passage facilities shall be developed by the Licensee in consultation and cooperation with the U.S. Fish and Wildlife Service (FWS), the Penobscot Indian Nation (PIN), and other fishery agencies (including the Maine Department of Inland Fisheries and Wildlife, Maine Department of Marine Resources, Maine Atlantic Salmon Commission, and NOAA Fisheries). Functional design and final

design plans for all fishways shall be developed in consultation and cooperation with the FWS, Penobscot Nation, and other fishery agencies.

Downstream fishways shall consist of installation of trashracks with 1" clear opening at the powerhouse turbine intake and gated surface and bottom bypasses discharging up to 70 cfs during the downstream migration period. If shown to be necessary by studies of the effectiveness of these measures, but in no case before the expiration of the safe harbor period delimited in Attachment A, Section II(c) of the Lower Penobscot River Multiparty Settlement Agreement, the licensee shall institute nightly shut-downs for downstream eel passage for a two week period during downstream eel migration season.

Within 180 days from the date of the Commission order inserting this replacement article into the license, the licensee shall file, for Commission approval, a plan for installing the licensee's trashracks. This filing shall include a schedule for installing the trashracks with 1-inch clear opening within 1 year of the effective date of the Lower Penobscot River Multiparty Settlement Agreement.

Within 6 months of the effective date of the transfer of the licenses for the Veazie (no. 2710), Great Works (no. 2312), and Howland (no. 2721) Projects pursuant to the terms of the Lower Penobscot River Multiparty Settlement Agreement, the licensee shall file, for Commission approval, detailed design drawings for the surface and bottom bypasses. This filing shall include but not be limited to: (1) the location and design specifications of the bypasses; (2) a schedule for installing the facilities within 18 months of a Commission order approving the design drawings; and (3) procedures for operating and maintaining the facilities.

The Licensee shall include, with the filings required by the two previous paragraphs, documentation of consultation, copies of agency and PIN comments

and recommendations on the drawings, plans, and schedules after they have been prepared and provided to the agencies, and specific descriptions of how the agencies' and PIN's comments and recommendations are accommodated by the Licensee's facilities. The Licensee shall allow a minimum of 30 days for the agencies and PIN to comment and to make recommendations before filing the drawings, plans, and schedule with the Commission. If the licensee does not adopt a recommendation, the filing shall include the licensee's reasons, based on project specific information.

The Commission reserves the right to require changes to the proposed facilities and schedules. No construction of downstream fish passage facilities shall begin until the Licensee is notified by the Commission that the plan is approved. Upon Commission approval, the Licensee shall implement the proposal, including any changes required by the Commission.

Until the surface and bottom bypasses specified above are installed, the licensee shall continue to operate the existing surface weir bypass facilities at the project.

Article 407: Delete the existing Article 407 in its entirety and add the following new Article 407 in lieu thereof (for fish passage under MPA and DOI modified fishway prescriptions):

Article 407: The licensee shall install and operate permanent upstream fish passage facilities at the Stillwater Project. Fishways shall be maintained and operated to maximize fish passage effectiveness throughout fish migration period(s) as defined below. The upstream migration period shall be defined April 1 to November 30 for American eel. The licensee shall keep the fishways in proper order and shall keep fishway areas clear of trash, logs, and material that would hinder passage. Anticipated maintenance shall be performed in sufficient time before a migratory period such that fishways can be tested and inspected and will operate effectively prior to and during the migratory periods.

Fishway design, maintenance and operational plans (including schedules) for all fish passage facilities shall be developed by the licensee in consultation and cooperation with the U.S. Fish and Wildlife Service (FWS), the Penobscot Indian Nation (PIN), and other fishery agencies (including the Maine Department of Inland Fisheries and Wildlife, Maine Department of Marine Resources (MDMR), Maine Atlantic Salmon Commission, and NOAA Fisheries). Functional design and final design plans for all fishways shall be developed in consultation and cooperation with the FWS, Penobscot Nation, and other fishery agencies.

During the first upstream eel migration season after the date of the Commission Order inserting this replacement article into the license, the licensee shall assess the appropriate location for the siting of a new upstream eel fishway at the project, in consultation with the FWS, MDMR, and PIN, and these entities' approval of a proposed location, file, for Commission approval, a plan for the fishway. This filing shall include but not be limited to: (1) the location and design specifications of the passage facilities; (2) a schedule for installing the facilities and completing initial testing prior to the third upstream migration season following the effective date of the Lower Penobscot River Multiparty Settlement Agreement; and (3) procedures for operating and maintaining the facilities.

The licensee shall include with the plan documentation of consultation, copies of agency and PIN comments and recommendations on the completed plan after it has been prepared and provided to the agencies, and specific descriptions of how the agencies' and PIN's comments and recommendations are accommodated by the plan. The licensee shall allow a minimum of 30 days for the agencies and PIN to comment and to make recommendations before filing the plan with the Commission. If the licensee does not adopt a recommendation, the filing shall include the licensee's reasons, based on project specific information.

The Commission reserves the right to require changes to the proposed facilities and schedule. No construction of upstream fish passage facilities shall begin until the Licensee is notified by the Commission that the plan is approved. Upon Commission approval, the licensee shall implement the proposal, including any changes required by the Commission.

Article 408: Delete the existing Article 408 in its entirety and add the following new Article 408 in lieu thereof (for fish passage under MPA and DOI modified fishway prescriptions):

Article 408: Within 12 months of the deadline established by Articles 406 and 407 for filing design drawings or a plan for a fish passage device, the licensee shall file with the Commission, for approval, a plan to monitor the effectiveness of all the facilities and flows provided pursuant to Articles 406 and 407 of this license that will enable the efficient and safe passage of diadromous fish migrating upstream and downstream. The results of these monitoring studies shall be submitted to the agencies listed below and shall provide a basis for recommending future structural or operational changes at the project.

The monitoring plan shall include a schedule for: (1) implementation of the plan; (2) consultation with the appropriate federal, state, and tribal agencies concerning the results of the monitoring; and (3) filing the results, agency comments, and licensee's response to agency comments with the Commission.

The licensee shall prepare the monitoring plan after consultation with the U.S. Fish and Wildlife Service, Maine Fisheries Agencies (IFW, DMR, MASC), the Maine Department of Environmental Protection, the Penobscot Indian Nation (PIN), and NOAA Fisheries.

The licensee shall include with the plan documentation of agency consultation, copies of agency and PIN comments and recommendations on the plan after it has been prepared and provided to them, and specific descriptions of

how the agencies' and PIN's comments are accommodated by the licensee's plan. The licensee shall allow a minimum of 30 days for the agencies to comment and to make recommendations before filing the plan with the Commission. If the licensee does not adopt a recommendation, the filing shall include the licensee's reasons, based on project specific information.

The Commission reserves the right to require changes to the proposed plan. Upon Commission approval, the licensee shall implement the plan, including any changes required by the Commission.

If the results of the monitoring indicate that changes in project structures or operations, including alternative flow releases, are necessary to protect fish resources, the licensee shall first consult with the agencies listed above to develop recommended measures for amelioration and then file its proposal with the Commission, for approval. The Commission reserves its authority to require the licensee to modify project structures or operations to protect and enhance aquatic resources.

Article 409: Delete the existing Article 409 in its entirety and add the following new Article 409 in lieu thereof (for fish passage under MPA and DOI modified fishway prescriptions):

Article 409: Authority is reserved by the Commission to require the licensee to construct, operate, and maintain, or to provide for the construction, operation, and maintenance of, such fishways as may be prescribed by the Secretary of the Interior or the Secretary of Commerce under Section 18 of the Federal Power Act consistent with the Lower Penobscot River Multiparty Settlement Agreement.

Add the following Article (for MPA):

Article . The licensee shall implement the requirements of Attachment B to the Lower Penobscot River Multiparty Settlement Agreement, dated June

2004 (Contingent Mitigation Fund), as it pertains to the Stillwater Hydroelectric Project.

Dear Scott:

I have now reviewed the water quality impacts of the Phase I energy enhancements that are included in the Lower Penobscot River Conceptual Agreement with our technical staff and have the following to report.

The Phase I energy enhancements included in the Conceptual Agreement consist of (1) increasing headpond elevations by 1 foot at the Medway, Stillwater, and West Enfield Projects and (2) redeveloping the currently inoperable Orono Project.

The DEP has recently collected data to calibrate and verify a water quality model for the Penobscot River. The model run at worst case conditions of 7-day 10-year low flow, high water temperatures, and point sources at licensed loads predicts that minimum Class B dissolved oxygen criteria will not be met in about 51 river miles. In addition, the model predicts that algae blooms are expected to occur in about 25 river miles.

The DEP Penobscot River model has now been used to predict the changes in dissolved oxygen and algae levels expected to result from the Phase I energy enhancements.

In reviewing the water quality impacts of the Phase I energy enhancements, DEP assumed the following conditions:

 Stillwater and Orono Projects. Changes in water levels and generation on the Stillwater River will not measurably affect water quality conditions on the main stem Penobscot River, due to the small flow on the Stillwater relative to that on the Penobscot.

- 2. Medway Project. The existing headpond has a surface area of 120 acres and extends upstream about 1.8 miles to a point about 200 yards below the East Millinocket Dam, and the proposed 1-foot headpond increase would increase the surface area of the project impoundment by about 5 acres.
- 3. West Enfield Project. The existing headpond has a surface area of 1125 acres and extends upstream about 6 miles to Mohawk Rapids, to a point just upstream of Mohawk Island, and the proposed 1-foot headpond increase would increase the surface area of the project impoundment (including the Merrill Brook "runaround") by about 23 acres.

Based on this review, the DEP has concluded that none of the Phase I energy enhancements, either singly or in combination, will have any measurable impact on water quality. Our technical analysis (memo dated January 20, 2004 from Paul Mitnik to Dana Murch) is attached.

Expected Water Quality in Rockabema and West Enfield Impoundments

As you have requested, I have investigated the expected change in water quality assuming both the Rockabema and West Enfield impoundment headpond levels are increased by an elevation of one foot. A water quality model, that has been calibrated and verified with data collected in 1997 and 2001, was used to predicted the expected changes in dissolved oxygen and algae levels (measured as chlorophyll-a). The model is explained in detail in a draft DEP report (Penobscot River Modeling Report, April 2003) that can be downloaded from DEP's website.

Compliance of class C dissolved oxygen criteria in the Rockabema impoundment is currently not an issue. However non-compliance of minimum class B criteria is an issue in the West Enfield impoundment. The occurrence of algae blooms is a greater issue in the Rockabema impoundment than the West Enfield impoundment.

Due to the increased time of travel that will occur with the larger impoundments, it is possible that lower dissolved oxygen and higher chlorophyll-a could result. Adjustments were made to the hydraulic component of the model to account for the increased volume and depth and decreased velocity. Since the estimated change in impoundment surface area is small in both cases, it was assumed that the river width should not change.

The model predicts that no lowering of dissolved oxygen levels should occur in the Rockabema impoundment. The maximum lowering of dissolved oxygen that should occur in the West Enfield impoundment is 0.1 ppm. This is within the measurement error of dissolved oxygen. The maximum increase in chlorophyll-a predicted is 0.01 ppb for Rockabema and 0.25 ppb for West Enfield. In either case, the expected change in chlorophyll-a is neglible.

Projected Impacts of Penobscot River Restoration Project Phase I Energy Enhancements (Impoundment Elevation Increases) at the Stillwater, West Enfield, and Medway Projects

(by C. Fay, Fisheries Manager, Penobscot Indian Nation DNR)

Recognizing that, except for spawning activity, smallmouth bass in the Penobscot watershed use impounded habitat as readily as free-flowing reaches, then the increased impoundment elevations associated with the Penobscot River Restoration Project Phase 1 energy enhancements at Stillwater (SW), West Enfield (WE), and Medway (MW) projects (1 foot at each location) are judged to be at worst neutral, and at best, a net positive, with respect to general bass habitat quantity and quality. To the extent that bass spawning activity occurs or would occur in these impoundments (most spawning in the main stem Penobscot River occurs in free-flowing reaches), they should simply be shifted shoreward proportional to the depth increase at the location in question.

As far as angler access to bass fisheries, and navigational safety issues, in these impoundments, again, the Phase 1 energy enhancements should result in either neutral or net positive impacts at all three projects. Specifically at West Enfield, and recognizing that in some cases, new navigational hazards will be formed where there was none previously, the one foot increase should overall reduce the potential for larger power boats/outboards to hit one of the numerous submerged log and rock cribs that are scattered throughout the lowest river mile of the impoundment, and that currently rise to within 0.5-3.0 feet of the normal water surface elevation. This is particularly true for those cribs located well above the dam, which are generally closer to the surface, harder to distinguish, and where several instances of damaged outboard motor lower units have been observed in the recent past.

Finally, and again specific to West Enfield, the increased impoundment elevation should result in improvements in gross habitat quality for bass in the so-called "Merrill Brook Runaround" segment of the project. Presently, that segment of the project area becomes fairly stagnant in the summer due to diminished inflow over the upstream berm that funnels water from the main river into the runaround.

These are basically OK, with a couple of comments:

General: in your executive summary, you state that the Agreement "will resolve all fish passage, energy generation and tribal issues". It would be more accurate to say that it "presents the opportunity to resolve" all such issues. This is for two reasons - first, it emphasizes the next point, which is that the Commission must act in the right way to make this happen, and, second, because it may not resolve all issues with respect to Howland and Great works if they are not purchased - we may go right back into relicensing with no prejudice to anyone's position. The opportunity is certainly there if FERC does what it's supposed to and the dams are bought, but it's not a certainty.

Veazie-specific. You ask to set the timeframe of article 413 to "as ordered by the Commission." I would prefer to include language, as I suggested in my effort at our filing, pushing back this requirement until 5 years, 6 months from now, or 6 months after a decision not to remove if the option is exercised, as with the fish passage facilities. The delay makes sense, but your suggestion means we will have to badger the Commission for an order to get recreational facilities at all, which is the next best thing to giving up on them entirely, in my book. Also the language of the MSA states that this is to be delayed until after that decision point, not indefinitely.

I may discover more when I get back to this next week, but that's all I've spotted so far - Gordon, of course, has a better handle on the technical stuff than I do.

As we've indicated previously to you, DOI will be sending a single, short letter of concurrence and support for the proposed license amendment applications. It will be signed by our Regional Environmental Officer, Andy Raddant, who is in Boston.

However, there were a few specific items that caught me eye as I looked through the applications that I thought I'd pass on.

Medway:

p. E-6: you can delete the sentence on peregrine falcon - it was delisted in 1999.

p. E-9: you should say something like, "The existing upstream and downstream fish passage measures for eels will not be affected by the 1-ft headpond increase."

Stillwater:

p. E-9: last sentence in the paragraph on fish passage isn't quite accurate - Art. 407 of the license requires fish passage plan for upstream and downstream passage.

p. E-12: should say something like, "The proposed l-ft. increase in headpond level and decrease in minimum bypass flow will not affect existing or proposed fish passage facilities or their operations."

West Enfield:

p. E-6: similar to last comment. Add sentence such as, "The 1-ft increase will not affect existing upstream and downstream fish passage facilities or their operations."

Milford:

p. ES-2: as we've discussed recently, Art. 405 (DO monitoring) would be modified, not deleted.

We have no substantial comments to make at this time regarding the license amendments for the Stillwater, Milford, West Enfield, and Medway projects or the new license application for the Orono Project. Attantic Salmon Commission staff has participated in the development of the Lower Penobscot River Conceptual Agreement signed by numerous parties last fall as well as in the development of the Lower Penobscot River Multiparty Settlement Agreement. We expect that the MPA will be finalized in April 2004. Consequently, much of MASC's issues have been resolved through the Conceptual Agreement and MPA processes. As such, we support PPL's request to waive the three stage consultation requirements normally associated with license amendments and for a new license application under 18 CFR Sec. 4.38(a)(5) and Sec. 16.8(e)(1) of the Federal Power Act.

The MPA is the foundation for the Penobscot River Restoration Project, an extensive and comprehensive undertaking to improve water quality and fish and wildlife habitat, to enhance the ecology of the Penobscot River watershed, and to improve access and habitat for diadromous fish species in the Penobscot basin. We look forward to working with all stakeholders involved in this ambitious effort to restore balance to the Penobscot River.

The DEP has reviewed your letters of February 17 and 25, 2004 and the accompanying draft Applications for Amendment of License for the Veazie, Milford, West Enfield, Medway and Stillwater Hydro Projects and the draft Application for New License for the Orono Hydro Project.

We have the following comments on the draft applications.

Veazie Hydro Project, FERC No. 2403

1. We understand that the amendment application calls for: (a) modifying the fish passage requirements in the current FERC license to be consistent with the modified DOI/NMFS fishway prescriptions outlined in Attachment A to the Lower Penobscot River Conceptual Agreement; and (b) extending the deadline for filing and implementing a final recreation plan.

- 2. We understand that, with respect to the Veazie Project, the modified DOI/NMFS fishway prescriptions outlined in Attachment A to the Lower Penobscot River Conceptual Agreement provide that PPL Maine will continue to operate the project without modifications in existing generating facilities or fish passage facilities, including full responsibility for their operation and maintenance, and to extend, until the expected option to purchase the Veazie, Great Works, and Howland Projects is exercised or expires, the deadlines for complying with the fish passage requirements contained in the current FERC license.
- 3. In the Maine Waterway Development and Conservation Act Permit and Water Quality Certification previously granted by the DEP for the project (Order #L-16880-35-D-N dated November 10, 1993), compliance with fish passage and recreation conditions is required upon such schedule as established by FERC. Therefore, any extension of these compliance deadlines that is approved by FERC will automatically apply to the certification, and no specific DEP approval of these extensions is required.

Milford Hydro Project, FERC No. 2534

- 1. We understand that the amendment application calls for: (a) incorporating the provisions of an expected settlement agreement between the Penobscot Indian Nation, PPL Maine, and the DOI Bureau of Indian Affairs; (b) modifying the fish passage requirements in the current FERC license to be consistent with the modified DOI/NMFS fishway prescriptions outlined in Attachment A to the Lower Penobscot River Conceptual Agreement; and (c) deleting several articles from the current FERC license.
- We understand that, with respect to the Milford Project, the provisions of the expected settlement agreement between the Penobscot Indian Nation, PPL Maine, and the DOI Bureau of Indian Affairs call for PPL Maine to: change to run-of-river project operation; implement a stream bank stabilization and monitoring plan; provide a contribution to the Penobscot Indian Nation Curational Fund; provide funding to PIN to establish the Milford Project Monitoring Fund; remove semi-buoyant logs from the project impoundment; provide notice of and access to PIN to participate in any FERC inspections; provide compensation to PIN for flooded land in the impoundment; develop a canoe portage trail under specified circumstances around the western end of the Milford Dam; and include PIN and BIA in all future consultations.
- 3. We understand that, with respect to the Milford Project, the modified DOI/NMFS fishway prescriptions outlined in Attachment A to the Lower Penobscot River Conceptual Agreement provide that PPL Maine will continue to operate the project without modifications in existing generating facilities or fish passage facilities and to extend, until the expected option to purchase the Veazie, Great

Works, and Howland Projects is exercised, the deadlines for complying with the fish passage requirements contained in the current FERC license, except that PPL Maine will develop and implement plans for the installation and operation of a new upstream eel fishway. The modified prescriptions further provide that, upon the exercise of the option and the purchase of the designated projects by the Purchasing Entity, PPL Maine will install a new state-of-the-art fish lift, discontinue use of the existing Denil fishway, and implement physical and operational changes to improve downstream fish passage.

- 4. We understand that the articles proposed for deletion from the FERC license require that the licensee monitor dissolved oxygen in the Penobscot River below the project (Article 405) and develop and implement a plan to evaluate measures to mitigate for any unavoidable losses to Atlantic salmon due to fish passage inefficiencies (Article 410).
- 5. The proposed amendments constitute a change in project facilities and operation as previously approved by the DEP (Order #L-16011-35-B-N dated October 23, 1992). Therefore, the proposed amendments must be approved under the Maine Waterway Development and Conservation Act and Section 401 of the Clean Water Act. Please submit a completed Application for Project Modification to the DEP, along with two copies of the final Application for Amendment of License as filed with FERC. A fee of \$109.00 must accompany the application. Please note that public notice is not required for this application.

West Enfield Hydro Project, FERC No. 2600

- 1. We understand that the amendment application calls for: (a) increasing the height of the existing flashboards by 1 foot; (b) establishing a Contingent Mitigation Fund to fully mitigate for the habitat impacts of increasing the headpond elevation in the event that the Veazie and Great Works Dams are not removed; (c) incorporating the provisions of an expected settlement agreement between the Penobscot Indian Nation, PPL Maine, and the DOI Bureau of Indian Affairs; and (d) requiring the installation of upstream eel passage facilities.
- 2. We understand that the proposed higher headpond elevation will increase the surface area of the project impoundment by 23 acres and will increase annual generation by 6.412 million kW-hours annually.
- 3. We understand that, with respect to the Milford Project, the provisions of the expected settlement agreement between the Penobscot Indian Nation, PPL Maine, and the DOI Bureau of Indian Affairs calls for PPL Maine to provide compensation to PIN for the flooding of additional reservation lands.

- 4. We understand that the proposed requirement for the installation of upstream eel passage facilities will be consistent with the provisions outlined in Attachment A to the Lower Penobscot River Conceptual Agreement.
- 5. Please verify that there will be no in-stream construction work associated with the installation of 1-foot higher flashboards.
- 6. Please verify that the increase in impoundment area resulting from the 1-foot higher flashboards will be 23 acres (from an existing size of 1,125 acres to a new size of 1,148 acres).
- 7. Please state the increase in installed capacity that will result from the 1-foot higher flashboards. We note that the project is currently licensed for an installed capacity of 13 MW.
- 8. We note that, as amended, the project will have 7-foot-high flashboards that will be designed to fail when overtopped by 1 foot of water (i.e., at elevation 157.1 feet NGVD), which is 0.5 feet higher than the elevation at which the existing flashboards are designed to fail (when overtopped by 1.5 feet of water). We also note that the project has substantial gate capacity to pass excess flows and that, as a result, flashboard failure is expected to occur less than 10% of the time. Consequently, we are not concerned that the reduced overtopping tolerance may cause the higher flashboards to fail more frequently, thus adversely affecting aquatic habitat.
- 9. The proposed installation of higher flashboards qualifies as the structural alteration of a hydropower project in ways that change water levels or flows above or below the project. The other proposed amendments constitute changes in project facilities and operation as previously approved by the DEP. Therefore, the proposed amendments must be approved under the Maine Waterway Development and Conservation Act (MWDCA) and Section 401 of the Clean Water Act. Please submit a completed Application for Project Approval (Form "Hydro.2") to the DEP, along with two copies of the final Application for Amendment of License as filed with FERC. This will also serve as an application to amend the MWDCA permit and Section 401 water quality certification previously issued by the DEP for the project (Order #L-007973-35-A-A dated February 12, 1986). Please note that public notice of the application must be given to the owners of all property adjacent to the impoundment area affected by the amendment.
- 10. The Application for Project Approval must be accompanied by the appropriate fee. For a capacity increase of up to 0.4 MW, the base fee is \$235.00. For a capacity increase of greater than 0.4 MW, the fee is \$590.00 per megawatt of additional capacity.

Medway Hydro Project, FERC No. 2666

- 1. We understand that the amendment application calls for increasing the height of the existing flashboards by 1 foot. We understand that the proposed higher headpond elevation will increase the surface area of the project impoundment by 3.5 acres and will increase annual generation by 2.3 million kW-hours annually.
- 2. Please verify that there will be no in-stream construction work associated with the installation of 1-foot higher flashboards.
- 3. Please verify that the increase in impoundment area resulting from the 1-foot higher flashboards will be 3.5 acres (from an existing size of 98 acres to a new size of 101.5 acres). We note that recent survey work has corrected the size of the existing impoundment from 120 acres to 98 acres.
- 4. Please state the increase in installed capacity that will result from the 1-foot higher flashboards. We note that the project is currently licensed for an installed capacity of 3.44 MW.
- 5. We note that, as amended, the project will have 5.75-foot-high flashboards that will be designed to fail when overtopped by 1 foot of water (i.e., at elevation 261.3 feet NGVD), which is the same elevation at which the existing flashboards are designed to fail (when overtopped by 2 feet of water). We also note that the flashboards cannot be replaced until river flows drop below turbine capacity, which is exceeded about 58 percent of the time. We further note that the project has limited gate capacity to pass excess flows. As a result, while we appreciate your interest in maintaining the flood flow discharge capacity of the existing project, we are concerned that the reduced overtopping tolerance may cause the higher flashboards to fail more frequently, resulting in larger and more frequent fluctuations in impoundment levels, which may in turn adversely impact aquatic habitat (as well as cause a reduction in generation). Please comment on the likelihood of increased flashboard failure. If increased flashboard failure is likely, please comment on (a) the anticipated impacts on aquatic habitat and (b) the economics of replacing the current flashboard system with an inflatable flashboard system (i.e., a "rubber dam") that will automatically deflate and reinflate to maintain more stable pond levels.
- 6. The proposed installation of higher flashboards qualifies as the structural alteration of a hydropower project in ways that change water levels or flows above or below the project. The proposed amendment also constitutes a change in project facilities and operation as previously approved by the DEP. Therefore, the proposed amendment must be approved under the Maine Waterway Development and Conservation Act (MWDCA) and Section 401 of the Clean Water Act.

Please submit a completed Application for Project Approval (Form "Hydro.2") to the DEP, along with two copies of the final Application for Amendment of License as filed with FERC. This will also serve as an application to amend the Section 401 water quality certification previously issued by the DEP for the project (Order #L-18893-33-B-N dated December 23, 1998). Please note that public notice of the application must be given to the owners of all property adjacent to the impoundment area affected by the amendment.

7. The Application for Project Approval must be accompanied by the appropriate fee. For a capacity increase of up to 0.4 MW, the base fee is \$235.00. For a capacity increase of greater than 0.4 MW, the fee is \$590.00 per megawatt of additional capacity.

Stillwater Hydro Project, FERC No. 2712

- 1. We understand that the amendment application calls for: (a) increasing the normal headpond elevation by 1 foot by increasing the height of the existing flashboards and by adding flashboards as needed where none currently exist; (b) modifying the minimum bypass flow requirements in the current FERC license; (c) modifying the fish passage requirements in the current FERC license to be consistent with the modified DOI/NMFS fishway prescriptions outlined in Attachment A to the Lower Penobscot River Conceptual Agreement; and (d) establishing a Contingent Mitigation Fund to fully mitigate for the habitat impacts of increasing the headpond elevation in the event that the Veazie and Great Works are not removed.
- 2. We understand that the proposed higher headpond elevation will increase the surface area of the project impoundment by 7 acres and will increase annual generation by 0.965 million kW-hours annually.
- 3. We understand that the proposed amendment calls for reducing minimum bypass flows from 40 cfs to 20 cfs in the west bypass channel and from 155 cfs to 40 cfs in the east bypass channel.
- 4. We understand that, with respect to the Stillwater Project, the modified fishway prescriptions outlined in Attachment A to the Lower Penobscot River Conceptual Agreement provide that PPL Maine will: develop and implement plans for the installation and operation of a new upstream eel fishway; continue to operate the existing downstream fish passage facilities; and reduce trashrack spacing to 1 inch. The modified prescriptions further provide that, upon the exercise of the expected option and the purchase of the Veazie, Great Works, and Howland Projects by the Purchasing Entity, PPL Maine will implement physical and operational changes to improve downstream fish passage but will not be subject to any additional requirements for upstream fish passage.

- 5. Please verify that there will be no in-stream construction work associated with the installation of new and higher flashboards.
- 6. Please verify that the increase in impoundment area resulting from the 1-foot increase in headpond elevation will be 7 acres (from an existing size of 184 acres to a new size of 191 acres).
- 7. Please state the increase in installed capacity that will result from the 1-foot increase in headpond elevation. We note that the project is currently licensed for an installed capacity of 1.95 MW.
- 8. We note that, as amended, the project will have flashboards ranging in height from 0.65 feet to 3 feet that will be designed to fail when overtopped by 1 foot of water (i.e., at elevation 95.64 feet), which is the same elevation at which the existing flashboards are designed to fail (when overtopped by 2 feet of water). Because of the limited turbine capacity and the small impoundment size, we do not have any concerns about the effects of flashboard failure in aquatic habitat.

Please note that public notice of the application must be given to the owners of all property adjacent to the impoundment area affected by the amendment.
- 10. The Application for Project Approval must be accompanied by the appropriate fee. For a capacity increase of up to 0.4 MW, the base fee is \$235.00. For a capacity increase of greater than 0.4 MW, the fee is \$590.00 per megawatt of additional capacity.

Orono Hydro Project, FERC No. 2710

1. We understand that the original FERC license for the Orono Project has expired and that the project has been operating under a self-renewing annual license since September 25, 1985.

- 2. We understand that, as part of the subsequent proposal by Bangor Hydro-Electric to construct the Basin Mills Dam, the Orono Project was to be decommissioned.

 As a consequence, no application for new license was ever filed for the project.
- 3. We understand that the project penstocks collapsed and were removed in 1996 by Bangor Hydro-Electric. The project has been inoperable since that time.
- 4. We understand that PPL Maine now proposes to rehabilitate the Orono Project and restore the project to operation at its previous capacity of 2.3 MW. PPL Maine also proposes to file an application for a new license for the project.
- 5. We understand that the proposed project rehabilitation includes: (a) installation of new penstocks; (b) rehabilitation of the concrete surge tank; (c) replacement of the wheelpit floors; (d) rehabilitation of the turbines; (e) removal of accumulated debris from the tailrace and turbine discharge flumes; (f) rehabilitation of the generators and associated ancillary equipment; (g) replacement of the generator controls and switchgear; and (h) rehabilitation of the powerhouse structure.
- 6. We understand that PPL Maine proposes to continue to operate the project in a run-of-river mode and to provide a 200 minimum flow in the project bypass reach.
- 7. None of the proposed rehabilitation activities appear to trigger the permitting requirements of the Maine Waterway Development and Conservation Act. However, the proposed relicensing of the Orono Project is subject to DEP approval under Section 401 of the Clean Water Act. Therefore, please submit a completed Application for Water Quality Certification (Form "Hydro.1") to the DEP, along with two copies of the final Application for New License as filed with FERC. Please note that public notice of the application must be given to the owners of all property adjacent to the dam, penstocks, and powerhouse.
- 8. The Application for Water Quality Certification must be accompanied by a fee of \$949.90 (2.3 MW x \$413/MW).

We are in receipt of your memoranda dated Pebruary 17, 2004 and February 25, 2004, as well as the draft license amendment applications attached thereto. The memoranda were directed to the parties involved in the Lower Penobscot River Conceptual Agreement, of which the National Marine Fisheries Service (NOAA Fisheries) was not a party. We appreciate your sending us a courtesy copy.

As you are aware, NOAA Fisheries has not been involved in the negotiation of this matter or in the development of the resultant Multiparty Settlement Agreement (MPA). Accordingly, we are not in a position to offer commentary on the draft applications, nor is the agency, for similar reasons, in a position to sign the MPA. NOAA Fisheries does, however, have significant interest in the aquatic resources of the Penobscot River. We intend to become involved in the imminent Federal Energy Regulatory Commission (FERC) post-filing application process and will provide comments in the usual course as set forth under the FERC's regulations. In developing our comments and modified Section 18 fishway prescription, NOAA Fisheries will take into full consideration the objectives of the MPA and actions proposed therein.

NOAA Fisheries recognizes the substantial efforts undoubtedly made by the involved parties in developing the Lower Penobscot River Conceptual Agreement and Multiparty Settlement Agreement. Further, the agency applauds as a general matter the restoration of free flowing riparian corridors and enhancement of long dormant diadromous fish habitat. NOAA Fisheries looks forward to working with you throughout the FERC license amendment process.

PIN's (Clem Fay) Technical Comments on Draft Amendment Applications

Milford

1. Revise page ES-2 to reflect that Art 405 (D.O. Monitoring) is not being deleted. If any revision of language in 405 is proposed, provide opportunity for review prior to final PIN approval.

Stillwater

1. Insert language where appropriate that stipulates no effect, or if an effect, specify, as to impoundment increases and existing or proposed fishways at that project, with "sign off" from FWS.

West Enfield

1. Page E-5: Existing Fish Resources:

More of a curiosity than something critical needing revision, and recognizing that the source was FERC (1986), I know of no documented presence of brown trout in the WE impoundment now or ever, nor does DIFW. DIFW indicated that there was some stocking of browns long ago in the Mattawamkeag River, and in Side Pistol Lake in 1984, but that hardly seems basis for including them as a "resident species in the impoundment" in the context of a hydropower EA. Browns were not stocked in the Piscataquis until after 1992.

2. Page E-6, fourth line from top:

Add "physical" between "original/unaltered" and "habitat".

3, Page E-6, fifth line of SMB impact paragraph:

Extend the sentence that ends "on bass habitat." to "on bass habitat in the impoundment proper and the so-called "Merrill Brook Runaround" (Fay 2004)" and then delete rest of paragraph.

- 4. Substitute revised bass impact document (i.e. "new" Fay 2004; attached), for original document, and modify citation in reference list as needed to reflect revised doc.
- 5. Insert language as appropriate that indicates no effect, or if an effect, specify, as to impoundment increases and existing or proposed fishways at that project, with sign off from FWS.
- 6. I suggest section 6.1 of Exhibit E be updated to recognize that there are now more than "a few seasonal camps" on the shores of the impoundment. As you know, about 5 or 6 new year-round residences now on east shore of lower impoundment, at least one new

year-round residence at one of the new lots along the west shore, one new year-round residence on the north side of the runaround near the bridge (Ralph), an upgrade of an old/unoccupied residence to year-round residence on the west shore just up from the runaround bridge (Scott), and finally John York's year-round residence.

Medway

Insert language as appropriate that indicates no effect, or if an effect, specify, as to impoundment increases and existing or proposed fishways at that project, with sign off from FWS.

Projected Impacts of Penobscot River Restoration Project Phase I Energy Enhancements (Impoundment Elevation Increases) at the Stillwater, West Enfield, and Medway Projects

(by C. Fay, Fisheries Manager, Penobscot Indian Nation DNR)
March 17, 2004

Recognizing that, except for spawning activity, smallmouth bass in the Penobscot watershed use impounded habitat as readily as free-flowing reaches, then the increased impoundment elevations associated with the Penobscot River Restoration Project Phase 1 energy enhancements at Stillwater (SW), West Enfield (WE), and Medway (MW) projects (1 foot at each location) are judged to be at worst neutral, and at best, a net positive, with respect to general bass habitat quantity and quality. To the extent that bass spawning activity occurs or would occur in these impoundments (most spawning in the main stem Penobscot River occurs in free-flowing reaches), they should simply be shifted shoreward proportional to the depth increase at the location in question.

As far as angler access to bass fisheries, and navigational safety issues, in these impoundments, again, the Phase 1 energy enhancements should result in either neutral or net positive impacts at all three projects. Specifically at West Enfield, and recognizing that in some cases, new navigational hazards will be formed where there was none previously, the one foot increase should overall reduce the potential for larger power boats/outboards to hit one of the numerous submerged log and rock cribs that are scattered throughout the lowest river mile of the impoundment, and that currently rise to within 0.5-3.0 feet of the normal water surface elevation. This is particularly true for those cribs located well above the dam, which are generally closer to the surface, harder to distinguish, and where several instances of damaged outboard motor lower units have been observed in the recent past.

By letter dated February 17, 2004, PPL Maine, LLC ("PPL") submitted the above-referenced applications (hereinafter referred to collectively as "the applications") to the Maine resource agencies and requested comments in 30 days. Having reviewed the applications, the Maine resources agencies offer the following comments, which are made contingent on the anticipated execution of the Lower Penobscot River Multiparty Settlement Agreement ("MPA") that provides for the license amendments and new license requested in the applications.

mitigate for habitat impacts in the event the Veazie and Great Works dams are not removed.

E. Medway Project

PPL requests the following license modifications:

- Headpond increase of one foot; and
- Monetary payments into a CMF in the manner provided in Attachment B of the MPA to fully mitigate for habitat impacts in the event the Veazie and Great Works dams are not removed.

F. Orono Project

PPL proposes to:

- Relicense and refurbish the Orono Project;
- Operate the facility in a run-of-river mode;
- Provide a flow of 200 cfs into the approximately 1,000 foot long bypass reach making about 250 units (one unit = 100 square yards) of salmon nursery habitat available;
- Provide upstream American eel passage and modified downstream fish passage measures consistent with Attachment A of the MPA and DOI/NMFS modified fishway prescriptions; and
- Make monetary payments into a CMF in the manner provided in Attachment B of the MPA to fully
 mitigate for habitat impacts in the event the Veazie and Great Works dams are not removed.

II. Comments

A. Hoodplain management

In the event of any changes to a watercourse, regulations governing the National Flood Insurance Program ("NFIP") obligate the community in which the change occurs to notify the Federal Emergency Management Agency ("FEMA") (in Maine, via the state NFIP coordinator) and, depending on the nature of the change, a letter of map revision application to FEMA may be required. If, for example, one or more of the changes proposed under the applications would result in a change in the base flood elevation, revision of the pertinent flood bazard maps may be required under the NFIP regulations. At this stage, the Maine resource agencies suggest that PPL consult with Maine's NFIP coordinator Lou Sidell at SPO (207-287-3261) and pertinent communities to identify additional information needs, if any, and applicable floodplain management procedures.

B. Community effects

The Maine resource agencies encourage PPL to continue its efforts to coordinate with pertinent state and federal agencies, the Penobecot Indian Nation, and any municipalities, businesses, individuals or other

potentially affected entities to identify and address as appropriate adverse effects, if any, that may result from the changes to PPL's hydro power projects requested in the applications.

C. Coastal Zone Management

The Veazie project is located in Maine's designated coastal zone. By letter dated March 12, 2004, the Maine Department of Environmental Protection ("MDEP") has noted that the proposed changes do not trigger DEP license or permit requirements that serve as the pertinent enforceable policies of the Maine Coastal Program. The proposed license amendments concern timing of actions required under the current FERC license and authorized under an existing DEP approval and do not involve any construction or other physical alterations. Thus, the proposed application does not involve a federal license or permit action for which federal consistency review is required.

The Orono, Stillwater, Milford, West Enfield and Medway projects are not located in Maine's designated coastal zone. The proposed federal license or permit actions regarding these projects may affect coastal resources or uses related to diadromous fish. SPO anticipates that any issues regarding coastal resources or uses will be addressed through pertinent state license and permitting processes, as applicable.

D. Energy

The Maine resource agencies support the increased energy generation capacity proposed by the applications as an important element of the MPA.

III. Conclusion

The Maine resource agencies offer no specific, additional substantial comments at this time regarding the license amendments for the Veszie, Stillwater, Milford, West Enfield, and Medway projects or the new license application for the Orono Project. The Maine resource agencies have participated in the development of the MPA and anticipate that it will appropriately address natural resources issues pertinent to their legal interests regarding the changes proposed by the applications. Consequently, the Maine resource agencies support PPL's request to waive the three-stage consultation requirements normally associated with applications for license amendment or a new license under the Commission's regulations. The Maine resource agencies intend to continue their involvement as appropriate in Commission as well as other related regulatory processes and may have additional, detailed comments as these processes move forward, as contemplated by the parties to the MPA.

We look forward to continued work with all stakeholders involved to realize the many and significant public benefits of the ambitious Penobscot River restoration effort pursuant to the MPA.

The Milford Project powerhouse and dam are listed in the National Register of Historic Places. Although you have stated on page E-1 that the license changes needed to satisfy the Lower Penobscot River Multi-Party Settlement Agreement (MPA) as it pertains to the Milford Project will not adversely effect the environmental resources described in Exhibit E of the 1997 FEIS, the Commission requests documentation to support this conclusion. Specifically, we ask that you provide us with a comparison between the fish passage requirements as they exist in the current license to those set forth in the MPA, along with a description of how the respective requirements in each scenario might be met through modifications to the historic property. The written analysis should include preliminary plans or other graphic material as appropriate. While you have indicated on page C-1 that consultation with agencies will occur for construction and operation of the fish passages, the Commission requires this material before issuing a finding of effect in accordance with the Advisory Council's regulations in 36 CFR Part 800.5.

In addition to the issue of fish passage at the Milford Project dam, we request clarification of the area subject to the proposed language change in Section E (Schedule for Implementation) on page ES-8. In particular, does this include the former Argyle Boom?

Organization of Amendment Application

This Amendment Application presents information and a discussion of those facilities and resources which will be affected by the proposed one-foot impoundment elevation increase, reduced bypass minimum flow and modified fish passage measures. Since the Amendment will only affect limited aspects of the Project, only relevant sections of the "Stillwater Hydroelectric Project, New License Application for Major Water Power Project 5 MW or Less" (Bangor Hydro-Electric Company [BHE] 1991) are presented herein. The previously filed Application for New License, and other relevant documents, including the 1997 "Lower Penobscot River Basin Final Environmental Impact Statement" (FERC 1997), are referenced for additional details, as appropriate.

This Amendment Application has been prepared in accordance with 18 CFR §4.201. Consistent with that subsection, and because the Stillwater Project has an installed capacity of 5 MW or less, this application includes an Initial Statement and Exhibits A, E, F and G, prepared pursuant to 18 CFR §4.61.

Exhibit A

Project Description

I. Project Facilities

A. Introduction

PPL Maine, LLC (PPL Maine) owns and operates the Stillwater Hydroelectric Project, which is licensed by the FERC as Project No. 2712. The project is located in the City of Old Town, Penobscot County, Maine on the Stillwater Branch of the Penobscot River. The Stillwater Branch is 10.5 miles long and is essentially a channel of the Penobscot River as it flows around the west side of Orson and Marsh islands. The Stillwater Dam spans the Stillwater Branch 2.4 miles upstream of its confluence with the mainstem of the Penobscot River in Orono. Figure A-1 presents a location map for the Stillwater Project. The Orono Hydroelectric Project (FERC No. 2710) is located on the Stillwater Branch just upstream from its confluence with the Penobscot River, 2.4 miles downstream of the Stillwater Project. The Gilman Falls Dam, a part of the Milford Hydroelectric Project (FERC No. 2534), is located approximately 3.1 miles upstream of the Stillwater Project.

The Stillwater Project facilities consist of a 1,712-foot-long concrete gravity dam, and one operating powerhouse integral with the dam. The remains of an older powerhouse, abandoned in 1942, are visible on the southeast portion of the dam. The operating powerhouse, located on the south side of the dam, has been generating electricity since its construction in 1932. The four existing turbine-generator units in the operating powerhouse pass a total flow of 1,700 cubic feet per second (cfs) and have a combined total installed capacity of 1,950 kilowatts (kW) at 18.0 feet of net head.

A detailed description of the Stillwater Hydroelectric Project can be found in Exhibit A of the Application for New License filed with FERC in 1991 (BHE 1991). In this section of the amendment application, the only changes to project structures that PPL Maine is proposing are to raise the height of the existing wooden flashboard system by one foot and to reduce the length of

flashboards removed to provide minimum flows². Thus, only those sections of the existing Exhibit A which describe the existing and proposed flashboards (Exhibit A.I.B); project operations (Exhibit A.I.C); enhancement costs (Exhibit A.I.D); and anticipated changes to annual generation (Exhibit A.I.E) have been revised and presented herein. All other sections of Exhibit A remain unchanged. Table A-1 (located at the end of this Exhibit) summarizes the project data for those aspects of the project affected by the proposed changes.

Exhibit F contains updated plans depicting the dam and flashboards. Exhibit G contains maps, which have been revised to depict the proposed new project boundary at elevation 94.65³. All elevations contained herein are consistent with the National Geodetic Vertical Datum (NGVD), which is equivalent to the 1929 Mean Sea Level Datum (MSL), unless otherwise noted.

The Stillwater Project dam is classified as a low hazard structure and was exempted from Part 12 Independent Safety Inspections and Emergency Action Plan requirements by letter dated December 28, 1993. However, in preparing this Amendment Application, PPL Maine had existing engineering and flood studies reviewed in order to confirm that the impoundment raising will not affect project engineering or have flooding impacts. Memoranda discussing flooding impacts and engineering issues have been provided in the CEII volume. Additional information related to flooding impacts is discussed in Section C below.

B. Description of Project Structures Affected by Proposed Amendment

B.1 Existing Flashboards

The 1,712-foot-long Stillwater Dam consists of 13 separate structures with varying profiles, ranging in height from a few inches to 22 feet. The dam is of concrete gravity construction and

In this Amendment Application PPL Maine is also proposing provisions related to fish passage consistent with the provisions of the MPA and the DOI modified fishway prescription dated June 2004. However, the proposed new license conditions will require submittal of plans, as a condition of the amended license, at a later time. Therefore, no design details for fish passage are reflected in this project description.

Consistent with the Commission's Critical Energy Infrastructure Information (CEII) regulations [18 CFR §388] Exhibits F and G are provided in a separate volume filed only with Commission staff. However, a description of the changes made to existing plans is provided in Exhibits F and G in this volume.

is built primarily on ledge. It is a long, meandering structure that takes advantage of the ledge formations at the site. Its length is misleading given the overall size of the project site. The Stillwater Branch is only 300 feet wide, 100 yards upstream of the dam. The existing project is equipped with flashboards on three of the 13 sections, and currently operates with a normal water surface elevation of 93.65. The following is a description of the existing configurations of the three sections of the dam, which carry flashboards (C, F, and I). In addition, five other sections that will need to have flashboards added to maintain the new normal pond elevation of 94.65 are described below (D, E, G, H, and J). Five sections (A/B, K, L, M, and the abandoned powerhouse foundation) will not be affected by the proposed changes and are not discussed herein.

- Section C is located in the main thread of the river and is the major structure of the dam. It is 381 feet long with an ogee shape and varies in height from three feet to 22 feet. The average height is 20 feet and it is currently fitted with two-foot-high wooden flashboards supported by metal pins which raise the 91.65 foot permanent crest to 93.65. The current 155 cfs minimum flow for the east channel of the bypass reach is provided at the southerly end of Section C.
- Section D consists of a concrete leveling course about two feet wide and 2-1/2 feet high. Its total length is 85 feet. This non-overflow section does not currently carry flashboards and has a permanent crest of 93.65.
- Section E sits between two ledge outcrops on a small low profile island. It is
 43 feet long. The section is a concrete sill on top of the ledge island and it does
 not currently carry flashboards.
- Section F is 174 feet long with an ogee shape and varies in height from four feet along the western third of the structure to 20 feet along the remaining two-thirds of the structure. This section of the dam currently includes two-foot-high wooden flashboards with metal pins on the crest of the structure. The permanent crest elevation is 91.65
- Section G is 52 feet long and has a maximum height of nine feet. Initially constructed with wooden flashboards, the structure has since been modified. The

The above-listed modifications will result in a one-foot increase in the normal water surface elevation to 94.65. The new flashboard system will retain the metal pins and has been designed to allow failure when overtopped by one foot of water, whereas the existing boards are designed to fail when overtopped by two feet. Thus, by maintaining the same flashboard failure point, upon failure of the flashboards the dam's flood flow discharge capacity will be maintained, and there will be no change in upstream water levels during high-flow periods. Additionally, the flashboards will fail at a lower flow.

C. Mode of Operation

C.1 Existing Operations

The Stillwater Hydroelectric Project is operated as a run-of-river facility. It is an unmanned station that is monitored several times daily by a roving operator.

The existing hydraulic capacity of the turbines is approximately 1,700 cfs. This flow is exceeded approximately 62 percent of the time, based on average daily flows recorded by the Licensee between 1968 and 1990.

The current normal impoundment elevation of 93.65 feet is maintained when river flows are at or below the hydraulic capacity of the units (1,700 cfs). The project impoundment created by the Stillwater dam extends upstream approximately 3.0⁴ miles at normal river flows. The present impoundment has a surface area of approximately 184 acres. When river flows exceed the hydraulic capacity of the units, water spills over the flashboards. When the water reaches a height of approximately two feet over the top of the flashboards, the boards begin to fail.

The Licensee is not able to replace the flashboards on the crest of the dam until the river flow is at or below the units' hydraulic capacity, when the impoundment can be drawn down to approximately the permanent crest elevation of 91.65 feet so that workers can safely install the flashboards.

The probable maximum flood (PMF) flow at the Stillwater Project has been calculated at 115,000 cfs, based on the proportionate flow to the Stillwater Branch. The spillway discharge capacity of the Stillwater Hydroelectric Project is approximately 25,000 cfs with the headwater at the top of the non-overflow sections (elevation 96.3 feet with the flashboards down). This value does not include flow through the powerhouse. This available capacity represents 22 percent of the 115,000 cfs PMF flow.

C.2 Proposed Operations

The proposed project enhancements and changes will not alter project operations. The normal impoundment elevation at the dam will be raised from 93.65 feet to 94.65 feet. Normal pond will continue to be maintained when river flows are at or below the hydraulic capacity of the units (1,700 cfs). The proposed one-foot increase in headpond elevation will result in minor changes to the length and area of the project impoundment. The shoreline of the Stillwater Project impoundment is predominantly steep sided, so the impoundment surface area of approximately 184 acres will be increased minimally by seven acres to approximately 191 acres.

In previous documents the impoundment area was listed as 300 acres and 3.1 miles long. It is believed those numbers were estimated based upon a rough measurement of the river and shoreline as depicted on topographic maps. Recent data obtained from a field reconnaissance survey and analysis of aerial photos indicates that the impoundment is 184 acres and 3.0 miles long.

There are prominent hydraulic controls at the upstream end of the impoundment, so the length of the three-mile project impoundment is not expected to increase appreciably (see Field Reconnaissance Memorandum, Exhibit E, Appendix E-B).

The new flashboard system has been designed to allow failure when overtopped by one foot of water, whereas the existing boards are designed to fail when overtopped by two feet. Thus, by maintaining the same flashboard failure point, upon failure of the flashboards the dam's flood flow discharge capacity will be maintained, and there will be no change in upstream water levels during high-flow periods. Additionally, the flashboards will fail at a lower flow. The new flashboard system will be installed in the same manner as regular flashboard replacements and will not require any instream construction activity.

In its comments on the draft of this Application, the Maine State Planning Office (MSPO) noted that changes resulting from the increased headpond level could require adjacent communities to consult with the Federal Emergency Management Agency (FEMA) regarding impacts to the National Flood Insurance Program (NFIP) maps (letter dated March 17, 2004, Appendix ES-A, Consultation Documentation). The increased headpond elevation will not impact flood levels because the flashboards will still fail at flows that are less than flood stage. However, the applicant is consulting with the Maine's NFIP coordinator, as the MSPO requested (see Telephone Discussion Notes dated June 10, 2004 [Appendix ES-A]). Any additional information received will be filed with FERC upon receipt.

The proposed project changes also include a reduction in minimum flows to the bypass reach from 195 cfs to 70 cfs. As discussed above, bypass flows are provided by removing a portion of the flashboards from Sections C and I of the dam which are of a specified length capable of passing the required flows. The proposed flow of 50 cfs in the east channel will require removal of an 4.4-foot-long section of flashboards on Section C, and the 20 cfs west channel flow will require removal of 1.6-foot section of flashboards on Section I.

- D. Estimated Annual Average Generation
- D.1 Existing Estimated Annual Average Generation

Based on the Licensee's records, the average annual net generation between 1961 and 2003 has been 12.644 MWh/vr.

- D.2 Proposed Estimated Annual Average Generation
- PPL Maine estimates that the annual average generation increase that will result from the one-foot increase in headpond elevation will be approximately 965 MWh/yr.

The increase in generation from reduced bypass flows will be approximately 723 MWh/yr.

- E. Estimated Cost of Project
- E.1 Existing Estimated Cost of Project

The costs of the existing project are provided in Exhibit A.I.E of the Application for New License (BHE 1991).

E.2 Proposed Estimated Cost of Project

The costs for all proposed project improvements and changes will be financed through PPL Maine's normal operating budget. The costs associated with the modification of the existing flashboard system, including adjustments to accommodate the reduced minimum flow, are negligible. The capital and operating costs of the fish passages will be determined based upon the final passage design, after consultation with agencies.



A detailed description of the environmental resources present in the Project area has been presented in Exhibit E of "Stillwater Hydroelectric Project, New License Application for Major Water Power Project 5 MW or Less" (BHE 1991). In addition, the resources of the project area were analyzed in the "Lower Penobscot River Basin Final Environmental Impact Statement" (FERC 1997), and a limited field reconnaissance survey was conducted in the fall of 2003 (Exhibit E, Appendix E-B). This section discusses only those resources affected by the proposed project improvements and changes, including the impoundment raising, reduced bypass flows, and modified fish passage measures. The potentially affected resources include fisheries and wetlands.

Environmental Report

I. General Description of Locale

A. Description of Existing Resources

The Stillwater Hydroelectric Project is located on the Stillwater Branch of the Penobscot River in the community of Stillwater, part of the city of Old Town, Maine. The Stillwater Branch is a 10.5-mile-long branch of the Penobscot River and the Stillwater Hydroelectric Project is located 2.4 miles upstream of the confluence of the Stillwater Branch and the mainstem of the Penobscot River in Orono. The Penobscot River and Stillwater Branch drainages above the project encompass approximately 7,602 square miles. The Penobscot River Basin's surface topography ranges from low hills and monadnocks to wide, flat river valleys. Surficial soils include ice-contact soils, out-wash sands, morainic silts, and clays. Bedrock is formed from a variety of metamorphosed sediments, and it is exposed near the river's surface along much of the river. A complete description of the Stillwater Project locale and geologic resources can be found in Exhibit E.I of the Application for New License (BHE 1991) and in the 1997 FEIS (FERC 1997).

B. Anticipated Environmental Impacts and Enhancement and/or Mitigation Measures Proposed

1. Anticipated Environmental Impacts

The project enhancements and changes proposed in this Amendment Application will not adversely affect geologic resources.

2. Studies/Measures Recommended by Resource Agencies

No additional studies or resource protection, mitigation, or enhancement measures have been requested by resource agencies to address impacts to geologic resources (see Appendix ES-A, Consultation Documentation).

3. Enhancement and/or Mitigation Proposed by Licensee

No changes to facilities or the operations of the Stillwater Project are proposed that would adversely affect geologic resources, and no mitigation measures are proposed.

II. Botanical Resources

The Stillwater Project area cover types include predominantly hardwood (39 percent), softwood (22 percent) and mixed (19 percent) forests, with lesser amounts of agricultural land (14 percent) and wetlands (6 percent). A complete description of the Stillwater Project botanical resources can be found in Exhibit E.II of the Application for New License (BHE 1991) and in the 1997 FEIS (FERC 1997). Additional information was obtained during a 2003 field reconnaissance survey (Exhibit E, Appendix E-B). Discussed below are those resources that may be affected by the impoundment raising, including wetlands, and critical areas and threatened/endangered species.

A. Description of Existing Resources

1. Wetlands

Thirty-four acres of small, independent, wetlands are found within the project area: 23 acres of palustrine forested wetland, four acres of palustrine scrub-shrub wetland, and seven acres of riverine emergent wetland. These wetlands are concentrated in the mid to upper portion of the impoundment, with a few small forested wetlands in the lower impoundment.

2. Critical Natural Features and Rare, Threatened, and Endangered Plant Species

There are no registered critical areas and no state-listed or federally-listed threatened or endangered plants known to occur the vicinity of the project area. The project area does have a unique natural community, a Northern New England Riverside outcrop, located 2.8 miles upstream of the dam. Riverside outcrops are areas of exposed bedrock with vegetation rooted within crevices in the rock. Riverside outcrops can contain rare plants, but none have been found on the Stillwater Branch outcrop.

According to the Maine Natural Heritage Program, there are seven rare plant stations historically known to be located within the project area. Rare plant stations within the project area include

two occurrences of Orono sedge (Carex oronensis), which is on Maine's Special Concern Plant List, three locations for long-leaved bluet (Hedyotis longifolia), one pale green orchis (Platantheria flava var. herbiola), and one occurrence of shining ladies'-tresses (Spiranthes lucida), a state-listed threatened species. The Spiranthes lucida station within the project area was found over two miles upstream of the dam and is an historical record that has not been confirmed to be extant in modern times. Similarly, the Pale green orchis was found in 1933 in an area approximately one mile upstream of the dam, but has not been found recently. Carex oronensis is a sedge endemic to the Penobscot Valley region of Maine; one station for this species is found approximately two miles upstream of the dam, and another occurs less than a mile downstream of the dam. The exact status of this species in Maine is not known at this time. Hedyotis longifolia is found on three sites within the project area, one approximately one mile upstream of the dam, and the other two near the northern limits of the project area. None of these existing rare plant stations are believed to be located within the small area influenced by the impoundment raising.

In its 1997 FEIS, FERC determined that the continued operation of the Stillwater Project would not adversely affect any botanical resources, including any federally threatened/endangered or rare plant species.

- B. Anticipated Environmental Impacts and Enhancement and/or Mitigation Measures Proposed
- 1. Anticipated Environmental Impacts

The project enhancements and changes proposed in this Amendment Application will not adversely affect botanical resources, including threatened and endangered species, in the Stillwater Project area. The increase in headpond elevation will have no material impact on wetlands within or adjacent to the project impoundment because these wetlands are concentrated in the mid to upper portion of the impoundment, where the increase in water level will be minimal (see Field Reconnaissance Memorandum, Exhibit E, Appendix E-B). None of the rare

III. Wildlife Resources

A. Description of Existing Resources

Wildlife habitats within the surrounding project area are predominantly riverine and hardwood forest, with lesser amounts of mixed and softwood forest, residential and disturbed areas, forested wetlands, and scattered shrub and emergent wetlands. In its 1997 FEIS, FERC determined that the continued operation of the Stillwater Project would not adversely affect any wildlife resources, including any federally threatened or endangered wildlife species. A complete description of the wildlife resources of the Stillwater Project area can be found in Exhibit E.III of the Application for New License (BHE 1991) and in the 1997 FEIS (FERC 1997).

B. Anticipated Environmental Impacts and Enhancement and/or Mitigation Measures Proposed

1. Anticipated Environmental Impacts

The project enhancements and changes proposed in this Amendment Application will not adversely affect wildlife resources, including threatened/endangered species, in the Stillwater Project area.

2. Studies/Measures Recommended by Resource Agencies

No additional studies or resource protection, mitigation, or enhancement measures have been requested by resource agencies to address impacts to wildlife resources (see Appendix ES-A, Consultation Documentation).

3. Enhancement and/or Mitigation Proposed by Licensee

No changes to facilities or the operations of the Stillwater Project are proposed that would adversely affect wildlife resources, and no mitigation measures are proposed.

IV. Fish Resources

A. Existing Fish Resources

The Stillwater Project includes a shallow riverine impoundment that extends upstream to a point just below PPL Maine's Gilman Falls Dam. A small amount of riverine habitat exists downstream of the Stillwater Project in the multi-channeled reach between the dam and the Orono Project impoundment (FERC No. 2710). Resident riverine species found in the project waters include minnows, smallmouth bass, white perch, pickerel and hornpout (BHE 1992). There are no known threatened or endangered fish species in the Stillwater Project area.

A complete description of the fisheries resources of the Stillwater Project area can be found in Exhibit E.III of the Application for New License (BHE 1991). Additional information is available in the 1997 FEIS (FERC 1997) and the 1992 Water Quality Certification (Maine Department of Environmental Protection [MDEP] 1992). The fisheries resources potentially impacted by the project improvements and changes proposed in this Amendment Application, including the impoundment and bypass fishery habitats, and fish passage, are discussed below.

Stillwater Impoundment

The Stillwater Project impoundment is a shallow three-mile riverine segment of the Stillwater River with a maximum depth of approximately 31 feet. The majority of the deeper water (15 feet or greater) is in the lower impoundment. There are a variety of substrates, ranging from ledge, through cobble and gravel, to fines and clay. Shoreline slopes are flat to steep. Aquatic plants are not prolific and emergents predominate over submergents; however, there are several "pocket" weed beds and a wetland around one of the islands. There are a number of timber cribs, ledge outcrops and overhanging and downed trees at various locations, as well as the remains of an old bridge, all of which provide excellent cover for smallmouth bass. The lower and upper reaches of the impoundment have considerably more ledge, coarser substrates, steeper shoreline slopes, and less aquatic vegetation than the middle reach. However, the middle reach

does have an interspersion of coarse substrates, and the lower and upper coarser-substrate areas do have considerable fines and some areas of aquatic vegetation.

A fish resource survey conducted in 1992 (BHE 1992) documented minnows, smallmouth bass, sunfish and white sucker as the dominant species in the Stillwater impoundment. Coldwater species are present seasonally, but the area is not known as a coldwater fishery. The impoundment does not stratify thermally and dissolved oxygen concentrations are in the range of 7.3 to 8.4 ppm. Summer water temperature may approach 80°F during extended warm periods, outside suitability range for coldwater species such as Atlantic salmon and trout. However, there are no water quality characteristics that interfere with fisheries management or the attainment of agency fishery goals for warmwater species such as smallmouth bass.

Stillwater Bypass Reach

The bypass channel below the Stillwater dam is rather complex with several channels and islands. There are two channels below the spillway sections (referred to as the east channel and west channel), which join in a large pool. There is a runaround channel between this pool and the downstream Orono Project impoundment, and the main channel below the pool diverges with one channel joining the powerhouse tailrace. The approximately 3,900-foot east channel contains large deep pools, rifles, flat shallow pools, and backwater areas with varied substrates. The approximately 100-foot-long west channel contains generally shallow riffle habitats with course substrates. It is known that there is recreational fishing in the bypass, primarily for smallmouth bass, which are readily observed. Agency management goals are primarily for smallmouth bass.

Pursuant to the Order Amending License issued June 29, 2001 [95 FERC ¶62,292], current bypass flows are 40 cfs in the west channel and 155 cfs in the east channel.

Fish Passage

Anadromous species including Atlantic salmon and alewife are believed to utilize the Stillwater Branch as a secondary migratory route, and occur in the project area as dropdowns and migrants from upstream stocking on the mainstem of the Penobscot River. The catadromous American eel is present throughout the Penobscot Basin. While currently the license requires plans for upstream and downstream fish passage, the only provision for passage currently in place at the Stillwater Project, is a downstream bypass.

- B. Anticipated Environmental Impacts and Enhancement Measures Proposed
- 1. Anticipated Environmental Impacts

Impoundment Raising

Smallmouth bass in the Penobscot watershed use impounded and free-flowing reaches equally, with the exception of spawning which occurs primarily in free-flowing stretches. To the extent that bass spawning activity might occur in the impoundment, the bass would be expected to shift shoreward proportional to the depth increase. Thus, the increased impoundment elevation proposed in the Amendment will have either no effect, or a net positive effect, on bass habitat (Fay 2004). Raising the Stillwater impoundment one foot will not appreciably affect the impoundment fishery habitat and will not adversely affect smallmouth bass management goals.

Bypass Reach Minimum Flows

PPL Maine is proposing to reduce current bypass minimum flows from 40 cfs in the west channel and 155 cfs in the east channel to 20 cfs in the west channel and 50 cfs in the east channel. The proposed minimum flows will continue to provide quality fisheries habitat, and will support agency management objectives, while increasing project generation by 723 MWh annually.

Environmental Report

An instream flow study was conducted in 1991 in association with the project relicensing (BHE 1991). The weighted usable area (WUA) for target species and lifestages was determined for both channels, at various flows. Tables E.3-1 and E.3-2 provide the WUA estimates comparing leakage to the proposed flows in each channel.

The proposed minimum flows will provide 71 and 80 percent of total maximum WUA in the west and east channels, respectively. This flow equates to 2.4 WUA per cfs in the west channel and 28.2 WUA per cfs in the west channel.

PPL Maine's proposed minimum bypass reach flows are consistent with the interim flows approved by the MDEP in the 1992 Water Quality Certification for the Stillwater Project (MDEP 1992). These proposed flows will provide significant habitat for target species and lifestages and are consistent with the MPA.

Fish Passage

PPL Maine's proposal to implement the DOI modified fishway prescription, consistent with the MPA, will support agency fish management plans and objectives. The proposed one-foot increase in impoundment level and decrease in minimum bypass flows will not affect existing or proposed fish passage facilities or their operations.

2. Studies/Measures Recommended by Resource Agencies

No additional studies or resource protection, mitigation, or enhancement measures beyond those proposed in this Amendment Application have been requested by resource agencies to address impacts to fisheries resources (see Appendix ES-A, Consultation Documentation).

3. Enhancement Measures Proposed by the Licensee

PPL Maine's proposal to implement the DOI modified fishway prescription, consistent with Attachment A of the MPA and as described in the proposed license articles presented in the Executive Summary, will support agency fish management plans and objectives.

In order to fully mitigate for any potential habitat impacts associated with the requested modifications, parties to the MPA developed a Contingent Mitigation Fund (CMF) (Attachment B to the MPA), whereby it was agreed that the impacts will be fully mitigated by removal of the Veazie (FERC No. 2403) and Great Works (FERC No. 2312) dams. If those dams are not removed, then the MPA provides for the establishment of the CMF and requires PPL Maine to make monetary payments in certain circumstances, as specified in Attachment B to the MPA, to the CMF to fully mitigate for the habitat impacts.

V. Water Quantity and Quality

A. Description of Exiting Resources

The Stillwater River in the vicinity of the project is designated by the State of Maine as a Class B water. The Maine Department of Environmental Protection (MDEP) issued a Section 401 Water Quality Certification for the Stillwater Project in 1992, finding that the project, as then proposed for relicensing, would comply with applicable state water quality standards. By letter dated January 26, 2004, the MDEP stated that the amendments proposed in this application will have no measurable effect on water quality in the Stillwater Project area. PPL Maine has applied for Water Quality Certification for the project improvements and changes proposed in this Amendment Application (Exhibit E, Appendix E-A). A complete description of the water resources of the Stillwater Project area can be found in Exhibit E.V of the Application for New License (BHE 1991) and in the 1997 FEIS (FERC 1997).

- B. Anticipated Environmental Impacts and Enhancement and/or Mitigation Measures Proposed
- 1. Anticipated Environmental Impacts

The project enhancements and changes proposed in this Amendment Application will have no measurable effect on water quality in the Stillwater Project area (MDEP 2004).

2. Studies/Measures Recommended by Resource Agencies

No additional studies or resource protection, mitigation, or enhancement measures have been requested by resource agencies to address impacts to water quality (see Appendix ES-A, Consultation Documentation).

3. Enhancement and/or Mitigation Proposed by Licensee

No changes to facilities or operations of the Stillwater Project are proposed that would have a measurable effect on water quality (MDEP 2004), and no mitigation measures are proposed.

VI. Land and Water Uses

A. Description of Existing Resources

The land bordering the Stillwater impoundment is predominantly forested, with smaller residential areas along the lower impoundment. There are no known domestic, irrigation or other consumptive uses of the river water in the project area. There are also no known industrial uses of the water nor any points of industrial wastewater discharge into the impoundment. A complete description of the land and water resources of the Stillwater Project area can be found in Exhibit E.VI of the Application for New License (BHE 1991) and in the 1997 FEIS (FERC 1997).

B. Anticipated Environmental Impacts and Enhancement and/or Mitigation Measures Proposed

1. Anticipated Environmental Impacts

The project enhancements and changes proposed in this Amendment Application will not adversely affect land and water uses in the Stillwater Project area. Due to the relatively small increase in impoundment water levels and steep topography of the shoreline, any affects along the impoundment will be negligible. In addition, because the flashboard system will be designed to have the same failure point, there will be no changes in upstream flooding impacts.

2. Studies/Measures Recommended by Resource Agencies

No additional studies or resource protection, mitigation, or enhancement measures have been requested by resource agencies to address impacts to land and water uses (see Appendix ES-A, Consultation Documentation).

VII. Recreation Resources

A. Existing Recreational Resources

Recreational facilities within the Stillwater Project area include a canoe launch, portage trail and fishing area below the dam (owned and operated by PPL Maine); and trails, fishing access, canoe launches, swimming areas and picnicking areas in the University of Maine Forest along the impoundment. A complete description of the Recreation resources of the Stillwater Project area can be found in Exhibit E.VII of the Application for New License (BHE 1991) and in the 1997 FEIS (FERC 1997).

B. Anticipated Environmental Impacts and Enhancement and/or Mitigation Measures Proposed

1. Anticipated Environmental Impacts

The project enhancements and changes proposed in this Amendment Application will not adversely affect the recreational resources in the Stillwater Project area. Whitewater boating that occurs downstream of the project will not be affected because this activity predominantly occurs in the spring when the flashboards are not in place. Kayaking and canoe use of the impoundment will not be affected by the higher impoundment elevation. None of the licensee supported University of Maine recreational facilities along the impoundment shoreline will be affected by the impoundment increase.

2. Studies/Measures Recommended by Resource Agencies

No additional studies or resource protection, mitigation, or enhancement measures have been requested by resource agencies to address impacts to recreational resources (see Appendix ES-A, Consultation Documentation).

VIII. Historical and Archaeological Resources

PPL Maine consulted with the State Historic Preservation Officer (SHPO) and the Penobscot Indian Nation (PIN) Tribal Historic Preservation Officer (THPO) regarding the improvements and changes proposed in this Amendment Application to confirm that there are no additional historic or archaeological issues at this time. By letter dated March 15, 2004 (Executive Summary, Appendix ES-A), the SHPO stated that the Amendments to the Stillwater Project license proposed herein will have no effect on archaeological or architectural historic properties. Additional consultation with the SHPO and THPO will occur as necessary to address potential impacts from construction activity at the projects.

In association with the previous relicensing proceeding, the MHPC found that there are no properties in the project area of archaeological, historic or architectural significance, as defined by the National Historic Preservation Act of 1966 (as amended). Based upon consultation with the SHPO and THPO, no enhancement and mitigation measures were determined to be necessary.

IX. Scenic and Aesthetic Resources

A. Description of Existing Resources

The Stillwater Hydroelectric Project encompasses the Stillwater dam and powerhouse in Stillwater Village, the area immediately below the dam that encompasses several small islands, and an approximately 184-acre impoundment extending three miles upstream. The area on either side of the river, within a one-half mile radius of the dam, is a relatively heavily-developed residential area. The rest of the area surrounding the impoundment is either lightly developed or undeveloped. Much of the western shoreline remains farmland, including a large tract owned by the University of Maine. Along the eastern shore of the impoundment, almost ninety percent of the shoreline remains undeveloped, including the University of Maine Forest, which comprises about fifty percent of the shoreline. Aside from the natural scenery of the area, there are no prominent scenic features. A complete description of the scenic and aesthetic resources of the Stillwater Project area can be found in Exhibit E.IX of the Application for New License (BHE 1991) and the 1997 FEIS (FERC 1997).

In accordance with the Lower Penobscot River Multiparty Settlement Agreement, June 2004 (MPA), PPL Maine, LLC has prepared various applications requesting approval for changes to the subject projects' water quality certifications and respective Federal Energy Regulatory Commission (FERC or Commission) licenses that are intended to implement the first phase of the MPA. The MPA is entirely consistent with the Lower Penobscot River Conceptual Agreement, August 2003, that we briefed the Department on several months ago. Please note that we expect to file the MPA, as well as all associated documents and requests with FERC, on or about 14 June 2004. Included in that filing, which will be copied to the Department, will be an explanatory statement that outlines the MPA and how the various requests for changes at our hydro projects fit within it.

We appreciate the Department's 12 March 2004 letter commenting on the draft applications. Without waiving any objections we may have as to provisions of State law that are preempted by the Federal Power Act, PPL Maine, LLC (and Bangor-Pacific Hydro Associates in the case of West Enfield) are submitting an original and one copy of each of the application forms for the above-referenced projects under the Maine Waterway Development and Conservation Act and Section 401 of the Clean Water Act. You will note that each application form cites applicable exhibits in the corresponding FERC application that will be filed soon hereafter. In the FERC applications we are requesting that the Commission use the revised license article provided by us to implement the requested changes and we also request that the Department, to the extent practicable, utilize the same language for changes to the water quality certification conditions.

Specifically, the enclosed application forms request changes to various projects as summarized below:

Medway Hydro Project, FERC No. 2666, Medway, Maine: increasing the normal headpond elevation by 1 foot by increasing the height of the existing flashboards

Stillwater Hydro Project, FERC No. 2712, Old Town, Maine: increasing the normal headpond elevation by 1 foot by increasing the height of the existing flashboards; modifying the minimum bypass flow requirements; and modifying the fish passage requirements to be consistent with the modified DOI/NMFS fishway prescription.

Milford Hydro Project, FERC No. 2534, Milford and Old Town, Maine: modifying the fish passage requirements to be consistent with the modified DOI/NMFS fishway prescription.

Orono Hydro Project, FERC No. 2710, Orono Maine: relicense and rehabilitate the Project to operate at its existing capacity of 2.3 MW; and modifying the fish passage requirements to be consistent with the modified DOI/NMFS fishway prescription.

West Enfield Hydro Project, FERC No. 2600, Enfield and Howland, Maine: increasing the normal headpond elevation by 1 foot by increasing the height of the existing flashboards, and incorporating the installation of upstream eel passage facilities.

3. In order to grant an MWDCA permit, and applicant must demonstrate that seven specific criteria have been met (See Section 636 of the statute). These criteria address the following issues: financial capability and technical ability; public safety; public benefits; traffic movement; LURC zoning; environmental mitigation; and environmental and energy considerations.

In order to grant Water Quality Certification, the Department must conclude that there is a reasonable assurance that the continued operation of a hydropower generating or storage project will not violate applicable Water Quality Standards. These standards have been established in the State's Water Classification Program (Title 38 MRSA Sections 464-469). These standards designate the uses and related characteristics of those uses for each class of water and establish water quality criteria necessary to protect those uses and related characteristics.

 Most proposals for the construction, reconstruction or structural alteration of a hydropower project will be subject to federal as well as state review and approval.

Any applicant for a FERC license must complete a three-stage consultation process with appropriate state and federal agencies. The purpose of this process is to identify and analyze the potential environmental and socioeconomic impacts of a project.

The consultation process requires an applicant to have either requested or obtained water quality certification at the time of filing with FERC. The process also requires that an applicant serve a copy of its FERC application, including any revisions, supplements or amendments thereto, on each of the agencies consulted.

Any applicant for a license, amendment of license, or exemption from the Federal Energy Regulatory Commission must complete a three-stage consultation process with appropriate state and federal agencies. The purpose of this process is to identify and analyze the potential environmental and socioeconomic impacts of a project.

Massey, Linda Breathitt, and Curt Hébert, Jr. On December 23, 1991, Bangor Hydro-Electric Company (Bangor Hydro) filed an application with the Federal Energy Regulatory Commission (Commission) under Part I of the Federal Power Act 1 (FPA) for a new license authorizing the continued operation and maintenance of the 1.95-megawatt (MW) Stillwater Hydroelectric Project No. 2712, located on the Stillwater Branch of the Penobscot River in the city of Old Town, Penobscot County, Maine. ² The Commission issued an original license for this project to Bangor Hydro in 1978, effective April 1, 1962. The original license expired on December 31, 1993, and since then Bangor Hydro has operated the project under an annual license. Bangor Hydro proposes no major construction or project modifications. For the reasons discussed below, we will issue a new license to Bangor Hydro for a period of 40 years. Background Notice of the application for the Stillwater Project was published. Four parties filed timely and unopposed motions to intervene in this proceeding: Maine FLOW, Maine State Planning Office, U.S. Department of the Interior (Interior), and the Penobscot Indian Nation (Penobscot Nation). These motions were granted automatically under Rule 214(c)(1) of the Commission's Rules of Practice and Procedure. 5 American Rivers' motion to intervene was opposed by Bangor Hydro. We are granting its motion. Comments on the application were filed by the U.S. Fish and Wildlife Service (FWS), Atlantic Sea Run Salmon Commission, U.S. Army Corps of Engineers (Corps), Maine Department of Marine Resources, Maine Department of Environmental Protection (MDEP), U.S. Department of the Interior (Interior), Maine State Planning Office, National Marine Fisheries Service (NMFS), and the Penobscot Nation. On November 15, 1994, the Commission's staff issued the Lower Penobscot River Basin Draft Environmental Impact Statement (Draft EIS), analyzing the Basin Mills, Milford, and Stillwater hydroelectric projects, and requesting public comment. The Commission received comment letters from Bangor Hydro; Atlantic Salmon Federation; Maine Council of Atlantic Salmon Federation; American Rivers, Inc.; Maine Audubon Society; Sportsman's Alliance of Maine; Trout Unlimited; Maine Council of Trout Unlimited; the Corps; Department of Commerce; Interior; U.S. Geological Survey; U.S. Environmental Protection Agency; Penobscot Nation; and the Penobscot River Coalition. The Commission's staff considered these comments in preparing [61,106] the Final Environmental Impact Statement (Final EIS). Concurrently with this order, we are issuing an order on Applications for New and Original Licenses, which discusses

issues common to three projects on the Penobscot and Stillwater Rivers. The discussion in that order is incorporated by

reference berein.

Project Description

The Stillwater Project's principal features are a meandering dam approximately 1,720 feet long, consisting of 13 sections, a concrete and wooden powerhouse, an impoundment about 3.1 miles long with a surface area of about 300 acres, and appurtenant facilities. The existing project has a total nameplate generator capacity of 1.95 MW and an average annual generation of about 13.1 gigawatthours (GWh). The maximum hydraulic capacity of the Stillwater Project is 1,700 cubic feet per second (cfs). Flows in the Stillwater Branch exceed the maximum hydraulic capacity of the project 60 percent of the time. A more detailed project description is contained in Ordering Paragraph B(2).

Water Quality Certification

Under Section 401(a)(1) of the Clean Water Act, 33 U.S.C. §1341(a)(1), the Commission may not issue a license for a hydroelectric project unless the state's certifying agency has issued a water quality certification for the project or has waived certification. ⁶ On October 23, 1992, the Maine Department of Environmental Protection granted water quality certification for the project, subject to certain conditions. The water quality certification contains 11 conditions, which are attached in full as Appendix A to this order.

Applicant's Plans and Capabilities

In accordance with Sections 10(a)(2)(C) and 15(a) of the FPA, we have evaluated Bangor Hydro's record as a Licensee with respect to the following: (1) consumption improvement program; (2) compliance history and ability to comply with the new license; (3) safe management, operation, and maintenance of the project; (4) ability to provide efficient and reliable electric service; (5) need for power; (6) transmission services; (7) cost effectiveness of plans; and (8) actions affecting the public.

1. Consumption Improvement Program

Section 10(a)(2)(C) of the FPA, 16 U.S.C. §803 (a)(2)(C), requires the Commission, in acting on a license application, to consider the extent of electricity consumption efficiency improvement programs in the case of license applicants primarily engaged in the generation or sale of electric power. Bangor Hydro submitted a comprehensive and detailed report, entitled "1988 Annual Narrative Energy Management Services," that covers programs designed to improve the consumption efficiency and to reduce peak demands of metered customers.

We have reviewed the report cited and conclude that Bangor Hydro has made in good faith a satisfactory effort to establish and maintain efficiency improvement and load management programs that comply with Section 10(a)(2)(c) of the FPA and to support the objectives of the Electric Consumers Protection Act of 1986.

2. Compliance History and Ability to Comply with the New License

We have reviewed Bangor Hydro's license application and its record of compliance with the existing license in an effort to judge its ability to comply with the articles, terms, and conditions of any license issued, and with other applicable provisions of this part of the FPA.

Based on our review of Bangor Hydro's compliance record, we find that Bangor Hydro has complied in good faith with all articles, terms, and conditions of its current license. As a result of our review of its compliance record and the license application, we believe Bangor Hydro can satisfy the conditions of a new license.

3. Safe Management, Operation, and Maintenance of the Project

Bangor Hydro ensures safe management, operation, and maintenance by holding periodic meetings for maintenance and management personnel to review and update safety procedures and maintain a comprehensive safety policy. This includes displaying warning signs and buoys and installing and maintaining safety equipment.

Although Stillwater is exempt from FERC's five-year inspections, Bangor Hydro retains an independent consultant to inspect the project facilities every five years. In addition, the facility is inspected annually, and remedial/monitoring programs are developed as necessary.

As a result of our review of Bangor Hydro's plans, we conclude that it will be able to manage, operate, and maintain the Stillwater Project in a safe manner.

4. Ability to Provide Efficient and Reliable Electric Service

We reviewed Bangor Hydro's plans and its ability to operate and maintain the project in a

manner most likely to provide efficient and reliable electric service.

Bangor Hydro evaluated four alternatives for the Stillwater Project, ranging from life extension of the original units to construction of a new powerhouse on the opposite side of the river. Bangor Hydro's economic analysis of the alternatives determined that none of the upgrade/expansion alternatives are presently feasible; therefore, Bangor Hydro is proposing no increase in either installed capacity or energy generation.

There are no personnel stationed at the project. Roving operators make a minimum of three trips to the plant during each shift for three shifts a day. During each of these plant visits, an operator takes water readings and makes adjustments to keep the impoundment level as constant as possible. The operator also checks the equipment, the plant, and its surrounding grounds including the substation and takes a full set of readings that are reported to the System Operator.

Bangor Hydro is refining the project operation to protect or enhance the project area's natural resources, such as passing minimum flows. Bangor Hydro also maintains and improves the project through various programs and refinements.

Based on our review of the information, we conclude that Bangor Hydro has been operating the project efficiently within the constraints of the existing license and that it would continue to provide efficient and reliable electric services in the future.

5. Need for Power

Bangor Hydro is an investor-owned electric utility serving more than 110,000 customers in the central and southern counties of Maine. As licensed herein, the Stillwater Project will generate an average of 13.1 gigawatthours (GWh) of energy annually for Bangor Hydro.

To assess the need for power, we reviewed not only Bangor Hydro's use and need for the project power, but also the needs in the operating region in which the project is located. The Stillwater Project is located in the New England Power Pool (NEPOOL) area of the Northeast Power Coordinating council region of the North American Electric Reliability Council (NERC). NERC annually forecasts electrical supply and demand in the nation and the region for a ten-year period. NERC's most recent report ⁷ on annual supply and demand projections indicates that, for the period 1995-2004, loads in the NEPOOL area will grow faster that planned capacity additions. The project displaces nonrenewable fossil-fired generation and contributes to diversification of the generation mix in the NEPOOL area. We conclude that the project's power, its low cost, its displacement of nonrenewable fossil-fired generation, and its contribution to a diversified generation mix will help meet a need for power in the NEPOOL area.

6. Transmission Service

We find that licensing the project to continue its current operations will have no significant effect on the licensee's existing or planned transmission system.

7. Cost Effectiveness of Plans

Bangor Hydro has no plans for making other significant project changes, except for those periodically required to ensure the project's safety. Based on the license application and past practice, we conclude that Bangor Hydro's plans for constructing fish and recreation facilities, as well as its continued operation of the project, will be achieved in a cost-effective manner.

8. Actions Affecting the Public

Constructing fish passage facilities and additional recreational facilities and releasing minimum flows will increase benefits to fisheries and recreation opportunities and, therefore, will benefit the public.

Fish Passage

Bangor Hydro contends that prescriptions filed by Interior and Commerce should not be given mandatory status, because they were filed after the deadline established in the public notice that the project was ready for environmental analysis. 8

Interior and Commerce both filed requests that the Commission include in the license a reservation of their authority to prescribe fishways. ⁹ Interior subsequently submitted a fishway prescription on February 17 and revised the prescription on June 22, 1995, and May 20, 1997; and Commerce submitted a prescription on February 16, 1995. A request for a reservation of prescription authority is

not itself a prescription. ¹⁰ And since the request is that a reservation of authority be included in the license, the reservation request cannot be invoked before the license is issued, and thus cannot make an untimely pre-license prescription timely. ¹¹

In any event, the agencies' late prescriptions were analyzed in the EIS as recommendations pursuant to FPA Section 10(a) and, as described below, we adopt most of those recommendations.

Article 405 requires that Bangor Hydro construct, operate and maintain fishways for the design populations of the species specified by Interior and to provide personnel of the U.S. Fish and Wildlife Service access to the project site and pertinent project records for the purpose of inspecting the fishways to determine compliance with the fishway conditions of the license. ¹²

Articles 406 (addressing downstream fishways) ¹³ and 407 (addressing upstream fishways) require that the licensee install and operate fish passage facilities at the project. These articles specify the migration periods during which the facilities must be operated. These articles also require Bangor Hydro to file and implement fishway maintenance and operational plans and to modify the fishways if the effectiveness studies required by Article 408 indicate that modifications are needed. ¹⁴

Article 408 requires Bangor Hydro to file and implement a plan to study the effectiveness of the fishways required by Articles 406 and 407. If the study indicates that changes in the project's structures or operations, including flow, are necessary, Article 408 requires Bangor Hydro to file and implement a plan to improve the effectiveness of the fishways.

Article 409 contains a reservation of authority for the prescriptions of fishways under Section 18 of the Federal Power Act by the Secretary of the Interior. ¹⁵

Recommendations of Federal and State Fish and Wildlife Agencies

Section 10(j) of the FPA requires the Commission, when issuing a license, to include conditions based on recommendations of federal and state fish and wildlife agencies submitted pursuant to the Fish and Wildlife Coordination Act, ¹⁶ to "adequately and equitably protect, mitigate damages to, and enhance fish and wildlife (including related spawning grounds and habitat)" affected by the project.

Pursuant to Section 10(j) of the FPA, we evaluated each recommendation of the federal and state fish and wildlife agencies for consistency with the purpose and requirements of Part I of the FPA or other applicable law. By executive order of the Governor of the State of Maine, the terms and conditions contained in Maine's 401 Water Quality Certifications represent the state's official recommendations regarding the application and supersede all preliminary recommendations by individual state agencies.

The draft EIS stated that Interior's recommendations concerning a recreation monitoring plan was an inappropriate fish and wildlife recommendation, ¹⁷ and that a 230-cfs minimum flow in the Stillwater bypassed reach may be inconsistent with the balancing provisions of Sections 4(e) and 10(a) of the FPA.

Under Section 10(j)(2) of the FPA, whenever the Commission believes that any recommendations of the federal and state fish and wildlife agencies may be inconsistent with the FPA or other applicable law, the Commission shall attempt to resolve such

inconsistencies. In a Section 10(j) meeting held on February 9, 1996, the Commission's staff requested that Interior consider specifying the habitat goals it sought and allow permanent flows to be within the range of 70 cfs, as specified in the water quality certification, up to 230 cfs, as originally sought by Interior. The required flow would be that amount sufficient to achieve the habitat goals after the berm is modified. Interior's subsequently provided revised minimum flows are incorporated in Articles 402 and 404.

Comprehensive Plans

Section 10(a)(2) of the FPA requires the Commission to consider the extent to which a project is consistent with federal or state comprehensive plans for improving, developing, or conserving a waterway or waterways affected by the project. Under Section 10(a)(2), federal and state agencies filed a total of 18 plans. Of these, we identified eight as relevant to the project. ¹⁸ No conflicts were found.

Comprehensive Development

Sections 4(e) and 10(a)(1) of the FPA, 16 U.S.C. §§797 (e) and 803(a)(1) require the Commission, in acting on applications for license, to give equal consideration to the power and development purposes and to the purposes of energy conservation, the protection, mitigation of damage to, and enhancement of fish and wildlife, the protection of recreational opportunities, and the preservation of other aspects of environmental quality. Any license issued shall be best adapted to a comprehensive plan for improving or developing a waterway or waterways for all beneficial public uses. The decision to license this project, and the terms and conditions included herein, reflect such consideration.

The EIS analyzed the effects associated with the issuance of the new license for the Stillwater Project. It recommends a number of measures to protect and enhance environmental resources, which we adopt, as discussed herein. These measures will provide improved fish passage at the dam, protect fish and wildlife resources by requiring run-of-river operation, and enhance recreational resources in the project area.

In determining whether a proposed project will be best adapted to a comprehensive plan for developing a waterway for beneficial public purposes, pursuant to Section 10(a)(1) of the FPA, the Commission considers several public interest factors, including the economic benefits of project power.

Under the Commission's approach to evaluating the economics of hydropower projects, as articulated in Mead Corporation, Publishing Paper Division, ¹⁹ the Commission employs an analysis that uses current costs to compare the costs of the project and likely alternative power with no forecasts concerning potential future inflation, escalation, or deflation beyond the license issuance date. The basic purpose of the Commission's economic analysis is to provide a general estimate of the potential power benefits and the costs of a project, and reasonable alternatives to project power. The estimate helps to support an informed decision concerning what is in the public interest with respect to a proposed license. In making its decision, the Commission considers the project power benefits both with the applicant's proposed mitigation and enhancement measures and with the Commission's proposed modifications and additions to the applicant's proposal.

In addition, certain economic factors related to project decommissioning impinge on the decision to issue a new license that are not present in the licensing of new projects. If an existing project is not issued a new license, or if the Licensee declines to accept the new license, the project probably will have to be retired in one form or another. This could range from simply removing the generator at the project to major environmental restoration varying from minor measures to dam removal.

As licensed by the Commission, the Stillwater Project will produce an average of about 12.208 GWh of energy, at an annual cost of about \$552,300 (45.2 mills/kWh). The current annual value of the project's power would be \$376,800 (30.9 mills/kWh). We base this value on the cost of alternative resources, which in this case is the cost of a new combined cycle combustion turbine plant and the regional cost

of natural gas. ²⁰ To determine whether the proposed project is currently economically beneficial, we subtract the project's cost from the value of the project's power. Thus based on current costs, the project, as licensed by the Commission would cost about \$175,500 (about 14.3 mills/kWh) more than the current cost of alternative power.

As described above, our evaluation of the economics of the project shows that the power it generates costs more than alternative power. However, as explained in *Mead*, the economic analysis is by necessity inexact, and project economics is only one of many public interest factors considered in determining whether or not, and under what conditions, to issue a license. ²¹ Bangor Hydro is ultimately responsible and best able to determine whether continued operation of the existing project, with the conditions adopted herein, is a reasonable decision in these circumstances.

Based on our review of the comments on this project filed by agencies and the public, our review of the staff's evaluation of the environmental and economic effects of the proposed project and its alternatives, and our analysis pursuant to Sections 4(e) and 10(a)(1), we find that the Stillwater Project, with our mitigative and enhancement measures, will be best adapted to the comprehensive development of the Stillwater River for beneficial public uses.

License Term

Section 15(e) of the FPA specifies that any license issued under Section 15 shall be for a term that the Commission determines to be in the public interest, but not less than 30 years, nor more than 50 years. The Commission's policy is to establish 30-year terms for projects that propose little or no redevelopment, new construction, or new capacity; 40-year terms for projects that propose moderate redevelopment, new construction, or new capacity; and 50-year terms for projects that propose extensive redevelopment, new construction, or new capacity.

In our policy statement on cumulative impacts and license reopeners, we stated that we would endeavor to coordinate the expiration dates of licenses for projects located in the same river basin to the maximum extent feasible, consistent with our commitment to considering the cumulative impacts of projects in the same river basin collectively at relicensing. ²² Issuing a license for the Stillwater Project with the same expiration date as for the Milford and Veazie Projects would further this policy by ensuring that these licenses expire simultaneously. Therefore, we will issue a license for a 40-year term for the Stillwater Project, effective the first day of the month in which this license is issued.

Summary of Findings

The EIS issued for this project includes background information, analysis of effects, discussion of enhancement measures, and support for related license articles. The project will not produce any major, long-term adverse environmental effects.

The design of this project is consistent with the engineering standards governing dam safety. The project will be safe if operated and maintained in accordance with the requirements of this license.

We conclude that the project will not conflict with any planned or authorized development and will be best adapted to the comprehensive development of the lower Penobscot River Basin for beneficial public uses.

The Commission orders:

(A) This license is issued to Bangor Hydro-Electric Company (Licensee) for a period of 40 years, effective the first day of the month in which this order is issued, to operate and maintain the Stillwater Hydroelectric Project. This license is subject to the terms and conditions of the Federal Power Act, which is incorporated by reference as part of this license, and subject to the regulations the Commission issues under the provisions of the Federal Power Act.

(B) The project consists of:

(1) All lands, to the extent of the Licensee's interest in those lands, enclosed by the project boundary shown by Exhibit G:

(2) Project works consisting of:

- (a) A main concrete gravity dam, totaling about 1,720 feet long, with a maximum height of 22 feet at crest elevation 91.65 feet National Geodetic Vertical Datum (NGVD), consisting of 13 sections: a non-overflow section, totaling 63 feet long, which serves as an abutment and wingwall, containing a 6-footwide unused stoplog sluice gate; a 381-foot-long primary spillway section, with a maximum height of 22 feet at a crest elevation of 91.65 feet NGVD, topped with 2.0-foot-high pin-supported flashboards; an 85-foot-long by 2-foot-wide by 2.5-foot-high leveling concrete course; a 43-foot-long concrete sill Section on top of a ledge island; a 174-foot-long ogee section, with varying heights from 4 to 20 feet, topped with 2.0-foot-high pin-supported flashboards; a 52-foot-long ogee section, with a maximum height of 9 feet, topped with a concrete curb, 15 inches wide by 25 inches high; a 105-foot-long spillway section, with an average height of 6 feet; a 42-foot-long spillway section, with a maximum height of 8 feet, topped with 1-foot-high pin-supported flashboards; a 73.5-foot-long abutment section, with an average height of 4 feet; a 187-foot-long non-overflow section, which is part of the abandoned powerhouse's foundation; a 197.5-foot-long section, with varying heights from 2 to 4 feet, abutting the old and existing powerhouses; and a 162.5-foot-long non-overflow section, with a downstream-facing earth backfill, having a maximum height of 12 feet, topped with a 2-foot-high concrete curb and a driveway on top of the earth backfill;
- (b) A concrete and wooden powerhouse, about 83.5 feet long by 32 feet wide by 45 feet high, equipped with four horizontal hydroelectrical generating units: three of which are rated at 450-kilowatts (kW) each, with a net head of 18 feet and a hydraulic capacity range from 380 to 1,140 cubic feet per (cfs); and one rated at 600 kW, with a net head of 18 and a hydraulic capacity of 560 cfs; all totaling a rated capacity of 1,950 kW; a hydraulic capacity range from 380 to 1,700 cfs; an average annual generation of about 13,120,000 kWh; and each having a net head of 18 feet;
- (c) An impoundment, about 3.1 miles long, having a surface area of about 300 acres (AC); a gross storage capacity of 3,040 acre-feet (AF); a negligible useable storage capacity; a normal headwater surface elevation of about 93.65 feet NGVD; and a normal tailwater surface elevation of about 73.65 feet NGVD; and
 - (d) Appurtenant facilities.

- (3) All of the structures, fixtures, equipment, or facilities used to operate or maintain the project and located within the project boundary, all portable property that may be employed in connection with the project and located within or outside the project boundary, and all riparian or other rights that are necessary or appropriate in the operation or maintenance of the project.
 - (C) The Exhibits A, F, and G described above are approved and made part of the license.
- (D) This license is subject to the articles set forth in Form L-3 (October 1975), entitled "Terms and Conditions of License for Constructed Major Project Affecting Navigable Waters of the United States," and the following additional articles:

Article 201. The Licensee shall pay the United States the following annual charges, effective as of the first day of the month in which this license is issued, for the purposes of reimbursing the United States for the costs of administering Part I of the Federal Power Act, a reasonable amount as determined in accordance with the provisions of the Commission's regulations in effect from time to time. The authorized installed capacity for that purpose is 1,920 kilowatts.

Article 202. Within 45 days of the date of issuance of the license, the licensee shall file an original set and two duplicate

sets of aperture cards of the approved drawings. The set of originals must be reproduced on silver or gelatin 35-mm microfilm. The duplicate sets are copies of the originals made on diazo-type microfilm. All microfilm must be mounted on type D (31/4" x 73/8/") aperture cards.

Prior to microfilming, the FERC Drawing Number (2712-1001 through 2712-1006) shall be shown in the margin below the title block of the approved drawing. After mounting, the FERC Drawing Number must be typed on the upper right corner of each aperture card. Additionally, the Project Number, FERC Exhibit (e.g., F-1, G-1, etc.), Drawing Title, and date of this license must be typed on the upper left corner of each aperture card.

The original and one duplicate set of aperture cards must be filed with the Secretary of the Commission, ATTN:

DPCA/ERB. The remaining duplicate set of aperture cards shall be filed with the Commission's New York Regional Office.

Article 203. Pursuant to Section 10(d) of the FPA, a specified reasonable rate of return upon the net investment in the project shall be used for determining surplus earnings of the project for the establishment and maintenance of amortization reserves. The Licensee shall set aside in a project amortization reserve account at the end of each fiscal year one half of the project surplus earnings, if any, in excess of the specified rate of return per annum on the net investment.

To the extent that there is a deficiency of project earnings below the specified rate of return per annum for any fiscal year, the Licensee shall deduct the amount of that deficiency from the amount of any surplus earnings subsequently accumulated, until absorbed. The Licensee shall set aside one-half of the remaining surplus earnings, if any, cumulatively computed, in the project amortization reserve account. The Licensee shall maintain the amounts established in the project amortization reserve account until further order of the Commission.

The specified reasonable rate of return used in computing amortization reserves shall be calculated annually based on current capital ratios developed from an average of 13 monthly balances of amounts properly included in the Licensee's long-term debt and proprietary capital accounts as listed in the Commission's Uniform System of Accounts. The cost rate for such ratios shall be the weighted average cost of long-term debt and preferred stock for the year, and the cost of common equity shall be the interest rate on 10-year government bonds (reported as the Treasury Department's 10 year constant maturity series) computed on the monthly average for the year in question plus four percentage points (400 basis points).

Article 401. The Licensee shall operate the Stillwater Project in a run-of-river mode for the protection of fisheries resources and recreational opportunities in the Stillwater Branch of the Penobscot River. Except as temporarily modified by approved maintenance activities, inflows to the project area, or operating emergencies beyond the Licensee's control, the Licensee shall maintain water levels in the Stillwater impoundment within one foot of normal full pond elevation of 93.65 feet NGVD while flashboards are in place.

The Licensee shall at all times act to minimize the fluctuation of the reservoir surface elevation by maintaining a discharge from the project so that, at any point in time, outflows, as measured immediately downstream from the project tailrace, approximate the sum of inflows to the project reservoir.

Run-of-river operation may be temporarily modified if required by operating emergencies beyond the control of the Licensee, and for short periods upon mutual agreement between the Licensee and the Maine Department of Environmental Protection. If the flow is so modified, the Licensee shall notify the Commission as soon as possible, but no later than 10 days after each such incident.

The Licensee shall prepare a plan in consultation with the Maine Department of Environmental Protection to monitor the water levels in Stillwater Impoundment and file the plan with the Commission, for approval, no later than 180 days after the issuance of this license. The Commission reserves the right to require changes to the water level monitoring plan. Upon Commission approval, the Licensee shall implement the plan, including any changes required by the Commission.

Article 402. The Licensee shall release from the Stillwater Project an interim minimum flow of 40 cubic feet per second (cfs) into the so-called west bypass channel and an interim minimum flow of 190 cfs into the so-called east

bypass channel, as measured at a location determined in consultation with the Maine Department of Environmental Protection, the U.S. Department of the Interior, the U.S. Geological Survey, and the Penobscot Indian Nation, or inflow to the project reservoir, whichever is less, for the protection and enhancement of fish and wildlife resources, water quality, and

recreation opportunities on the Stillwater Branch of the Penobscot River.

This flow may be temporarily modified if required by operating emergencies beyond the control of the Licensee, and for short periods upon mutual agreement between the Licensee and the Maine Department of Environmental Protection. If the flow is so modified, the Licensee shall notify the Commission as soon as possible, but no later than 10 days after each such incident.

Article 403. The Licensee shall, in consultation with the Maine Department of Inland Fisheries and Wildlife, the Maine Department of Marine Resources, the Atlantic Sea Run Salmon Commission, the U.S. Fish and Wildlife Service and the Penobscot Indian Nation, prepare a plan to make physical modifications to the gravel/cobble berm separating Sections 1 and 3 of the Stillwater bypassed reach to improve fish habitat availability. The Licensee shall file the plan with the Commission, for approval, no later that 180 days after issuance of this license.

The plan shall be reviewed by the state and federal fisheries agencies and the Maine Department of Environmental Protection Bureau of Land Quality Control. The Commission reserves the right to require changes to the berm modification plan. Activities shall not begin until the Licensee is notified by the Commission that these plans are approved. Upon Commission approval, the Licensee shall implement the plan, including any changes required by the Commission.

Article 404. The Licensee shall, in consultation with the Maine Department of Inland Fisheries and Wildlife, the Maine Department of Marine Resources, the Atlantic Sea Run Salmon Commission, the U.S. Fish and Wildlife Service and the Penobscot Indian Nation, prepare a plan to study various minimum flow releases between leakage and 40 cfs in the west bypassed reach and between leakage and 190 cfs on the habitat in Sections 1, 2, and 3, of the east bypassed reach, following berm modification. The purpose of the study will be to determine the permanent minimum flow in the east and west channels of the Stillwater bypassed reach. The target habitat units of the combined areas of the east bypassed reach are an additional 80.6 salmon nursery habitat units, 176.6 smallmouth bass spawning/incubation habitat units, 268 smallmouth bass young-of-year habitat units, 434.9 smallmouth bass juvenile habitat units, 311.4 smallmouth bass adult habitat units, 60 shad spawning/incubation habitat units, and 328.2 shad larvae/juvenile habitat units. These target habitat units are to be attained with flows into the bypassed reach no greater than 230 cfs and no less than 70 cfs.

The plan shall be reviewed by the state and federal fisheries agencies and the Maine Department of Environmental Protection Bureau of Land Quality Control. The Licensee shall file the plan with the Commission, for approval, no later than 180 days after issuance of this license.

Results from the minimum flow study and the Licensee's plans for maintenance of the berm and long-term minimum flow releases that will adequately maintain fish habitat in Sections 1, 2, and 3 shall be submitted to the Maine Department of Environmental Protection Bureau of Land Quality Control and the Commission within 18 months of license issuance for the project.

The Commission reserves the right to require changes to the berm maintenance plan and minimum flow study. Activities shall not begin until the Licensee is notified by the Commission that these plans are approved. Upon Commission approval, the Licensee shall implement the plan, including any changes required by the Commission.

Article 405. Fishways shall be constructed, operated, and maintained at the Stillwater Project to provide effective (safe, timely, and convenient) passage for the mainstem Penobscot River design populations of Atlantic salmon, American shad, alewives, and unquantified numbers of blueback herring and American eels at the Licensee's expense. The quantified design populations dor the mainstem Penobscot River for each target species is: 2.1 million Atlantic salmon; 250,000 American shad; up to 12,000 alewife. The fishways for the Stillwater Project should be sized appropriately for the migrating populations that use this portion of the river.

The Licensee shall provide personnel of the U.S. Fish and Wildlife Service, and other Service designated representatives, access to the project site and to pertinent project records for the purpose of inspecting the fishways to determine compliance with the fishway prescriptions.

Article 406. The Licensee shall install and operate permanent downstream fish passage facilities at the Stillwater Project. Fishways shall be maintained and operated to maximize fish passage effectiveness throughout fish migration period(s) as defined below. The downstream migration period is defined as April 1 to

June 30 for Atlantic salmon, July 1 to December 31 for American shad and alewife, August to December 31 for blueback herring, and August 15 to November 15 (or other time periods determined when adequate information is available, and during any spring run that may occur) for American eel. Downstream facilities are to operate whenever generation occurs during the downstream migration period. The Licensee shall keep the fishways in proper order and shall keep fishway areas clear of trash, logs, and material that would hinder passage. Anticipated maintenance shall be performed in sufficient time before a migratory period such that fishways can be tested and inspected and will operate effectively prior to and during the migratory periods.

Fishway maintenance and operational plans (including schedules) for all fish passage facilities shall be developed by the Licensee in consultation and cooperation with the U.S. Fish and Wildlife Service (FWS), the Penobscot Indian Nation (Penobscot Nation), and other fishery agencies (including the Maine Department of Inland Fisheries and Wildlife, Maine Department of Marine Resources, and the National Marine Fisheries Service). Functional design and final design plans for all fishways shall be developed in consultation and cooperation with the FWS, Penobscot Nation, and other fishery agencies.

Downstream fishways shall consist of installation of trashracks with 1" clear opening at the powerhouse turbine intake and gated surface and bottom bypasses discharging up to 70 cfs during the downstream migration period.

Within 180 days after the date of license issuance, the Licensee shall file, for Commission approval, detailed design drawings of the Licensee's proposed permanent downstream fish passage facilities. This filing shall include but not be limited to: (1) the location and design specifications of the passage facilities; (2) a schedule for installing the facilities; and (3) procedures for operating and maintaining the facilities.

The Licensee shall include with the filing documentation of consultation, copies of agency comments and recommendations on the drawings, plans, and schedule after they have been prepared and provided to the agencies, and specific descriptions of how the agencies' comments are accommodated by the Licensee's facilities. The Licensee shall allow a minimum of 30 days for the agencies to comment and to make recommendations before filing the drawings, plans, and schedule with the Commission. If the Licensee does not adopt a recommendation, the filing shall include the Licensee's reasons, based on project-specific information.

The Commission reserves the right to require changes to the proposed facilities and schedule. No construction of downstream fish passage facilities shall begin until the Licensee is notified by the Commission that the plan is approved. Upon Commission approval, the Licensee shall implement the proposal, including any changes required by the Commission.

Article 407. The Licensee shall install and operate permanent upstream fish passage facilities at the Stillwater Project. Fishways shall be maintained and operated to maximize fish passage effectiveness throughout fish migration period(s) as defined below. The upstream migration period is defined as April 15 to November for Atlantic salmon, May 1 to June 30 for American shad and alewife, June 1 to July 31 for blueback herring, and April 1 to November 30 for American eel. The Licensee shall keep the fishways in proper order and shall keep fishway areas clear of trash, logs, and material that would hinder passage. Anticipated maintenance shall be performed in sufficient time before a migratory period such that fishways can be tested and inspected and will operate effectively prior to and during the migratory periods.

Fishway design, maintenance and operational plans (including schedules) for all fish passage facilities shall be developed by the Licensee in consultation and cooperation with the U.S. Fish and Wildlife Service (FWS), the Penobscot Indian Nation (Penobscot Nation), and other fishery agencies (including the Maine Department of Inland Fisheries and Wildlife, Maine Department of Marine Resources, and the National Marine Fisheries Service). Functional design and final design plans for all fishways shall be developed in consultation and cooperation with the FWS, Penobscot Nation, and other fishery agencies. Upstream fishways must be designed to operate at mainstem Penobscot River flows up to 40,000 cfs (as measured for the Penobscot River at the U.S. Geological Survey gaging station at Eddington) during any upstream migration period designated herein. An attraction flow of up to 50 cfs at the fishway entrance shall be provided.

Within 180 days after the date of license issuance, the Licensee shall file, for Commission approval, detailed design drawings for permanent upstream fish passage facilities. This filing shall include but not be limited to: (1) the location and design specifications of the passage facilities; (2) a schedule for installing the facilities; and (3) procedures for operating and maintaining the facilities.

The Licensee shall include with the plan documentation of consultation, copies of comments and recommendations on the completed plan after it has been prepared and provided to

the agencies, and specific descriptions of how the agencies' comments are accommodated by the plan. The Licensee shall allow a minimum of 30 days for the agencies to comment and to make recommendations before filing the plan with the Commission. If the Licensee does not adopt a recommendation, the filing shall include the Licensee's reasons, based on project-specific information.

The Commission reserves the right to require changes to the proposed facilities and schedule. No land-disturbing or landclearing activities related to upstream fish passage shall begin until the Licensee is notified by the Commission that the plan is approved. Upon Commission approval, the Licensee shall implement the proposal, including any changes required by the Commission.

Article 408. Within 18 months after license issuance, the Licensee shall file with the Commission, for approval, a plan to monitor the effectiveness of all the facilities and flows provided pursuant to Articles 406 and 409 of this license that will enable the efficient and safe passage of anadromous fish migrating upstream and downstream. The results of these monitoring studies shall be submitted to the agencies listed below and shall provide a basis for recommending future structural or operational changes at the project.

The monitoring plan shall include a schedule for: (1) implementation of the plan; (2) consultation with the appropriate federal and state agencies concerning the results of the monitoring; and (3) filing the results, agency comments, and Licensee's response to agency comments with the Commission.

The Licensee shall prepare the monitoring plan after consultation with the U.S. Fish and Wildlife Service, Maine Department of Marine Resources, the Maine Department of Environmental Protection, the Penobscot Indian Nation, and the National Marine Fisheries Service.

The Licensee shall include with the plan documentation of agency consultation, copies of agency comments and recommendations on the plan after it has been prepared and provided to them, and specific descriptions of how the agencies' comments are accommodated by the Licensee's plan. The Licensee shall allow a minimum of 30 days for the agencies to comment and to make recommendations before filing the plan with the Commission. If the Licensee does not adopt a recommendation, the filing shall include the Licensee's reasons, based on project-specific information.

The Commission reserves the right to require changes to the proposed plan. Upon Commission approval, the Licensee shall implement the plan, including any changes required by the Commission.

If the results of the monitoring indicate that changes in project structures or operations, including alternative flow releases, are necessary to protect fish resources, the Licensee shall first consult with the agencies listed above to develop recommended measures for amelioration and then file its proposal with the Commission, for approval. The Commission reserves its authority to require the Licensee to modify project structures or operations to protect and enhance aquatic resources.

Article 409. Authority is reserved by the Commission to require the Licensee to construct, operate, and maintain, or to provide for the construction, operation, and maintenance of, such fishways as may be prescribed by the Secretary of the Interior under Section 18 of the Federal Power Act.

Article 410. Within one year of license issuance, the Licensee shall construct and provide for the operation and maintenance of the following recreational facilities:

- (1) provide fencing around the parking area on the east bank of the Stillwater dam and signs warning against launching canoes and walking out on to the dam;
- (2) provide gravel fill to the University of Maine to be used to create parking areas and one hand-carry boat and canoe access site;
- (3) provide surfacing materials for handicapped access to the northern cove in the University Forest adjacent to the Stillwater impoundment; and

(4) designate a visitor parking area at the Stillwater powerhouse and continue to provide and maintain the portage trail around Stillwater dam, providing safety booms and hazard warning signs near the Stillwater dam, and assess the demand for additional recreational opportunities in conjunction with FERC Form 80 surveys.

The Licensee shall construct these facilities after consultation with the Maine Department of Conservation and the Maine Department of Environmental Protection Bureau Land Quality Control. These facilities shall be shown on the as-built drawings filed pursuant to this license.

The Licensee shall file a report with the as-built drawings, which shall include the entity responsible for operation and maintenance of the facilities, documentation of consultation, copies of comments and recommendations on the report after it has been prepared and provided to the agencies, and specific descriptions of how the agencies' comments are accommodated by the report. The Licensee shall allow a minimum of 30 days for the agencies to comment

before filing the report with the Commission. If the Licensee does not adopt a recommendation, the filing shall include the Licensee's reasons, based on project-specific information.

Article 411. The Licensee, after consultation with the Town of Orono, National Park Service, Penobscot Indian Nation, Maine Department of Environmental Protection, and Maine Department of Conservation, shall monitor recreation and Indian cultural use of the project area to determine whether existing recreation facilities are meeting recreation and Indian cultural use needs. Monitoring studies shall begin within six years of the issuance date of this license. Monitoring studies, at a minimum, shall include collection of annual recreation use data.

Every six years during the term of the license, the Licensee shall file a report with the Commission on the monitoring results. This report shall include:

- (1) annual recreation and Indian cultural use figures;
- (2) a discussion of the adequacy of the Licensee's recreation facilities at the project site to meet recreation demand;
- (3) a description of the methodology used to collect all study data;
- (4) if there is need for additional facilities, the licensee's design of recreational facilities and how such design takes into account the national standards established by the Architectural and Transportation Barriers Compliance Board pursuant to the Americans with Disabilities Act of 1990;
- (5) documentation of agency consultation and agency comments on the report after it has been prepared and provided to the agencies; and
 - (6) specific descriptions of how the agency comments are accommodated by the report.

The Licensee shall allow a minimum of 30 days for the agencies to comment and to make recommendations prior to filing the report with the Commission.

Article 412. The Licensee shall implement the "Programmatic Agreement Among the Federal Energy Regulatory Commission, the Advisory Council on Historic Preservation, and the Maine State Historic Preservation Officer, for Managing Historic Properties That May Be Affected By A License Issuing To Bangor Hydro-Electric Company To Continue Operating The Stillwater Hydroelectric Project In Maine," executed on August 8, 1997, including but not limited to the Cultural Resources Management Plan for the Project. In the event that the Programmatic Agreement is terminated, the Licensee shall implement the provisions of its approved Cultural Resources Management Plan. The Commission reserves the authority to require changes to the Cultural Resources Management Plan at any time during the term of the license. If the Programmatic Agreement is terminated prior to Commission approval of the Cultural Resources Management Plan, the Licensee shall obtain Commission approval before engaging in any ground disturbing activities or taking any other action that may affect any historic properties within the Project's area of potential effect.

Article 413. (a) In accordance with the provisions of this license, the Licensee shall have the authority to grant permission for certain types of use and occupancy of project lands and waters and to convey certain interests in project

lands and waters for certain types of use and occupancy, without prior Commission approval. The Licensee may exercise the authority only if the proposed use and occupancy is consistent with the purposes of protecting and enhancing the scenic, recreational, and other environmental values of the project. For those purposes, the Licensee shall also have continuing responsibility to supervise and control the use and occupancies for which it grants permission, and to monitor the use of, and ensure compliance with the covenants of the instrument of conveyance for, any interests that it has conveyed, under this license. If a permitted use and occupancy violates any condition of this license or any other condition imposed by the Licensee for protection and enhancement of the project's scenic, recreational, or other environmental values, or if a covenant of a conveyance made under the authority of this license is violated, the Licensee shall take any lawful action necessary to correct the violation. For a permitted use or occupancy, that action includes, if necessary, canceling the permission to use and occupy the project lands and waters and requiring the removal of any non-complying structures and facilities.

(b) The type of use and occupancy of project lands and water for which the Licensee may grant permission without prior Commission approval are: (1) landscape plantings; (2) non-commercial piers, landings, boat docks, or similar structures and facilities that can accommodate no more than 10 watercraft at a time and where said facility is intended to serve single-family type dwellings; (3) embankments, bulkheads, retaining walls, or similar structures for erosion control to protect the existing shoreline; and (4) food plots and other wildlife enhancement.

To the extent feasible and desirable to protect and enhance the project's scenic, recreational, and other environmental values, the Licensee shall require multiple use and occupancy

of facilities for access to project lands or waters. The Licensee shall also ensure, to the satisfaction of the Commission's authorized representative, that the use and occupancies for which it grants permission are maintained in good repair and comply with applicable state and local health and safety requirements. Before granting permission for construction of bulkheads or retaining walls, the Licensee shall: (1) inspect the site of the proposed construction; (2) consider whether the planting of vegetation or the use of riprap would be adequate to control erosion at the site; and (3) determine that the proposed construction is needed and would not change the basic contour of the reservoir shoreline.

To implement this paragraph (b), the Licensee may, among other things, establish a program for issuing permits for the specified types of use and occupancy of project lands and waters, which may be subject to the payment of a reasonable fee to cover the Licensee's costs of administering the permit program. The Commission reserves the right to require the Licensee to file a description of its standards, guidelines, and procedures for implementing this paragraph (b) and to require modification of those standards, guidelines, or procedures.

(c) The Licensee may convey easements or rights-of-way across, or leases of, project lands for: (1) replacement, expansion, realignment, or maintenance of bridges or roads where all necessary state and federal approvals have been obtained; (2) storm drains and water mains; (3) sewers that do not discharge into project waters; (4) minor access roads; (5) telephone, gas, and electric utility distribution lines; (6) non-project overhead electric transmission lines that do not require erection of support structures within the project boundary; (7) submarine, overhead, or underground major telephone distribution cables or major electric distribution lines (69-kV or less); and (8) water intake or pumping facilities that do not extract more than one million gallons per day from a project reservoir.

No later than January 31 of each year, the Licensee shall file three copies of a report briefly describing for each conveyance made under this paragraph (c) during the prior calendar year, the type of interest conveyed, the location of the lands subject to the conveyance, and the nature of the use for which the interest was conveyed.

(d) The Licensee may convey fee title to, easements or rights-of-way across, or leases of project lands for: (1) construction of new bridges or roads for which all necessary state and federal approvals have been obtained; (2) sewer or effluent lines that discharge into project waters, for which all necessary federal and state water quality certification or permits have been obtained; (3) other pipelines that cross project lands or waters but do not discharge into project waters; (4) non-project overhead electric transmission lines that require erection of support structures within the project boundary, for which all necessary federal and state approvals have been obtained; (5) private or public marinas that can accommodate no more than 10 watercraft at a time and are located at least one-half mile (measured over project waters) from any other private or public marina; (6) recreational development consistent with an approved Exhibit R or approved report on recreational resources of an Exhibit E; and (7) other uses, if: (i) the amount of land conveyed for a particular use is five acres or less; (ii) all of the land conveyed is located at least 75 feet, measured horizontally, from project waters at normal surface elevation; and (iii) no more than 50 total acres of project lands for each project development are conveyed under this clause

(d)(7) in any calendar year.

At least 60 days before conveying any interest in project lands under this paragraph (d), the Licensee must submit a letter to the Director, Office of Hydropower Licensing, stating its intent to convey the interest and briefly describing the type of interest and location of the lands to be conveyed (a marked Exhibit G or K map may be used), the nature of the proposed use, the identity of any federal or state agency official consulted, and any federal or state approvals required for the proposed use. Unless the Director, within 45 days from the filing date, requires the Licensee to file an application for prior approval, the Licensee may convey the intended interest at the end of that period.

- (e) The following additional conditions apply to any intended conveyance under paragraph (c) or (d) of this article:
- (1) Before conveying the interest, the Licensee shall consult with federal and state fish and wildlife or recreation agencies, as appropriate, and the State Historic Preservation Officer.
- (2) Before conveying the interest, the Licensee shall determine that the proposed use of the lands to be conveyed is not inconsistent with any approved Exhibit R or approved report on recreational resources of an Exhibit E; or, if the project does not have an approved Exhibit R or approved report on recreational resources, that the lands to be conveyed do not have recreational value.

- (3) The instrument of conveyance must include the following covenants running with the land: (i) the use of the lands conveyed shall not endanger health, create a nuisance, or otherwise be incompatible with overall project recreational use; (ii) the grantee shall take all reasonable precautions to insure that the construction, operation, and maintenance of structures or facilities on the conveyed lands will occur in a manner that will protect the scenic, recreational, and environmental values of the project; and (iii) the grantee shall not unduly restrict public access to project waters.
- (4) The Commission reserves the right to require the Licensee to take reasonable remedial action to correct any violation of the terms and conditions of this ice, for the protection and enhancement of the project's scenic, recreational, and other environmental values.
- (f) The conveyance of an interest in project lands under this license does not in itself change the project boundaries. The project boundaries may be changed to exclude land conveyed under this license only upon approval of revised Exhibit G or K drawings (project boundary maps) reflecting exclusion of that land. Lands conveyed under this license will be excluded from the project only upon a determination that the lands are not necessary for project purposes, such as operation and maintenance, flowage, recreation, public access, protection of environmental resources, and shoreline control, including shoreline aesthetic values. Absent extraordinary circumstances, proposals to exclude lands conveyed under this license from the project shall be consolidated for consideration when revised Exhibit G or K drawings would be filed for approval for other purposes.
- (g) The authority granted to the Licensee under this article shall not apply to any part of the public lands and reservations of the United States included within the project boundary.
- (E) The Licensee shall serve copies of any Commission filing required by this order on any entity specified in this order to be consulted on matters related to that filing. Proof of service on these entities must accompany the filing with the Commission.
 - (F) The motion to intervene filed by American Rivers is granted.
- (G) This order is final unless a request for rehearing is filed within 30 days from the date of its issuance, as provided in Section 313(a) of the FPA. The filing of a request for rehearing does not operate as a stay of the effective date of this license or of any other date specified in this order, except as specifically ordered by the Commission. The Licensee's failure to file a request for rehearing shall constitute acceptance of this license.

FOLLOWING CONDITIONS:

1. Interim Minimum Flows

- A. Except as temporarily modified by operating emergencies beyond the applicant's control, as defined below, the facility shall be operated as run-of-river (outflow equals inflow) while passing an interim minimum flow of 20 cfs in the so-called west bypass channel and an interim minimum flow of 50 cfs in the east bypass channel.
- B. Operating emergencies beyond the applicant's control include, but may not be limited to, equipment failure or other temporary abnormal operating condition, generating unit operation or interruption under power supply emergencies, and orders from local, state, or federal law enforcement or public safety authorities.
- C. The applicant shall, in accordance with the schedule established in a new FERC license for the project, submit plans for providing and monitoring the minimum flow required by Part A of this condition. These plans shall be reviewed by and must receive approval of the DEP Bureau of Land Quality Control.

2. Berm Modification and Minimum Flow Study

- A. The applicant shall make physical modifications to the gravel/cobble berm separating habitat Sections 1 and 3 and conduct a minimum flow study to determine habitat availability for the life stages of the target fish species previously evaluated.
- B. The applicant shall, in consultation with the Department of Inland Fisheries and Wildlife, the Department of Marine Resources, the Atlantic Sea Run Salmon Commission, and the Penobscot Indian Nation, prepare a plan to make physical modifications to the gravel/cobble berm separating Section 1 and 3 as seen on Exhibit #3, and to conduct a study assessing the impact of various minimum flow releases between leakage and 190 cfs, on the habitat in Sections 1, 2, and 3. The plan shall be reviewed by and must receive approval of state and federal fisheries agencies and the DEP Bureau of Land Quality Control.

C. The results of the minimum flow study and the applicant's proposals for maintenance of the berm and long-term minimum flow releases that will adequately maintain fish habitat in Sections 1, 2, and 3 shall be submitted to the DEP Bureau of Land Quality Control within one full field season following the issuance of a new FERC license for the project. After reviewing the study results, the applicant's proposal, and agency comments, the Department shall order such continuation or modification of the interim minimum flow established by this approval as is deemed necessary to maintain adequate fish habitat in Section 1, 2, and 3 and in the west bypass channel.

3. Water Levels

- A. Except as temporarily modified by normal maintenance activities or by inflows to the project area or by operating emergencies beyond the applicant's control, as defined below, water levels in the Stillwater impoundment shall be maintained within one foot of normal full pond elevation of 93.65 feet (NGVD) while flashboards are in place.
- B. Operating emergencies beyond the applicant's control include, but may not be limited to, equipment failure or other temporary abnormal operating conditions, generating unit operation or interruption under power supply emergencies, and orders from local, state, or federal law enforcement or public safety authorities.
- C. The applicant shall, in accordance with the schedule established in a new FERC license for the project, submit plans for providing and monitoring the water levels in the Stillwater impoundment as required in Part A of this condition. These plans shall be reviewed by and must be receive approval of the DEP Bureau of Land Quality Control.

4. Fish Passage Facilities

- A. The applicant shall install and operate permanent upstream and downstream fish passage facilities at the Stillwater Project as proposed in the application.
 - B. The applicant shall, in accordance with the schedule established in a new FERC license for the project, submit

functional design drawings, a construction schedule, and operating and maintenance plans for all fish passage facilities required by Part A of this condition, prepared in consultation with state and federal fisheries agencies and the Penobscot Indian Nation. These submittals shall be reviewed by and must receive approval of state and federal fisheries agencies, FERC and the DEP Bureau of Land Quality Control prior to facilities construction.

5. Fish Passage Studies

- A. The applicant shall, in consultation with state and federal fisheries agencies and the Penobscot Indian Nation, conduct a study to monitor and evaluate the effectiveness of all fish passage facilities constructed pursuant to Condition 4 of this certification.
- B. The applicant shall, within 1 year following the issuance of a new FERC license for the project, submit a fish passage study plan and schedule, prepared in consultation with state and federal fisheries agencies and the Penobscot Indian Nation. This plan and schedule shall be reviewed by and must receive approval of state and federal fisheries agencies, FERC, and the DEP Bureau of Land Quality Control.
- C. The applicant shall, in accordance with the schedule established in a new FERC license for the project, submit the results of the fish passage study, along with any recommendations for structural, operational changes, or additional fishways, based on the results of the study, to the DEP Bureau of Land Quality Control and to all consulting agencies. The Department reserves the right, after opportunity for hearing, and after reviewing the comments and recommendations for the consulting fishery agencies and the Penobscot Indian Nation, to require reasonable structural and/or operational changes to the existing fish passage facilities, or require additional fishways, as may be necessary to effectively pass anadromous fish through the project area. Any such changes or new fishways must also be approved by FERC.

6. Recreational Facilities and Access

- A. The applicant shall: provide fencing around the parking area on the east bank of the Stillwater Dam and provide warning signs; provide gravel fill and surfacing materials as agreed to in the Memorandum of Understanding between the applicant and the University of Maine; designate a visitor's parking area at the Stillwater powerhouse; continue to maintain the portage trail around the Stillwater Dam; continue to provide safety booms and hazard warning signs in the vicinity of the Stillwater Dam; and continue to assess the demand for additional recreational opportunities.
 - B. The applicant shall, in accordance with the schedule established in a new FERC license for the project, submit a schedule for implementing Part A of this condition. This schedule shall be reviewed by the Department of Conservation and must receive approval of the DEP Bureau of Land Quality Control.

7. Limits of Approval

This approval is limited to and includes the proposals and plans contained in the application

and supporting documents submitted and affirmed to by the applicant. All variances from the plans and proposals contained in said documents are subject to the review and approval of the Board or Department prior to implementation.

8. Compliance with All Applicable Laws

The applicant shall secure and appropriately comply with all applicable federal, state and local licenses, permits, authorizations, conditions, agreements and orders required for the operation of the project.

9. Effective Date

This water quality certification shall be effective on the date of issuance of a new hydropower project license by the Federal Energy Regulatory Commission (FERC) and shall expire with the expiration of this FERC license.

Order Approving Transfer of Licenses

(Issued April 1, 1999)

J. Mark Robinson, Director, Division of Licensing and Compliance.

By application filed December 7, 1998, as amended January 22, 1999, Bangor Hydro-Electric Company (Bangor or transferor) and Penobscot Hydro, LLC (Penobscot or transferee) request Commission approval to transfer the licenses for the Veazie, Milford, Medway, Orono, Stillwater, Howland, and Ellsworth Hydroelectric Projects (Nos. 2403, 2534, 2666, 2710, 2712, 2721, and 2727, respectively) from Bangor to Penobscot. The first five named projects are located on the Penobscot and Stillwater Rivers in Penobscot County, Maine; the sixth on the Piscataquis River in Penobscot County, Maine; and the seventh on the Union River in Hancock County, Maine.

Transfer of the licenses for these projects is requested in connection with the divestiture by Bangor of certain generation and other assets, pursuant to Maine Public Law 1997, ch. 316, 35-A §3204, et seq. (An Act to Restructure the State's Electric Industry).

As discussed below, the transfers will be approved. 2

Background

Bangor holds original licenses for the Medway, Orono, and Howland Projects, ³ and new licenses for the Veazie, Milford, Stillwater, and Ellsworth Projects. ⁴

Bangor proposed to decommission the Orono Project No. 2710 (which is operating under an annual license) as part of its proposal to build the downstream Basin Mills Project No. 10981. However, by order issued April 20, 1998, the Commission denied Bangor's application for license for Project No. 10981. ⁵ Bangor subsequently requested rehearing of the denial, which is pending before the Commission.

Penobscot will be succeeding to the interests of PP&L Global, Inc., under an Asset Purchase Agreement entered into between Bangor and PP&L Global, Inc., on September 25, 1998, pursuant to the noted Maine restructuring law, whereby Bangor agreed to sell certain generation and other assets to PP&L Global, Inc., including the seven subject hydroelectric projects, subject to Commission approvals. PP&L Global, Inc. is a wholly owned subsidiary of PP&L Resources, Inc., and is primarily engaged in the development, acquisition, ownership, and management of generation, transmission, and distribution facilities worldwide. Penobscot is a wholly owned subsidiary of PP&L Global, Inc.

On January 29, 1999, public notice of the amended transfer application was issued. A timely motion to intervene was filed by the Maine State Planning Office (requesting party status only). ⁶ The U.S. Department of the Interior filed comments.

Discussion

Interior notes that it has reserved authority to prescribe fishways under Section 18 of the Federal Power Act (FPA) at the Ellsworth and Medway Projects. It describes Bangor's cooperation in developing fish passage measures at Ellsworth and eel passage measures at Medway, and urges the Commission to view with disfavor any transferee request for extensions

of compliance deadlines based solely on the transfer.

The applicants request substitution of Penobscot for Bangor as applicant in the pending relicensing proceedings in Project Nos. 2666 and 2721 and waiver of the requirements of Section 16.9(d)(1) pertaining to the public notice requirements for material amendments relicensing applications. ⁷

The public notice of the transfer application stated that the transfer would lead to the substitution of the transferee for the transferor as the applicant for new licenses for Project Nos. 2666 and 2721. This notice was published in the Federal Register and in the local newspaper once, and was served on federal and state resource agencies and Indian tribes, substantially as required by Section 16.9(d)(1). Adherence to the remaining notice requirements of Section 16.9(d)(1) would serve no useful public purpose, and those requirements are therefore waived.

Applicants request that the substitution be made contingent upon the consummation of the asset sale contemplated in the Asset Purchase Agreement and be made effective upon the "transfer date." Since the "transfer date" is unknown to the Commission until the date of the filing of transferee acceptance forms and conveyance documents (see Ordering Paragraph (C), below), substitution is approved as of the latter date.

As noted in the public notice of the transfer application, the Commission's policy is to scrutinize transfer requests that are filed during the last five years of a license to determine if the transfer's primary purpose is to give the transferee an advantage in relicensing, such as when a transfer is intended to escape consideration of a transferor's poor compliance record. ¹⁰ Here, the compliance record of the transferor is satisfactory, and the transfer will facilitate the continued operation and maintenance of the projects under the described transaction. Therefore, there is no basis for concluding that the transfer is intended to avoid a poor compliance record or otherwise give Penobscot an advantage in relicensing.

Conclusions

Bangor has satisfactorily complied with the terms and conditions of the licenses. Bangor has paid and agrees to continue to pay charges which accrue until the transfer is effective. 11

Penobscot is not a licensee of the Commission. Therefore, we have no hydroelectric compliance record to review. However, Penobscot intends to hire several employees of the transferor who have experience operating and maintaining the licensed projects. Penobscot is qualified to hold the licenses and to operate the properties under the licenses, and it has agreed to accept all the terms and conditions of the licenses, and to be bound by the licenses as if it were the original licensee. In the January 22, 1999 amendment to the transfer application, at p. 3, Penobscot states that it has not yet obtained, but will obtain, authority to conduct business in the State of Maine.

The proposed transfers are consistent with the Commission's regulations and are in the public interest.

The Director orders:

(A) Transfer of the licenses for Projects Nos. 2403, 2534, 2666, 2710, 2712, 2721, and 2727, the Veazie, Milford, Medway, Orono, Stillwater, Howland, and Ellsworth Hydroelectric Projects, from Bangor Hydro-Electric Company to Penobscot Hydro, LLC is approved.

- (B) Bangor Hydro-Electric Company shall pay all annual charges that accrue up to the effective date of the transfer.
- (C) Approval of the transfers is contingent upon: (1) transfer of title of the properties under license and delivery of all license instruments to Penobscot Hydro, LLC, which shall be subject to the terms and conditions of the licenses as though it were the original licensee; (2) Penobscot Hydro, LLC acknowledging acceptance of this order and its terms and conditions by signing and returning the attached acceptance sheets [omitted in printing]; and Penobscot Hydro, LLC obtaining authorization to conduct business in the State of Maine. Within 60 days from the date of this order, Penobscot Hydro, LLC shall submit certified copies of all instruments of conveyance, the signed acceptance sheets, and the state authorization to

PURPOSE OF STUDY

The purpose of this study was to assess the potential impacts to wetland systems and wildlife habitat adjacent to the Stillwater and Medway impoundments resulting from a proposed one foot increase in headpond elevation to these impoundments.

WETLAND SYSTEMS OBSERVED

Wetland areas were observed and photo documented on December 4 - 5, 2003. Photo locations are shown on the figures entitled "Stillwater" and "Medway". Palustrine forested wetland, palustrine scrub-shrub wetlands, and riverine emergent wetlands as defined by Cowardin et. al. (1979) were observed along both Stillwater and Medway impoundments. Forested wetlands are dominated by northern white cedar, red maple, silver maple, and green ash, and typically have a sparse understory of sensitive fern, royal fern (Osmunda regalis) and cinnamon fern. The scrub wetland type includes sweet gale (Myrica gale), winterberry (Ilex verticillata), red maple, sheep laurel (Kalmia angustifolia), bog laurel (K. polifolia), alder, and willow (Salix spp.). Emergent wetlands are vegetated by typical marsh species such as cattail, (Typha latifolia), sedges and rushes (Cypereaceae), wapato (Sagittaria latifolia), pickerelweed (Pontedaria cordata), and yellow pond-lily (Nuphar variegatum)

STILLWATER

Assessment

On December 4, 2003 staff from Devine Tarbell & Associates (DTA) visited the Stillwater Impoundment. Surface water elevations were taken at the Stillwater dam at the water surface on the north and south shore. Elevations recorded were compared to the gauge reading at the dam. The water surface elevation on the north shore at the dam was 94.23 NGVD 291 and on the south shore of 94.01. The gauge reading at the time of the survey was noted at 94.35. The normal headpond elevation of the Stillwater impoundment is 93.65. Conditions observed at the impoundment were approximately 0.6 feet above the normal pool. DTA observed at least 0.5 feet spilling over the dam, indicating the gauge elevation and surveyed elevations appear to be accurate. An elevation of 94.8 was observed approximately 1 mile north on the west shore of the impoundment. This indicates that the surface water elevation of the impoundment under these conditions increased by approximately ½ foot in elevation per mile of distance.

The shoreline of the current Stillwater impoundment was digitized on an aerial photo based on the shoreline at the time of the photography (1998)² The proposed head pond limits were determined by field observations, noting that the observed head pond elevation was approximately ½ foot higher than the normal impoundment elevation of 93.65. The area of the Stillwater headpond is approx. 184 acres based on the (1998) photography. The approximate level of inundation from the proposed increase in headpond elevation was extrapolated based on visual field observations of adjacent topographic characteristics of the shoreline. The approximate location of the shoreline under the proposed conditions is shown on the aerial graphic entitled "Stillwater", in blue. The area of the Stillwater impoundment under proposed conditions was determined to be approximately 191 acres, an increase of approximately 7 acres.³

Conclusions

Seasonal and intermittent increases to the impoundment elevation occur on a regular basis depending on naturally occurring runoff and rain events. Under the proposed conditions the

water surface elevation over the lower 2/3rds of the impoundment will permanently increase ranging from one foot at the dam decreasing in elevation to approximately 2 miles upstream from the dam. The upstream limit of the impoundment is not expected to be affected. Wetland areas as shown on photos 15 and 16 are expected to experience a minimal permanent water surface increase. These forested wetland systems will alter slightly, in the near term, however, similar wetland systems will reestablish up gradient with little or no permanent affects to the current systems. A similar affect to the wetland systems closer to the dam are anticipated, with a longer duration, however, fewer wetlands are present in this area. Backwater wetland areas located in the upper reaches of the Stillwater impoundment are shown on photos 6-13. These are forested wetland areas that will be unaffected or only minimally affected by the proposed increase. Wetlands will not be affected under periods of high water flows as the proposed flashboard system will be designed to fail at the same elevation as the current flashboard system.

MEDWAY

Assessment

On December 5, 2003 DTA visited the Medway Impoundment. Water surface elevations were taken above the Medway dam at the water surface on the north shore. Water surface elevations were compared to the gauge reading at the dam to determine its accuracy. The elevation on the north shore at the dam was 259.1. The gauge reading at the time of the survey was noted at 259.29. The 0.2' difference is most likely due to affect of the intake to the powerhouse. Normal head pond elevation of the Medway impoundment is 259.3 feet. A water surface elevation of 262.2 was observed approximately 1000' southerly of the upstream Millinocket dam. This indicated that, under these conditions, there was an increase of approximately 1.8 feet in surface water elevation per mile of distance.

The shoreline of the Medway impoundment was digitized on an aerial photo based on the shoreline at the time of the photography (1998)². The proposed headpond limits were determined by field observations of shoreline topographic features. The area of the Medway head pond is approximately 98 acres, based on the 1988 photography. The approximate level of inundation from the proposed increase in headpond elevation was extrapolated based on visual field

observations of adjacent topographic characteristics of the shoreline. The approximate location of the shoreline under proposed conditions is shown on the aerial figure entitled "Medway", in blue. The Medway impoundment under the proposed conditions was determined to be approximately 101.5 acres, an increase of approximately 3.5 acres.

Wetland areas were observed and photo documented on December 5, 2003. Photo locations are shown on the figure mentioned above.

Conclusions

Naturally occurring seasonal and intermittent increases to the impoundment occur on a regular basis depending on spring runoff volumes and rain events. Overall increases of water surface elevation over the lower 2/3rds of the impoundment will permanently increase ranging from one foot at the dam decreasing in elevation to approximately 1.2 miles upstream from the dam. Wetland areas shown on photos 18-24 will be unaffected due to steep shoreline topography and outside of the proposed impoundment increase. Wetland areas shown on photo 27 and 28 are a series of isolated small linear islands containing fringe emergent wetlands and scrub-shrub wetlands toward the center. These wetland areas will experience a slight permanent water surface increase. It is expected that there will be minimal impacts, in the near term, however, similar wetland systems will reestablish themselves up gradient with little or no permanent affects to the current systems. A similar affect to the wetlands systems closer to the dam are anticipated, with a longer duration, however, fewer wetlands are present due to steeper topography. Wetlands will not be affected during periods of high water events as the proposed flash board system will be designed to fail at the same elevation as the current flashboard system.

The proposed project improvements and changes will affect limited structures as depicted on Exhibit F-1 and F-2. Revised plans have been prepared which reflect the following changes:

- F-1:
 - New flashboard height reflected on cross sections of C, F, and I;
 - New flashboards added to cross sections of D, E, G, H, and J; and
 - New normal pond elevation of 94.65 feet reflected on all cross sections.
- **■ F-2**:
 - Headpond elevation on powerhouse cross section revised to 94.65 feet.
