Case Study of Fluvial Modeling of River Responses to Dam Removal

5 Abstract: A plan was made to remove Matilija Dam on the Ventura River. With dam removal, the delta in the reservoir and the **6** downstream channel were expected to undergo major changes in morphology. The FLUVIAL-12 model was employed to simulate **7** reservoir and river channel responses after dam removal. As a first step, the model was calibrated using the Ventura River data to establish **8** its validity. In calibration, the model was used to simulate the fluvial processes starting from the time of dam completion. The simulated **9** sediment deposition above the Matilija Dam matches closely with the deposits measured by the U.S. Bureau of Reclamation. A large **10** amount of sediment was stored in the reservoir; some of the stored sediment was transported downstream after dam removal. An important **11** consequence of dam removal is the major increase of sediment release to the river channel downstream. The sediment supply to the **12** downstream reach is not only from the stored sediment in the reservoir but also from natural sediment inflow from the upstream **13** watershed. Therefore, sediment supply to the downstream reach will exceed the natural sediment flow before the dam presence. This **14** situation tends to overload the downstream reach with sediment, resulting in excessive deposition. The amount of sediment release from **15** the area above the removed dam is closely related to the changes in reservoir morphology. It is necessary to model changes in the channel **16** bed profile and channel width during erosion in order to determine the amount of sediment removal. The amount of sediment release may **17** not be simulated using an erodible-bed model but it may be determined using an erodible boundary model.

22 Introduction

23 A plan has been made to remove Matilija Dam as shown in Figs. 24 1 and 2 on the Ventura River. After the dam is removed, sediment 25 stored in the reservoir will be flushed down the river channel. It is 26 necessary to determine the amount and process of sediment re-27 lease from the reservoir and to assess downstream river channel 28 responses to a major increase of sediment input. The impact of 29 sediment release from the reservoir needs to be assessed in order 30 to develop proper mitigation measures for potential adverse im-31 pacts. A fluvial modeling study has been made to analyze and 32 quantify potential stream channel changes after dam removal. The 33 results will be used to develop controlling or protection measures 34 for flood control and stream channel stabilization, and to recom-35 mend mitigation measures for environmental concerns and issues. Matilija Dam was completed in 1947. The reservoir above the 36 37 dam has become smaller resulting from siltation. At this time, the 38 area above the dam has the three following parts: the small re-39 maining reservoir, the delta, and the upstream channel. Sediment 40 deposit in the reservoir consists of silt and some clay. In the delta, 41 the deposited sediment is sand with up to 50% fines. In the upstream channel, the bed sediment consists of sand and gravel with ⁴² a minor amount of fines. 43

The amount of sediment flushing from a reservoir after dam 44 removal is closely related to the changes in morphology in the 45 reservoir. It is necessary to model changes in channel bed profile 46 and in channel width during erosion in order to determine the 47 amount of sediment removal. The amount of erosion can be de- 48 termined using an erodible boundary model, such as FLUVIAL- 49 12, but not an erodible bed model. Leopold et al. (1964) stated 50 that deposition in a river tends to spread out in the channel and to 51 flood adjoining areas but a channel undergoing erosion tends to 52 slide back into its banks. Gully formation, typically, occurs in the 53 process of reservoir bed erosion. The channel width affected by 54 erosion tends to be small but sediment deposition in the down- 55 stream channel tends to spread out to a large width. Such pro- 56 cesses occur after dam removal.

Modeling Study

The geometry of the stream channel is defined by a series of cross 59 sections. Points of interest and their respective river stations are 60 listed in Table 1. Cross-sectional data of the stream channel below 61 the dam were prepared and supplied by the U.S. Bureau of Rec- 62 lamation (USBR). These cross sections are viewed toward down- 63 stream. 64

The modeling study for stream dynamics was made for a 50- 65 year flood series based on stream gauging records. The 66 FLUVIAL-12 model (Chang 1988) was employed for this study. 67 For a given flood hydrograph, the FLUVIAL-12 model simulates 68 spatial and temporal variations in water-surface elevation, sedi- 69 ment transport, and channel geometry. Scour and fill of the stre- 70

71 ambed are coupled with width variation in the prediction of river
72 channel changes. The FLUVIAL-12 model is an erodible bound73 ary model since it simulates the interrelated changes in channel74 bed profile and channel width. Computations are based on finite75 difference approximations to energy and mass conservation that
76 are representative of open channel flow.

77 The model simulates the interrelated changes in channel-bed 78 profile and channel width, based upon a stream's tendency to seek 79 uniformities in sediment discharge and power expenditure. At 80 each time step, scour and fill of the channel bed are computed 81 based on the spatial variation in sediment discharge along the 82 channel. Channel-bed corrections for scour and fill will reduce the 83 nonuniformity in sediment discharge. Width changes are also 84 made at each time step, resulting in a movement toward unifor-85 mity in power expenditure along the channel. Because the energy 86 gradient is a measure of the power expenditure, uniformity in 87 power expenditure also means a uniform energy gradient or linear

water-surface profile. A river channel may not have a uniform ⁸⁸ power expenditure or linear water-surface profile, but it is con- ⁸⁹ stantly adjusting itself toward that direction. The model was cali- ⁹⁰ brated using 14 sets of field data. Such calibration studies are ⁹¹ listed in the users manual for FLUVIAL-12. Most of the calibra- ⁹² tion studies were peer reviewed. ⁹³

The Engelund–Hansen formula was selected for this study be- 94 cause the results generated by the Engelund–Hansen formula can 95 be correlated with the measured sediment deposition (Engelund 96 and Hansen 1967). 97

The basic data requirements for a modeling study include (1) 98 topographic maps of the river reach from the downstream end to 99 the upstream end of study; (2) digitized data for cross sections in 100 the HEC-2 format with cross-sectional locations shown on ac- 101 companying topographic maps; (3) flow records or flood hydro- 102 graphs and their variations along the study stream reach, if any; 103 and (4) size distributions of sediment samples along the study 104 reach. Additional data are required for special features (such as 105 physical constraints) of a study river reach. 106

Simulation of Sediment Delivery

Sediment delivery is defined as the cumulative amount of sedi- 108 ment that has been delivered passing a certain channel section for 109 a specified period of time, that is 110

In which Y=sediment delivery (yield); Q_s =sediment discharge; 112 t=time; and T=duration. The sediment discharge Q_s pertains 113 only to bed-material load of sand, gravel, and cobble. The fine 114 sediment of clay and silt that constitute the wash load may not be 115 computed by a sediment transport formula. Sediment delivery is 116 used herein to keep track of sediment supply and removal along 117 the channel reach. 118

Spatial variations in sediment delivery are manifested as chan- 119 nel storage or depletion of sediment-associated stream channel 120 changes since the sediment supply from upstream may be differ- 121 ent from the removal. The spatial variation of sediment delivery 122 depicts the erosion and deposition along a stream reach. A de- 123 creasing delivery in the downstream direction, i.e., negative gra- 124 dient for the delivery-distance curve, signifies that sediment load 125 is partially stored in the channel to result in net deposition. On the 126 other hand, an increasing delivery in the downstream direction 127 (positive gradient for the delivery-distance curve) indicates sedi- 128 ment removal from the channel boundary or net scour. A uniform 129 sediment delivery along the channel (horizontal curve) indicates 130 sediment balance, i.e., zero storage or depletion. Channel reaches 131 with net sediment storage or depletion may be designated in each 132 figure on the basis of the gradient. 133

Model Calibration

In order to assess the applicability of the FLUVIAL-12 model for 135 the study, model calibration was made using available data as 136 described below. Matilija Reservoir has been trapping sediment 137 since its completion in 1947. Matilija Dam has a watershed area 138 of 141.7 km². The U.S. Army Corps of Engineers (USACE 2002) 139 estimated sediment deposition in the reservoir; the USBR (2002) 140 measured the volume of sediment deposit. According to the 141

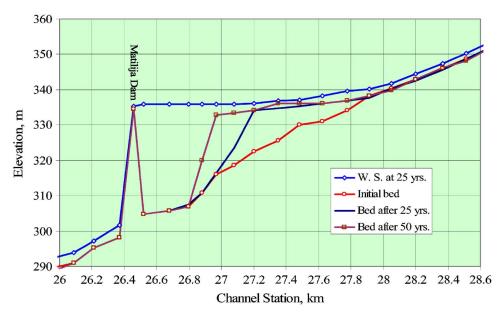


Fig. 3. Longitudinal profiles of water surface and channel bed during reservoir deposition after dam completion

¹⁴² USACE, material trapped behind the dam is 4.4 million cubic 143 meters, of which 2.28 million cubic meters are considered to be 144 coarse sediments (sand and gravel). The USBR made a more-145 detailed measurement of sediment deposition in Matilija Reser-146 voir, delta, and upstream channel for a total length of about 1 147 mile. According to the USBR, total sediment deposition in the 148 surveyed area was 4.5 million cubic meters, with 2.91 million 149 cubic meters in the coarse sediment size range.

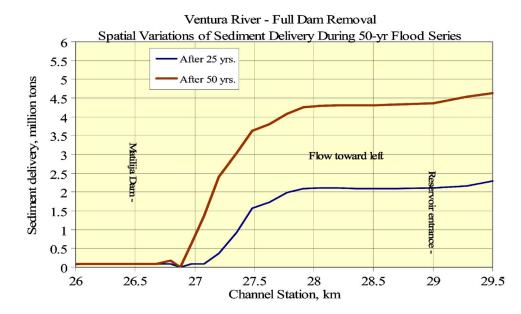


Fig. 4. Simulated spatial variations of sediment delivery during 50-year flood series since dam completion showing sediment deposition in the reservoir

150 The processes of reservoir deposition during the 50 years since 151 dam completion are simulated as shown in Figs. 3 and 4. It can be 152 seen from Fig. 3 that deposition of coarse sediment starts from the 153 reservoir entrance and it advances into the reservoir gradually. At 154 a cross section in the reservoir, the deposition tends to build up 155 the bed elevation in horizontal layers. A low-flow channel gradu-156 ally forms in the reservoir deposit. Simulated spatial variations of sediment delivery in the 50-157 year time span are shown in Fig. 4. Fig. 4 shows approximate 158 sediment equilibrium above Channel Station 28 km and sediment 159 deposition from Channel Station 28 km to the dam. The total 160 amount of sediment delivered passing Channel Station 28 km is 161 4.31 million t. The USBR measured the deposited sediment from 162 the dam to Channel Station 28 km. Since no significant amount of 163 coarse sediment passed over the dam before 2002, the delivery 164 passing Channel Station 28 km is also the amount of measured 165 deposit. 166

The sediment deposit has more or less consolidated; therefore, 167 it is estimated to have a unit weight of 1.6 t/m^3 . The estimated 168 deposit of 2.28 million m by the USACE has a weight 3.65 mil- 169 lion t. The measured volume of 2.91 million cubic meters by the 170 Bureau weighs 4.66 million t. This simulated sediment yield is 171

¹⁷² compared with previous measurement and estimate as shown in 173 Table 2.

174 It can be seen from Table 2 that the simulated value based on 175 the 50-year flood series is similar to the measured value by the 176 USBR and the estimated value by the USACE. For this reason, 177 the FLUVIAL-12 model was calibrated based on data from the 178 Ventura River and its 50-year flood series. The model was, there-179 fore, adopted as the basis for the modeling study. The mean an-180 nual deposit in the reservoir also represents the mean annual sedi-181 ment supply to the reservoir from the watershed.

182 Simulation of Complete Dam Removal

183 The 50-year flood series was used to simulate reservoir and184 stream channel dynamics after the dam is completely removed.185 The results pertaining to sediment delivery and changes in reser-186 voir and channel morphology are described below.

187 Spatial variations of sediment delivery during the 50-year188 flood series after complete dam removal are shown in Figs. 5 and189 6. The spatial pattern depicts the following:

190 1. Erosion above the removed dam. The increase in sediment

191 delivery from Channel Station 28 km to the dam site at Sta-

tion 26.5 km is about 1.8 million t. This amount represents

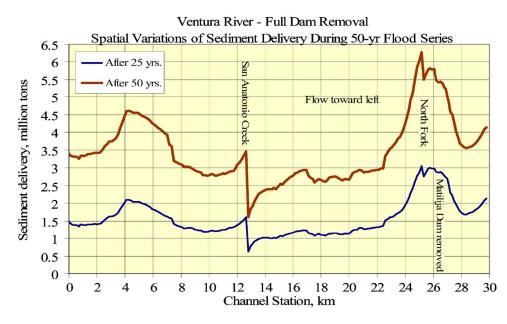
erosion from the area above the dam, principally from thedelta deposit.

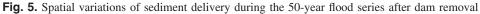
- No major changes in delivery through the channel gorge between Stations 25.5 and 26 km.
 195
- Deposition below the dam. The decrease in sediment deliv- 197 ery from the North Fork confluence at Station 25.4 km down 198 to Station 22.5 km is about 2.8 million t in the 50-year time 199 span. This amount represents sediment storage along the 200 channel reach. Most of the sediment supply for the reach is 201 from the area above the dam but a small portion of the sedi- 202 ment is supplied by the North Fork. 203
- Approximate sediment equilibrium from Station 22 km to 204 the San Antonio Creek confluence. 205
- The river channel is subject to erosion from Station 4 km to 206 Station 8 km. It is subject to deposition below Station 4 km. 207

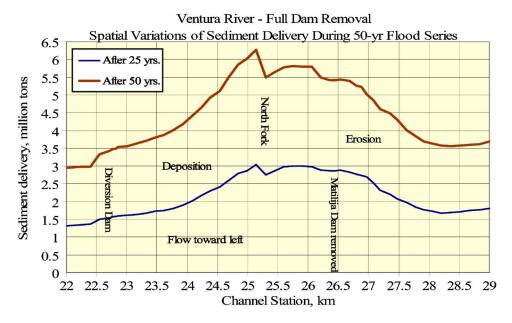


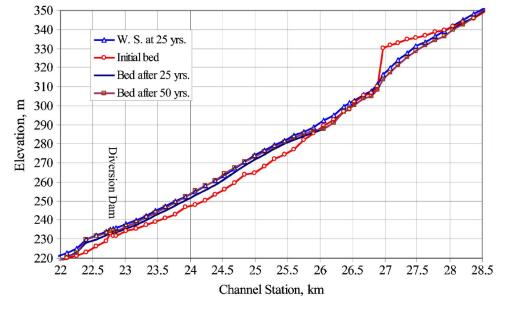
Fig. 6. Spatial variations of sediment delivery during the 50-year flood series after dam removal in the vicinity of the removed dam

The spatial variations of sediment delivery along the study 208 river reach are shown in Fig. 5; those in the vicinity of the re- 209 moved dam are shown in Fig. 6. The spatial pattern depicts ero- 210 sion from the delta area above the dam and deposition below the 211 North Fork confluence. From the removed dam site to the North 212 Fork confluence (26.5–25.5 km) is a narrow gorge, where sedi- 213 ment does not settle. The diversion dam at Station 25.75 km has a 214 height of 3.2 m. The major deposition that occurs from the North 215 Fork confluence to the diversion dam is related to the decrease in 216 channel slope, increase in channel width and backwater from the 217 diversion dam. 218

An important consequence of dam removal is the large amount 219 of sediment released to the downstream river channel. This major 220 increase in sediment supply tends to overload this downstream 221 reach with sediment. The sediment supply to the downstream 222 reach is not only from the stored sediment in the reservoir delta 223 but also from the natural sediment inflow from the upstream wa-224 tershed. In other words, the sediment supply to the downstream 225 exceeds the natural sediment inflow before the dam presence. 226 Amounts of sediment supply to the dam site are as follows: 227

- 1. Natural conditions before dam presence: 86,200 t per year; 228 and 229
- 2. After full dam removal: 109,000 t per year230
 - A large amount of sediment has been stored in the reservoir 231

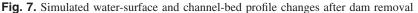
232 since the dam completion and some of the stored sediment will be
233 transported downstream after the dam removal. The amount of
234 sediment release from the area above the removed dam is closely
235 related to the changes in reservoir morphology; therefore, simu236 lation of the morphological changes are of great importance for
237 dam removal projects.

238 Morphological Changes after Dam Removal

239 It was assumed in the study that the dam is totally removed and240 the fines in the reservoir are also removed. Simulated water-241 surface and channel-bed profile changes are shown in Fig. 7. The242 following features characterize channel-bed profile changes near243 the dam site:

- Aggradation in the downstream channel. Dam removal increases sediment supply to overload the downstream channel. Aggradation occurs as released sediment settles in the downstream channel. The simulated results show major 247 channel-bed aggradation in the downstream reach from Station 25.5 km down to the diversion dam.
- Degradation in the delta and upstream channel. The delta is 250 located above Station 26.85 km about 400 m upstream from 251 the removed dam. After the dam removal, simulated channel- 252 bed profile changes depict rapid degradation that also ex- 253 tends gradually upstream. 254
- The aggradation and degradation have high initial rates as 255 most of the changes occur in the first half of the flood series. 256 The rate slows down considerably later on. 257 After dam removal, stored sediment is released to cause down- 258





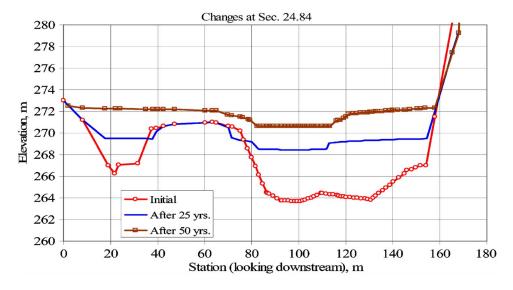


Fig. 8. Morphological changes in downstream river channel at Channel Station 24.84 after dam removal

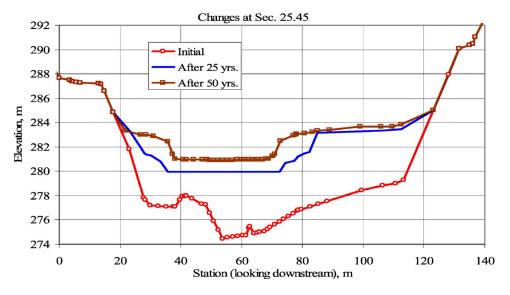


Fig. 9. Morphological changes in downstream river channel at Channel Station 25.45 km after dam removal

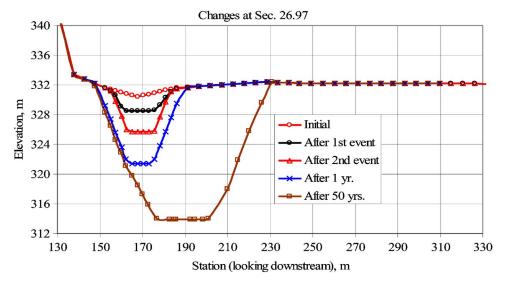


Fig. 10. Simulated morphological changes after dam removal at Channel Station 26.97 km near the tip of the delta

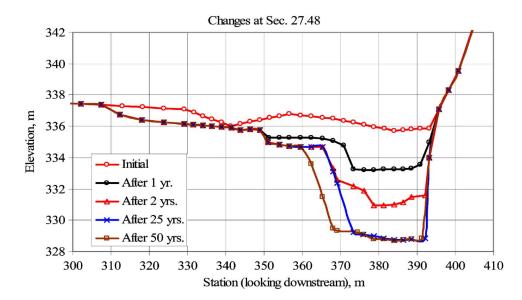


Fig. 11. Simulated morphological changes after dam removal at Channel Station 27.48 km located at one half kilometer above the tip of the delta

259 stream channel-bed aggradation. In the time period of 50 years, 260 the amount of deposition from Channel Station 25.5 km down to 261 22.5 km is computed to be 2.8 million t. Those shown in Fig. 8 262 for Channel Station 24.84 and in Fig. 9 for Channel Station 263 25.45 km exemplify morphological changes in the river channel 264 along the reach. Figs. 8 and 9 illustrate the characteristic changes 265 in channel morphology below the dam. In the process of deposi-266 tion, sediment tends to build up the bed profile in horizontal lay-267 ers. The bed profile during deposition is rather flat but not totally 268 flat. A small low-flow channel also forms in the flat channel bed. 269 Simulated morphological changes above the removed dam are 270 depicted in Figs. 10 and 11 by the changes in cross-sectional profile at Channel Stations 26.97 and 27.48 km, respectively. Sec-271 272 tion 26.97 is near the tip of the delta and section 27.48 is about 273 0.5 km below the upstream end of the delta. The simulated mor-274 phological changes have the following features.

Dam removal will cause higher flow velocities on the delta 275 1 276

channel will first develop on the delta starting from the tip and it will extend gradually upstream. The incision is the 278 most pronounced on the delta. 279

- The incised channel has a small width at the initial stage. 280 2 After the incision reaches the original bed elevation before 281 the dam, the incised channel begins to expand in width. The 282 width change is a slow process. Simulated results show that 283 channel width at the end of the 50-year time period is much 284 smaller than the natural channel width before the dam. 285
- After dam removal, sediment stored in the delta and up- 286 3 stream channel will be removed gradually with time. Sedi- 287 ment removal is a slow process. Complete removal of all 288 stored sediment will take a time span much longer than 50 289 years. 290

The amount of sediment release resulting from erosion in the 291 delta is closely related to the changes in the channel morphology 292 on the delta. Such changes include the changes in channel-bed 293 profile as well as changes in channel width. The changes in 294

and upstream channel to induce head cutting. An incised

 channel-bed profile and channel width are also closely interre- lated. Any effort to quantify sediment release after dam removal hinges on adequate simulation of morphological changes associ- ated with erosion and deposition. It may, therefore, be concluded that the fluvial process after dam removal can only be simulated using an erodible boundary model that allows for bank erosion and not an erodible bed model.

302 Summary and Conclusions

303 In planning for dam removal, it is essential to determine the pro304 cesses of sediment release from the area above the dam. It is also
305 important to quantify erosion and deposition after dam removal
306 and the pattern of sediment redistribution along the channel reach.
307 FLUVIAL-12 was employed to simulate the fluvial processes
308 related to the proposed removal of Matilija Dam on the Ventura

River. As a first step, the model was calibrated using data of ³⁰⁹ reservoir deposition above Matilija Dam since its completion. The **310** simulated deposition was confirmed by measurements. **311**

The simulated results for full dam removal are presented in 312 this paper. The results show that dam removal will result in a 313 major increase of sediment supply to the channel reach below the 314 dam over the natural sediment supply before the dam presence. 315 The quantity of sediment release from dam removal is closely 316 associated with the changes in channel morphology. Since the 317 channel adjusts in bed profile as well as in channel width, any 318 effort to quantify sediment release after dam removal hinges on 319 adequate simulation of morphological changes associated with 320 erosion and deposition. The changes in channel-bed profile and 321 channel width are also closely interrelated. It may, therefore, be 322 concluded that the fluvial processes after dam removal can only 323 be simulated using an erodible boundary model but not an erodible bed model. 325
