I just tested this one and it CRUSHED. It beat the other 3 subject lines by over 200% in CTR. Triple the response just from a subject line, no change to the email body copy. The point of this type of email is that you are killing two birds with one stone.

The two benefits and supposed to be mutually exclusive...yet you've found a way to do both at once.

2. Intrigue

-"Did you know that there are 3 things are you probably doing right now that are preventing you from increasing your income this year? And, get this: You're definitely doing 2 of them, almost without question. See why HERE (link.)"

3. Clear Content

- Communicate your message in the most straightforward way possible. Use P.S. for a link.

4. Step by Step plan for Opposite of Goal

- Show them exactly what to do if they want to achieve the opposite of their. AKA what not to do.

IE: Step by step plan to get FAT
Step by step plan to never make a dime online
Step by step plan to destroy your score
Step by step plan to stay celibate

5. Profit off of disaster

- These can be tricky but they can work great if you do it well. Disasters tend to make people think about their own mortality. If you do this right (and in a tasteful way) you can use that spur them to take action.

6. Email relating popular news or trend to topic

- Take trending news story and relate it to your product or topic. Could be Miley Cyrus or Bitcoins. Anything that is currently a big deal. Just tie it in using a correlation email.

7. Borrowed Credibility

- Borrow quote from authority on topic or famous historical figure. Use it to boost your own credibility and authority.
 - -Warren Buffet on credit.
 - -Albert Einstein on investing

8. Reveal Something

- Tell them a personal story that's embarrassing or damaging. The more open you are the more people tend to like you. I didn't realize the power of this until I started doing stand up comedy. The more you are willing to let your guard down, the more people will trust you. It makes you human and takes you off of the "guru" pedestal.

9. Profit from Competitors

- Point out a flaw in what they do.
- IE: The diet may work...but it's a pain in the ass to follow it.
- -Dave Ramsey is right about a lot of things, but the fact is you need a credit score. And to get a high score you need to use credit cards.

10. Paradigm Shift

- Take a commonly held belief or phrase and say how wrong it is.
 - -Why "game" is bullshit
 - -Don't pay your bills on time
 - -Go into debt

All of those things above are commonly held beliefs. You should pay your bills on time. You shouldn't go into debt. "Game" gets you women. But you can find an exception to the rule or debunk the myth and your list will trust you for it.
