

## **Artist Rider Agreement**

### **SECURITY**

Purchaser shall guarantee proper security at all times to insure the safety of Artists instruments, costumes and personal property before, during and after their performance. Any loss or damage to Artists property shall be the sole responsibility of Purchaser. The backstage shall be supervised by no less than two (2) security guards.

### **SOUND CHECK**

A sound check is required prior to the performance. The place of engagement shall be ready and available to Artist on the day of engagement. Light and sound people (those who will be operating the systems during the performance) shall be available to do a complete rehearsal.

### **TECHNICAL SUPPORT**

Purchaser agrees to provide professional sound & monitor systems.

### **LODGING / FLIGHTS**

The Purchaser is responsible for Artist's lodging; reservations will be made in advance and approved by management. **FOUR STAR QUALITY HOTEL ROOMS ONLY. \*\*Absolutely no motels or Inns.\*\***

The Purchaser is responsible for airline tickets(with departure and arrival times pre-approved by management) and sent to management at least **TWO** weeks prior to the day the Artist leaves per the ticket. Premium seating preferred.

**BEFORE** purchasing tickets, flight times and locations **MUST** be approved by management. Refundable tickets should always be purchased, as Artist will not be held responsible for any necessary changes.

### **TRANSPORTATION**

Ground Transportation is to be provided by Purchaser at its own expense **\*\*With FULL insurance coverage\*\*** from the airport, to the hotel, to the venue, back to the hotel and then to the airport.

**CATERING REQUIREMENTS** Clean Towels, Bottled water, apples, seedless grapes, chicken salad, assorted dressing, appetizer (no pork products), \$100 bar tab.

## **CANCELLATION**

In the event performance is canceled in less than 90 days by Purchaser for any other reason than an Act of God, Artist is to be paid the Agreement fee in full. In the event of such cancellation, Artist shall not be required to perform at any later time (but may do so at their own discretion). In the event performance is cancelled by Artist for any other reason than Act of God, Artist will refund to Purchaser any deposits paid to Artist.

## **LIABILITY INSURANCE**

Purchaser agrees to retain any and all necessary personal injury or property damage liability insurance with respect to the activities of the Artist on the premises of Purchaser or at such other location where Purchaser directs Artist to perform.

Purchaser agrees to indemnify and hold Artist harmless from any and all claims, liabilities, damages, and expenses arising from any action or activity of Purchaser while Artist is rendering the contracted services except for claims arising from Artist's willful misconduct or gross negligence.

## **BREACH OF AGREEMENT**

In the event of breach by Purchaser of any of the terms, covenants, or conditions of this Agreement, Artist shall not be required to perform hereunder and Purchaser shall pay Artist the full amount of the Agreement fee as specified herein.
