GENERAL INFORMATION

Zinc 15% is a liquid formulation of both primary (N) and micro (Zn) plant elements. It is formulated for use with pre-plant or liquid starter fertilizers, including polyphosphates and nitrogen solutions. **Zinc 15%** is recommended for crops that require high zinc usage, such as corn, edible beans, onions and potatoes. **Zinc 15%** is generally compatible with fertilizer solutions. Proper timing, rate, and placement is important for desired results. Results are dependent on stage of crop growth, soil fertility levels, and environmental conditions. Utilize a jar test if compatibility is questionable.

DIRECTIONS FOR USE

Broadcast Soil Treatment: Apply 1-4 quarts of **Zinc 15%** per acre
Row Application: Apply 1-4 quarts of **Zinc 15%** per acre

DO NOT USE AS A FOLIAR SPRAY

STORAGE AND DISPOSAL

Store in cool, dry place. Store in original container. Keep container tightly closed. Do not reuse empty container. Triple rinse, then offer for recycling or for disposal in a sanitary landfill, or by other means in accordance with local, state and federal regulations.
