## GENERAL INFORMATION

**CRUSTGARD** is a superior non-ionic wetting agent designed to break up the molecular structure of hard crusty soils allowing water penetration to the rooting areas of plants. **CRUSTGARD** thus saves on repeated waterings, prevents puddling and aerates the soil. Moisture remains in treated areas longer because it is not exposed to surface evaporation. **CRUSTGARD**, when added to liquid fertilizer, allows the plant nutrients to be carried to the rooting zone where they are immediately available. Seeds germinate faster in treated areas and transplants grow faster.

## DIRECTIONS FOR USE

For hard and adobe soils and other compacted areas, nursery beds, lawns, golf greens and tee areas use:

Broadcast Application: Use 2-3 gallons per acre.

Banded Application: Use approximately 1-4 quarts per acre.

**CRUSTGARD** may also be added to liquid fertilizer at the above dosage.

## PRECAUTIONARY STATEMENTS

Keep container tightly closed. Avoid contact with eyes, skin and breathing vapors or spray mist. Wear protective gloves. Do not eat, drink or smoke when using this product. Wash hands thoroughly after handling. Use adequate ventilation when handling. Keep away from open flame. In case of fire: Dry chemical fire extinguisher to extinguish and call CHEMTREC (800) 424-9300. First Aid: If exposed call CHEMTREC or refer to SDS First Aid section. If on skin: Take off contaminated clothes immediately. Rinse skin with water.
