

# MANAGER'S NOTES


I would like to remind all residents that the speed limit in the resident parking garage, as well as the guest parking area is not to exceed 5 miles per hour. There have been several near misses and a few not so near misses. I would appreciate everyone's cooperation to avoid the expense to the Association of installing speed restrictors

## Move In/Outs And Deliveries

I would like to inform all residents that if you are planning to move in and/or out or expecting deliveries that will require the freight gate to be unlocked for more than a half-hour you must schedule it through the management office at least three days in advance. We are required to have a Security Officer on duty anytime the freight gate is unlocked. Regularly scheduled Security Officers can be assigned if it is a half-hour or less. If it is for more than the half-hour, we must assign an extra Security Officer and we need the 3 days prior notice to assure an Officer is present. Also all move in/outs and deliveries are scheduled on a first come first serve basis, so schedule as early as possible.

#### Remodeling

Management would appreciate it if you plan any remodeling, etc. that will cause noise, to please notify us prior to the commencement of any work. This way we can notify your neighbors, so that they can plan to be away from their units during this time, if they so desire.



Impatiens


#### SUN OR SHADE
