I, the undersigned, being duly sworn, state that all facts contained in this Complaint and Affidavit, known by me or told to me by other reliable persons form the basis for my belief that the defendant committed this crime

State all facts and persons relied upon supporting elements of alleged crime

On 10-5-17, at approximately 1855 hours, officers responded to the 300 block of 5th Avenue South at the request of the Public Service Officer due to her being told people were being held captive at gun point. Officers were then directed to 417 5th Avenue South where they met with Antwon Buchanan, Tony Jenkins, and Brionna Walton.

Buchanan and Jenkins said they, along with Zach Ross and Demetreus Armstrong were robbed at gun point by three black males in Davenport,

lowa around 1600 hours. Buchanan described one of the guns the assailants brandished as a subcompact pistol, possible a Mac 11 with a large clip. They had all of their possessions their possessions taken from them including cell phones, money and ID's. Buchanan knows one of the three assailants as "TY".

Buchanan was asked where "DO" was. DO is an alias for Shayne Cox. Buchanan told them he was in Clinton. Buchanan was told he was going to show them where DO was.

Buchanan was placed into the trunk of a gold colored 4 door passenger car with WI plates driven by TY. A female, described as a light skinned black female, sat in the front passenger seat. The other two assailants got into Buchanan's vehicle which included Jenkins, Ross, and Armstrong. Jenkins was ordered to drive and follow TY to Clinton.

Once in Clinton Buchanan was removed from the trunk and placed into the back seat of the car driven by TY. Buchanan was told to show TY where DO's apartment was. Buchanan directed TY to DO's apartment building, 417 5th Avenue South.

When they arrived at DO's building, there were many people around due to a parade so TY drove to the Shell gas station located at 1003 8th Avenue South. The front seat female passenger was given money by TY, who then went inside the store and paid for gas. The vehicle and the female were captured by surveillance video.

After getting gas all went back to DO's apartment building. Buchanan was removed from the car and ordered to take them to DO's apartment, which he did. While heading to the Apartment Buchanan said they ran into Brionna Walton and a person he knows as "Mooda". They were also told to go to DO's apartment, and did so. Buchanan said they all went Inside the apartment where juvenile male (DW) and Walton's baby were located. The assailants took everyone's cell phones from them in the apartment except one, which they broke. The assailants demanded to know where the money was, and where DO was. One of the assailants handed his gun to TY and then went out and brought Jenkins, Ross, and Armstrong into the apartment.

Buchanan was given his cell phone back and ordered to call DO, which he did. DO answered the call and the phone was taken from him by one of the assailants, who then spoke to DO. Everyone in the apartment was ordered at gunpoint to lie on the floor and not move. Walton began to cry and was told by one of the assailants if you keep being loud we are going to kill you. Another assailant told Walton that they had this; showing her a large knife / sword and said to her, it is silent and he we will cut their necks. The assailants left the apartment after speaking with DO.

Walton told officers she has known one of the assailants for several years, and knows him as TY. Walton told officers she has TY on her Facebook account and showed them his profile picture which lists the name of "Ty Ty". Officers researched the Facebook profile of Ty Ty and found a picture of Aubrey Davey, who appears to be the same female captured by Shell surveillance video while Buchanan was being held captive in the back seat. Davey's profile lists she is from Madison WI.

Officers contacted Wisconsin State Patrol who located a Gold 2006 Honda Accord registered in her name with WI plate, ABC 9581. On 10-6-17 Det. Blount contacted Madison PD, and the WI State Police to request information on TY and Aubrey Davey. He was told WI State Patrol was involved in a high speed pursuit with Davey's vehicle on 10-6-17, at approximately 0106 hours.

The vehicle was stopped and the driver, Tyresse Triplett, was arrested. The front seat passenger was identified as Aubrey Davey. The back seat passengers were identified as Antwan Evans and Aaron Triplett.

Officers located the ID of Tony Jenkins in a wallet inside the car. They also recovered a pistol that was thrown out of the vehicle during the pursuit. Det. Blount was sent a picture of the pistol, which is similar in style to a Mac-11 subcompact.

Clinton Police records list an alias for Tyrese Tripplett as, "TY".
