NARRATIVE

Narrative of Offense Committed On or about the above stated date and time, the Defendant did commit an act against Krystal Kosub, with the intent to cause serious injury and cause bodily injury

AFFIDAVIT**STATE OF IOWA, CLINTON COUNTY**

I, the undersigned, being duly sworn, state that all facts contained in this Complaint and Affidavit, known by me or told to me by other reliable persons form the basis for my belief that the defendant committed this crime

State all facts and persons relied upon supporting elements of alleged crime

On April 30, 2018 an ambulance was dispatched to 333 7th Avenue North for injuries to Krystal Kosub which she received during an assault. Officer Unke also responded to this address to follow up on the assault. Officer Unke talked with Breanna Rettkowski and Kayla Mundhank and learned that Kosub was assaulted while she was at Rhonda Namer's house at 2321 Garfield Street.

Based on the information Officer Unke obtained from Kosub, Rettkowski and Mundhank, they were invited into the house by Teighlor Namer. Once inside the house they noticed several other people inside the house which included Rhonda Namer and Jessica Gibson (Cooper). They told Officer Unke that Rhonda Namer became upset with Kosub and began beating her. The information received by Officer Unke about the assault at this time was very vague and Officer Unke requested statements from all involved.

During the investigation into the assault, a video surfaced on Facebook showing the assault of Kosub at Rhonda Namer's residence. From the video you can hear Teighlor Namer talking to Kosub as she walks into the apartment. Teighlor is heard saying, "You know I told you not to fuck me over and if you did, you would get hurt". Teighlor is heard saying "let's go guys" and in the video you can see Jessica Gibson and Rhonda Namer grab Kosub and throw her to the floor. Rhonda Namer is heard saying, "remember I get first hit" and she begins beating Kosub as she is on the floor. Rhonda

slams Kosub's head into the floor several times and is punching her in the head as she is screaming at Kosub. Kosub is helpless and is heard screaming to please, please stop and Rhonda says, "No I'm not going to stop" and Rhonda continues to punch Kosub in her face.

Teighlor is heard telling Rhonda to get up and after Rhonda gets up and Kosub is on the floor, Teighlor says, "Go for it" and Jessica Gibson begins assaulting Kosub. Jessica Gibson is seen in the video dragging Kosub around the room by her hair and punching her in the face multiple times. As Jessica Gibson is assaulting Kosub, Teighlor Namer is seen kicking Kosub in the head several times and Kosub falls to the floor and is not moving. Teighlor continues to the assault Kosub as she is lying face down on the floor and he continues to punch her several more times in the head.

During an interview with Rettkowski, she stated she took Kosub to Teighlor Namer's residence because Teighlor contacted Kosub and asked her to come to his house to talk with his mother Rhonda. Rettkowski stated once they were inside the apartment, Teighlor locked the door and Kosub was assaulted. Rettkowski said she was crying and did not help Kosub because she was scared they would assault her if she helped. Rettkowski said she thought they were going to kill Kosub by the way they were assaulting her. Rettkowski said she thought Kosub lost consciousness after she was kicked in the head during the assault. Rettkowski stated after assaulting Kosub, the suspects threw Kosub out on the street and Kosub was taken to Rettkowski's residence and an ambulance was called.

Based on the interviews during the investigation, Rhonda Namer, Teighlor Namer and Jessica Gibson are positively identified as the three people in the video assaulting Kosub.
