



Appendix "A" to Great-West Life Wayfinder "Fill your life" Contest Rules

1. How to participate

The sponsor of the Wayfinder Contest ("Contest") is *The Great-West Life Assurance Company* ("Great-West Life").

- **1.1 Eligibility:** The Contest is open to membership of Great-West Life group retirement plans that offer Wayfinder, for the first time, between Oct 24, 2017 to April 18, 2018. They must be eligible to participate in Wayfinder and meet the following criteria:
 - Active plan members, enrolled in their Great-West Life group retirement and savings plan(s)
 - Employees must be Canadian residents
 - Register with Wayfinder and set a retirement goal by May 16, 2018 (11:59 p.m. ET).

Members can register with the Wayfinder website by using their current GRS Access credentials or by creating a new User ID and password specific to Wayfinder. To be eligible for the Contest, Members need to set a retirement goal by:

- Registering with Wayfinder
- Providing the required personal information
- Completing the investment personality questionnaire
- Choosing a retirement lifestyle
- **1.2 Contest period:** The Contest period runs October 24, 2017 (12:00 a.m. ET) to May 16, 2018 (11:59 p.m. ET).
- **1.3 Contest entry:** Members who receive an invitation to register with Wayfinder may enter the contest by registering with Wayfinder and completing all actions necessary to set a retirement goal. A Wayfinder registration and setting of a retirement goal (as defined in Section 1.1) automatically enters the Member into the Contest.
- 2. Prizes (101): Grand prize \$2,500 cheque. Secondary prizes: 50 \$25 gift card "Ultimate Dining Card."
- **2.2 Prize draw:** On May 17, 2018 a winner for each of the Prizes will be randomly drawn from all Members who have entered. The draw will be held at Great-West Life's office at 255 Dufferin Avenue, London, Ontario, N6A 4K1 at 11:00 a.m.
- **2.3 Odds:** The odds of being randomly selected to win the Prizes depend on the total number of plan members who registered for Wayfinder.
- **2.4 Notification of selection:** The selected Members will be contacted by Great-West Life at the email address that is associated with the Wayfinder website. If no response is received after the first contact, another contact will be made (if phone number is available, Great-West Life will follow up with a call), within eight (8) calendar days of the initial contact. If the selected Member cannot be contacted within fourteen (14) calendar days of the initial contact, another Member will be randomly drawn and the previously selected Member will be disqualified.
- **2.5** To win, the selected Members must respond to the email received from Great-West Life, outlined in section 2.4. The selected Members must correctly answer, unaided, a mathematical skill-testing question and will be required to acknowledge the terms outlined in the email. No substitution for or transfer of any of the Prizes will be allowed. If the selected Member does not return via email the answer to the skill-testing question and acknowledgement of the terms seven (7) calendar days after the second email, another Member will be randomly selected. The previously selected Member will be disqualified and will have no recourse towards Great-West Life or anyone involved in the Contest.
