

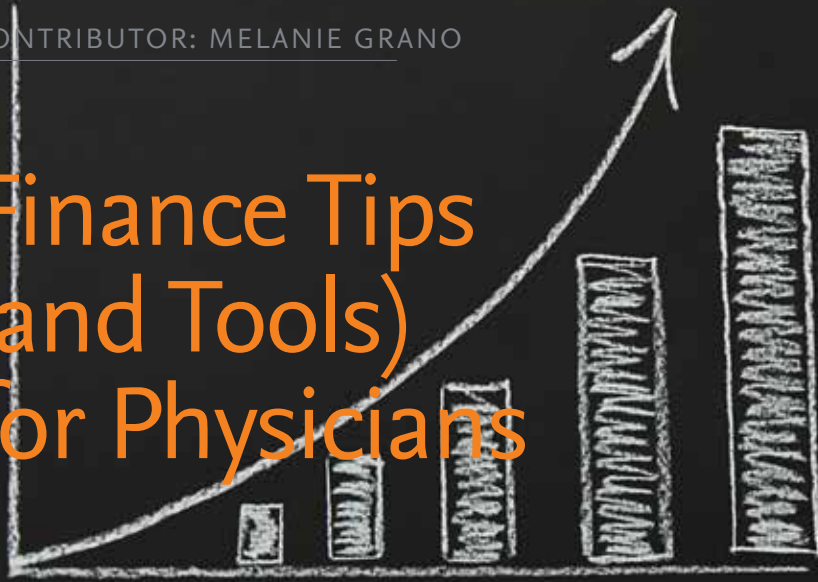

Finance Tips (and Tools) for Physicians



Managing finances is often a headache for many people. Even though most doctors earn a reasonable income, it helps to practice good money management habits. Here are a few personal finance tips and tools to help you manage your money.

Track Your Finances

Keep track of how much you make, when you will be paid and how much you spend. List all your expenses, their costs, and when they occur. A little organization goes a long way. Each month, there are fixed expenses, such as rent or mortgage, insurance and car payments. These usually come due at about the same time every month and cost about the same each time. Then, there are the variable expenses which may be one-time expenses such as car maintenance or a recurring expense taken out at various times and amounts such as subscription or tax payments (see below). Know how much money you will need to make all these payments.

The traditional way is to use an Excel spreadsheet - which may work for some people while others prefer pen and paper or a ledger. Alternatively, there are pay-to-use tools that can help you manage your money. These include:

Mint (www.mint.com) is a budgeting app by parent company Intuit. The app creates a picture of your spending in real time. It automatically updates and categorizes transactions. Add in your own categories, track bills, split ATM transactions into the purchases made with that cash, and set budgets that alert you when they start to top out. This service enables you to check your credit score for free.

Wally (wally.me) is an app that provides insight into where your money is going. If you want to track your personal expense,

this app can provide with what you need. Instead of manually logging your expenses at the end of the day (or week or month), Wally lets you simply take a photo of your receipts. In addition, if you enable geo-location on your device, it fills in that info which is convenient and saves you the hassle of filling in the relevant details.


Pay Bills On Time

Pay your bills when they come due. Many people tend to want to hold onto their money until the due date is near. Unfortunately, this may give them a false sense of how much money they actually have available. Use your money and/or credit cards wisely, and be sure to avoid late fees, overdraft fees, and declined charges. To help you pay in a timely manner, sign up for automatic payments, but only if you're sure you will have money in your account. If you find that you have too many bills due at the same time, you may be able to contact the company to change your billing cycle.

Plan for the Future

Set goals if you have plans to buy big ticket items such as a house, a new car or pay off student loans. There are a few items to consider:

- Do you have any money left over after your bills are paid? If you find that you are scraping by each month, take a hard look at your expenses and see what you can cut out.
- Is your rent/mortgage payment too high?
- Are the subscriptions services you have worth the monthly expense?



Keep track of what you are paid and when you are paid. List all of your expenses and when they occur. A little organization can go a long way.

- Are you eating out/entertaining too much?

Exercising discipline can be the key to achieving your goals. If you find yourself with a surplus after all your bills are paid, set aside a portion of it for your savings. Even if it is a small amount, every bit brings you closer to your goals.

Brian J. Knabe, a doctor and a Certified Financial Planner with Savant Capital Management says that there are certain expectations of wealth and lifestyle associated with the medical profession. In addition to entering the workforce later, he says that many physicians feel the pressure to live up to those expectations. Agreeing with Dr. Knabe is Dr. David Rosen who adds, "I have found that what is unique amongst physicians versus other highly educated and paid professionals is that they are never taught about money during their training, they don't talk about it, and are actually encouraged not to." Dr. Rosen is a board-certified anesthesiologist with nearly two decades of residency experience specializing in obstetric, trauma, orthopedics, and regional blocks, who helped found the Midwest Anesthesia Partners. He explains that physicians finish their education after years of studying and inevitably start spending with abandon and usually "don't think about saving, retirement or the impact of delayed investment."

Both physicians acknowledge that many physicians are extremely confident and this serves them well in medical practice as it helps them to make good decisions for their patients. The downside of this overconfidence can be damaging financially. Dr. Rosen adds, "They think that since they are knowledgeable in medicine, that knowledge translates into their finances." In many cases, physicians are "more apt to listen to and act on a tip from a colleague regarding a hot stock, than actually do research, or even consult with a professional advisor."

Insurance

Dr. Knabe advises physicians to remember that the value of future earnings is a young physician's largest asset. Be sure to invest in disability insurance to protect your financial future.

Aside from obtaining insurance to protect yourself should you become injured or disabled, you should also consider malpractice insurance. According to a 2010 American Medical Association report, 61% of doctors over the age of 55 were sued for malpractice. Although 65% of the claims are dismissed or dropped, they still cost doctors an average of \$22,000 per suit. Sometimes, when a claim does go to trial, the average cost increases to in excess of \$100,000. For this reason, be sure to purchase a good malpractice policy from a reputable insurance carrier.

In addition, physicians have a one in five chance of being on the wrong end of a lawsuit that's outside of their practice. According to Dr. Knabe, physicians are viewed as having deep pockets so they are more vulnerable to lawsuits. This is why, to minimize risks, he suggests that physicians should make sure they are insured in all areas, "including a substantial umbrella policy."

Travel Expenses

For regular physicians who make house calls and locum tenens physicians (before you take on an assignment), find out if you have to pay for travel out-of-pocket. These can include tolls, mileage, car service, gas, hotel and other unforeseen charges. Note that even if you are have these expenses reimbursed, you may still need to foot the bill upfront.

Record-Keeping

Use your smartphone as your digital assistant. Keep all your information about your assignments, speaking engagements or house calls in one place: a schedule of confirmations, travel itineraries, status updates, all through e-mail. Having your e-mail available on your phone in addition to using an app like Evernote (www.evernote.com), for example, helps keep you organized with all your information together. If you have receipts, paperwork, or notes that need to be kept together with a certain worksite, you can take a photograph and have access to all your documents on your phone and on your computer.

Taxes

One of the top priorities for physicians is to manage their taxes. Tax implications can vary depending on income level, family size, and property ownership. Typically, an employer pays one-half of your social security and Medicare taxes. Don't think of taxes only at "tax time" when it's too late to do anything about it. Most doctors file their personal taxes on a calendar year basis which means that you pay on April 15th for everything that happened between January 1 and December 31 of the prior year. It may be worthwhile engaging a financial advisor and tax specialist throughout the year to see what you can do to pay no more than what you owe.

If you are a locum tenens provider, you are an independent contractor. This means you are responsible for federal income, Social Security, and Medicare taxes. Depending on whether you own a corporation or file as an individual you will use different IRS forms. You may also have to pay tax estimates in quarterly installments. This is so you don't find yourself with an unmanageable amount after you file your taxes.

Whatever your particular circumstances, if you still encounter financial challenges, consider hiring a financial advisor. While this is an added expense, financial experts may have some creative solutions for your situation and should be able to personalize their advice for you. ■

Prepare for Retirement Short Term

RETIRE

As a medical practitioner, once you decide to retire, there is a to-do list that you should follow to ensure a stress-free post-employment life. If retirement is right around the corner, these steps can help with your impending transition out of practice.

Make Sure You Are Insured

A physician restrictive covenant, also referred to as a “non-competitiveness” or “non-compete” clause, is good practice to review your insurance or indemnity arrangements on a regular basis as well as whenever your terms of employment change. Failure to inform your insurance provider of any change in your circumstances, including retirement, may invalidate your policy. Physicians will have one of two types of insurance:

1) Occurrence Based Insurance

Occurrence coverage (www.medpro.com) policy limits remain in place after the end of the policy period to pay claims arising from healthcare incidents occurring during the policy period. Occurrence coverage is triggered the moment treatment occurs, regardless of when an eventual claim is made. For example, if a claim is made today based on treatment rendered in 2014, the 2014 occurrence policy responds.

2) Claims Made Insurance

A Claims Made Insurance policy covers claims that arise out of damage or injury that took place during the policy period, regardless of when claims are made. When you cancel a Claims Made policy, coverage ceases for the past as well as the present and future unless tail coverage (www.acponline.org) is secured. This covers you during your retirement for any future claims that arise from the practice period in question. From

the moment you start to plan for your retirement, discuss tail coverage options with your insurer.

Generally, insurers provide coverage at different prices and with different benefits. If you meet certain criteria, the insurer may provide you with tail coverage and credits for prepaid premiums or discounts. Bear in mind that switching insurers may result in losing your premiums. This is because equity built with one insurer does not transfer to another.

Also, consider your insurer’s financial stability. You are committing to that insurance company for your entire retirement; most tail coverage cannot be cancelled once the contract is bound. If the company becomes insolvent, you will no longer be insured and will be personally responsible for any claims that arise.

Consult your insurance provider to fully discuss your options.

Your Medical License

What to do with your medical license can be a complicated and difficult decision. It is also a decision that must be made well ahead of time. In some states, renewing a license can take up to 6 months.

Retirement doesn’t always mean the end of a medical career. If you would like to continue practicing in some way – including working as a locum tenens practitioner, or undertaking research related activity or medico-legal work – then you will need to retain your license. This means that you will still be subject to the same standards of professional competence as other registered practitioners. In most states, this is viewed as “Active Status.”



RETIREMENT PLAN

As a medical practitioner, once you decide to retire, there is a to-do list that you should follow to ensure a stress-free retirement life.

Active Status

This means that you can practice and prescribe medicine and are subject to the same restrictions and guidelines as practicing physicians. You will also have to continue to meet the state requirements. Again, this varies from state to state but usually includes completing the renewal process, continuing medical education and maintaining insurance.

Many practitioners may choose to maintain an “Active Status” if they think they would like to return to medicine in the near future and don’t want to go through the hassle of reactivation. Bear in mind that if you retire completely, it may be difficult to meet all the requirements needed for an active license to be issued to you again.

Inactive Status

This is the middle ground option offered by several states. This option means that you are exempt from having to meet education and training requirements. However, you are also not permitted to practice or prescribe medicine. You can apply to reactivate your license at any point.

Retired Status

Many medical boards such as Massachusetts, Texas, Washington and Florida permit you to apply for retired status. This means that you surrender your license and ability to practice or prescribe medicine and are no longer required to meet educational or other requirements. If you do not see yourself returning to medicine, this is the easiest option.

Lapsed License

This option is not ideal. If you do not complete your renewal application in time, your license will be considered lapsed. This is viewed as revocation and is treated similarly to suspension or

revocation for a cause. Renewal of lapsed license is complicated and not guaranteed. If you are in doubt as to which option is best for you, seek advice from the medical board you are registered with.

Medical Contracts

Any people and organizations with whom you have contracted should be informed of your plans well ahead of time. Some may require that you serve a period of notice.

If you are employed by a hospital, medical practice etc. then your contract will probably have defined clauses regarding your retirement. In this case, review your contract before you inform your employers of your intentions. In particular, look at any clauses regarding timing requirements for the advanced written notice of your retirement. Check that your departure date does not result in penalties or unnecessary forfeitures. If you are unsure, consult a legal professional for guidance.

If you are in a partnership, you will need to inform your partner(s) of your plans. If you intend to return or continue working on a part-time basis, then it is best to negotiate this before you retire. Get all agreements in writing, and ideally have a signed and dated contract for returning to the partnership. You should also decide with your partners how you wish to handle dissolution accounts, notional rent payments and equity in the practice before you retire.

In general, many doctors and physicians will be party to at least one if not more contracts which will all come with their own

obligations. In addition to medical contracts, there may also be maintenance and service contracts, utility agreements and leases. As soon as possible after deciding that you want to retire, review all these contracts to determine the steps you will need to take, short-term and long-term.

For the most part, legal and financial consultants advise that you should do review all contracts at least one year before your retirement date. This will give you enough time to assess notice and termination provisions and how your rights are affected if any agreement is terminated prematurely. If you are unsure what action to take, consult a qualified legal professional.

Patient Records

Managing medical records properly is a time consuming but necessary task. Remember that you may also be required to keep records pertaining to your medical practice after you retire. These may include payroll records, personnel files, accounts payable invoices and credits. Any patient records may also have to be retained.

Review your electronic medical records (E.M.R.) Retention Strategy and decide what you need to do with patients' records upon your retirement.

The four key factors to consider include:

- 1) Do you intend to continue practicing part time?
- 2) Will the practice continue after your retirement?
- 3) Where you are based
- 4) Your role in the healthcare system

If you are an employee, then your employer will oversee the management of your patients' medical records and notify them of your retirement. However, if you are in private practice and transferring records to another physician, it is advised that you consult with an experienced healthcare attorney to ensure that the arrangement complies with both state and federal laws. If you are in private practice, discuss ongoing care with patients and agree on a plan for future care. When appropriate, you will need to obtain informed consent to pass patients' records to the doctor who will be caring for them.

Any agreement should allow the receiving physician the right to access the records in the future or to receive copies on request as well as the right to be notified if the receiving physician retires or plans to dispose of the records. This is also the time to transfer legacy medical records in your possession into an archive. Electronic medical records can be stored securely in vendor managed clouds. These allow for third party access saving you the trouble of spending your retirement responding to record access requests. Other records such as business and employee information can also be safely stored in this manner.

The length of time for which you are required to retain medical records varies between states and countries. For example, the state of Massachusetts Board of Registration in Medicine requires that patient records be retained for at least seven years. The length of time records must be kept for also varies depending on the practice, for example, pediatric practices will need to maintain patient records for far longer. How the

records must be stored and the degree of access patients and others can be granted also varies between states.

If your retirement means the closure of your medical practice, then you should obtain legal advice. A qualified legal professional will be able to make sure that all relevant parties are notified in a timely manner and that E.M.R. retention and destruction laws are complied with. Your medical malpractice insurer may also have requirements for the storage and retention of records

Informing Patients

When informing patients of your retirement date, also include the relevant information about their medical records so that their next physician can access them. Give the post office a forwarding address should a patient or another party need to contact you after you retire. If you are unsure about what to do with medical records in your possession, seek advice from your state medical board.

Retirement is a new chapter in your life and should be viewed as an empowering opportunity to bring in the return on investment generated by a successful career. It should be a prospect that gets you excited and an opportunity to do the things you've always wanted to do. Having the right and positive attitude is key. Retiring from medicine deserves careful thought and planning. Most people only get one chance to do it right, so finding and taking good advice is worthwhile. ■



Is Locum Tenens Work Right for You?

Locum Tenens (Latin for “to hold the place of”) is a temporary work assignment for a physician. The reasons for considering locum tenens work can vary as widely as the physicians considering it. Perhaps you’re a new physician and you want to try out several positions to help you decide on a long-term job. Perhaps the idea of committing to a practice or hospital full time doesn’t appeal to your sense of freedom and adventure. Maybe you’re a mom and you want to be able to spend more time at home. Or, you’re a retired (or semi-retired) physician not quite ready to hang up the stethoscope.

The good news is that there is no shortage of locum tenens work for physicians. According to The Association of American Medical Colleges, the advancing age of the American population will create a demand for physicians that will exceed the supply by 91,000 by the year 2020. This deficit will grow to 131,000 by 2025 because the supply of physicians has remained flat over the last 20 years. A 2015 Staff Care Survey of Temporary Physician Staffing Trends reports that 91% of healthcare facilities used locum tenens physicians. Seventy three percent of healthcare facility managers said they use at least one locum tenens physician a month while 18% reported using four or more.

A primary care physician has a per-diem rate of \$600-\$800 daily and can make approximately \$150,000 a year, slightly less than an employed physician. Locum tenens salary is dependent, of course, on how often a physician is working assignments. Most assignments last a couple of weeks, while some can last up to a year. “Some locations have a hard time finding permanent primary care doctors and rely on locum tenens help, which can take some time,” says Sean Ebner, President of Staff Care. Sixty-eight percent of healthcare facility managers typically use locum tenens physicians to fill in until a permanent doctor is found while 67% use them to fill in for staff who have left. Today, more physicians are making locum tenens their full-time employment. Staff Care estimates that fewer than 50% of physicians remain in private practice. Most locum tenens physicians have worked in a permanent practice, but over 7%

have indicated they have only ever worked on a locum tenens basis. Twenty-one percent of physicians begin working locum tenens directly after completing their residencies and that number of younger physicians is increasing. Many physicians have become disenchanted with the “business” of medicine and have opted to become temporary staff on a full-time basis. The top reported benefits to working locum tenens include flexibility (85%), pay rate (53%), and “no politics” (51%).

Janice Boughton, MD left her private practice to become a locum tenens physician and wrote of her experience on the medical social media blog Kevin MD. Having worked in several states including Alaska, she discusses selecting an agency (Staff Care is one of them), the application and screening processes and the ups and downs of locum tenens work. The experience for her was a positive one, but it is not for everyone.

Howard Rodenberg, MD MPH, columnist for the Journal of Emergency Medical Services, wrote about his locum tenens experience on his blog Writing with Scissors. While locum tenens wasn’t for him, he notes it was great for his ego. He discusses the great demand for his experience from numerous agencies vying to place him during his locum tenens stint.

The fact is, all specialties are in high demand for locum tenens work. For those interested in higher pay with work flexibility, locum tenens may become the rule rather than the exception.




