### **HABITAT PARTNERSHIP COMMITTEE (HPC) Meeting Minutes**

The meeting began at 10:40, after a quick welcome from Dan Sturla, AGFD Habitat Enhancement (HE) Coordinator. Dan announced that had promoted to HE Coordinator position and Kirby Bristow will replace him as HPC Coordinator. Kirby brings over 26 years of wildlife habitat research experience that he hopes will help him keep up the good work Dan has done with the program over the last few years.

Commissioner Eric Sparks will be the new Chair of the HPC, with Commissioner Bill Brake staying on as Co-Chair. Unfortunately, Commissioner Sparks was unavailable to attend today's meeting.

Other attendees included AGFD employees, AGFD Commissioner Jim Zieler, representatives from local HPCs, representatives from several Wildlife Conservation Organizations (WCOs), and livestock producers.

**2018 funding:** The HPC allocated \$2.5 million for 66 projects last year including water developments, grassland restoration, spring boxes, prescribed fire, pipelines, emergency waters, etc.

**2019 fundraising:** The WCOs have raised just short of \$2.5 million dollars in 2019, with over \$600.000 raised at the Arizona Big Game Super Raffle.

**Updates from Local HPCs:** AGFD personnel from Regions 1-6 provided updates on all the projects around the state.
