

2018 Stewardship Report



Dear Valued Brewers Association Member:

2018 was another milestone year for the craft brewing community. With more than 7,000 small and independent breweries in operation and a brewery within 10 miles of 85 percent of all Americans, the Brewers Association accomplished much on your behalf throughout the year to strengthen the brewing community and provide tools to succeed in a competitive environment. In 2018, the BA focused on:



FUELING INDEPENDENCE

Our second national awareness campaign in as many years, That's Independence You're Tasting promoted small and independent breweries to a broader audience. The campaign, the largest in the association's history, was centered around two 30-second advertisements broadcast on a variety of media, including cable, satellite, and broadcast television; social media; and Pandora radio. With the advertisements realizing more than 170 million impressions, the BA is proud to be able to do for all of our members what would be extremely difficult for them to do individually. To date, more than 4,000 brewing companies, representing more than 85 percent of the craft beer brewed in the U.S., have adopted the independent craft brewer seal. Together we are united in independence.



ENSURING A HEALTHY SUPPLY CHAIN

To further the development of a robust and sustainable raw materials supply chain, the Brewers Association's Research and Service Grants program awarded \$430,000 to 17 research projects in 2018. Since the inception of the grant program in 2015, the BA has provided more than \$1.7 million in funding for 77 projects-addressing public barley and hop variety development, hop disease, and hop aroma-as well as supported affiliated national and state-level grower organizations. The BA also continued to work with the United States Department of Agriculture to revitalize public hop breeding.

PROMOTING BREWING EXCELLENCE

To provide guidance for operating a successful, safe, and sustainable business and to equip our members for excellence in brewing, the BA continued to deepen its educational resources through hands-on instructional workshops, best practices publications, online webinars, and a robust in-the-field ambassador program.

Craft Brewer Defined. An American craft brewer is a small and independent brewer.

Small. Annual production of 6 million barrels of beer or less (approximately 3 percent of U.S. annual sales). Beer production is attributed to a brewer according to rules of alternating proprietorships.

Independent. Less than 25 percent of the craft brewery is owned or controlled (or equivalent economic interest) by a beverage alcohol industry member that is not itself a craft brewer.

Brewer. Has a TTB Brewer's Notice and makes beer.



These resources address safety, sustainability, supply chain, quality, draught beer quality, and engineering topics; relay industry guidelines and metrics; and help bridge the gap in technical acumen.



FOSTERING COMMUNITY

Diversity and inclusion are opportunities for businesses to lead and succeed. In 2018, the BA welcomed Dr. J. Nikol Jackson-Beckham as its first diversity ambassador. Similar to other ambassador roles at the BA, Dr. J traveled around the country to state guilds and other craft brewing events to speak on best practices for diversifying both customer bases and staff, and to listen to current challenges in this area. Five new best practice resources are now available for member download on BrewersAssociation.org.

RECOGNIZING INNOVATION

The Brewers Association board of directors completed the next step in the evolution of the craft brewer definition at its fourth-quarter meeting in Scottsdale, Ariz. President & CEO The process to review and update the definition started in summer 2018 with a survey to determine what products members are brewing or may brew in the future, followed by a request for input on a proposed change. This fourth evolution of the definition is more

inclusive, recognizes the innovation and evolution of the brewing community, and adds more breweries to the craft data set.

FORTIFYING OUR VOICE

Also at its final meeting of 2018, the BA board of directors approved the creation of a new membership class to recognize the growth and importance of taprooms with representation and a voice at the table. In addition, the board approved the formation of a political action committee to strengthen our position in Washington., D.C. Look for more information to come in 2019.

HONORING CHARLIE

2018 was also bittersweet as we bid farewell to Charlie Papazian, our guiding light for the past 40 years. His influence on the homebrewing and craft brewing community is immeasurable. Who could have predicted that a simple wooden spoon, ingenuity, and passion would spawn a community of more than 1.1 million homebrewers and 7,000 small and independent U.S. craft breweries? We are all here today because of Charlie and we are beyond grateful for his many contributions.

Amid all this activity and development, the Brewers Association's purpose remains unwavering: "To promote and protect American craft brewers, their beers, and the community of brewing enthusiasts." Our members-first approach and firm dedication to building tangible membership value and programming has brought us to this point, and there is every reason to believe that it will sustain us into 2019 and well beyond.

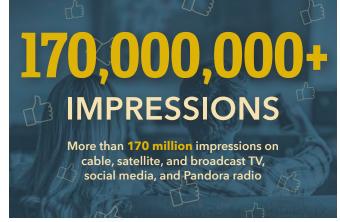


THAT'S INDEPENDENCE YOU'RE TASTING

Our second national awareness campaign in as many years, That's Independence You're Tasting launched in August with the goal of promoting small and independent breweries to a broader audience. The campaign, the largest in the association's history, centered around two 30-second advertisements broadcast on a variety of media, including CBS and CBS Sports, Comedy Central, The Travel Channel, NBC Universal, Hulu, YouTube, Adobe, Pandora radio, Facebook, Instagram, and Twitter.



That's Independence You're Tasting took a proud and positive tone, focusing on two key tenets of The ads showcased the grit, determination, innovation, and passion of America's more than 7,000 independent brewers.



The campaign videos proudly displayed the independent craft brewer seal—a mark that brings transparency to the marketplace and symbolizes a world that was turned upside down by the ingenuity and iconoclasm of the craft brewing movement. Our hope is that after being exposed to these stories, beer lovers are moved to support independent breweries and seek the seal when making their beer purchases.

INDEPENDENT CRAFT BREWER SEAL GAINS MOMENTUM

The independent craft brewer seal, launched in June craft brewing culture: independence and choice. 2017, made significant inroads into the beer marketplace-and popular consciousness-in 2018. More than 4,000 small and independent brewing companies have adopted the mark-a 33 percent increase from



2017 and representing more than 85 percent of craft beer volume. Notably, more than 60 percent of the top 50 craft brewing companies have added the seal to their packaging.

Breweries continue to find ways to incorporate the seal into their branding and promo-

tional materials, driving beer lover awareness, guiding purchase decisions, and underlining the importance of brewery independence.



Retail Support

On April 25, 2018, the association launched a program to equip on- and off-premise retailers with free assets to activate the independent craft brewer seal and elevate how they promote independent craft beer. Since the launch, retailers, breweries, and beer industry stakeholders have declared their support for the seal and requested point-of-sale materials.

In addition, several influential publishers have incorporated the independent craft brewer seal into their businesses, including BeerAdvocate, BreweryDB, Craft Beer & Brewing, TapHunter, Tavour, BrewGene, and Untappd.

Industry Snapshot



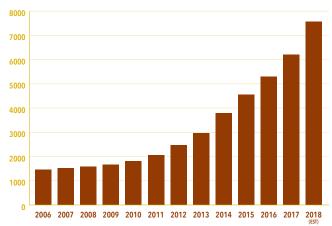
STEADY GROWTH

Although the craft market has matured in recent years, craft brewers continued to grow and gain market share in 2018.

The Brewers Association 2018 mid-year survey measured 5 percent production growth year-overyear for small and independent brewers. Full year IRI Group scan data numbers showed 2 percent (TTB) showing 10,115 active brewers permits as of the growth for BA-defined craft brewers, and given the continued growth in non-measured sales, 4 percent competition in U.S. brewing. overall growth seems likely for the year.

With total beer sales down around 1 percent in JOBS AND ECONOMIC IMPACT volume, that would take craft brewer share of the U.S. beer market to roughly 13 percent by volume in 2018.

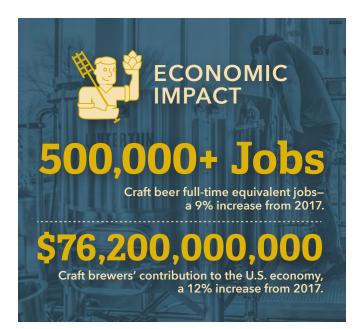
Number of Operating U.S. Breweries



Some of the growth in market share has been driven by the continued rise in the number of breweries. Although final 2018 numbers are still being compiled, it is certain that more than 7,389 American breweries operated in 2018, a record number for the United States. It's now easier than ever to tour or visit a local brewery-85 percent of 21+ adults now live within 10 miles of a brewery.

It is anticipated that this number will continue to rise in the coming years, with the U.S. Tax and Trade Bureau end of 2018. This will continue the trend of increased

Brewery growth has driven tremendous job growth as well. The BA's Economic Impact Report, featuring

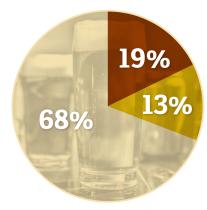


economic data of craft brewing for all 50 states and the District of Columbia, showed that craft brewers contributed \$76.2 billion to the U.S. economy in 2018, a 12 percent increase from 2017. Craft brewers were responsible for more than 500,000 full-time equivalent jobs, a 9 percent increase from 2017, with 135,000 of those jobs directly at breweries and brewpubs.

Based on preliminary Bureau of Labor Statistics (BLS) figures, those jobs numbers could rise sharply in 2017, with ~10,000 new jobs being created between June of 2017 and June of 2018 in BLS data (QCEW, 2019).

That figure may continue to grow as craft brewers reinvest their tax savings from a recalibrated federal excise tax. In a survey of BA members, 95 percent indicated that they were re-investing their tax savings, with purchasing new equipment and hiring new employees as the two most popular responses.

Ensuring a Healthy Supply Chain

Craft brewers produce approximately 13 percent of the beer sold in the U.S. but consume well over one-third of the hops and malt used by U.S. brewers. To meet the Brewers Association's primary strategic objective—brewer access to an adequate supply of high quality ingredients the BA puts member dues to work in support of public hop and barley breeding, research and development programs, and strategic partnerships.



PUBLIC HOP BREEDING PROGRAM

In 2018, the Brewers Association continued to work with the United States Department of Agriculture-Agricultural Research Service (USDA-ARS) to revitalize public hop breeding. Program goals focus on the development and commercialization of public aroma hop varieties with improved disease resistance and yield. The BA-funded, USDA-hired breeder will be stationed at the Washington State University Irrigated Agriculture Research and Extension Center (WSUexisting industry infrastructure. In the near-term, the program will leverage existing public germplasm under a newly executed Material Transfer Agreement between USDA-ARS and WSU. In the long-term, the program will produce varieties that can potentially travel to any U.S. hop-producing region. BA investment to hop industry stewardship, exceeding \$400,000 in future years.

RESEARCH & SERVICE GRANTS

In 2018, the Brewers Association invested nearly \$430,000 in support of 17 research projects, including five focusing on hops and 12 on malting barley crops. Researchers continue to emphasize disease resistance and yield improvements to maintain crop competitiveness and grower interest. They are also working on quality improvements prioritized by craft brewers such as understanding malt flavor outcomes in beer, increased extract, and a lower total enzyme package. IAREC) located in Prosser, Wash., in order to utilize Finally, the expansion of malting barley and hop production into new growing regions has resulted in an increased geographic spread of production for risk management, as well as access to local ingredients by craft brewers. HOPSOURCE HOP SENSORY ASSESSMENT

In September, Brewers Association staff piloted HopSource Hop Sensory assessment. This first of its kind, weeklong event was a carefully designed sensory exercise

to characterize hop sensory attributes and measure likely brewer acceptance of new hop varieties in the experimental public pipeline. The Brewers Association partnered with Yakima Valley Hops and DraughtLab during the heart of the hop selection season. More than 200 people participated in this crowd-sourced





sensory exercise, evaluating over 50 varieties for likely future acceptance. The Brewers Association plans to demo HopSource at the 2019 Craft Brewers Conference, and will repeat the event during two weeks in late September 2019 in Yakima. We invite all members to participate and help steer the future of the U.S. public hop breeding program.

SUPPLY CHAIN FEDERAL ADVOCACY

In 2018, Brewers Association staff participated in two efforts to secure favorable regulation and funding for barley and hop crops. For more than 30 years, the National Barley Improvement Committee (NBIC) has conducted three days of lobbying under the auspices of the American Malting Barley Association (AMBA), and BA staff was on hand to help with more than 60 office visits. The Brewers Association government affairs staff also organized and led a brewing and hop industry-wide coalition that conducted lobbying on behalf of the hop industry for the second consecutive year. The coalition visited more than 30 House and Senate offices to share concerns about the public hop research program, and to successfully secure congressional commitment for continued funding.

Protecting and Promoting Business: Federal Government Affairs

2018 saw breweries begin to realize their savings from the recalibrated federal excise tax (FET) as part of the December 2017 passage of a two-year provision of the Craft Beverage Modernization and Tax Reform Act (CBMTRA), a legislative victory the BA has been working toward for the last decade. In addition to working to make the FET savings permanent, the BA advocated on numerous agricultural issues, and worked to mitigate the impact of tariffs on the brewing industry. The BA is grateful for member involvement and advocacy at federal and local levels to help fortify the brewing community's voice.



FEDERAL EXCISE TAXES

The language that recalibrated the federal excise tax (FET) for breweries went into effect on January 1, 2018 and will expire on December 31, 2019. A bill similar to CBMTRA, with the goal of making the legislation permanent, will be reintroduced in 2019. CBMTRA finished the year with 303 co-sponsors in the House and 56 in the Senate.

Small breweries are expected to save approximately \$80 million each year the FET recalibration is in place. According to a survey conducted by the BA:

- 73% of breweries are purchasing new equipment, upgrading their tasting rooms and/or breweries, moving to new buildings, etc.
- 53% are hiring new employees at an average of 2.7 per brewery.
- 39% are increasing their employee benefits by raising pay, offering insurance, and expanding vacation time.
- 21% are increasing their charitable contributions.
- 58% are doing two or more of the abovementioned actions.

TARIFF

The BA has been working with Congress to mitigate the impact of tariffs on the brewing industry. The BA reached out to the administration and the Department of Commerce to explain how the tariffs would impact small and independent breweries and asked for exclusions, some of which were granted.

- 232 Tariffs on aluminum and steel: In June, tariffs on imported unmanufactured aluminum (10 percent) and steel (25 percent) went into effect. These tariffs could have an impact on breweries who can their beer, purchase new stainless steel items, or plan to expand their brewery.
- 301 Tariffs on goods from China: Tariffs have been levied on more than \$200 billion of goods imported from China. Ten-percent tariffs on items like kegs and vats (stainless steel drums) will have an impact on American breweries.

AGRICULTURAL ISSUES

The BA has been working with supply chain partners, hop growers, and barley growers on an array of issues from appropriations funding to the Farm Bill. BA staff participated in fly-ins with all parties to support legislative issues that would positively impact them, such as fully funded research programs with the U.S. Department of Agriculture-Agricultural Research Services and crop insurance for farmers.

CAUCUS

The House Small Brewers Caucus ended 2018 with 240 members from 43 states, making it the largest special interest caucus in Congress. The Senate Bipartisan Small Brewers Caucus ended 2018 with 37 members from 26 states. Throughout the year, the BA hosted

educational events including a homebrew demonstration, food and beer pairings, and hop sensory training for caucus members and their staff.

HILL CLIMB

In June, the Brewers Association hosted the 2018 Hill Climb, with 120 brewery owners and employees participating from across the country. The group converged on Washington, D.C. to advocate for making the two-year FET recalibration permanent and for increased funding for hop and barley research as well as the Alcohol and Tobacco Tax and Trade Bureau.

Protecting and Promoting Business: State Government Affairs

SUPPORTING STATE GUILDS

The Brewers Association has long made supporting state brewers guilds/associations a priority. Crucial issues such as franchise law, self-distribution, and the regulation of on-site sales fall almost wholly within the domain of state authority. The BA provides valuable resources to state guilds to help ensure small brewers have equitable and open access to markets, distribution, and sales. In 2018, the BA supported state guilds on these issues as well as matters related to the statutory definition of a small brewer, satellite retail locations, comprehensive alcohol law reviews, California-specific Proposition 65 alcohol warnings, and trade practice issues involving advertising and the provision of "things of value."

SIGNIFICANT STATE WINS

- South Dakota: Legislation was signed into law creating self-distribution rights for microbrewers (up to 1,500 barrels annually). The new law also provides for an increased production cap on microbreweries to 30,000 barrels under which a manufacturer may maintain on-site sales rights, the ability to operate additional locations, and the ability to transfer beer between those locations without regard to the self-distribution limitation.
- Vermont: Legislation was signed into law that creates an exception to the beer franchise law for brewers that manufacture not more than 50,000 barrels of malt beverages and whose products comprise 3 percent or less of the wholesale dealer's total annual sales by volume.

GUILDS EXECUTIVE DIRECTOR COOPERATIVE FUNDING GRANT PROGRAM

In 2018, 13 total grants were approved in the BA's Guilds Executive Director Cooperative Funding Grant Program. The grant program addresses the need for guilds to hire paid staff, particularly in the executive director role. Filling this leadership position has proven to be an indispensable step for state guilds seeking to elevate organizational efficacy and advance small brewer interests on both the state and national levels.

ISSUES FOR 2019

2018 saw a marked increase in TTB trade practice enforcement cases, many in cooperation with state alcohol enforcement agencies, which led to numerous license suspensions and monetary penalties. Brewers should expect continued heightened scrutiny of marketplace activities in 2019.

HOW TO GET INVOLVED

The Brewers Association provides programs and resources to assist its members and the greater beer and brewing communities with taking an active part in educating and championing the interests of small and independent brewers.

• Support Your Local Brewery (SYLB) is a communication network that informs brewery members, homebrewers, and beer enthusiasts (more than 81,000 nationwide) about issues that impact small brewers and organizes grassroots activities to defend the interests of small brewers. The network is designed for quick mobilization when issues arise, with SYLB members contacting their elected officials to support small brewer positions. In 2018 five action alerts were issued: Louisiana (self-distribution), Massachusetts (franchise modernization), South Dakota (self-distribution/retail sales), Ohio (access to market) and Wisconsin (access to market).

Supporting Business Health: Technical & Quality Resources

Building upon existing resources and launching new initiatives, the Brewers Association continued to expand the collection of technical resources available to members. Below are highlights from the BA's technical and quality efforts in 2018.

AMBASSADOR OUTREACH

Brewers Association technical resources are supported by an ambassador outreach program. Experts in the areas of quality, safety, sustainability, and draught quality attend state brewers guild meetings and other industry events to disseminate information and promote available resources. BA ambassadors presented at 27 different events in 2018.

SAFETY

Online Brewery Safety Training

The BA is committed to promoting safety in the brewhouse by providing free resources to members and non-members alike. Since the Online Brewery Safety Training series was launched in September 2015, more than 30,000 lessons have been completed. The curriculum is supported by best management practice documents and regular communication from the safety subcommittee through the Safety Exchange and Lessons Learned programs. In 2018, Hazard Assessment Principles, a best management practice guide for developing or improving brewery safety programs, was published. The Brewers Association also entered into an industry alliance with the District Five office of the Occupational Safety and Health Administration, the Ohio Craft Brewers Guild. and the Master Brewers Association of the Americas. The alliance will serve as a model program to reduce and prevent exposure to hazards throughout the brewing industry.

QUALITY

Quality Workshops / Videos

The Basics of Beer Quality Workshop program conducted six workshops in 2018 in Ohio, Colorado, Illinois, Michigan, Oregon, and California. These full-day workshops, led by quality instructor Lauren Torres, covered the fundamentals of the most common methods used to ensure consistency and quality in a brewery. With a hands-on approach, attendees have the opportunity to use lab equipment and practice quality analysis methods. The workshop is supported by a series of videos, produced in collaboration with the American Society of Brewing Chemists, that demonstrate basic laboratory methods. Three new videos were added to the series in 2018 addressing Beer Degassing, Specific Gravity Determination, and Apparent Extract Determination.



Draught Beer Quality Summit At GABF

As part of the ongoing effort to improve the quality of draught beer at retail, the Draught Beer Quality subcommittee conducted the 8th Annual Draught Beer Quality Summit in Denver during the Great American Beer Festival. A record number of attendees heard presentations from draught quality experts, experienced hands-on demonstrations, and participated in sensory evaluation.

BEST PRACTICES

Benchmarking Reports And Dashboard

The Brewers Association Benchmarking Reports provide a platform for the craft brewing community to share best practices for how to use water more efficiently, generate less wastewater and solid waste, decrease total energy usage, and reduce greenhouse gas emissions. Using the Benchmarking

Dashboard, breweries can easily identify areas to improve efficiencies and increase profitability by comparing themselves to industry averages of similar breweries. Additionally, brewers can enter target usage and cost values and track ongoing monthly performance. The publication of a multi-year summary report marked the fourth year of the project.

Food Safety Modernization Act (FSMA)

In collaboration with the Master Brewers Association of the Americas, the Brewers Association published "Brewers' Responsibilities and Obligations under the Food Safety Modernization Act (FSMA)." The format addresses frequently asked questions to help brewers understand which portions of FSMA apply to them and provides references to relevant sections of the Code of Federal Regulations.

A second resource published in 2018, "Voluntary Market Withdrawals and Recalls," explains brewers' legal obligations when a product is withdrawn from the market and makes suggestions for how to prepare for and execute a market withdrawal or recall.

Keg Return - Free Freight

As the brewing community has grown, so has the number of "lost" kegs. The Brewers Association worked with MicroStar to educate brewery members regarding the ongoing keg repatriation program though a "free freight" offer. Brewers Association paid the way for 4,228 kegs from 99 breweries to be returned home where they could be put back in circulation, delivering draught beer to thirsty consumers.



Supporting Business Health: Educational Resources

The Brewers Association develops resources and compiles data for members to help guide business decisions, because operating a brewery is more than making high quality beer—it requires running a good business.

INDUSTRY BENCHMARKING AND BREWERY OPERATIONS SURVEY

Compiled and published by the BA, this survey provides aggregated data covering core business functions throughout the brewery. Salary and benefit information provide insights to industry standards when opening or expanding. Revenue and cost of goods data guides financial planning when breweries are looking to scale production.

POWER HOUR

These 60-minute live webinars cover a wide range of timeless and timely business topics, including technical brewing, market changes, statistical insights, and brewery marketing. Archived recordings of past Power Hours are available to members at any time on BrewersAssociation.org. In 2018, the BA hosted six Power Hours on the following topics:

Eleven discussion boards allow brewers to post and search by specific topics, as well as subscribe to subjects of ongoing interest. With a daily email digest, the BA Forum is always at members' fingertips.



CRAFT BREWERS CONFERENCE® & BREWEXPO AMERICA®

The Craft Brewers Conference (CBC) is the premier industry event that serves the entire brewing community, including brewers, distributors, retailers, and suppliers.

For professional brewers, CBC is the number one environment for concentrated, affordable brewing education, idea sharing, and networking. Twelve educational











tracks streamline learning based on job function. These valuable resources are available to all members after the conference on BrewersAssociation.org. The conference is also a great social event with thousands of brewing industry professionals from around the world enjoying craft brews together.

BrewExpo America allows exhibitors and buyers to develop profitable business relationships and helps brewing professionals find the latest and best products and services that industry vendors have to offer.

In 2018, more than 15,000 brewing professionals and 700 exhibitors convened in Nashville, Tenn., for discussion and dialogue around America's craft brewing business and culture. The conference added a new Leadership track that featured noted speakers from outside the craft brewing community.

Ten years ago, small and independent American craft beers did not have a significant international presence and suffered from a limited awareness of proper storage and handling when available.

Today, small and independent American craft beer is one of the major reasons behind the drive for quality and increase in demand for innovative beer styles. In 2017, American breweries reported all-timehigh export figures of 482,309 barrels with a value of \$125 million.

In 2004, the Brewers Association had the foresight to start the Export Development Program (EDP). Funded by a grant from the United States Department of Agriculture, the EDP focuses on educating international

trade and media about proper storage and care for craft beer as well as the quality and diversity of styles created by small and independent American craft brewers. Resources such as the Best Practices Guide to Quality Craft Beer and technical seminars are brought to global markets to focus on quality—which has benefited the newly exporting members, the reputation for American craft beer generally in international markets, and conditions for new breweries in international markets.

Today, the Export Development Program boasts more than 90 members who participate in sending beer to events, festivals, and competitions around the world.

2018 saw no shortage of stories that spoke to the diversity, heart, and creativity of small and independent craft breweries, and CraftBeer.com was proud to tell these stories. As the BA's beer lover-facing website, CraftBeer.com published more than 200 original articles, videos, and social assets featuring small brewers.



The website partnered with the North American Guild of Beer Writers for the first annual Diversity in Beer Writing Grant. The winning pitch, "Pride, not Prejudice: Brewing Safe Spaces for the LGBTQ+ Community," was published on CraftBeer.com just before the Great American Beer Festival. Nearly 2,000 people

took the CraftBeer.com Beer 101 course with tens of thousands also utilizing the CraftBeer.com Beer & Food Course content. The site accrued more than 4.7 million page views in 2018, and also published more than 900 member-submitted press releases.

Social media channels tied to CraftBeer.com engaged more than 220,000 followers—growing despite a major Facebook algorithm change that hit publishers hard. Additionally, the North American Guild of Beer Writers, the top beer writing award organization, recognized two CraftBeer.com articles amidst a competitive pool of talented journalists.

With the most extensive online brewery database, one of the largest online recipe collections for cooking with craft beer, and access to some of the world's most authoritative resources on beer styles and educational tools, the site continues to advance both small and independent brewers and the beverage of beer.



SAVOR™: AN AMERICAN CRAFT BEER & FOOD EXPERIENCE

The 11th edition of SAVOR offered an intimate environment for attendees to sample craft beers, mingle with brewery representatives, and experience the full potential of beer and food.

Drawing support from a veritable who's who of culinary talent, the SAVOR menu was designed by Brewers Association executive chef Adam Dulye.



The occasion provided an opportunity to elevate the conversation around the relationship between craft beer and food and served as the anchor event for what has evolved into "SAVOR week" in our nation's capital.

The event returns to the historic National Building Museum on May 17, 2019.



GREAT AMERICAN BEER FESTIVAL®

A record-breaking 62,000 beer lovers flocked to the 2018 Great American Beer Festival (GABF) to sample more than 4,000 beers from 800 breweries.

GABF continued to provide educational opportunities such as the Protect Craft Guilds Pavilion, Brewers Studio Pavilion, and Beer & Food Pavilion. At Paired®, attendees had the

chance to sample unique craft beer and food pairings in an intimate setting just off the main festival hall.





The 32nd annual Great American Beer Festival competition, the largest ever, awarded 306 medals to some of the best beers in the United States, plus three GABF Pro-Am medals to teams of homebrewers paired with professionals. In total, 2,404 breweries from 49 states (plus Washington, D.C.) entered the competition, with 293 judges evaluating 8,496 entries across 102 beer categories, including five new style categories:

- Juicy or Hazy IPA (391 entries*)
- Juicy or Hazy Pale Ale (132 entries)
- Juicy or Hazy Imperial or Double India Pale Ale (150 entries)
- American-Style Pilsener (91 entries)
- Australian-Style Pale Ale (46 entries)

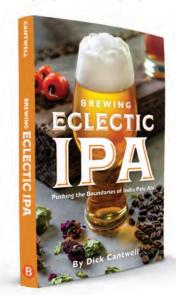

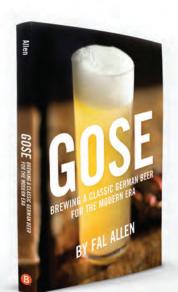

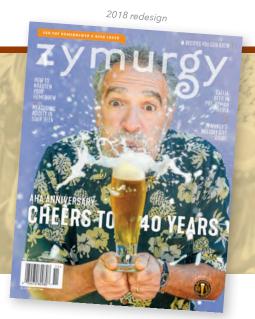
