## **SMHA CONCESSION APPLICATIONS 2023-2024**

## REQUIRED TEMPLATE FOR APPLICATIONS BY ZONES OR INTERLOCK MHA'S

# **IMPORTANT:**

- Concessions will be heard at Program Committee Meetings only and not directly to the SMHA Board;
- All concession applications must be submitted per this SMHA application template;
- All concession applications must be approved by the Zone or interlock MHA's Board of Directors <u>prior to</u> being submitted to SMHA;
- Deadline for submission of written (by email) Concession applications (to go below OR above the approved grid) is September 5<sup>th</sup> to SMHA Executive Director- applies to SMHA zones and interlock associations;
- SMHA Age Division Chairs will schedule their committee meetings to be conducted between September 6 17, 2023. Concession applications will be reviewed at these meetings;
- SMHA Age Division Chairs will present any concession requests coming from their meetings to SMHA Board meeting on September 18, 2023;
- Process does not apply to female hockey;

# COMPONENTS OF THE CONCESSION APPLICATION TO SMHA

## 1. Cover Letter / Email:

General information summarizing the concession being requested by the zone or the interlock MHA that must include the following:

- -date that the Board of Directors of the Zone or Interlock MHA approved the request to go forward to SMHA;
- -the age division being requested to have a concession;
- -whether the request is to go below or above the approved grid;
- -specification of the applicable approved grid that the zone should be following and what grid format is being requested via the concession process; Example:

5-team U13 grid requires a 2-2-1 grid and our zone is applying for a concession to have a 2-1-2 grid;

-provide the Zone's / MHA's rationale for making the concession request; -provide who will be the main contact for the zone / interlock MHA and who will be attending the Age Division Committee meeting for the zone / MHA;

### 2. STEP 1 Criteria Submission

- -provide a summary sentence / paragraph on the % of first year players that are registered with the zone / MHA a minimum of 60% is required to proceed;
- provide a summary sentence / paragraph on the % of players that played below the Tier 1 level the previous year; a minimum of 60% is required to proceed;
- for U15 and U18 concessions, provide a summary sentence on the number of players that have voluntarily opted into the C (no body checking) level and whose numbers do not count towards player totals for the purpose of the concession application;
- provide a spread sheet that clearly lists the name, birthdate and the level played the previous season of each registered player;

Note: - Please sort the list of players by birth year; For players new to SMHA hockey, please indicate their previous MHA and level played or record as New to Hockey if they have not played before;

### 3. STEP 2 Criteria Submission

- -provide a complete summary of standings from the previous two seasons of the Zone's / MHA's teams in the age group for which the concession is being applied for;
- -provide a complete summary of standings from the previous two seasons for the age group moving into the age group for which a concession is being applied for;
- **-Example**: if a U13 concession is being applied for, provide standings for the previous two seasons of U13 as well as the previous two seasons in U11; -for U9 age concession requests, please be sure to indicate which players are New to hockey;
