Hey Darrell,

Here is the summary of the goalie training and equipment from the last year.

We completed 43 training sessions this year between Josh and myself. I seen improvements across the board in skill and a few new goalies between U9 and U11 that are interested in developing full time which is a good sign. We tried a group U9/U11 one around February break and I think we'll incorporate more of those and a lot earlier next year. I'm not sure of the projected numbers in all of the birth years that want to be full time yet so more work to do there. We need to make sure we have the numbers in U9 and U11 and encourage their future development as much as they want it.

As for equipment, we purchased 2 full sets, as well as a few bags and sticks for U9. Aside for some minor repairs (toe straps) and one set of U9 blocker/catcher needed for the fall, we should be OK if the team numbers stay the same.

I'm proposing a \$3500 budget for training and equipment for next year.

Thanks, it was lots of fun working with these tendies this year!

We are continuing to go through the process of upgrading our U18, U15 & U13 Jersey set's. We had received the 2 new white sets for U18 and 2 white sets for U15 two years back. We are seeking to purchase 8 more sets now and have them ready to go prior to next season. 2 black sets for U18, 2 black sets for U15 (this will complete the full refresh for U18 and U15). We are also looking to replace 2 sets of U13 whites and 2 sets of U13 blacks for this upcoming year.

We are looking at options to purchase slightly higher quality jerseys for better longevity and will discuss pricing as part of the budget review at this meeting.

We are looking into the option of having Cougar logo' d jersey bags available to include at the time of registration. Costs still being reviewed.

We will be looking to offload some old jerseys available for our Clavet teams\alumni\fans\parents. Option for disposal is still being reviewed. We would like to keep some old sets for Evaluations, 3 on 3 teams, etc. (Use these instead of our new sets).

Jersey pick up: Will set up a date to have jerseys picked up from Jesse and I at the rink, hangers will not be provided to the teams. We will go over the condition of the jerseys and go through the jersey numbers and agree on what was handed out to the manager, including the state of the locker. Manger to sign off.

Jersey return: Starting next year we will set up a date for managers to return the jerseys to Jesse and I at the rink. They are expected to be washed, checked over, any damage noted, sorted into 2 groups (lights and darks and in number sequence) The Letters must be removed and handed in to us at that time. We will also expect the locker to be cleaned out and organized for the upcoming year by this time. It is expected that if any jerseys are damaged that the manger take them to Tari-Lynn Beamish to have repaired prior to this date.

Jerseys: From this past year we are missing:

U9 Tim Horton - Green x 3, White x 5

U11 Team 3 – Black x 1

U15 Team 2 - Black x 1

Locker codes have been changed. Moving forward only the manager will be given the code for the locker at the beginning of the season, the manager and team is responsible for the **full jersey sets** and other content within the locker (Goalie gear, etc in some cases).

All locker items from this year have been removed and if you require items see Jesse or myself. If items are not claimed by the beginning of next year (Oct 1<sup>st</sup>) they will be reused, disposed, etc. depending on the nature of the items. Moving forward, the lockers will be cleaned out with the manager as part of the season wrap up meeting, with Jesse and I.

3 on 3 jersey usage; This will need to be arranged through Jesse and I and we will keep track of who has what jerseys and ensure they are properly\promptly handed out and returned. We will be using older jersey sets for this purpose and will still require the jersey deposit cheques.

Pant shells, we are looking into providing pant shells. Cost of shells, socks and jersey bags will eventually be part of the registration costs. This will be discussed further as part of the budget review.

The U11 Atomic jerseys and socks have been ordered for next year. Enough for 3 teams. Extra socks have been ordered as well. Green color was ordered, so the teams will have black sets and green sets in this upcoming season. The Green sets are required to be returned and the Black sets can be kept by the players. Next year we plan to order white so the year after they will have green sets and white sets. Unless keeping the black and green sets is preferred.

We have a good level of the Cougars socks for this year. We are looking at phasing out the current style, they are \$40 per pair, and you will have an option to purchase and include the price at time of registration. New styles are currenting being discussed.

Freezer was purchased for game pucks and is located in the score clock booth. The arena board is looking to mount it in a more appropriate\accessible area within the score clock booth.

Game pucks (Cougar Logos) were purchased for the purpose of only being used for games and being kept in the freezer.

We have used over 300 pucks (non cougar logo) this year. Please help in returning pucks or finding around the ODR.

We have more and more teams coming on board, which is great to see but it makes locker space difficult. We have freed up 2 more lockers for the upcoming season and we are looking into purchasing a few more. Will discuss as part of the budget review. The lockers will be much better organized next year and depending on the number of teams, we are trying not to have to share. If additional lockers are purchased and in place, then we definitely will not need to share lockers.

Here is something I put together for a report. We are unable to make it to the meeting this week. Mel and Teresa, please feel free to add anything.

This season's ref coordinator role was divided among 3 coordinators. This lightened the workload. Overall, the season went well for us. There was a large enrollement of 15 new referees (all ages 11-12). With this amount of kids it was a bit of a challenge to get each official more than a few games but it seemed to work out. These officials mainly reffed U7 and U9 divisions and each one was able to try a U11 game. For the U11 and U13 divisions there were a good amount of officials for these games. It was a bit of a struggle to find refs for U15. Many times we needed to find officials from other communities which then mileage would apply. The U18 group took care of finding their own refs for this year.

The plan for scheduling at the beginning of the year was to use Team linkt. There were some challenges with this system and we were unable to use it. We ended up creating our own spreadsheet to assign. This worked well but hopefully next year we can find another online system to use.
