



EBJC Coronavirus/COVID-19 Waiver of Liability

ASSUMPTION OF THE RISK AND WAIVER OF LIABILITY RELATING TO CORONAVIRUS/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and wearing of face coverings and have, in many locations, prohibited or limited the congregation of groups of people.

East Brunswick Jewish Center (“EBJC”) has put in place preventative measures to reduce the spread of COVID-19; however, EBJC cannot guarantee that you or your minor child(ren) will not become infected with COVID-19. Further, attending EBJC or EBJC-related activities could increase your risk and your child(ren)’s risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending EBJC or EBJC -related activities and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at EBJC or EBJC -related activities may result from the actions, omissions, or negligence of, among others, EBJC employees, volunteers, officers, directors, agents, representatives, congregants and EBJC -related activity participants and their families.

On my behalf and on behalf of my minor child(ren) named below, I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)’s attendance at EBJC or participation in EBJC -related activities (“Claims”). On my behalf, and on behalf of my minor child(ren) named below, I hereby release, covenant not to sue, discharge, and hold harmless EBJC, its employees, agents, officers, directors and representatives, from and against the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of EBJC, its employees, agents, officers, directors and representatives, whether a COVID-19 infection occurs before, during, or after participation in any EBJC -related activity.

I understand and agree that the law of the State of New Jersey will apply to this Waiver of Liability.

I HAVE CAREFULLY READ AND FULLY UNDERSTAND ALL PROVISIONS OF THIS WAIVER OF LIABILITY, AND FREELY AND KNOWINGLY ASSUME THE RISK AND WAIVE MY RIGHTS ALONG WITH THE RIGHTS OF MY MINOR CHILD(REN) NAMED BELOW CONCERNING LIABILITY AS DESCRIBED ABOVE:
