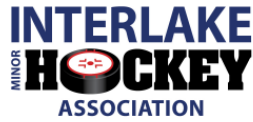

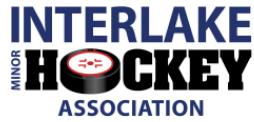
### 7. Unsanctioned Tournaments
