 - There will be positions on the Hockey Manitoba board open, if anyone is interested.
 - Issues with racism in Interlake Minor Hockey will not be tolerated and will be dealt with accordingly.

6. **Referee-In-Chief Report**
 - Season going fairly well, only a couple of issues.
 - Junior officials doing Atom games without a mentor on the ice.
 - For the Atom playoffs there will be a mentor on the ice OR a senior official with a junior official.
 - U18 suspensions are quite high.
 - 35 suspensions issues over the weekend of February 14th - 16th from Pee wee to U18.
 - 22 of those occurred at the Gimli U18 Tournament.

7. **Development Plan**
 - Pee wee
 - For 2020/2021 season program that mimics Rising Stars will be introduced for all Pee wee players and will run for the entire season.

- Will be divided into 3 regions (North/Central/South) to reduce travel.
- Coaches will be encouraged to participate as well.
- There will be a fee - amount still to be determined.
- Increased development opportunities for goalies at all levels.
- More coach clinics
 - Reward vs penalty for participation (IE: reward for completing X clinic hours)
- Female development
 - Trial program with a female Atom team playing in Pembina Valley this year.
 - Well received, only 2 Fridays per month.
 - Would like to see it carry over into next year. Blackout dates for IMH league games if required.
 - Involve the Female AAA Midget players with practices.

8. Development Programs

- **Rising Stars**
 - 51 skaters and 7 goalies registered
 - Evaluation completed by Scott Wong on February 17th in Teulon
 - 31 players cut after evaluation.
 - 2nd evaluation to happen week of February 24th-28th to get roster down to 21.
- **Female Peewee Prospects**
 - Going well overall.
 - Not a lot of participants this year.
- **Director's Cup**
 - Only 18 registered players
 - Are players feeling intimidated by Lightning players who are also registered?
 - Does there need to be more advertising done for the program?
