4. Old Business

a. Logos for zamboni and ice surface (order and install)

b. Travelling Team Policy

Overview: Update on discussion with RRA regarding their Travelling Team Policy.

Discussion: General discussion on the draft policy and feedback from Jeff. Support for providing ice times to approved teams but will charge back costs (i.e. 2hrs / month) and the removal of the exhibition game restriction.

Overview: Concerns were raised over officiating in 2023-24 and a meeting is planned to discuss with RRA, SRA, and RAS.

c. Jersey Management

Overview: Replacement of BPRA jerseys and overarching jersey management.

Discussion: Storage room is getting full and some division jerseys need replacing. It was suggested that since several of the older age groups go with custom jerseys, the younger divisions jerseys be replaced first. Reversible is preferred given experience with 14B jerseys last season, comparable costs and due to storage considerations. Fundraising options were discussed including auctioning off or selling old jerseys, finding grants or sponsorship for jerseys.
