

# **BUFFALO PLAINS RINGETTE ASSOCIATION**

Board Meeting Minutes 7:00 pm - May 8, 2023

- 1. Call Meeting to Order Meeting called to order by Amanda O'Donnell at 7:15pm
- 2. Adoption of Agenda Addition of bank signatories to New Business. Motion to adopt Denise, seconded by Daegan

- b. Travelling Team Policy

Overview: RRA Travelling Team policy has been shared.

*Discussion*: A number of questions to discuss with RRA were identified, including if BPRA can have a modified policy (ice, fees, etc.) if the terms of affecting both associations are the same, would RRA allow BPRA to have a two year team?

## 5. New Business

a. Board Director and Commissioner Changes

Overview: Discussion and assignment where applicable of Director and Commissioner roles.

- Director, Sport/Player Development Janelle Gordon will assume the position effective immediately.
- Director, Officiating Discussed options given current relationship with ROAR for officiating. Decided that this is not a required role and it will remain vacant for 2023-24 and be revisited at the next AGM. Denise will be primary contact with ROAR on behalf of BPRA.
- Scheduling No interested party was identified. This position will be advertised to see if a volunteer can be found and trained under current Scheduler, Ken Nagy.
- BP Charge Tournament Coordinator Melissa Wasilow and Crystal Lavadiere will assume the role of Tournament Coordinators effective immediately.
- Children's Ringette Commissioner General discussion of current state of program and the need to revamp it with the support of RAS. Focus needs to be put on increasing participation. Jennifer Krekewich will continue to be the Director of Children's Ringette. At least one Commissioner was recommended. This role will be advertised to see if an interested volunteer can be found. A separate meeting will be set up to discuss the program.
- U12 Commissioner Tracey Stechyschyn will assume the position effective immediately.
- U16/19 Commissioner Melissa McCullough will assume the position effective immediately.

Action:

## b. Strategic Planning Session

Overview: Organization of strategic planning session.

*Discussion*: General preference for Sunday or evening(s). Feedback has been requested on topic items. The session needs to occur before summer, with late May/early June preferred.

- c. Board Incentive (in constitution, 70% of board meetings, vote at 2021-22 AGM) Angela

*Overview:* In the AGM minutes from 2021-22, a motion was passed that states all voting members must attend 70% of Board meetings in order to qualify for incentive next season.

*Discussion:* General discussion on value and mechanism for incentive. The incentive needs to be considered on an annual basis.

*Motion:* Denise motioned that the 2022-23 BPRA Voting Board members (using the definition of voting members updated at the 2022-23 AGM), who attended at least 70% of BPRA Board meetings be provided an incentive of \$200 towards registration for the 2023-24 season. Motion was seconded by Jennifer, carried.

## d. Board Swag

*Overview*: General discussion on whether the association should provide a small allowance for Board members to purchase BPRA logoed clothing to promote the association and sport.

*Discussion*: General discussion on idea resulted in the recommendation not to move this forward at this time. Promotional items for BPRA events will be considered.

## e. Outdoor Ringette Sticks for School Use

Overview: Opportunity to encourage ringette in schools to promote the sport.

Discussion: Discussion of options/ideas.

- Stick drive is being planned during Fall 3 on 3, which then can be provided to schools for use on outdoor rinks. There are also a number of used rings in the equipment room that could be provided to schools.
- Reminder that some schools have indoor ringette equipment and there is equipment available for rent by RAS.

## f. Bank Signatories

Overview: With updates to the BPRA Board, new signatories are required on bank accounts. Discussion: Signatories need to be updated to replace Cara (Past President) and Ian (Tournament Coordinator). Replacements were discussed.

*Motion*: Angela motioned to replace Ian and Cara as signatories on the account with Amanda O'Donnell and Janelle Gordon. To avoid any delays in year end transactions, Cara and Ian will be able to approve transactions until the end of the fiscal year which is May 31, 2023. Daegan seconded the motion, vote was carried.
