 - More organized coached.
 - Sharing of drills between coaches in the zone.
- Goalie development
 - U7 U9: "Try Goalie for a Day" session ice times midseason
 - U11-U18: zone goalie development. Zone books ice times and offers goalie development sessions at a reduced rate to Renegade goalies.

 - U7-U18: zone booked ice times. Multiple teams on ice at the same time. Use professional instruction. Focused training/coach mentoring sessions. Experience running efficient practices.

- 1. SMHA is asking that we assist them with ideas for how to acquire sponsorships for each zone. If we have a template that we can share with them for all zones to use.
- 2. U9 CCM Academy in Aberdeen is considered non-sanctioned and anyone found involved will be dealt with via the HS rules for suspensions.
- 3. Kinsmen inner city program is having an equipment drive on Oct 21st aimed at U9-U15 age group sizes. If you or anyone you know would like to donate please contact SMHA.
- 4. All concessions were denied this year except U11 in Martensville.
- 5. HC has created a Pathways to success program for U13 and U15 just like they had for U9 and U11. (Mandatory pre-skates and team numbers on ice for eg.) This is a recommendation and not mandatory and at this time HS and SMHA will not be following the recommendations.
- 6. Blades are offering a free ticket to all SMHA players through Teamlinkt for the home opener on Sunday.
- 7. 33 players from the U15A league were selected to a U15AA team this year. Proving that the new league is working for the purpose it was made for. Feeder league for U15AA.
- 8. Thanks to everyone who helped with the U15A tryouts. Especially Paul and his daughter who were there helping all week and weekend.
- 9. Saskatoon will be hosting the Women's Canada/US Rivalry series.

 - b. Regina Feb 9th.
- 10. U13 coordinator honorarium. I'd like to make the motion for us to use the honorarium this year to buy a table of 8 at the SMHA 50th anniversary. We can then donate whatever is left over to the Ultimate parent party. I have been running the age group with help from various board members. Even if we elect someone to be the U13 coordinator this year prior to the AGM they would not be participating in the tryouts which is the biggest reason for the honorarium.
