- This release will apply to any field or location where Tri-Boro Sanctioned events or games will take place.
- Tri-Boro Softball is in no way responsible for any non-sanctioned events run by Tri-Boro Softball, including, but not limited to, practices, pick-up games, scrimmages, home run derby, games played in other tournaments or leagues.
- This form must be signed by all rostered players before they partake in any sanctioned events. Any players not on this form are not permitted to be on any roster until they sign the form
- This form must be completed in full and returned to Tri-Boro Softball before the start of the season.
- 1. I voluntarily and of my own free will, elect to participate as a member of the softball team and agree as indicated below.
- 2. I understand that there are certain risks and hazards involved in participating in softball that may result in injury or death to me or other players, spectators, or umpires. Including, but not limited to those hazards associated with weather conditions, playing conditions, playing conditions, equipment and other participants.
- 3. I understand that sliding into a base, playing any position in the field, batting, being in the dugout area, and in the spectator area is dangerous to me and to other players and may result in serious injury and death.
- 4. I understand that the very nature of the game of softball is hazardous and risky, including, but not limited to, the acts of pitching, throwing, fielding and catching of the ball, the swinging of the bat, running, jumping, stretching, sliding, diving, and collisions with other players and with stationary objects, all of which can cause serious injury or death to me and to other players.
- 5. I understand that this release extends to all spectators who are at the field and associated with me or my team in any way.

Further, I, the undersigned player, agree that in consideration for the right to play as a member of the team designated below and in consideration for permission to play on the fields arranged by the team or league:

- I voluntarily elect to accept and assume all risks of injury incurred or suffered by me (a) while practicing or playing as a member of the team so designated, (b) while serving in a non-playing capacity as a team member during practice or play by other teams or by other players on my team, and (c) while on or upon the premises of any and all of the fields arranged for by my team or league for practice or play.
- 2. I release, discharge and agree not to sue the team and league designated below, all officers or board members of the league, the field owners or other entity where sanctioned league events/games are taking place, the National Softball Association or their owners, officers, agents, servants, associations, employees, or any person or entity connected with the team, league, field, or other National Softball Association for any claim, damages, costs of cause of action which I have or may in the future have as a result of injuries or damages sustained or incurred by me form whatever cause including but not limited to the negligence, breach of contract or wrongful conduct of the parties hereby released.
