## Important Prayer Vigil Info.

- **Parking:**
  - You may park on Willetta and Brill Streets. Do not park across the street in designated spaces next to Tutor Time, they will tow your vehicle if they know you are praying outside of FPA. **Never** park in the Papago building garage or in any restricted parking spots, including city designated **no parking** street zones.
- **Where to Pray:**
  - All prayer vigils are on held in front of the building on public sidewalks. Please be aware of your surroundings, making sure not to block pedestrian traffic. Do not block building entrances or enter the property, or stand in building property.
- **Praying at the site:**
  - **The Statement of Peace** is to be either digitally accepted before signing up for vigil hours or printed and signed. It is available at [www.40daysforlife.com/phoenix](http://www.40daysforlife.com/phoenix)
  - **Amplified sound devices (bullhorns and speakers).** Only during official campaign events, or at the discretion of campaign leadership for large prayer group vigils.
  - **Your safety comes first!**
    - It is preferable to have at least two vigil participants per hour. If you need a prayer partner, please call Campaign Leader, Nancy 480-459-6283 [40dfiphx@gmail.com](mailto:40dfiphx@gmail.com) to check the availability of others.
    - Take videos or pictures of anything strange or if someone become threatening. **Always leave and call 911 in case of an emergency.**
  - **Unity is key to a successful campaign.** We are bringing Christ to the sidewalks through our presence and prayers – please be respectful of all faith traditions, and refrain from political references. Prayer should be the primary focus at the site.

- **Emergency Responders:** If an ambulance or Fire truck comes to pick up a patient. Please video or take pictures, then inform Nancy Brady 480-459-6283 as soon as possible with any important details. Do not assume it's not an FPA patient.
- **Abortion Workers:** Do not engage clinic workers unless they speak to you. You may say "Hello!" & "I'm praying for you too!" or wave - but do not approach them. If an FPA worker approaches you for help to get out of the abortion business, please follow these guidelines:
  - Listen and take their name and cell number. Let them know we have contacts with the organization, *And Then There Were None* who helps abortion workers find other work. 888-570-5501 [AbortionWorker.com](http://AbortionWorker.com)
  - **Call Campaign Leader: Nancy Brady at 480-459-6283 A.S.A.P.** Give all contact details. We will refer the information to someone on the national 40 Days for Life team.
  - To protect the worker's privacy, please be discreet with the information and do not share with anyone.
- **Harassment by staff:** If, you are approached by building security, management, or staff from Family Planning Associates, and they are taking your pictures or threatening to call the police. Please use your phones to record the situation A.S.A.P! Be calm, do not argue, (remember Statement of Peace) take notes and contact Campaign Leader, Nancy Brady at 480-459-6283.
- **Community opinion:**
  - Contrary to popular belief, there is strong public support by the local community. Many times, this support is shown with a wave, smile, friendly vehicle honk, and a "thumbs up!" Always smile!
  - For those who do not support your efforts, never argue or yell back at anyone. If possible, engage in peaceful dialog. Make sure you always smile and pray for those who would persecute you.
- **Sidewalk Counseling:**
  - If you wish to Sidewalk Counsel during your prayer vigil, please contact Nancy Brady at 480-459-6283 to set up a time for online training through [40 Days for Life Sidewalk Outreach University](http://40DaysforLifeSidewalkOutreachUniversity.com).

  - Again - be respectful to clients and building personnel. Please follow the "Statement of Peace" and the prayer site guidelines.

- **Prolife Signs: Remember that you are the last sign of HOPE and the first sign of MERCY**
  - Do not bring any pictures of aborted babies to the site. Appropriate ones are life affirming signs such as, "We Love You" & "Choose Life". You may make your own signs and add local resource information. ## Family Planning Associates Details and Incidents since 2013

FPA is a late term abortion facility (Abortions up to 15 weeks) Monday – Saturday from 8:00am to 4:30pm. It is located within Papago Medical building. The abortionists are Paul Isaacson M.D. and Eleanor Powell Stanley M.D. <https://www.fpamg.com> .

February 2016 “Baby”, which is Hebrew for “life.” Was born alive after an abortion at Family Planning Associates. This occurred on a Friday in the early afternoon during a 40 Days for Life Phoenix Campaign. Baby Chava was 21 weeks.

Day 1 of the Fall 2019 Campaign on September 25, 2019 – A medical emergency with Family Planning Associates client at Papago Medical. An ambulance arrived to take a young Hispanic woman, along with a doctor that looked from a distance to be abortionist, Elenore Stanley. Here is a dictation of the redacted 911 call:

### **Public Records Request of 911 Call for 9/25/19, 12:20pm, 1331 North 7th Street, Phoenix**

*“The caller is from a “medical office” and requests “paramedics” for a “transport” for “a patient post, ‘um’, termination procedure, ah, young healthy, born in [redacted] ‘um, but she has a uterine bleeding that we can’t get stopped so we need to get her over to banner.” [Name of business redacted.] “Young, healthy, first pregnancy.””*

## Current Arizona Abortion Laws

- Minors must have parental consent.
- A mother cannot be coerced into having an abortion.
- A mother must be given information 24 hours in advanced about abortion risks, alternatives, gestational age and physical characteristics of the unborn child.
- An ultrasound must be performed 24 hours in advance and a mother must have an opportunity to see and hear her child's heartbeat.
- **Abortions can be done up to 15 weeks.**
- Foster parents may not consent to abortion for a foster child.
- Fiduciaries may not consent to abortion for a ward without a court order.
- Abortions cannot be done due to race or sex of the unborn child.
- **The “abortion pill” RU-486 can be administered up to nine weeks.**
  - **RU-486 cannot be distributed at pharmacies or mail in Arizona.**
  - The Ninth Circuit Court of Appeals struck down Arizona state law banning the use of RU-486 for abortions past seven weeks on June 3, 2014.
  - State law requiring mothers to be informed about the RU-486 reversal protocol <http://www.abortionpillreversal.com> has been blocked in the courts.
- Pregnancy diagnoses: Lethal and non-lethal
  - A baby may not be aborted due to genetic reasons.
  - For a lethal diagnosis, the mother must be given information about Perinatal hospice services as an alternative to abortion 24 hours in advance, as well as an opportunity to review AZ Department of Health Services website and given a printed copy of resource materials must be offered.
  - For non-lethal diagnosis, the mother must be given information about adoption, up-to-date outcomes, and provided resources from state and national support programs.
