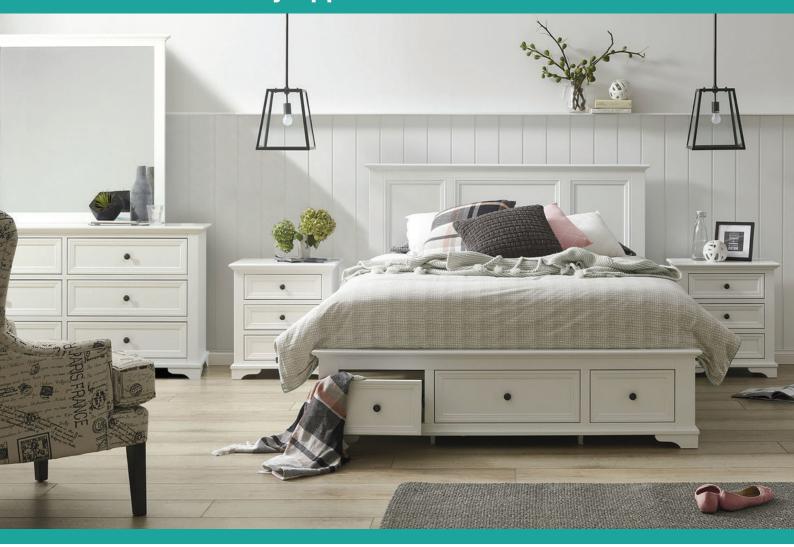

Guidelines for renting a property through Southlands Estate Agents

The applicant accepts the following guidelines when applying for a rental property through Southlands Estate Agents:

- Our Agency reserves the right to accept multiple applications for each property.
- 2. All Adults over the age of 18 who will occupy the premises must complete a Tenancy Application Form.
- 3. If the application is not completed in full, or is submitted not in full, it will not be processed until such information is made available.
- The Applicant agrees they have viewed the property or someone on their behalf has viewed the premises with an agent from our office before and application can be processed.
- 5. Bond Transfers are not accepted by this office.
- Keys will not be handed over until the full bond has been received and confirmation from the Rental Bond Board has been given to our office, 2 6. weeks rent has been paid and all Tenants have signed the Tenancy Agreement.
- 7. We will endeavour to notify you by phone whether or not your application has been approved within two business days of receipt of the complete application.
- The Landlord's decision to approve or decline your application will be based on the number and quality of references provided and demonstrated 8. ability to pay rent and maintain the property to an acceptable standard.
- We always require our tenants to pay their rent and maintain a minimum of one week in advance at all times.

Privacy Acknowledgement

In accordance with Privacy Principal 1.3 of the Privacy Act we require you to read and sign this acknowledgment. In order to process a tenancy application, a tenancy applicant is required under the National Privacy Principals of Privacy Act to be aware that an organisation may access a database. In addition, a tenancy applicant is entitled to know what will happen to their information when it is passed onto an agent. In accordance with the National Privacy Principles, the database member discloses that in addition to information being supplied to a database company, other organisations may receive information from time to time. Other organisations may include debt collection agencies, insurance companies, government departments and other landlords or agents.
