

IN BOARD OF SELECTMEN
THURSDAY, JULY 17, 1997

Present: Chairman Blacker and Selectmen Maryann K. Clark and John C. Drobinski.

The statutory requirements for notice having been met, the meeting was convened by Chairman Blacker at 7:30 a.m. at the Loring Parsonage, 288 Old Sudbury Road.

Conservation Restriction - Dutton Road

Present: Kathleen Wyman and Patricia Siff, Hunneman & Company, 327 Boston Post Road, and others.

Upon request from Kathleen Wyman and Patricia Siff, Hunneman & Company, it was on motion unanimously

VOTED: To approve, subject to approval by Town Counsel and acceptance by the Conservation Commission, a conservation restriction granted by R & D HOMES, INC., on that portion of a certain parcel of land situated on Dutton Road, Sudbury, Middlesex County, Massachusetts, being lot 9 as shown on a subdivision, as approved by the Court, filed in the Land Registration Office (Plan 38006B), a copy of which is filed with the Registry of Deeds for the South Registry District of Middlesex County in Book 1121, page 092 with Certificate of Title #198242 that is located within the "No-Disturbance" area as shown on a plan entitled "Proposed Sewage Disposal System" By: Michael J. Sullivan, dated July 25, 1994, revised March 6, 1995 on file with the Sudbury Conservation Commission.

Request for Overhead Utilities - 789 Boston Post Road

Present: Applicant Al Hussain, 789 Boston Post Road, and others.

Continued from its meeting of July 14, the Board considered a request from Mr. Al Hussain for a waiver of Town Bylaws to allow utility wires to be extended across Rt. 20 to his building lot.

Following discussion, it was on motion unanimously

VOTED: To grant special permission for installation of overhead electrical and telephone service to a new pole at 789 Boston Post Road from Boston Edison Pole No. 18/150/186, as authorized by Town of Sudbury Bylaws Art. XX, Sec. 3.E, for a new home.

Armstrong Livery and Limousine License - 57 Union Avenue

Present: Applicant Charles Armstrong and others.

Having received all necessary documentation, and an affirmative report from the Police Department, it was on motion unanimously

VOTED: To grant Armstrong Limousine Service, 57 Union Avenue, Sudbury, MA 01776, a limousine and livery license with the licensee providing limousine service between Sudbury and Logan International Airport at \$55 each way and dedicated hourly service with an executive sedan at \$35.00 per hour; conversion van at \$40.00 per hour and 10/15 passenger van at \$75.00 per hour, with an additional 15% gratuity.

Drainage Easement - Greenhill Estates

It was on motion unanimously

VOTED: To table indefinitely the Board's execution of the 1991 Greenhill Estates drainage easement.
