7. Describe the undertaking and nature of federal involvement (if multiple federal agencies are involved, specify involvement of each):

We have read the filing of the Army Corps e106 form and have determined that it does not adequately address our concerns raised directly with them concerning this project. We have informed them that we are concerned about the limited APE on this project as we have found through court documents that this rail line was not totally or completely abandoned, only one element relating to the line usage was addressed by the court in 1980 not the total line. Presuming the line to be open under other conditions, the repurposing of the rail line and right of way required additional federal review and authorization. We forwarded our records and comments to Mr. Nasemann for his review and comment and was never contacted back. Speaking hypothetically, even if there was no input required from the federal agency overseeing the railways, we still had questions and concerns regarding any phase I or phase II work that was done or was to be done and we questioned the limitations on the APE for such work and review. Here to we were not contacted or consulted because and here we can only assume, of the outstanding legal questions surrounding the status of the whole railway and right of way. We feel this matter needs to be further vetted because of the impacts to historic properties located in the right of way and total project area.
