

## Prayer Vigil Guidelines

**Prayer vigil site:** Family Planning Associates, inside of the Papago Medical Building, 1331 N. 7<sup>th</sup> Street, Phoenix 85006.

**Parking:** Park on Willetta and Brill Streets. Do not park in the Papago Medical Building garage or the lot across the building during business hours. Use discretion.

**Where to stand:** Prayer vigils take place on the public right of way in front of the building. Participants should not enter the building walkway, driveway, or grounds during the vigil. Please remain on the sidewalks and ensure that driveway traffic is not obstructed.

## Prayer vigil guidelines:

- To maintain a peaceful prayerful presence, please do not bring graphic signs with images of aborted babies to your vigil or any of our events. Our campaign often uses signs with messages such as "Pray to End Abortion" or other signage promoting life.

- As an official 40 Days for Life prayer vigil volunteer, you must agree to the <u>Statement of Peace</u> which can be accessed by logging in at <u>www.40daysforlife.com</u> or you can print, sign and return back to me directly.
- Non-compliance with the Statement of Peace guidelines may result in dissociation from the campaign.
- Prayer aids are encouraged.
- Please respect other people's prayer time by limiting conversations.
- Respect for each other's faith and prayer practices is key to the campaign's unity and integrity. Please refrain from contentious religious conversations.
- In the event you experience negative protesters or passersby, stay calm and document interactions. Recording your vigil with video or pictures is encouraged.



- If you feel unsafe or witness something unlawful, leave immediately and call 911. Then let me know as soon as possible so that I can report the incident to the national team.
- Please report any confirmed turnarounds, clinic closures, or unusual events, such as a medical emergency where a mother leaves in an ambulance.

**The Legality of Abortion in Arizona:** Family Planning Associates is a late-term abortion facility. After Prop 139 passed in November 2024, abortion rights were added to the Arizona State Constitution. Previous abortion regulations are currently under litigation.
