

Abortions from Marion & Polk Counties - Jan – Sep 2025 (Preliminary as of November 7, 2025, when the latest data were run)

2025 (January – September; 9 months; 39 weeks; 273 days)

Residents of Marion County (Jan-Sep)

643 abortions/39 weeks = 16.49 abortions/week AVERAGE

Residents of Polk County (Jan-Sep)

98 abortions/39 weeks = 2.51 abortions/week AVERAGE

Summary: Marion & Polk in 2025 January – September

**Weekly average (741 from Marion & Polk)/39= 19.00 abortions/week AVERAGE
Marion & Polk**

= 19/week AVERAGE

**Daily average (741 from Marion & Polk)/273 = 2.71 abortions/day AVERAGE
Marion & Polk**

= over 2/day AVERAGE
