

Arbitration Opt-Out Notice

For new (or continuing) users, the Opt-Out Notice must be submitted to us no later than thirty (30) days after the first date you accept / agree to the Terms/ Agreement (or amended Terms) for the first time. You must email the opt-out notice to us at legalone@collabcreators.com with the following in the subject line "Arbitration Opt-Out Notice." No exceptions. We may email you (at the primary email address you provide) a confirmation of receipt of your opt-out notice and require that you verify that you submitted the opt-out. If we do, and we do not promptly (within five [5] calendar days) receive back from you your verification, then you agree that your attempt to opt-out is deemed ineffective. It is your responsibility to please check your spam or junk email folders regularly for our confirmation request so that you don't miss the confirmation deadline. We reserve the right, without waiver or prejudice, to assert and take the position that any attempt or request to opt-out by or for an entity - and not a natural person, or personal "consumer" - is ineffective, and that an entity or individual in a capacity other than personal "consumer," cannot opt-out of the Arbitration Agreement and is bound by the Arbitration Agreement (which includes provisions agreeing that the contracting party not participate in class actions, etc.) Further, You agree that the burden to prove that You effectively and timely opted-out is on you, and not us, and that if you do not maintain admissible contemporaneous evidence of that any such assertion is deemed ineffective and our assertion that you did not opt-out will prevail, without more.
