As an assurance to the manufactured and modular home owners of fair treatment, trustworthy advertising, dependable service, fair sales practice and lasting good faith as a member of the Rocky Mountain Home Association, we pledge that we will:

- I. Fulfill all warranties, guarantees, and similar obligations professionally, promptly and faithfully.
- II. Conduct ourselves at all times in a professional manner and appearance which bring respect, credit, and prestige to the Association and to the industry.
- III. Endeavor at all times to promote products and services that shall contribute to the health, welfare and best interests of the public and the industry.
- IV. Maintain a position of civic responsibility and cooperation in the community.
- V. Represent accurately all products and services offered for sale, all advertising statements, complete terms of financing, and put all agreements in a truthful manner.
- VI. Provide equal and professional service to every person regardless of race, creed, sex, or national origin.
- VII. Maintain a practice of complete compliance with all existing laws and regulations governing the business operation.
