# CFA® Course Structure and Fees

## The CFA® Program Consists of Three Levels:

**Level I CFA®:** Introduces various topics like equity, derivatives etc. which are eventually used for creating portfolios. **Level I CFA® exam is offered in June and December. It has 240 MCQ's (120 questions each in the morning & afternoon sessions)**

**Level II CFA®:** Emphasizes on application of various tools like quantitative analysis, portfolio analysis for doing asset valuation. **Level II CFA® exam is offered in June and has 120 MCQ's (20 caselets with six questions each)**

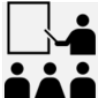
**Level III CFA®:** Focuses on Portfolio Management and different strategies for creating specific portfolios for individuals and institutions. **Level III CFA® exam is offered in June and has Essay type questions and MCQ's)**
