About D-Rev

D-Rev believes that good health is a human right. The need for quality healthcare spans the economic spectrum. Regardless of where you are from and what you do, health is critical to well-being, productivity, and autonomy. For people to live their best lives, they must be healthy. We exist to design and deliver medical technologies that close the quality healthcare gap for underserved populations. The scaling of our first product, Brilliance, is monumental in global health – it is one of the earliest examples of a nonprofit-developed global health product scaling through the market and impacting the world's poorest patients.

D-Rev operates at the intersection of user-centered design, evidence, and global health priorities. We partner with visionary funders who share our commitment to pragmatic, rigorously tested solutions, to create lasting impact on health disparity. More than 75 percent of revenue comes from private foundations, corporations, individual donors, and the majority of it is unrestricted. This allows us to focus on designing and delivering innovative medical solutions to those who need it most. Approximately 20 percent of our revenue derives from bilateral sources. Royalties and profits from our devices currently make up a small percent of our revenue, less than 5%. By forgoing higher profits, and selling our products with margins built in for manufacturing, distribution and sales partners we have been able to prove a model of scaling our products sustainably to high-need populations through the market. Our philanthropic revenue model has given us an average growth rate of 15%.

In the next five years, we will be expanding our revenue model as part of our strategy to grow significantly in size and capacity allowing us to build on D-Rev's proven successes at a faster rate. Our annual budget in 2018 is \$2.5M and we aim to grow by 45% over the next two years.
