Terms: Part-time (20 hours/week) for three-month contract, starting immediately. No travel required.

For this project, you will organize, coordinate, and help to complete a medical device clinical study protocol. Reporting to the Consulting Medical Director, you will be a key member of the team and critical to the future success of a product's development and launch. The ideal candidate is a researcher experienced in drafting and securing approval for clinical study protocols, as well as managing coordination of a research team. We look for individuals who will share our enthusiasm and drive to address urgent health gaps in low-resource settings.

Responsibilities

D-Rev will soon be launching a study of one of its devices in a clinical setting in India, and is preparing the necessary documentation and applications that describe the study background, methodology, analysis plan, study tools, etc. You will be instrumental in executing our study strategy in a timely fashion by:

- Organizing, coordinating, and completing the draft of a medical device study protocol for neonates in India
- Drafting literature review summaries based on academic articles
- Developing study tools (e.g., clinician surveys) and data monitoring system
- Creating consent forms and overseeing their translation into Hindi
- Coordinating with D-Rev employees and partners in both the US and India, including consulting with experts and integrating their feedback

Requirements

- Fluency in English (writing and speaking)
- Prior experience drafting clinical study protocols (designing clinical strategy is not necessary)
- Prior experience developing a data monitoring system
- Excellent attention to detail
- Enthusiastic / positive / can-do attitude
