You will deepen our understanding of global health issues around the world and assess which disease areas we should focus on. You will be responsible for developing expertise in the selected disease areas to ensure that our solutions are impactful. You will work closely with the Market Intelligence (field research) team to research, identify, and summarize underlying problems that prevent the treatment of these diseases. If you have experience evaluating disease burden and have a passion for closing the healthcare gap for under-served populations, this position is for you.

Responsibilities

- Conduct extensive research in the published literature and among experts in the fields of medicine, global health, international development, and social science and explain findings in plain language.
- Research, analyze, and estimate relative health benefits of a wide range of potential interventions in multiple health areas (newborn, maternal, child, and beyond).
- Estimate potential impact of projects using disability adjusted life years (DALYs) and other metrics.
- Serve as D-Rev's main in-house resource for published research related to health interventions in LMICs.
- Work as an essential contributor to the Sourcing and Evaluation team to screen and assess potential projects for further development.
- Analyze data collected by D-Rev, and summarize and present findings.
- Collaborate closely with colleagues and KOLs in India and East Africa to uncover underlying needs and causes of diseases.

Minimum Requirements

- Bachelor's Degree in health-related field (or other relevant scientific field) with at least 2 years of relevant work experience; OR MA/MPH graduate with 1+ year of relevant work experience. Candidates with an MPH or MD degrees strongly preferred.
- Experience researching the impact of public or global health interventions, including using disability adjusted life years (DALYs).
- Effective, clear communicator.
- Ability to work successfully on multidisciplinary teams.
- Experience conducting basic and advanced analysis using statistical software such as SPSS and STATA.

- Experience working or studying in low- and middle-income countries (LMICs) preferred.
