INTERCOLLEGIATE

TEAM CHOSEN.

EXCELLENT DEBATES DELIVERED

Borton, Hotle and Martin Will Represent California.

At Stiles Hall last evening the final preliminaries for the intercollegiate debate were held. The fortunate contestants were Messrs. Borton, Hotle and Martin, with Greely as substitute. These accordingly will champion the cause of California in the approaching forensic struggle with Stanford.

Clausen '00 presided at the debate. The board of judges consisted of Professor Thomas R. Bacon, Professor Frederick Slate and Mr. Brewton Hayne, City Attorney of Berkeley. The proposition for debate was: "Resolved, That the guarantees of the Constitution should be extended to all persons under the jurisdiction of the United States except those living in tribal relations." The debaters in their order of speaking were as follows, all, except the three indicated, taking the negative side of the question: 1, Greely '01, Aff.; 2, Pierce '01; 3, Steinhart '01; 4, Hotle '00, Aff.; 5, Cloud '00; 6, Aitken '00; 7, Martin '02; 8, Skaife '00, Aff.; 9, Borton, Law College; 10, Martin '00.

A large number were present to hear the debate. Not a hitch occurred in the entire program, and the high standard of excellence of all the speakers was much remarked upon. It was the opinion of Mr. Flaherty that California has never before had a preliminary contest of so great merit, nor one which afforded such bright prospects for California's victory in the intercollegiate debate.

At a meeting of the directors of the Art Association held recently three of the present directors were re-elected to serve in their present capacity: Misses Mary Bell '99, Agnes Frisius '01 and Anna Holmes '01. Another meeting of the entire Association will be held today at 11:15. At this meeting four new directors will be chosen. Absentees from this meeting will be fined.

The tickets for the military ball tomorrow night at Hearst Hall are nearly all sold. The number is limited to 125. The few remaining are on sale in the Co-op at the cashier's window.

TENNIS TRYOUT TOMORROW.

Men Selected Will Have Option on New Court.

Tomorrow morning in Alameda, a tryout will be held to determine the four men, who, with Sumner Hardy, shall have option on the new tennis court. Fifteen entries have been received, and drawings have been "seeded," that is, the four men who have shown up best in the past were favored in the drawings.

Those selected were: W. W. Mein, H. Braley, P. Selby and R. G. Hunt. The tournament will end at the semi-finals, thus leaving four men.

An entrance fee of fifty cents will be charged. This fee must be paid before playing. Owing to the field day and baseball game in the afternoon in Berkeley, the tournament will be run off as quickly as possible. All the players must be on the courts promptly at 9 a. m., because their matches will be liable to be called at any moment. Anyone not ready when his match is called, will be defaulted.

The Alameda Club Courts are situated on Encinal avenue, between Paru and Morton streets, Alameda near Morton street station of the narrow gauge. The best way to reach them from Berkeley is to take the Telegraph avenue cars to Fourteenth street, Oakland, then the narrow gauge to Alameda Mole and finally the Alameda local to Morton street station. The 8:15 a. m. narrow gauge local from Oakland arrives at Morton street station at 8:55 a. m. Mrs. Hearst's Plans.

Mrs. Hearst has discontinued her dinners to the women students of the University and has inaugurated in their place afternoon teas from three to six o'clock, the first of which teas will be held next Wednesday. To each of the teas to be given about forty of the women students will be invited in the alphabetical order of their names.

The last of the Sunday afternoon concerts will be given day after tomorrow, April 1st.

In the latter part of April Mrs. Hearst will leave for the East, to be gone until Class Day. Mrs. Hearst will return in order that she may be present at the Commencement Exercises. After those exercises Mrs. Hearst will again make the trip across the continent, to remain in the East for a month or more. At the end of that time she will return to California and take up her residence at her summer home near Pleasanton.

COMMUNICATION.

Professor Syle Writes Concerning Charter Day Play.

Editor Californian—Sir: Your readers will be pleased to hear, I am sure, that the Charter Day play was this year a distinct financial success. It is certain that we shall clear nearly two hundred dollars: the detailed accounts will be published within a few days.

To the audience before the footlights, the production of a play must seem a simple affair: it is, in reality, complicated. Many persons whose names appear little or perhaps not at all, have contributed materially to the success of this production. It seems fitting, therefore, that public acknowledgment should be made of the services of all.

In this age of lying advertisements, bought advance-notice and self-laudatory "Presenters," it is well to remember that the first and by far the most essential factor in the production of a play is an author with brains enough to write well. Actor, manager, scenic-artist, "angel," stage-director and press agent—all of these, however good, are easily duplicated by judicious expenditure of money; but you cannot duplicate a Sandeau and a Regnier. To the shades of these unmatchable let us then pour our plous libation, thanking them chiefly for what pleasure we may have derived from the contemplation of their art-work.

Next in importance to the author come the actors: they have already received due acknowledgment in the attendance and applause of the audiences and I am sure that they all feel amply repaid thereby for the time and pains they have bestowed upon their work.

Grateful acknowledgment is due to Mr. Chambers, who relieved me of one-half the labor of translation; to Miss Peixotto, who rendered valuable assistance in coaching and in suggestions for costuming; to Mr. Hansen for his efficient business management and to Mr. Hill who had charge of the setting of the stage; to Mr. Selby, to whose tireless energy the Tennis Association already owes so much; to Mr. Flynn, the University printer who ever responded with cheerfulness to the many calls upon his patience; to Mr. Maybeck according to whose plans the hall was transformed into what all acknowledge, I think, to have been a charming little theatre; to Mr. Peck, the head usher and his numerous assistants who distributed the audiences so correctly and so expeditiously—no easy task in a hall where chairs are reserved yet unmarked; last, and far from least, to Mrs. Hearst who, without any suggestion from me, authorized the considerable expenditures that were necessary to make the transformations referred to. Without these transformations the play could have been given, but it would have lost much in effectiveness: to Mrs. Hearst, then, more than to any other living person, we are indebted for what success the play achieved.

The French drama, judging by that part of it commonly represented, is little known among us save by meretricious plays of the "Camille" type or vulgar plays of the "On and Off" type. Yet the French drama contains thirty or forty high comedies as good as Made-moiselle de la Seigliere and half-a-dozen that are better. If the performances given shall lead students to mark, learn and inwardly digest this fact, they will have been worth giving and will have accomplished all that can reasonably be expected.

The strength of the men chosen to represent California in the coming intercollegiate struggle makes the prospects for victory this year very bright, and the excellence of the arguments presented by lower-classmen assures us that worthy material will not be lacking for future University teams

Upon the men chosen to represent us against Stanford devolves a great duty. Days and nights of incessant labor will be required of them—hard labor done in quiet places with no shouts from bleachers filled with enthusiastic students to give encouragement. But the reward of well spent effort will be greater than the task, however difficult, for it will mean one more victory for the University.

California has already carried off the Carnot laurels, and for a number of years has been successful in the intercollegiate contest. Our victories in debates have been our consolation when all other things went against us. Lately our endeavors in other directions have been crowned with success, but in the days of our prosperity, we should be none the less energetic in our efforts for victory in intellectual contests, for by them is the true worth of University training shown.

Moulthrop Made Colonel and Robinson, Lieutenant Colonel.

Major H. S. Robinson to be Lieutenant Colonel and in charge of the competitive examinations for determining the promotions of commissioned and non-commissioned officers for the term beginning in August, 1900.

Captain R. H. Collins to be Major in command of the 1st Battalion of Cadets.

Captain P. Dolman to be Major in command of the 2nd Battalion.

Captains Hoffman and Kuster are detailed on special examination duty with Lieutenant Colonel Robinson, and will report to him.

Captain Tasheira is assigned to the command of Captain Kuster's company.

First Lieutenant Paul Selby is appointed Captain, and will command Captain Hoffman's company.

First Lieutenant R. L. Oliver and M. L. McCullough are appointed Captains of Collins' and Dolman's companies, respectively.

Second Lieutenant Dibert is appointed First Lieutenant, and will report to the Regimental Adjutant for assignment.

In response to numerous inquiries, Professor Soule has made the following statements concerning the examinations to be held on April 14th.

The following rules of eligibility will apply: any Freshman may take the corporals' examination; any Sophomore, the sergeants'; and any Junior having the rank of lieutenant or sergeant, the captains' examination. But no classman may enter examination of a class higher than his own.

The examinations are planned to occupy two and one half hours, but a ready knowledge of the Drill Regulations will be necessary to enable one to answer the questions in that time. The questions will cover quite completely the sections indicated in the order published on the Military bulletin board.

The candidates will use exclusively examination books to be procured at the places of examination, which places will be announced later.

The appointments will not be based entirely on the theoretical examinations. Each man's field work and his personality, from a military point of view, will be carefully considered. Each captain will be required to give the commandant written recommendations concerning the candidates from his company.

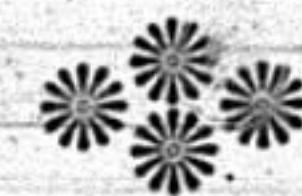
