

# Campus in Italy

The University will open foreign campuses next year in Germany and Italy.

President Clark Kerr recently said the first year of operation at the University's Bordeaux campus has been "quite successful" and that negotiations are under way with two German universities and one Italian school for additional foreign sites.

He added the University's Education Abroad program might also be expanded to Spain and Japan in the future.

The Bordeaux campus, which Kerr officially dedicated last November, is the first foreign campus site in the Education Abroad program.

A University spokesman said the names of the German and Italian universities will be released when Kerr presents the final plans for expansion of the foreign campus program to the Board of Regents within the next two months.

Kerr said the University may try to interest more men students in the foreign program by expanding the University's student loan program to include foreign campuses. Sixty of the 80 University students now at Bordeaux are women.

Kerr spent about a week in Bordeaux and received an honorary degree from the University of Bordeaux in addition to participating in the dedication of the University program.

He also spoke to most of the 80 University students now at Bordeaux. Kerr said most of them seemed "very interested in the cultural and academic opportunity they were getting."

He said that the only complaint the coeds at Bordeaux had was the 9:30 p.m. curfew in effect at French universities.

The University plan is the first foreign campus program to be adopted by a public institution in California. But three private schools in the state — Stanford, Redlands and Whittier — have similar programs.

Twenty-nine students from the Berkeley campus are in the 80-member University contingent at Bordeaux.

University students at Bordeaux receive credit from the University's Santa Barbara campus for their work.

# AEC on Bodega

The Atomic Energy Commission yesterday announced it will hold a public hearing in California on the nuclear reactor power plant proposed at Bodega Bay by the Pacific Gas and Electric Company.

Time and place will be announced later.

Also yesterday the California Public Utilities Commission, which had already approved the project, denied two petitions for a rehearing. One of the petitions was submitted by University biochemistry professor John B. Neilands, who had charged the PG&E reactor would harm the University's proposed biology station.

The commission ruled that "after considering every allegation, it is of the opinion that no good cause for a rehearing has been made."

Both the Public Utilities Commission and the Atomic Energy Commission must approve the PG&E project.

There has been vigorous opposition to the proposed PG&E reactor, with a good part of it centered on the University.

Neilands charged yesterday that the AEC hearings are just "window dressing" and the "whole thing is a charade."

But he added that both he and "a number of people" are going to attend the hearings. "It is necessary to make the protest and expose the phoniness of the so-called regulations of the AEC," he said.

Neilands said he felt there is "no possibility that PG&E's permit will be denied."

A spokesman for the Chancellor's office said University personnel will be allowed to appear before the hearings as individuals but they would not necessarily be representing the University.

Before the AEC hearing PG&E's permit application must be reviewed by the commission's regulatory staff and the advisory committee on reactor safeguards.

The advisory committee will review the safety studies and facilities and advise the commission on the proposed facilities and the adequacy of the reactor safety standards, an AEC spokesman said.

He added that the advisory committee report will be public record.

Former Berkeley Chancellor Glenn T. Seaborg is chairman of the AEC, but he will not be present at the hearing.

## 'Don't Take Those Drugs'

Cowell Hospital recently issued a warning to students about taking drugs for stimulation and sedatives during the tense, pressure-filled days of final examinations.

"Stimulant drugs, such as mathodrine or dexodrine, seem fine when they are first taken," said Dr. Henry Bruyn, director of the Student Health Service at Cowell Hospital.

"But soon after they are taken, depression sets in. Intellectual capacity is depressed, and the student finds it even harder to study or to remember."

"We have experienced serious reactions on this campus to both stimulating and sedative drugs taken without proper medical advice," the health service director said.

"Tranquilizers and sedatives have an unpredictable effect on different people," Bruyn said. "They are often followed by a real hangover which can again be utterly depressing."

"Students who take barbituates before an exam in order to relax may find themselves in a state of severe depression or repressive tension," Bruyn said.

"Required hospitalization after such affects certainly won't improve academic standing any."

Besides their over-all bad effects, stimulants and sedative drugs are notoriously known to be habit forming, Bruyn said.

"Stimulants and barbituates are well recorded in scientific literature to be habit forming," Bruyn continued, "and I have seen cases where certain students have needed from 10 to 11 sedative tablets a day, just to be able to walk around."

Certain pills that claim to do the same things as illegal stimulants and depressants have recently been glutting the public market. "These pills, designed to encourage sleeping, are truly mild and don't do an effective job in a tense situation," Bruyn said.

"Pills that are designed to keep one awake contain nothing but caffeine and are equal to about one cup of coffee."

A good cup of coffee or tea and a short break should be enough to calm any nonhypertense student. Any other problems should be handled by a physician who would know about proper dosage, Bruyn concluded.

## Cuban Exile To Speak on Castro Here

Former Cuban Ambassador to Great Britain Sergio Rojas will speak at noon today on "Cuba—the Great Communist."

Rojas served as ambassador for the Castro regime from January, 1959, until June, 1960,

When he broke with the Castro, his Minister and undersecretary for foreign affairs. Rojas said he would not serve a Communist government.

He has called Castro a "rotten tooth," and said that "until

you remove it, you will be yelling in pain. It will produce infections in other parts of the body and could even cause death if left unchecked.

Rojas was ordered arrested, but he took political asylum in the Argentina Embassy. He later escaped to Buenos Aires.

Previously Rojas had been a senior officer in the rebellion against Batista. He was engaged in secret political and diplomatic contacts with foreign governments and in the acquisition of armament supplies for the Castro forces.

Being an economist, Rojas has represented Cuba before

the Pan American Coffee Board and the Inter-American Coffee Bureau. He also holds the Grand Order of the Red Cross for services rendered to the organization.

Rojas is currently engaged in

confidential political and diplomatic activities in Washington, D.C. He commutes frequently between the United States and South America.

Rojas' talk today is sponsored by the ASUC.

## No Locks at UCLA

Lockout at women's residence halls at UCLA may be abolished by September if parents of the residents agree to discontinue the system.

The UCLA Office of Housing Services is polling parents this week, asking them to say whether "special restrictions for college women have become outdated" according to the UCLA Daily Bruin.

Results of the parent poll will not be available until late January.

In a poll conducted by residence hall officials in November, 71.2 percent of the women residents favored abolishing lockout.

The present UCLA system requires women to be in at 2 a.m. Friday and Saturday nights, and midnight Sunday through Thursday.

T. Robert Nudd, supervisor of housing services on the Los Angeles campus, said the housing office is not necessarily in favor of maintaining the system.

"We don't want to be doing something simply because we have always done it," Nudd said.

Lockout hours on the Berkeley campus are 2:30 a.m. Friday and Saturday, and 11 p.m. for lower division and 1 a.m. for upper division women Sunday through Thursday.

# UC Prof Wins Science Award

Another Award

University Professor Emeritus of Chemistry Joel H. Hildebrand recently added another award to his collection when he was presented with the 1962 William Proctor Prize for Scientific Achievement.

The prize was awarded by the Scientific Research Society of America.

In his acceptance speech he described science as a "life of variety and adventure" and urged young people to be inspired by the excitement and adventure of discovery.

"Science is not essentially a storehouse of information; a scientist is not a walking encyclopedia; his brain does not operate on 'pure reason,'" said Hildebrand, whose discoveries have spanned more than five decades.

"Science is an enterprise; a scientist is an adventurer."

He added that science and potential scientists would be much better appreciated by the public if more effort were made to describe the process of discovery, not just its end results.

Hildebrand also spoke of the "compelling curiosity" that urges a man to become a scientist:

"The earth's surface has now been pretty thoroughly explored; it no longer presents to adventurous souls the allure it formerly did to the great voyagers.

"But a life of adventure is not a thing of the past, for there are more vast, uncharted areas to be explored than ever before: nucleons, atoms, molecules, living cells, interplanetary space, stars and galaxies.

"No one need be earth-bound; he may lead a life of variety and adventure."

One of the most overrated basketball teams in a decade grapples with one of the most amazing here this week end to open the 1963 AAWU basketball season.

Pasadena won't be the site of this encounter, as the somehow nationally ranked Trojans of Southern California bounce into the Harmon Gym to meet the somehow winning Golden Bears of California.

Tipoff for both encounters are set for 8 p.m. and tickets are still available with athletic cards.

Always a favorite of local hooters and self-styled bench jockies, coach Forrest Twogood's Trojans are once again riding a wave of cosmic Southland publicity which has seldom impressed Berkeley hardwood "afficionados."

The Trojans are 10-2 on the season and Los Angeles journalists are tabbing this sophomore-dominated outfit as a sequel to Troy's Rose Bowl champs.

"They think they're the football team," one L.A. sportswriter wrote, "They just don't know how to lose."

Well, all of this was before the recent Los Angeles Basketball Classic where the Associated Press' seventh-ranked team fell heavily and even unexpectedly on its red face to Colorado State and St. Louis.

Now it's apparent that the Gold and Cardinal can be beaten but are Rene Herrerias' Bears the team to turn the trick?

In the Pete Newell tradition, California has a team which doesn't look capable of defeating anybody. But still the Bears continue to win.

The answer has been the age-old and subsequently worn out cliché called teamwork, but it is the answer.

Lacking finesse and real shooting ability, the Bears have had to fall back on their defense and the amazing ability of one man to take up slack when another is failing.

Up north against Seattle, Big Camden Wall came up with the Big Performance as did Bob Wueste against USF and Dan Wolthers against Oregon.

Wall, the rib-rocking 6-10 Bear center, is apparently recovered from an early season knee injury but is still feeling some effect in his timing and shooting from lack of practice.

Wall and his Cal front line teammates, Chris Carpenter and Don Lauer, will have plenty to handle from Troy's big combo of veteran Gordon Martin and soph Allan Young.

The only remaining vestige of the Rudometkin-Appel-Stanley clique of last season, Martin is a steady 6-7 forward with an unorthodox array of shots that can be deadly.

All-CIF and All-American in high school, Young is leading his mates in scoring and also is helping on the boards with his 6-5 frame.

Undefeated going into vacation play, the Bears upset Oregon State, 61-59, despite a 29-point outburst by Beaver center Mel Counts.

The following night, the nationally ranked Beavers evened their series with Cal by clubbing the Bears, 70-60, in Corvallis. The Bears led this one by one point with less than six minutes remaining but suddenly turned cold and a Beaver avalanche sky-rocketed the margin to ten points.

Camden Wall, absent when the Bears split with the Beavers, was forced to sit out the Wyoming and Texas games the next week end.

The Bears routed Texas, 82-66, and then downed Wyoming, 60-55, to wind up a perfect week end. The Bears, led by Dick Smith, had little trouble either night.

Wall made his long-awaited return in the Far West Classic this week end. The 6-10 Cal center netted 27 points on opening night as he led the Bears to an 85-78 overtime win over tenth-ranked Seattle.

All-American Mel Counts, however, stopped the heavily bandaged Bear junior in a second-round contest, the third between the two

teams. Wall was held to 12 points and 11 rebounds, while Counts garnered 17 points and the same number of rebounds.

Counts couldn't stop Wall's surge for an all-tourney berth, though, as each made the first all-Far West Classic team.

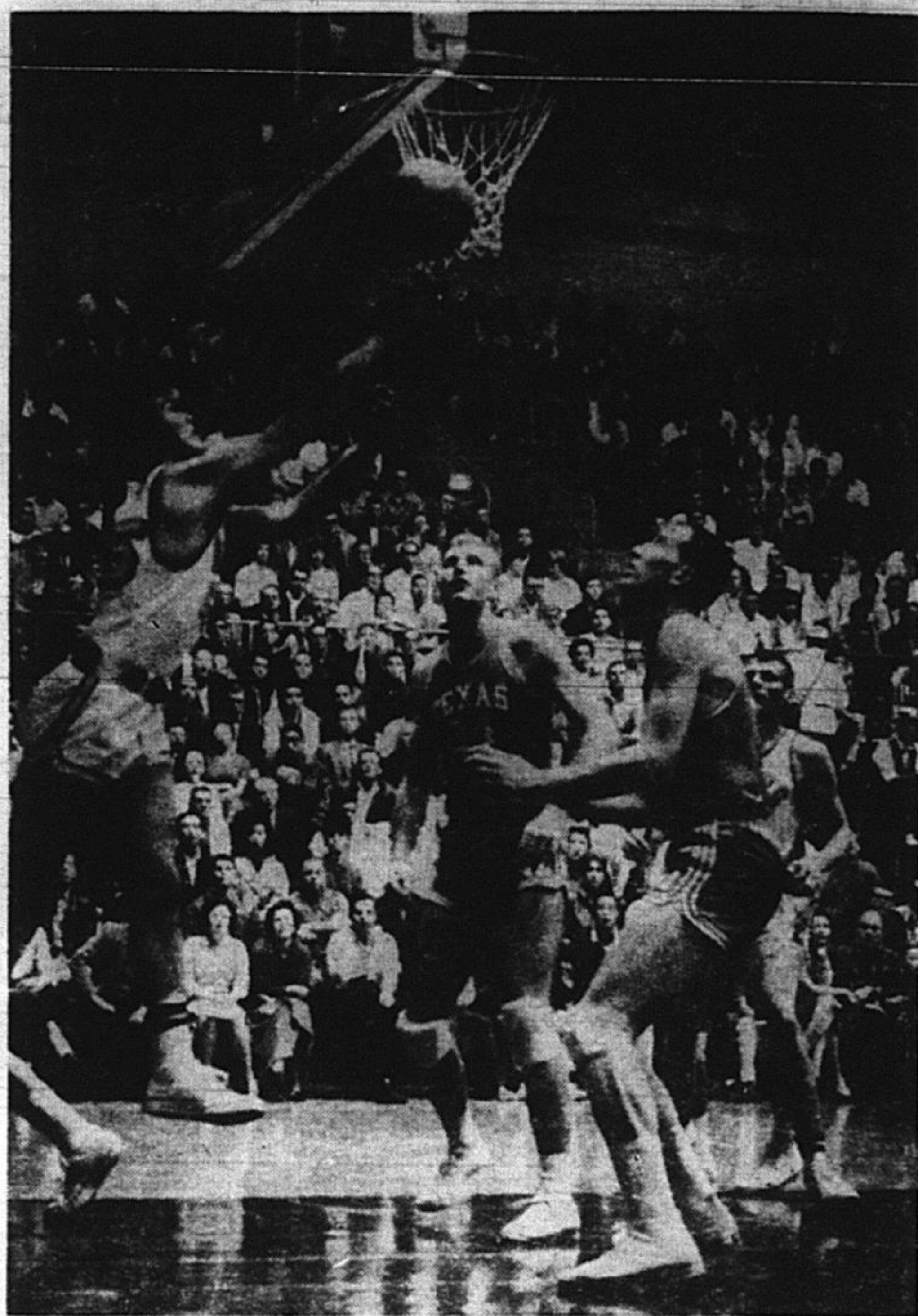
Guard Dick Smith was also included on the all-star five which had the Beavers' Terry Baker and Seattle's Eddie Miles rounding out the top five.

## Cal Tests Stanford Tuesday

Stanford's Indians, upset by two nondescript teams in the Los Angeles Classic Tournament two weeks ago, come to Harmon Gym Tuesday to test themselves and Cal's Bears.

The big test for the highly-regarded Indians will be their ability to perform under extreme pressure. For California the test will be to see how good the Bears do against the AAWU title favorites.

The Indians entered the Classic tourney, held December 26-29, established as favorites. Then the nationally-ranked Farmers ran into Northwestern, a Big Ten basketball doormat with a 2-5 record. Final score: 61-60, Wildcats.

What happened to the Indians should not happen to a basketball team. From the first few minutes the LA crowd was on the Injun crew, booing Stanford scores and cheering loudly whenever a Wildcat was fouled or scored a basket. Pressure from the crowd, not Northwestern's play, beat the Indians.

After that game Stanford lost again, to USC, before beating Washington to finish seventh out of eight teams. The hostile crowd unnerved the Indians and was the main cause of their poor play.

But coach Rene Herrerias warns that "the Indians don't play at all this weekend. They'll be able to see us in action (against the Trojans) and will be well-rested and prepared. We'll only have one day to practice against them."

Stanford's players will be very anxious to prove that they can play winning ball away from home. Four of their first seven victories were at home, and the away games included two wins over Oregon. Cal beat Oregon by 28 points in the Far West Classic.

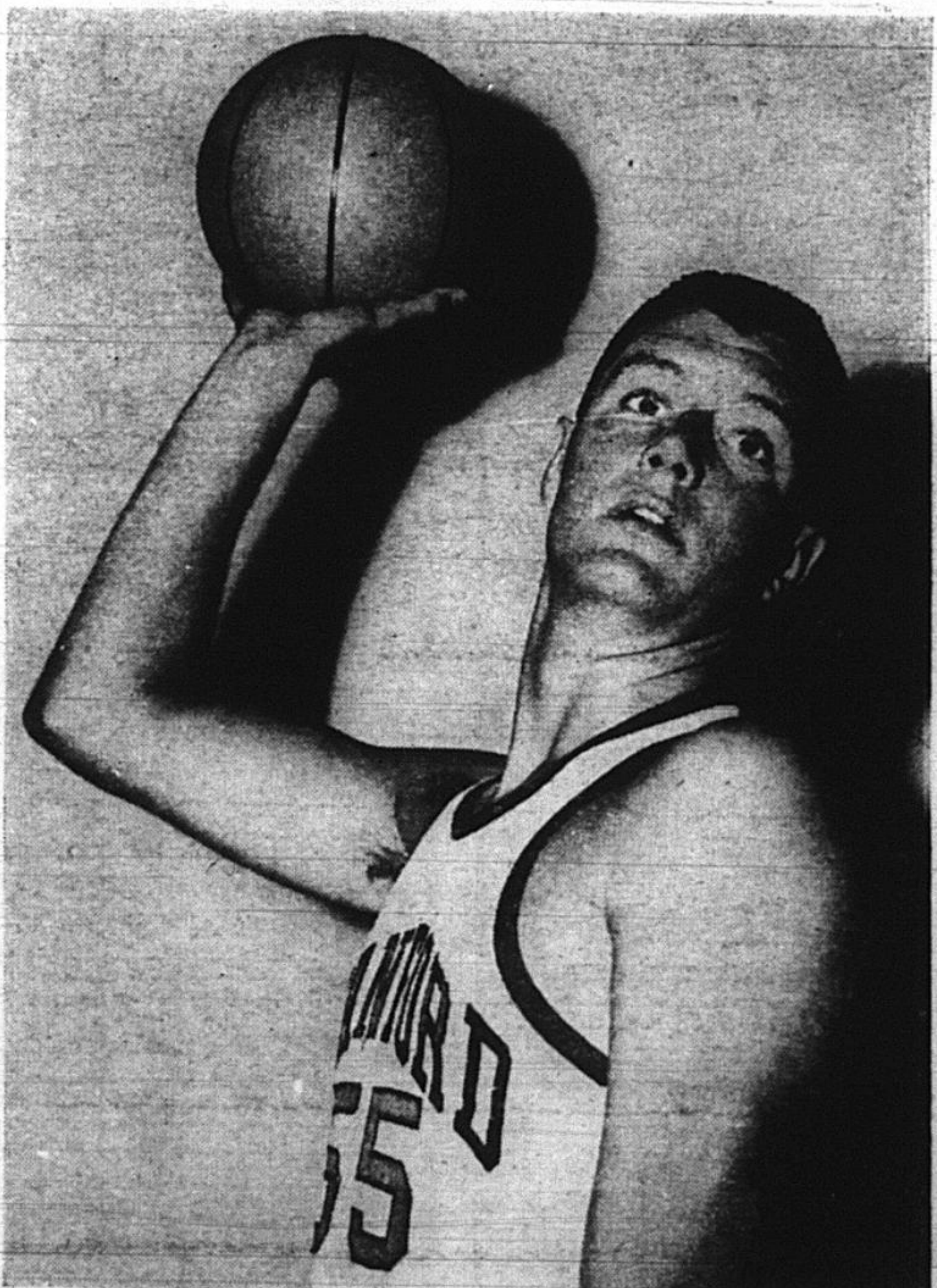
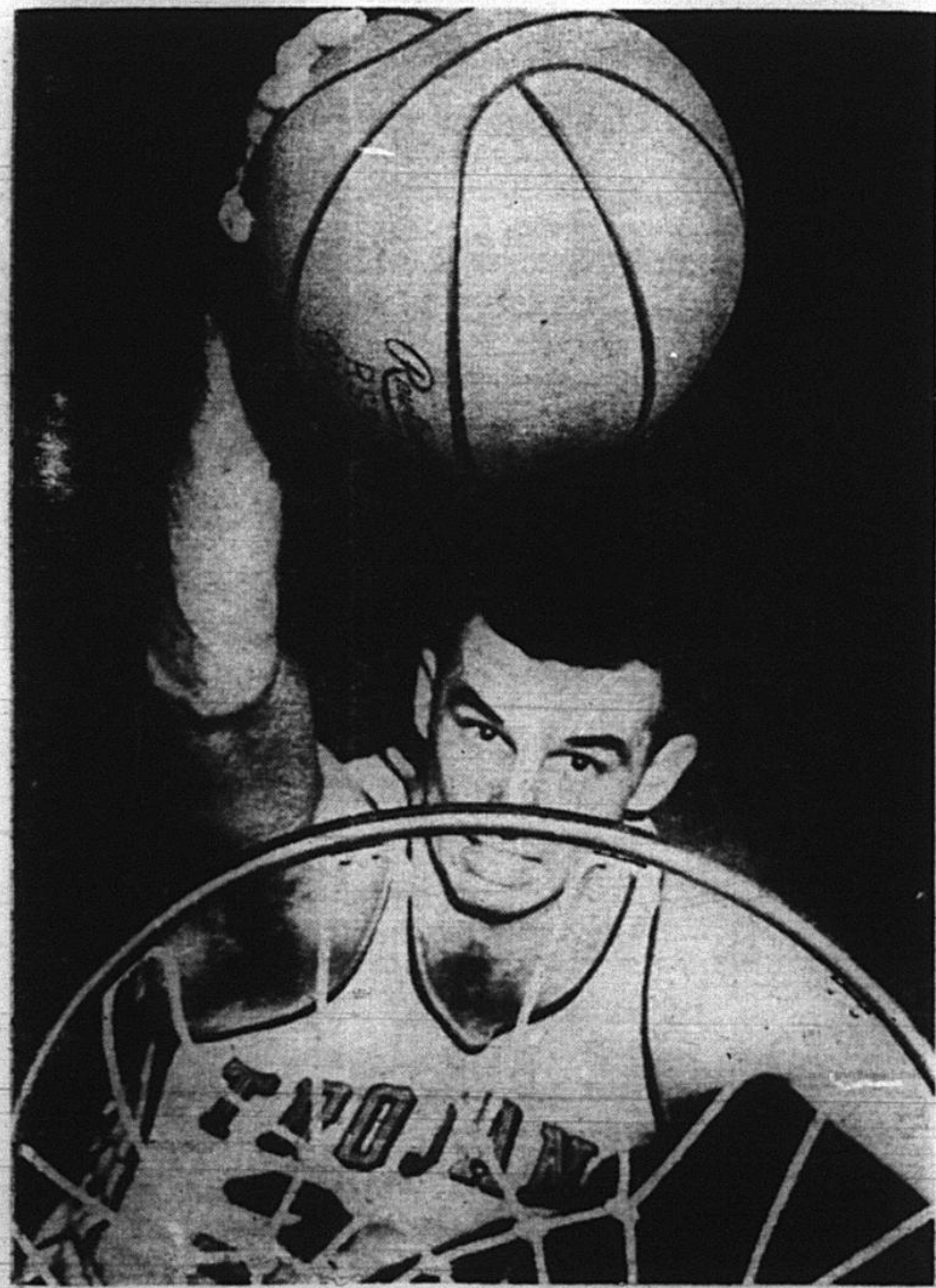
The Farmers will present almost the same lineup that tore Cal apart last year. Only John Windsor, who graduated, and Doug Clementson, out with an

## Underhill Ends 45-Year Job

University Vice-President and Treasurer Robert M. Underhill will retire this spring after 45 years of service—the longest career of any officer in University history.

Underhill's successor, appointed at the December meeting of the Board of Regents at UCLA, will be Hawaii businessman Owsley Hammond.

Underhill graduated from the University's College of Commerce, forerunner of the School of Business Administration, in 1917 and immediately went to work as a University accountant. He served in various posts until his appointment as treasurer in 1933.

He was made a University vice-president in 1959.

In addition to his work for the University, Underhill has also served on several committees of the United States Defense Department, Atomic Energy Commission and Office of Scientific Research and Development.

Hammond, who is now at the University preparing to take over as treasurer later this spring, will be responsible for the University's investments, real estate transactions and banking.

Hammond, a graduate of the Stanford University school of business, has worked for the Theo. H. Davies Company of Hawaii for the past fifteen years. He was also president of the Honolulu Symphony Society and the Tax Foundation of Hawaii.

# Cyclists, Beware—Restrictions Enforced

Violators of the no bicycle riding rule in the central area of the campus will now be handed a reminder notice of the regulation by a University policeman.

The restricted area includes the Student Union and Dining Commons, Student Union Plaza and Sather Gate, Sproul Hall, South Hall, Wheeler Hall, Main Library, Durant Hall and Dwinelle Hall.

The new procedure was announced yesterday by the chancellor's office which issued a renewed request for students to observe the rule. The University police department said the notice slip is only a reminder and not a citation with a penalty.

Renewed action on the bicycle restrictions was initiated late in the fall semester by the Student Affairs Committee, which became concerned with the threat to safety of pedestrians in continued violation of the rule.

The reminder slip for offenders explains that "several accidents and many near accidents have been reported." It also mentions many handicapped persons who are especially periled because of blindness or other illness.

Maps showing the restricted area for bicycle riding have been posted on bulletin boards around the campus, and "no riding" signs have recently been repainted on the pavement in the area. The maps also indicate 27 parking places for bicycles and three for motorscooters.

## An Inversion of Civil Rights

The problem of fraternity and sorority discrimination continues to be discussed in whispers. Everyone's so afraid of being branded "biased" that rational thought has given way to a twisted form of civil-liberties.

By September, 1964, all Greek living-groups must delete from their Constitutions all references to discriminatory practices. This little hollow ritual seems harmless enough.

However, rulings and regulations are not made without thought of enforcement, and this is what must be fought.

Any system which attempts to force a private living-group to accept members they do not want is inherently destructive. What we are concerned about is the prevailing climate in which everyone is so afraid to oppose anything which hints at integration of any type. Everyone is so concerned with what he thinks a good civil-libertarian should be like, that he forgets a fundamental Freedom, that in his personal life he is not forced to accept anyone he does not

wish to, regardless of his criteria.

We look with distaste on those so shallow as to relish a feeling of race or religious superiority. But we have less respect for those who have been so caught up in the fear of being regarded as "prejudice" that they have sacrificed a fundamental right.

We are tired of hearing every misuse of civil-liberties excused for some amorphous concept of the "social good." Forced integration of fraternities and sororities should be challenged for what it is, an infringement of personal freedom.

When individuals attain membership in private living-groups, not because of personal merit, but through some fear of being called "biased," or by administrative quotas, then our civil rights have reached complete antithesis . . .

Last week the House Committee on Un-American Activities subpoenaed 11 members of Women

For Peace. We are members of Campus Women for Peace. Our common goal is peace and total disarmament with international controls. The HUAC investigation is an attempt to discredit Women for Peace and to prevent it from continuing what has so dramatically begun to arouse the American public to the danger of the arms race and to the urgent need for an immediate end to it. Since Dagmar Wilson, the national figurehead of Women Strike for Peace in Washington, was subpoenaed to appear this Thursday, it becomes very clear that the women's peace movement itself is under attack. The aim of the House Committee on Un-American Activities is undoubtedly to tarnish the WISP "image"—to intimidate women who might become active—to stifle public debate. This we can't allow, because what we're doing is far too important.

After glowing promises of in-notch legislation from the many creased efficiency and more top-proponents of the legislative-executive split the results were disappointing.

In the entire semester only one item of long-range importance was approved: the Daily Californian Publishers Board.

# Understanding Thru Interaction — Aim of Stiles Counseling Project

The Interpersonal Relations Project, financed by the National Institute of Mental Health and coordinated by Stiles Hall, is now taking applications for activities counselors.

Applications are available at Stiles Hall, 2400 Bancroft Way.

The Project is designed to study the interaction of a University student and 10-year-old boy, in an attempt to find evidence of changes in the student and the boy caused by this relationship.

The project will try to reveal the emotional interaction that takes place when one person helps another.

Forty male students will be selected; each will spend five to eight hours a week with a fifth-grade boy, sharing hobbies, attending sports events, exhibits, hiking and playing games.

Counselors will be paid \$1.35 an hour.

Twenty students will be needed as a control group, to take tests before and after the project, but not actually participate in it. They will also be paid.

Besides the regular activities, counselors will talk with their boys every two weeks in a tape-recorded conversation so that observations can be made.

The boys will be chosen through their schools, and letters will be sent to parents of prospective participants inviting them to have their child join the project.

The boys selected for the project will be those with emotional problems or potential juvenile delinquents. University students participating will be from all departments, races and religions.

"At the moment it appears that we will be short of Negro and graduate students," said Gerald Goodman, director of the project.

Goodman described three main aspects of the project.

In the applied aspect, the project is trying to help "kids with emotional troubles" by providing them with a friend and companion.

In the second aspect, the project is an attempt to learn how to do research in the field of interpersonal relations.

In its theoretical aspect, the project is aiming to develop a theory on the interpersonal level—"to learn what happens when one person receives a lot of understanding," Goodman said.

"There are many competing theories of helping people, and all seem to work," Goodman said.
