

## Officer Takes Away 'Test Case' Signs

A frustrated Dean of Students' Office yesterday ordered a policeman to remove the troublesome University Civil Liberties Committee (UCLC) sign affixed to Sather Gate.

The officer confiscated the sign—but no sooner had he turned his back than another, duplicate sign went up again.

Underneath the table were more signs—each ready, said tablesetter Jo Freeman, to go up as soon as this one was taken down.

The officer threw up his hands in desperation.

"Do you want to be arrested?" he demanded, explaining that his orders clearly stated: the sign could not stay up.

"Exactly," replied Miss Freeman, folding her arms and sitting down again. "We want a test case of these rules."

"Sorry," said the policeman. His orders were not to cite anybody—just to see that the sign came down.

The sign would come down, agreed Miss Freeman—as soon as a citation was issued or a faculty committee agreed to hear her complaints against the rules.

She referred to Acting Chancellor Martin Meyerson's Interim Rules on Student Political Conduct, designed to serve until the Meyer Rules are accepted or rejected. They set down the basis of University jurisdiction as the "time, place and manner"—but not the content—of political expression.

Miss Freeman charged the dean's office with violating that understanding by pursuing a de facto policy of applying the rules only against political groups and ignoring offenses by "harmless" (Continued on page 12)

## Unruh Warns Probe of UC

The threat of legislative investigation into last semester's crisis was issued in Sacramento yesterday.

Assembly Speaker Jesse Unruh (D-Inglewood), at a joint press conference with Hugh Burns (D-Fresno), president pro tem of the State Senate, issued the warning while commenting on the recently-released Byrne Report.

"I am extremely displeased and unhappy, not over the report, but the way it was handled by the Regents and Mr. Byrne," Unruh said.

"They released the report before any other members, with the exception of the Governor, had a chance to look at it so that we could comment on it intelligently," he continued.

"What may have to happen is a broad and sweeping legislative investigation," Unruh warned.

"If that report is as critical as the newspaper accounts I've seen of it are of the entire establishment, then I think the time may have to come when the Legislature will have to delve quite deeply into the situation, something I am very reluctant to do," Unruh concluded.

## FSU Lauds Report

Student representatives of the Free Student Union and the Graduate Coordinating Committee expressed strong approval for the recent Byrne Report for University reform, at a noon rally yesterday.

Robin Room of the GCC dubbed the Report a "creative surprise." "It is a surprise when someone appointed by the Regents comes up with what we have known to be self-evident all along," he added.

Addressing himself to the Regents, who have generally reacted unfavorably to the report, Room said, "They again demonstrate how out of touch with the campus they are and they are painfully deluding themselves.

"Reinforcing illusions in the context of the University 30 years ago, the Regents view the implications of recent changes as incomprehensible or subversive," he added.

Room asked several hundred people in Sproul Plaza "not to

# Report Praised and Panned

Comment on the newly-released Byrne Report ranged from extreme criticism to warm praise yesterday as the contents of the report gradually became known.

Regent Donald H. McLaughlin of San Francisco had nothing but scorn for the report.

"Never before in my experience as a Regent has so much been paid for so little," he said.

The Byrne report "hardly deserves more serious consideration" than the many magazine articles written on the campus Free Speech crisis, he added.

Claiming the Report gives a "very one-sided picture" of the FSM, McLaughlin termed it "uncritical of some of the outrageous conduct" on this campus this year.

"The Report obviously is not based on an investigation of properly wide range," he continued.

"It reflects chiefly the views of those sympathetic to the students and others involved in the Berkeley disturbances," he charged.

"Little or no effort appears to have been made to express or give consideration to the opinion

of the many members of the academic community who have been shocked and dismayed by the conduct that has been so disturbing to the University in Berkeley."

The Report's overall attack on the structure of the University especially ired McLaughlin.

He claimed no recognition is given by the Byrne Committee to "the extraordinary standing attained by the University under this very effective system."

McLaughlin said he had voted against giving the eight-man Byrne committee the \$75,000 it used in compiling its report.

Members of the committee had "no special qualification for the task assigned to them," he continued.

They had "the temerity after a very unbalanced investigation to propose drastic changes in a system that has been widely acclaimed throughout the entire country for the results achieved under it," he said.

"And even worse," he added, "the committee had the extreme effrontery to advise acceptance of the extreme demands of dissident groups that have brought such discredit to the University."

Another regent, William K. Coblentz, also of San Francisco, said he would reserve judgment on the Report's "raw material" for a while.

Right now, he said, he is occupied with the recent recommendations in the Meyer Committee Report which the Regents may vote on next week.

(The tone and recommendations in the latter report are in many cases directly opposite to the ones in the Byrne Report.)

However, superficial reading of the Byrne Report, he added, raised "some questions concerning some of the statements which purport to be factual."

Specifically, there are "conclusions without the source material," he said.

"The report reviews the nature of the protest implicit in the Free Speech Movement, and the extent of alleged Communist influence and non-student involvement.

"It makes certain findings and conclusions which I feel the committee must examine carefully before either approving or disapproving.

## FSM Trial: Bettina Aptheker Cross Exam'd

Everything from roof-walking to sit-in menus was the subject of the extensive cross-examination of Bettina Aptheker in yesterday's session of the trial of the 155 Sproul Hall demonstrators.

Miss Aptheker has been under cross examination since Tuesday afternoon.

Prosecuting attorney Edwin Meese III directed questions to Miss Aptheker's position on the FSM steering committee last fall, and the events related to this position prior to the Dec. 2-3 sit-in.

On Nov. 29 the FSM steering committee voted to have the sit-in, Miss Aptheker testified. Though at previous meetings attorneys had been present, none attended that particular meeting.

No lawyers attended any subsequent meetings, Miss Aptheker testified.

Meese then turned to events during the demonstration.

Having established that preparations for the sit-in had been planned in advance by the FSM, for such things as walkie-talkies, speaker equipment, and food, Meese asked the extent to which these plans had been realized.

Miss Aptheker told the court of three walkie-talkies used to coordinate the sit-in, of movie equipment, including a Charlie Chaplin film, of bull-horns for announcements, and of food supplied the evening of Dec. 2.

"What was on the menu that evening?" Meese asked.

"It was bad," answered Miss Aptheker. "Sandwiches, fruit, and black coffee."

On returning from the afternoon recess, Miss Aptheker was asked to tell the court of her alleged roof-walk.

She testified that on the afternoon of Dec. 2 she had entered a ladies' room on the second floor of Sproul Hall. After noticing an open window she left the rest room, and returned shortly, with

"I am sure that while I feel the report can be of help to us, its supporting documentation on such a complex subject is so meager that we will need much more information before we can reach constructive conclusions."

Comment from Sacramento took several different forms.

State Assembly Speaker Jesse Unruh attacked the handling of the report, saying a legislative investigation might be called for.

Governor Edmund G. Brown was out of the state yesterday, and thus was unavailable for comment.

Charles Garrigus, chairman of the Assembly Committee on Education, said, "I thought it was a splendid report."

"I thought it was a clear insight into the basic problems which were essentially the failure of the students to have proper channels for communication with the Regents and the administration and proper outlets for opinion and conviction on important issues," he continued.

"I think the recommendations were fully justified," he said. "I'm hoping the Regents will give a very objective and thoughtful consideration for implementing the recommendations."

Assemblyman William Stanton (D-San Jose), one of the most sympathetic of the legislators toward the FSM, seemed pleased with the report.

Stanton said, "From what I can tell, they've done a good job."

"They've seen the problems are long-standing ones—problems of growth," he said. "I thought in many places they made it clear the Regents were putting a lid on the University."

He also expressed pleasure the students were "largely exonerated from what I felt were nasty and vicious charges."

Stanton admitted he was surprised by the contents of the report, adding he thought it was "a good form of criticism. It's institutional rather than personal."

Neither Assemblyman Don Mulford nor Senator Jack Schrade, both vociferous critics of the University's policies during the crisis, were available for comment yesterday.

Comment from faculty members was hard to find, since few (Continued on page 12)

## defendant Suzanne Goldberg.

At this time both of them proceeded through the window out onto the roof, testified Miss Aptheker, in an attempt to find a place which a rope could be lowered.

The rope could be used to haul up food after Sproul Hall was closed, she said.

Meese then asked Miss Aptheker, concerning FSM policy during the demonstration, if at any time she, or other monitors had "urged" individuals to go limp when and if they were arrested.

"No. We only told people they could go limp if they wanted to, but we did not 'urge' them to do so," she replied.

The defense will begin re-direct examination when court convenes today at 10 a.m. The purpose of this examination is to clarify portions of Miss Aptheker's testimony which might be unclear, and to further substantiate the sequence of negotiations occurring prior to Dec. 2-3.

### Ice Cream Cone Stolen

Two students were arrested early last Thursday morning after they were found wandering around in Unit I with an allegedly stolen ice cream cone. Also found with the students was the master key to Unit I which campus police say will open any door in the unit. The two students, Lawrence Cooper, a senior in business administration, and James Lieb, a senior in Letters and Science, were booked and then released. Roth are Putnam Hall residents.

According to the Berkeley police report, the two entered the unit and went into the dining commons using the master key which had been given to Cooper by Mark Kirby, another Putnam resident.

From the dining commons, they entered the kitchen where Cooper took the ice cream cone from a freezer.

While they were in the kitchen, the police report said, they met Richard Menezes, a steam plant

operator who was making his rounds.

Menezes asked them what they were doing in the building and they replied, "Nothing."

Menezes went away and called campus police.

Officer John Ziehe of the campus police came and found Cooper and Lieb. He reported them to the Berkeley police who sent two officers to take custody of the students, according to the police report.

The Berkeley police report said the two "or at least Cooper" were good for "many other malicious mischief cases in the dorms."

The report also noted Cooper was willing to aid the police in "closing many of the cases of this nature that have occurred in the dorms."

The case has been referred to the Dean of Students office but Arleigh Williams, dean of men, said Tuesday no action would be taken until a final report is received from the Berkeley police.

Dean Williams said the possible penalties ranged from a reprimand to dismissal. He noted "expulsion has only been used once in the last twenty years."

The ice cream cone is still being held in the campus police department's freezer.

### Few Doctorates

### Meyerson on Grad Program: Many 'Unfortunate' Effects

The quality of graduate instruction was criticized Monday by Acting Chancellor Martin Meyerson in a speech before the Academic Senate.

"We admit graduate students in some departments with many unintended unfortunate effects," Meyerson said.

He cited faculty feeling that students lack qualification, student complaints of insufficient faculty attention, and a lack of graduate degrees awarded in several departments.

"A few programs with many students are producing no more than one graduate degree for every ten students. In one department which is known for the best

faculty in its field in the world and which has the largest number of graduate students in this country in its field, only six students in an average year are awarded the doctorate," Meyerson said.

According to Meyerson, "Both faculty time and student time is being wasted. . . I am suggesting that we should review the effectiveness of the entire program of graduate instruction."

Meyerson proposed studies of graduate requirements and admissions, fellowships from private as well as public sources; and a review of teaching departments every five years by distinguished scholars, possibly outside the campus.

Sanford Elberg, dean of the graduate division, expressed "enthusiastic agreement" yesterday with Meyerson's proposals.

Plans for altering and modernizing the graduate division have been discussed since January, Elberg said, and specific programs of revision are handled within the departments.

Meyerson stressed greater attention should be paid to undergraduate teaching because "the quality and character of undergraduate instruction is linked with that of graduate instruction."

Also mentioned in Meyerson's speech was "a growing awareness of the need for campus autonomy."

"One of the best avenues to campus autonomy is for the campus to act autonomously," he said.

Commenting on campus rules, Meyerson stated rules "internalized within the character of the individuals concerned are the best rules," and "any rules must operate within a situation of mutual trust and good will."

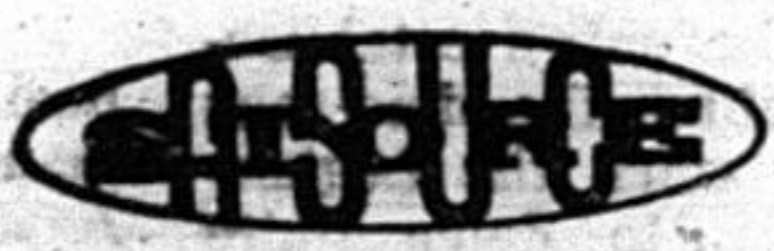

## Scalapino vs. Scott

### Vietnam Debate Given

"Withdrawal is the surest guarantee for World War III. You can't appease extremism that insists on total defeat."

"Escalating the war does not prove the good side is right."

Those remarks, made respectively by Robert Scalapino, University professor of political science and Peter Scott, University assistant professor of speech, formed the basis of a debate on American policy toward Vietnam at noon yesterday.

Before a crowd which overflowed onto the stage of 145 Dwinelle Hall, Scalapino and Scott agreed only rarely on the nature of the present situation in Vietnam and the proper course of future U.S. action.

Scalapino said, "Because China will take negotiations only on her own terms we have only two choices: unconditional surrender or struggle."

Citing a Peking editorial, Scalapino said there can be "no illusions" about who is running the revolution. Ho Chi Minh, president of North Viet Nam and the parties of Hanoi are "the real leaders."

Replying to Scalapino's charge that China will "take negotiations only on her own terms," Scott insisted "it hasn't been made clear that the U.S. primarily wants a negotiated settlement."

"It is wrong, he said, to assume just because Ho Chi Minh is Communist he is not a Vietnamese nationalist."

"Ho Chi Minh is not just a tool of the Communists. He has a following in both the North and the South," Scott said.

Scott called President Johnson's April 7 reply to Chinese terms for negotiations "a disappointment" in that it "refused to accept north-south unification."

"Johnson," he said, "could have made it clear that our aim is to prevent the conflict from escalating even if it means accepting the Viet Cong at the table."

Scalapino said it was "not true the majority of the South Vietnamese support the Viet Cong."

They support the Viet government, he said.

"The critical issue," he said, is "for more than five years Peking has been debating about how to handle American imperialism."

"Their philosophy is that U.S. defeat is certain, that it is in a position of inferiority."

"According to Peking," he said, "imperialism is a paper tiger; challenged it will retreat. They say the Communists have submitted to nuclear blackmail."

If they succeed in getting the U.S. to retreat, he said, they can go to a Communist conference table with Russia and say "see, we succeeded where you failed."

"We have done everything possible to sound them out on negotiations," he said, "but they always give a negative answer."

Scalapino recommended U.S. policy:

- Stand for a neutral non-aligned belt, offering in exchange, the removal of U.S. unilateral power.

- Agree to negotiate with all forces on different terms.

- Insist parties at the peace conference be represented by number, not by label.

Scott said, "The hopelessness of what the West has tried to do comes from a lack of domestic leadership willing to work on Western terms for Vietnam."

"We can try to localize the conflict and prevent escalation, or polarize the powers most involved in the conflict, i.e. China and the United States," he said.

Rather than relying on force, U.S. policy should be to work for "ground rules." "Otherwise," he said, "we are almost certain to have a global war."

## 'Apathy' Cancels Jr. Charity Ball

Governor Edmund G. Brown has given the University few accolades in the past few months, but Tuesday he sent a letter praising the junior class for sponsoring a charity ball to assist victims of the recent Northern California flood.

The only trouble, however, is that the ball will not be held.

According to Sandra Wallace, chairman of the ball, the activity is being cancelled because few tickets were sold. The ball was to have been held tomorrow.

Ticket holders will receive a full refund at the ASUC Box Office.

In his letter to Miss Wallace, Brown said, "The University of California at Berkeley, Class of 1966 is commended for sponsoring the May 14 charity ball to raise money to assist the victims of the recent Northern California flood disaster."

The junior class had previously written to Sacramento asking where flood relief money could be sent.

Brown wrote that relief money was being channeled through the Red Cross and other private charitable organizations.

Miss Wallace said the decision to cancel the ball was made just a little while before Brown's letter had been received.

She termed the cancellation a "great disappointment."

She did not wish to reveal how many tickets were actually sold for the ball, but she said the number of sold tickets was at

least 100 below the 150 break even mark.

Miss Wallace attributed the poor ticket sales to poor publicity and to "so much apathy on the campus."

There were, however, still signs

and news articles about the ball, she said. But the activity just didn't attract the students, she added.

Miss Wallace said it was "pretty sad that we couldn't create enough interest in this."

# Club Gives Fans Chance to View Indian Sport

Besides swiping North America, the White man also stole lacrosse from the Indians, and has developed it into an exciting sport which Cal sports fans are finally getting a chance to view this year.

Originating in Canada, lacrosse was "refined" by the Americans and mingled and mangled into their culture, and now is one of the most popular of Eastern college sports, especially among small colleges. This may be because a small college can't quite raise a large squad for football, but can manage to scrape together 10 to play Indians.

Southern California, the melting pot for nearly every sport under the sun, recently discovered this fascinating game, which slowly made its way up to the Bay Area where five teams have adopted it: Palo Alto La-

crose Club; Stanford, Peacock Gap, San Francisco, and the University of California Lacrosse Club. They form the Northern California Lacrosse Association.

So what is lacrosse? Picture a combination of skateless and iceless ice hockey, soccer, basketball, football, and maybe a touch of boxing.

Like in soccer and hockey, the object of the game is to get something into a goal or a net; not a puck, but a tennis-sized ball. The lacrosse player carries a stick or "crozier" in which he cradles the ball when he is in possession of it.

There are a goalie, three defenders, three midfielders, and three attackers, all with sticks, but only the goalie may touch the ball with his hands.

The game is played on a field approximately the same size as a football field, with a dividing line

down the center, and two goals ten yards in from the end lines of the playing area. As in hockey, play may go on behind the goals as well as in front.

The goals are located in nine foot circles called the "creases" which can be occupied only by the goalie.

With plenty of football-type running and blocking, with basketball-type passing and deception, and with the stamina and physical conditioning required by most field sports, the lacrossmen hustle from one end of the field to the other, defending and threatening to score. But there must always be three defenders and a goalie on their own side of the field, and three attackers on the other side of the field; the midmen may go anywhere they please, but they usually stay on the field.

The game, played in four 15-

minute periods like football, resembles boxing in that a player might receive many physical jolts. But a player may wear protective padding besides the required helmet, mask, and gloves.

Body blocks from the front are tolerated, and it is a penalty to hit or swing at another player abnormally hard. It is okay to hit him if the blow may be judged to be in order to dislodge the ball from his crozier.

Other penalties, punished either by loss of the ball or loss of a man—usually for a minute—are offsides and smashing an opponent on the head.

There is a "face-off" as in hockey to get the ball in play, and once a player has secured the ball he can run with it, pass it to a teammate, or shoot it to score. Each score is a single point. And if desperate enough, a player may kick the ball, but he may not

touch it manually.

A ball thrown or knocked out of bounds goes to the opposite team from the one who touched it last, and if a goal attempt shot goes out of bounds, the ball goes to the team whose members were closest to it as it left the field.

The Golden Bear lacrosse team this coming Saturday at 3:00 on Edwards Field, will play its Big Game with the Stanford team to decide the winner of the "Broken Stick" trophy, donated by Abercrombie and Fitch. This should be a very exciting contest considering that the Berkeley contingent barely topped the Indians 9-7 in their only other outing this year.

The Cal club has also beaten Palo Alto in a league match and in an exhibition tournament, but has lost two, also one in league and one exhibition. Peacock Gap was the third victim.

Answers to several questions concerning Cal's national track hopes will be at least partially answered Friday night when Brutus Hamilton leads his eager lads into the Coliseum Relays in Los Angeles.

The foremost question mark rests on the Bear mile relay team of Al Courchesne (or Chuck Glenn), Dave Fishback, Forrest Beaty and Dave Archibald. The flashy quartet is the defending relays and NCAA champion and looking for its twenty-second straight win. However, the Bears will be facing their stiffest field of the year.

Texas Southern, which features a pair of ex-local preps, and Southern Louisiana are entered and are among the nation's best.

Texas Southern has clocked a 3:07.8 as compared to Cal's fastest of 3:09.5. The crew from bayou country, anchored by Olympian Theron Lewis and including three freshmen, has an even faster time of 3:05.7. Texas is anchored by

Ray Saddler, formerly of Oakland's Castlemont High, while ex-McClymonds prep Jimmy Hines is doing his running in Texas Southern garb.

Freshman whiz Devone Smith of the Bears will get his first test in top-flight competition in the open 880. Smith, who has run a 1:49.7, second fastest in the country will be up against the only US runner to go faster this year, San Jose's Mike Gibeau. Gibeau, who has run a 1:49.3, will be joined by Darnell Mitchell, Spartan Joe Neff, and Ohio University's Barry Sugden.

Cal's 440 relay team is tentatively entered, although Hamilton is undecided whether the Bears will go, since regulars Steve Adams and Jim Blakeney are both ailing.

The Bear sprint quartet turned in a 40.4, one-tenth of a second off their best, with senior Bill Caldwell running lead-off in last week's West Coast Relays in Fresno. Beaty, Archibald and Bob Brinkworth normally run in the short relay along with Adams or Blakeney.

Bill Carter is entered in the stiff high-jump field and will be seeking to better his already-impressive best of 6-10 3/4.

about as good as Meyer. Edwards placed fourth this year in the Oakland City tournament.

Cal's chances in tournament play are better than for dual competition. The Bears are an erratic team, but any one of them on a good day can shoot high calibre golf. Thus if any four Bears can find the range this weekend Cal will finish way up in the standings.

Co-favored in the tourney are last year's champion USC and a fine contingent from Stanford, while Washington represents the class of the northwest. Perhaps the two top individuals entered are Rich Rhoads of the Trojans, who had a 281 for second place last year, and Jim Rheim, a Stanford entrant who had 292 for ninth in 1964.

**Student Protest**

**Chicago Profs Join Picket**

The faculty of the Chicago Art Institute voted last week to join the picket lines of students protesting the Institute's lack of student government and low teacher salaries.

"This is the last straw," exploded faculty union president Whitney Halstead as he learned of the Institute's decision not to grant requested salary increases.

He called for the faculty to join in the picketing and support the student boycott of classes which has emptied CAI classrooms in the dispute.

On one day only six students of the registered 705 showed up for roll call as the others marched in slow circles between the two massive stone lions flanking the Institute's Michigan Avenue entrance.

At issue for the students was a demand for the establishment of a student government with a "Bill of Rights" to guarantee "formal channels" of discipline and airing of grievances.

At issue for the faculty was the new contract which Halstead claimed "effectively" lowered salaries and the refusal of the trustees to recognize the teachers' union.

Angering both groups was the recent unexplained dismissal of the school's dean, Norman Boothy.

According to Halstead, the "unwarranted" firing of Dean Boothy triggered the student protests and led ultimately to the "total boycott" now in effect at the school.

Board Chairman William McCormick Blair had explained the Dean's job called for a person of "a different kind of temperament," and said sincere efforts have been made to communicate with the students and faculty to settle the problem.

In answer to the faculty complaint that their union had not been recognized, the administration explained that since the Institute was a non-profit organization, it was exempt from laws requiring recognition of unions.

While the faculty at least have an unrecognized union, said student leader Michael Horn, the students have no organization at all. This leaves them "totally without any channels of communication with the administration," he charged, and urged the establishment of a student government.

"These demands may sound very elementary at Berkeley," a strike spokesman told the Daily Californian, "but here they're pretty revolutionary."

The Institute has brought in substitute teachers who will temporarily replace those out on strike. Classes are meeting and roll is being taken; however, said an administration spokesman, barely one-fourth of the students show up.

Halstead declared the strike would continue until the student and faculty demands are met but did not comment on the probability of success.

At present faculty members from nearby universities are being urged to join the picket line, he said, and many outside people have shown their sympathy by refusing to cross the lines into the museum which is part of the same structure.

**TA's of FSM To Lose Pay?**

SACRAMENTO (AP)—A legislator yesterday urged that financial help be cut for University teaching assistants who joined in December's demonstrations on campus.

Assemblyman John L. E. Collier (R-Los Angeles), said he would offer amendments to the proposed state budget which would prohibit paying state funds to teaching assistants who refused to leave Sproul Hall.

The proposal also would bar the usual waiver of tuition fees granted to teaching assistants from outside California.

Collier said 37 teaching assistants and readers were arrested during the demonstrations. A fulltime assistant position costs \$5,140 a year, he said.

**Anti Sit-in Laws Eyed**

SACRAMENTO (AP) — The Senate Judiciary Committee Tuesday took a hard look at five bills that would have tightened laws dealing with civil rights sit-ins. Only one measure was allowed to reach the upper house floor.

Authors of the legislation were two Republicans — Sens. Jack Schrade of San Diego and Robert J. Lagomarsino of Ojai.

The package was aimed at recent demonstrations here, in Oakland restaurants and supermarkets and in the Los Angeles public school system.

Barely approved by voice vote was a Lagomarsino bill which would make it a misdemeanor to fail to leave a public or private property when asked to get out by the property owner.

Lagomarsino said the bill would mainly cover demonstrations on school property and would tighten present trespass laws.

The committee killed, however, a measure by the Ojai Republican which would make it a misdemeanor for anyone to enter public or private property against the owner's wishes.

Committee Chairman, Sen. Donald Grunsky, R-Watsonville, said trespass laws should perhaps be more carefully defined rather than give a property owner the right to exercise his own judgment based on "whim or caprice."

The committee also turned thumbs down on another Lagomarsino bill which would have

made it a misdemeanor for anyone to fail to leave property without legal cause. Lagomarsino said it was introduced mainly on behalf of private property owners.

Schrade's bill to make it a misdemeanor for a person to picket or conduct a sit-in in a public building after being asked to leave also was held in committee.

Charles Smoot, a member of the Los Angeles Board of Education, said pickets from the Congress of Racial Equality had interrupted several board meetings during the 1963-64 school year in an effort to seek "publicity of the sensational type."

Schrade testified the bill was also directed at students who took part in the Free Speech Movement on UC's Berkeley cam-

pus, and who, he declared, prevented students from attending classes.

Another Schrade measure which would make it a misdemeanor to disrupt public gatherings—such as demonstrations at city council meetings—also was killed.

## A \$75,000 Bluebook

The Byrne Committee has brought forth a report which purports to uncover the "basic factors contributing to recent unrest within the University," with special attention devoted to the recent "free speech" controversy on this campus.

The cost of the project was \$75,000.

The findings of the Byrne Committee indicate the primary cause for past eruptions of emotion and possible future disturbances lies within the sprawling bureaucratic structure of the state-wide University administration and within the Board of Regents itself.

They have cited the Regents for participating in policy determinations which, in theory, should belong on the campus level.

To solve the inherent inefficiencies and alienations of the University's vast bureaucracy, the committee has suggested, among other things, that the University decentralize its state-wide administrative control and form nine competitive, autonomous units that would comprise a "commonwealth of universities."

It is certainly true that bureaucratic decision-making in any organization reduces the efficiency of, and promotes friction within, that organization.

It is also true that the bureaucratic structure of the University contributed to the crises of last semester.

But what has been presented in the Byrne report leads one to believe that had it not been for this bureaucratic organization, the controversies would never have occurred.

We cannot help but question this logic.

Furthermore, if one were to assume that bureaucracy were the sole cause, which we do not, the proposed cure is worse than the disease.

The University, according to the report, should be reconstructed so that each campus defines its educational policies and establishes an independent reputation for excellence in instruction with little or no Regental control over campus affairs.

This University is great, not because the campuses compete with each other for faculty, funds, and students, but because they cooperate and complement one another.

If such a plan were to go into effect, the infant branches of this University would be cast adrift at a time when their future depends on the strength of the University system in its entirety.

This plan would cripple the University's attempt to supply educational opportunities to the population of this state.

Decentralization is certainly desirable . . . but emaciation is not.

Aside from the failure of the committee to display any understanding of the University system, a report has been produced, 85 pages in length, with a copious bibliography, yet void of documentation and abounding in rhetorical garbage as frequently seen in the midterm bluebooks of freshmen.

We question also why the committee found it necessary to retain a press agent at undetermined cost to insure widespread publicity of the report. To be sure, the report—an apparently "salted" goldmine—made headlines; but then, so did Mr. Byrne.

This one-sided examination of the problems of this University left readers with the impression that the tactics of the FSM were to be condoned due to the faults of the administration.

If the student conduct of last semester were to go uncriticized, as it did in this report, the committee has shown that it was tragically incapable of ascertaining the facts and delivering unbiased conclusions.

A freshman bluebook costs five cents, not \$75,000!

## 'The Trouble in Berkeley'— Photographs

"The Trouble in Berkeley" is a photo-essay with a text by Steven Warshaw. It has just been released by Diablo Press here in Berkeley.

The large paperback sells for \$1.95. In the first four hours of its sale in the ASUC Store, the total stock of 200 copies was sold out, and 400 more copies were rushed in as a line formed. Store officials said the copies were disappearing at the rate of one every three minutes.

Another printing is being released soon.

The book claims to tell "the complete history . . . of the great student rebellion against the 'new university.'"

It doesn't.

Too much is left out; there is almost no documentation, and the time, date, place, and contents of the pictures are not included. Pictures are juxtaposed out of context—a panel confrontation between students and administration placed with a commentary about paying for the police car, for example.

Statements from various key figures are also given out of context. President Kerr's description of a university president as being "mostly a mediator" is culled from the 1960 Godkin Lectures at Harvard. The source is not given, but the statement occurs shortly before an account of the negotiations that went on.

But the text of the book is not the important part of it. The value of "The Trouble in Berkeley" is in the striking collection of photographs tracing the story of the crisis from summer protests through the Sproul sit-in, and the strike.

It is unfortunate that much of the emphasis on cause is directed toward William Knowland, for no evidence is cited to show that he put any pressure on the administration.

Most of the pictures were taken by Howard Harowitz, Helen Nestor, Douglas Wachter, and Daily California photographers George Crow and Ron Enfield.

The photographers are not further identified, but Wachter gained prominence earlier as the University student called before the House Committee on Un-American Activities in their 1960 hearings.

The photographs in the book—more than 120 of them—are magnificent. They recall better than any text the excitement and terror of last semester, and provide a moving and vivid record of those events. They recall the impassioned addresses, the nightmare police, and the long cold nights in the plaza.

Perhaps the most powerful picture is the one of a lone handful of students with "Strike" signs standing alone in front of Sproul Hall with the marble columns towering above them.

The students—and the columns—are still there.

## Dominican Republic—Part I

Let us begin looking at the situation in the Dominican Republic by asking, in the style of *le grand Charles*: "What are the realities?" This question is not the same as "What are the facts?" That question may be harder to answer at first, but easier to answer in the end. The realities deal not with simple facts, but with the elements at work in a given situation.

When we discover the realities in the Dominican situation, we ought not to be surprised to find that the realities confound the basic abstractions of "liberalism." Alas, "liberalism" will not correct itself in this case any more than in all the other cases where it is confounded.

Two major points can be made about the situation in "DR." One pertains to the dynamic nature of the Revolutionary process and the other pertains to the nature of legitimacy.

The Marines are back in DR after 41 years, to protect American lives we are told, or to prevent a Communist take-over, or, no doubt, to establish a regime acceptable to the U.S. To protect the lives of foreigners caught in anarchy, such as in DR, may not fulfill all the legal niceties of that great statute book of dead letters—international law—but no decent and common sense person truly objects when a civilized power intervenes when needed—as in the recent and comparable example of the Congo.

"To prevent a Communist take-over" is more likely to make a fuss. The Communists and their sympathizers aside (not a small block to put aside, but put aside they must be if we are ever to get anywhere), a wide spectrum of the left and even the center will nurse qualms such as: "But how do we know what is best for the Dominican people?" "Are we certain there were Communists in control?" "Is it not for the OAS or UN to take action when needed?" "Is the DR (says the newest brand of isolationists) really our business?" Let us bypass these qualms and focus on the actual events in the DR.

Under the status quo ante, the DR was governed by a three-man civilian junta backed by the military, and, more or less, the propertied classes, the Church, and the U.S. The three civilians were young (all about 40), from good families, well-educated, and active Catholic laymen—none of which indicates competence to govern, to be sure, but only that they are "our kind of people"—reasonable, responsible, not given to wild adventures at home or abroad.

The initial coup was staged by junior officers and non-coms—not that it proves anything, but Peron and Nasser were junior officers, and Batista was a sergeant. They loudly proclaimed their loyalty to ex-president Juan Bosch, a non-Communist leftist social reformer, long the darling of the N. Y. Times-ADA-Bettancourt crowd. In office, he proved a poverty pocket of administrative skill, and a disaster area of statemanship (that is, corruption and unchecked mobs in the street, a petty feud with Haiti, and wide-spread Communist subversion).

The rebels' main support came from the urban masses of Santo Domingo. The rebels seemed to have won the day when Air Force General Wessin y Wessin rallied the loyalist forces, who controlled the countryside, and staged a counter-coup. So far so good, through coup and counter-coup, all was in a familiar Latin American pattern.

The coup is a technique for overthrowing a government with a minimum exercise of force. Classically, it is a family affair of persons already in power, or very near it. Classically, it is quickly over; hopefully, when the capital wakes the next morn, the new men are already in power, and any untidy details, such as those so unfortunate as to have been killed, are out of sight. The only popular participation is in the celebration.

Moreover, in Latin America, where a century and a half of practice has perfected the form, certain gentlemanly conventions are usually observed. At the appointed time, the "outs" move their troops into position, and serve an ultimatum to the "ins," the principal commanders are convassed, and a tally of relative power is quickly made. The obvious losers give up and are speeded off into exile (they have even been known to keep their pensions).

When the losers are executed, and the masses are called into play, then something is wrong. Castro's dealings with Batista's followers should have been the first tip-off that this was a different kind of government shift (differences in program left or right are all right, lapses into uncivility are of a different order).

The "tragic turn" in the Dominican Republic came when the rebels turned to the masses for active participation, and passed out 10,000 weapons. The coup became a REVOLUTION.

## 'We Recommend ...'

# Controversial Sections of Byrne Report Summarized

(Editor's note—Following is one of the most controversial sections of the Byrne Report, dealing with the proposal that each campus of the University receive a separate charter.)

We recommend that the Regents separately charter each campus as an autonomous University within the system of higher learning under Regental jurisdiction.

a. The Regents have shown wisdom and have demonstrated great perseverance in holding to the ideal of diversity in planning for the nine campuses of the University. We believe that diversity in planning should now be extended to diversity in operations, by establishing each campus as an autonomous member of a University commonwealth, and giving it maximum freedom to differ from the other campuses.

b. We urge that charters be drawn for each University of the commonwealth, establishing:

(1) That all powers and authority necessary to self-government and self-determination be placed with the Chancellors, faculty and students of the individual university, reserving to the Regents and the President only those powers and authorities essential to constitutional unity of the whole.

(2) That the Chancellors, administration, and academic community of each separately chartered university be held responsible for results achieved, not for conformity to method on a statewide basis.

(4) That each Chancellor be appointed by the Regents and report to the Regents through the President, with complete responsibility for leadership and management of the university under his jurisdiction.

(5) That the Chancellor have power to and be encouraged to redelegate the authority and responsibility vested in his office.

c. We recommend that the

charters provide for full freedom of organization by faculty and students, so that the Chancellor may have a resource responsive to the wishes of the members of the academic community to aid him in its governance. Guided by broad legislation at the Regental level each university should have:

(1) The freedom to establish its own educational policies and standards, (2) The responsibility for establishing its own reputation for excellence in teaching, (3) The freedom to give shape and substance to its own conception of academic freedom and responsibility.

e. We recommend that provision be made in the charters for their change and evolution as documents of government, with full recognition given to the variations in maturity among the existing campuses.

g. We recommend that the charters provide for direct communication and appeal to the Regents from any component of the University system.

## Sen Com Nixes JC Gov Board

SACRAMENTO (AP) — The Senate Education Committee yesterday blocked legislation to create a separate state governing board for California's 74 junior colleges.

The bill, by Sen. Walter W. Stiern (D-Bakersfield), could muster only five "yes" votes—one short of the majority needed to move it to the Senate floor.

The measure would have established a 10-member State Board of Community Colleges appointed by the governor to four-year terms with the consent of the Senate.

The state's vast junior college system, attended by some 473,000 students, is now administered by the Board of Education.

## 'Goofballs' Hit

SACRAMENTO (AP) — Atty. Gen. Thomas C. Lynch's bill to eliminate traffic in stimulant and depressing drugs — the so-called "bennies" and "goofballs"—was passed 30-5 by the Senate Tuesday.

The measure by Sen. Donald L. Grunsky (R-Watsonville) now goes to the Assembly.

Grunsky said that peddlers — frightened away from the hard narcotics trade by tough laws—were turning to selling dangerous drugs.

He called it a "new found gold mine for those who traffic in drugs."

These would be the new penalties:

Possession—A maximum \$1,000 fine and a year in the county jail for the first offense and up to five years in state prison for the second.

Possession for sale—up to three years in the state prison for a first offense and up to 10 years in state prison for the second.

Manufacturing, dealing or distributing or importing drugs — Up to five years in the state prison for the first offense and up to 10 years for the second.

Violation of the law in connection with minors — up to five years in the state prison for a first offense, and up to 10 for the second.

# UC Village Students Protest

Administration action has again been met with shouts of protest from University students.

Students who live in the University Village in Albany have formed the UC Village Fair Rent Committee to protest the recent Village rent raise.

Mrs. Roselyn Leonard, chairman of the committee, said the turmoil began in March when the University raised the monthly rent \$5 in the new apartments and \$8 in the old apartments. Mrs. Leonard said Mrs. Ruth

Donnelly, supervisor of housing services, claimed the rents were raised as a result of a poll. This poll, given to 20 per cent of the students living in the UC Village, was answered by ten per cent, showed that the students could afford the rate increase.

Mrs. Leonard said that another poll was taken by her committee which drew response from 87 per cent of the adult residents of the Village. Only 34 per cent answered that they could afford this rent increase with no difficulty, and five per cent said they would have to drop out of school if this increase went into effect.

# \$75,000 Byrne Report Praised, Panned

 professors had had a chance to read any more than newspaper accounts of the report.  
 Richard Jennings, professor of law and chairman of the Academic Senate, admitted he had not read the entire report, but said he was "very much impressed with the perception of the Byrne Report of the situation on the campus and with their analysis of student grievances."  
 He commented on the recom-

mendations of the Byrne Report, saying, "I think they should be taken seriously, especially with regards to student government."  
 One of the primary sources of speculation on the fate of the Byrne Report is the discrepancy both in substance and in spirit between it and the recommendations of the Meyer Committee.  
 The Meyer Committee submitted to the Board of Regents a set of recommendations for rules to govern student behavior and stu-

dent governments within the University system. Those recommendations will be voted on at the meeting of the Board of Regents scheduled for May 21 in Riverside.  
 The primary contradiction between the two reports is in the area of student government.  
 The Byrne Report recommends a liberalization of the rules concerning student governments, including giving student bodies the right to decide the legality of student governments taking positions on off-campus issues.  
 This was in direct contrast to the Meyer Committee's recommendations, which advocated an even more stringent control by the administration over the student government, than is presently in force, and enjoined student governments—voluntary or compulsory—from taking stands on off-campus issues.

case" heard by having the University prosecute simultaneously a political and a non-political group.  
There are plenty of violations, she claimed—a whole list of them, in fact, had been drawn up by UCLC against student organizations which had allegedly violated the same rules as had the Civil Liberties group.  
So far the administration has refused to prosecute—"knowing," she said, "that it would reveal a policy of selective and discriminatory enforcement of the rules."  
As an example, she claimed, the political groups are charged several times the actual cost of renting Pauley Ballroom or other University facilities in order to make up the expense of granting them free to non-political organizations.  
ASUC Student Union officials denied that any discrimination was intended in the rules which establish the different rates. In fact, said Services Director Stanley Elliott, changes were being considered now.  
Dean of Men Arleigh Williams also denied there existed any policy of "discrimination."  
However, he said, it is true there are more restrictions on the political groups. These date back, he explained, to the time when it was considered illegal for a student group to "initiate or advocate" socio-political action.  
At that time such groups were banned from many University privileges.  
Since the right to "initiate and advocate" has now been recognized by the University, he said, a "serious reconsideration" of the distinctions between political and non-political groups "ought to be undertaken soon."  
Miss Freeman was in complete agreement. However, she said, her definition of "soon" and the dean's differed substantially.
