
Q. Can a beneficiary of property in a will legally sell their part of the property 4 years before trustor dies.

December 4, 2022

A: Yes, you can sell. BUT

You own a mere expectancy, with probably no value.

You may sell,



Because if you are named in the will or trust and the maker of the will or trust is still alive, he can change the will or trust anytime he wants to.

You do not have a vested interest to sell.

Only a mere expectancy.

Q. Can I sue my lawyer for misrepresentation, he missed all filing dates ect.

June 30, 2022

A: You may sue your lawyer, but that does not mean that you will win anything.

You must prove all the elements of your case:

You must prove that he/she was your lawyer.

Did you have a client lawyer fee agreement?

You have to prove that your lawyer was negligent, pursuant to the law of your state.

You must prove your damages with specificity.

You must prove that your lawyer's negligence was the cause of your damages.
