<u>Drug and Alcohol Addiction: A Bio-psycho-social Approach</u> Spring 2016

Course Description:

"Drug and Alcohol Addiction: A Bio-psycho-social Approach" is a one unit DeCal course that introduces students to the dominant discourses surrounding drug addiction and the popular methods utilized by healthcare professionals in addressing the issue. During this course, students will explore a variety of themes including: stigma of addiction, comorbidity of mental health issues and addiction, relapse, biological processes of addiction, and a number of other topics. The purpose of this course is to provide students with a basis for understanding underlying causes of drug addiction and critically analyzing misconceptions that stem from this often contentious topic. This course is intended for anyone who has an interest in learning more about drug addiction, including those who have personally been affected by the issue and/or those who wish to work with individuals suffering from addiction.

Course Requirements/Grading:

<u>Attendance for this course is mandatory!</u> Students will be allowed two excused absences (must provide minimum 24 hour notice). Unexcused absences will result in a 5% reduction of course grade. More than two absences of either kind will result in a NP.

The class will meet for one hour once a week for twelve sessions.

Grading:

Attendance – 40% Weekly Assignments – 30% Short Essay – 15% Presentation – 15% Pass is 75%

Assignments:

- 1. Students will be assigned 10 weekly reflection responses relating to each week's reading assignments. Each reading response should be ½ page double space in 12 point Times New Roman font with 1 inch margins.
- 2. Short Essay: Students will be assigned to write a 1 page paper critically analyzing the portrayal of addiction in the documentary *Rehab* and the resulting impact that this portrayal would have on an audience member unfamiliar with addiction. The paper should have 12 point Times New Roman font with 1 inch margins.
- 3. Presentation: Students will select a drug or classification of drugs for a 2 to 3 minute presentation. In the presentation, the student should briefly summarize: the origins of the drug and the biological impact of the drug on the human body.

Course Objectives:

By the end of this course, it is our hope that students will be able to:

- 1. Identify and explain the major treatments for addressing drug addiction
- 2. Be aware of the major classifications of drugs and how each affects human physiology
- 3. Understand the relationship between mental health diagnoses and vulnerability to drug/alcohol addiction
- 4. Be aware of normative views of drug use in American society and the impact that this has on policies addressing addiction.
- 5. Utilize the Bio-Psycho-Social Model as a means of placing addiction within a greater sociocultural context rather than simply as an individual problem.

Links to readings and other educational material will be provided on the course website. These will include a combination of popular media articles/videos as well as academic literature.
