<u>Course Description:</u> The purpose of this course is to introduce students to the various socioeconomic, cultural, and political factors that affect maternal and child health. This will be accomplished through active engagement in the form of lectures, reading, reflection posts, and presentations. We will also examine current efforts in education, public health, and policy to combat disparities in mother and child health. In addition, students will also interact with professionals in this field, all leading to the goal of gaining personal insight into this field. Students will have the opportunity to present on a specific topic of their choice in the realm of maternal and child health.

Learning Objectives: By the end of this course, you will have learned:

- Intersectional factors of maternal and baby health
- How to educate your community
- How to advocate for marginalized groups
- Discuss and examine various perspectives in Public Health.
- Become educated on various topics in Maternal Child Health
- Introduction to Public Health and awareness of future research and careers in the field

<u>Pre-requisites:</u> A passion for learning about the biological, economic, and social disparities in global maternal and child health.

<u>Course Website:</u> bCourses will have all our information including weekly assignments and readings.

<u>Materials Needed:</u> All readings, articles, and reflection posts will be on the Bcourses site. Readings and articles can be found under the Files tab, while reflection posts are located in the Assignments tab.

<u>Methods of Instruction:</u> Instruction will be given in the first 40 minutes of class, mainly by the course facilitators for the first few weeks. For specific topics such as global health and careers in Public Health, etc we will work to invite a guest lecturer. For the remainder of the 1 hour class students will discuss the previous week's readings and assignment with the course facilitators. All class instruction will be in person unless stated otherwise.

<u>Technology Policy:</u> Cell phones, laptops, ipads and other devices should not be in use during class time.

<u>Attendance Policy:</u> Attendance is mandatory. If you know that you will not be present in class for a particular day, please let us know 24 hours in advance. You are allowed 3 excused absences.

<u>Grading:</u> Grades will be assigned based on a p/np basis, based on fulfilling the following requirements for the grade. Students who complete the course with a 70% or higher will receive a passing grade.

- Assignments (25%)
 - Assignments will consist of reflection posts (3-4 sentences) on class discussions, assigned readings, and personal insights. Each assignment will be based on that week's content and is due the following week by 6:00 p.m., just before the next class begins at 6:10 p.m.
 - Readings should be completed before lecture and will be discussed at the beginning of class.
- Presentations (25%)
 - Every student will present a final presentation on a topic related to global maternal and child health of their choice in the last two weeks of the semester. More details will be provided in class.
- Attendance (40%)
 - Attendance is mandatory. You are allowed 3 excused absences, including Midterms. If you are unable to make it to class, please inform one of the facilitators 24 hours before the class (emails found above).
- Participation (10%)
 - Participation is mandatory. It will be accounted for through our google forms which asks students for the attendance word of the day. To foster active participation in class content while respecting individual comfort levels, we aim to cultivate an inclusive environment that encourages engagement without placing students in the spotlight for refraining from raising their hands to speak aloud.
