Terms and conditions:

In these terms, "you" and "yours" means the dealer/exporter, 'We', "us" and "ours" means Directcars Pte Ltd, Including its successors and assigns.

1. Your Duties
 - 1.1 You have to fulfil and acknowledge your offer for the vehicle that you bid.
