Los Angeles Superior Court Case No. PC 038 334

This lawsuit seeks compensation for injuries received by an inmate while incarcerated in the Los Angeles County Jail.

The Claims Board recommended to the Board of Supervisors the settlement of this matter in the amount of \$750,000 and that the Auditor-Controller be instructed to draw a warrant to implement this settlement from the Sheriff's Department's budget.

- h. Rosa Franco, et al. v. County of Los Angeles
Los Angeles Superior Court Case No. BC 309 544

This medical negligence lawsuit arises from injuries sustained by a patient while hospitalized at LAC+USC Medical Center.

The Claims Board recommended to the Board of Supervisors the settlement of this matter in the amount of \$2,180,000 plus assumption of Medi-Cal Lien not to exceed \$183,390.30 and that the Auditor-Controller be instructed to draw a warrant to implement this settlement from the Department of Health Services' budget.
