Recap of Fatality Shootings by SPD Officers – 1980 through July 2001

SALGADO, Juan	5/20/80 1930 hrs	2 nd & Blanchard	M/M 36	Gun	The Suspect entered a bar very intoxicated, owner observed a handgun in his waist, asked him to leave and then called 911. Officers located suspect at 2 nd & Blanchard. Officer approached and put his hand on suspect's shoulder, suspect pulled away and lunged at officer, reaching into his coat in the area where witnesses had stated he was carrying a gun. Two officers fired, hitting the suspect. He was hit twice and died from his wounds at the hospital. Suspect had two other altercations with police that year.
BENSON, William	7/19/81 2300 hrs	3400 blk Beach Dr. SW	W/M	Gun	Suspect attempted to enter a vehicle parked and occupied with two witnesses. Police arrived on the scene and suspect pulled out a .357 Magnum revolver and pointed it directly at the marked patrol car. Suspect continued to point the gun at the officers, walking around to the back of the vehicle where the officers had taken cover. As he aimed his gun directly at officers two of the three shot hitting suspect.
McCune, Martin	10/26/81 1435 hrs.	2400 blk 3 rd	W/M 28	Knife	Suspect was wanted for stabbing his mother. Officers located him on a metro bus. He displayed a knife in a scabbard. As he exited the bus he drew a knife and confronted officers who had arrived as back-ups. All officers ordered him to drop the knife, the suspect responded by saying "I'll kill you, go ahead and shoot me, my blood won't die". The suspect continued to back away from the officers then suddenly whirled on an Officer and two elderly ladies who had been hiding behind a wall nearby. The suspect turned directly towards the officer and lowered the knife to a thrusting position. The officer again ordered the suspect to drop the knife, he yelled "no way" & lunged at the officer. He was then shot.

KRUPPA, Edward	5/19/82 2145 hrs	1161 21 st Avenue	W/M 28	Can Opener	Officers responded to a disturbance. An Officer went to the back of the residence and was attempting to get out of his patrol vehicle when suspect charged the patrol car, kicking the half opened door shut. The Officer was able to kick the door open and exit the car. At this point the suspect was fumbling with a coat he had picked up, apparently searching for something. As the officer approached him, the suspect drew a chrome colored object from within the coat. The officer feared it was a gun and pulled his weapon. The suspect then began to scream, raised the object over his head and began to charge the officer. The officer, now believing the object was a knife, fired two shots.
HENTHORN, Jack	2/10/82 1235 hrs	4000 Blk Aurora Ave. N.	W/M 48	Gun	A Patrol Officer was driving his patrol car when he saw the suspect standing on the corner pointing a gun in his direction. The officer pulled around the corner and heard gunshots. He observed the suspect running along side the car firing the weapon. The officer pulled ahead and exited the vehicle and returned fire. The officer fired six rounds, began to reload as the suspect was still standing. As the officer reloaded, the suspect fell.
BARSTOW, Alva Gregory	5/6/83 1500 hrs.	1500 blk 2 nd Avenue	W/M 29	Gun	Officers were dispatched to a disturbance-man with a gun call. As they entered the lobby of the building they were directed to the suspect. As they approached him, he jammed his hand in his right front pants pocket and yelled something unintelligible about the right to carry protection. One Officer grabbed the suspect in a bear hug just as the suspect shot at the second Officer hitting him in the left leg. As the first Officer struggled with the suspect, the second Officer was able to draw his weapon. The first Officer jumped out of the line of fire and drew his weapon and began firing at the suspect.

As they attempted to gain entry the suspect lunged out and mortally wounded one of the deputies. The suspect barricaded himself in the unit and refused to respond to attempts to get him out. After a stand-off the Emergency Response Team forced the door, the suspect lunged out and stabbed one of the officers, he was subsequently shot and killed at the scene.
WILLIAMS, Edgar	4/23/84 1521 hrs	1300 E. Madison	B/M teens	Gun	Victim was entering bank with two moneybags. Suspect Approached him and demanded the money. Suspect hit victim on the head with a gun. An off duty Officer was working at bank & was alerted and pursued the suspect. He was shot in the throat by suspect and returned fire, hitting suspect four times.
RAYMOND, Allen	1/12/84 0113 hrs	6932 Carleton Ave. S.	B/M 40	Gun	An off-duty Officer entered the Ox Box Inn and was confronted by suspects who were in the process of robbing the Inn He was ordered, at gunpoint, to lay on the floor with the other patrons. The suspect started taking wallets from the patrons. When he got to the officer he was able to grab or deflect the suspect's weapon away from him. As he did this the weapon discharged, striking the officer in the leg. He was able to draw his own weapon and fired six shots, hitting the suspect three times.
CLAYTON, Roland	1/5/85 0400 hrs	25 th NE & NE 160 th	W/M 25	Sawed off shotgun	Suspect robbed the AM/PM Mini Market using a sawed of shotgun. He fled the scene and was located by an officer. As the officer gave chase the suspect fired several rounds at him. The car chase ended when suspect pulled his car over blocking the road. The suspect got out of his vehicle and waited in ambush for the pursuing officer, who was about ½ block behind the suspect. As the officer turned the corner (fearing the suspect may indeed be waiting for him) the suspect began shooting, hitting the patrol car. The officer fired four shot in return, two from his service revolver and two from his shotgun, hitting the suspect in the left upper chest.

JACOB, Michael	9/13/88 0446 hours	5027 19 th Ave NE	I/M 19	Gun	A patrol officer responded to a call of a suspicious person. When the Officer arrived, the owner of the home opened the door and let him in. The officer observed suspect sitting on the stairs and victim explained he had been awakened by his dog, upon investigation he found the suspect in his home. When he asked the suspect what he was doing in his house, the suspect explained 3 men were chasing him. As the officer approached the suspect, he jumped up from his sitting position, pulling out a 9 MM handgun. The officer was unable to take evasive action and the suspect placed the weapon to the officer's temple and repeatedly threatened to kill him. A struggle ensued, during which the suspect momentarily lost control of the gun. The victim jumped on the suspect's back in an attempt to assist the officer. The suspect then suddenly turned towards the officer with gun in hand. The officer shot the suspect once in the lower torso.
BROOKS, Lynn	11/21/88	8500 6 th NW	W/M 35	Gun	Officer stopped a vehicle in which Mr. Brooks was a passenger. He had information that led him to believe that Mr. Brooks was a drug dealer and carrying a gun. During the contact Mr. Brooks was seen to attempt to bring a gun out of his coat and point it at the officer. The officer stepped back and fired at Mr. Brooks, killing him.
Bickler, Paul	10/5/88	630 Elliott Ave W.	W/M 44	Gun	Suspect had just robbed a service station, Officers had responded to an alarm down the street and were heading towards the location of the robbery when they spotted the suspect walking down the street. They pulled over and before they could get out of the car, the suspect began firing at them. They exited the vehicle, returned fire and chased the suspect to a nearby wooded area where they lost sight of him. He was located shortly thereafter, gravely wounded.
McDOWELL, Shawn	7/10/88 2355 hrs	1531 NE 145 th	B/M	Gun	Detectives were on a stakeout at the location. The suspect entered the establishment and forced the manager to open the safe. The suspect was taking money from the safe, when one of the detectives confronted him, identifying himself and ordering him to freeze. The suspect tried to get behind the door of the safe and began to raise his pistol towards the detective. The detective fired once with a 12ga. Shotgun striking him with several pellets.

They knocked and announced themselves and no one answered. They forced the door with a battering ram. Upon entering officers observed a male lying on a couch. He rose up, had a dark object in his hand, which he pointed at one of the officers. Believing it was a gun and that he was about to be shot, the officer fired one shot, hitting the victim once in the right chest.
McELROY, Jonny Lee	2/16/88 1030 hrs	8702 35 th Avenue NE	W/M	Gun	An officer was working off duty at People's Bank when suspect entered with drawn pistols. The suspects opened fire on the officer, he was able to duck behind a desk and returned fire. The officer was struck causing a grazing wound on his head. The suspects fled, one collapsed outside the bank and was arrested, the other fled on foot and later was found collapsed and wounded. He was pronounced dead at the scene.
TUCKER, William	2/2/88 2010 hrs.	541 23 rd Avenue	B/M	None	East Precinct Street Team was serving a narcotic warrant at the location. This was the 3 rd warrant served the past month. The first officers entered and followed normal procedures. The last officer in the premise was pulling out his service revolver when it accidentally discharged, hitting victim/suspect who was on the floor to his left. Neither the officer nor the ATF Agent next to him realized there was anyone on the floor.

The first detective who entered the house located two suspects in a back bedroom off the kitchen. One was aiming a large caliber handgun, (.357 Magnum) at him while the second was crouched behind the first and pointing a pistol gripped shotgun. The suspect holding the .357 fired at the detective, hitting the ceiling, causing debris to fall. The suspect then fled and the second suspect refused to drop his weapon when the detective ordered him to. The suspect then began pumping the shotgun's slide action and chambering rounds. The Detective fired 3 rounds striking the suspect.
SIMMAVONG, Sourisack	12/25/90 0130 hrs.	3800 Blk Lk. WA Blvd.	A/M 20	Gun	An officer encountered a suspicious vehicle parked in Stan Sayers Pits. He approached the vehicle and began questioning the occupants. While removing them from the car he discovered a handgun hidden in the vehicle. As the suspect exited the car he produced another handgun and pointed at the officer. Both the officer and the suspect began firing at each other, both were shot. The second occupant recovered the first gun and began striking the officer in the head with it. He managed to get away from the suspects and call for help. The Officer was shot three times.
Lyons, Anthony	2/21/92	1701 E. Madison	B/M	Gun	Suspect had robbed the Texaco at this location. The store had been held up several times in the recent past and was being "staked-out" by SPD patrol officers. As the suspect attempted to flee the store, both officers, who attempted to arrest him, confronted him. The suspect pointed his pistol at the officers and was shot twice.
McDONALD, John	2/28/92 1900 hrs.	4544 7 th NE	W/M 71	Large Hunting Knife	Officers had been dispatched to location on a disturbance and minor assault. The approached the suspect apartment with the building manager. They knocked on the door several times, when the suspect answered he was holding a large hunting type knife. The officers ordered the suspect to drop the knife several times, which he ignored. The suspect then turned the knife over, holding it by the blade, he raised the knife and began a motion to throw it at one of the officers. The officer fired two shot and struck the suspect.

LAWHORN, Roger	4/30/93 1930 hrs	6 th & Denny	W/M	Gun	Suspect began a series of armed robberies of downtown hotels. When officers responded he attempted his get-away in a taxi-cab and force the driver to flee from police. The cab driver and suspect struggled for the suspect's gun and a shot was fired towards the officers. One officer returned fire and the suspect was mortally wounded.
Bowerman, Dennis	10/8/93 1045 hrs	119 1 st Avenue S.	W/M 50	Wrench	A Suspect held up a Bank. Shortly after leaving the bank the suspect was observed by an officer. He ordered the suspect to stop, instead the suspect turned on the officer and began to advance on him while menacing a large wrench that he was using as a weapon. The Officer, with his gun drawn, continued to order the suspect to drop the weapon. The suspect continued to advance attacking the officer. The officer fired his service revolver in self-defense.
DUNSMOOR, Antonio	4/22/95 0042 hrs	23 rd & Cherry	A/M (Filipino)	Knife fake pistol	Several SPD Officers attempted to contact the suspect, who was reported to be armed with a handgun near Garfield High School. As officers approached the suspect brandished a knife. Officer told the suspect to drop the knife repeatedly, but he refused. While officers were waiting for a negotiator the suspect produced a pistol and aimed it at the officers. At that time several officers shot him. Although the pistol turned out to be an auto-loader replica the officers and several witnesses believed it to be real.
Anderson, Edward	1/15/96	200 blk 21 st Ave E.	B/M 29	None	Officers were responding to a repeat domestic violence call. As officers approached the residence the suspect fled the house into a vacant lot. Officers pursued and one of them caught up to the suspect at a fence. As the officer was attempting to take the suspect into custody, his weapon discharged, striking the suspect in the neck.

The suspect thought he was there to evict him and shot the victim once in the head. The victim was able to flee and call police. Police arrived and secured the scene. After over five hours, the SWAT team inserted a mirror into the apartment and suspect fired one shot at them. Gas was then inserted into the apartment and the suspect came charging out and fired one shot at officers. One officer was wounded in the arms and face but both he and the other officer were able to return fire, mortally wounding the suspect.
Okarma, Mike	7/1/99 0601 hrs	800 blk S. Thistle	W/M 56	Gun	An Officer was attempting to verify the address of the suspect who was a registered sex offender. He located the suspect in his pick up truck. The Officer asked the suspect to exit his vehicle and as he did the suspect armed himself with a 9 MM pistol. The suspect pointed the pistol at the Officer and a struggle ensued. During the struggle the suspect was shot.
MORGAN, Thomas	12/7/99 0625 hrs	2324 NE 91 st	W/M 45	Guns	Suspect called 911 indicating he had just shot and killed his brother and sister-in-law. SWAT responded and set up containment. Through numerous conversations they learned that the suspect had several weapons in the house, armor-piercing bullets, and the he was a marksman. During the negotiations, the suspect shot numerous times out of his residence striking vehicles and building in the neighborhood. He notified police that he was going to come out shooting, exited the residence with a shotgun, and shot at officers. Officers returned fire and the suspect was fatally wounded.
DELFIERRO, Daniel	6/22/00 1145 hrs	13273 Aurora N.	H/M	Gun	Officers were responding to a bank alarm. As they approached the suspects were attempting to flee on a stolen motorcycle. They were ordered to surrender, but instead fired at the officers. One of the officers was struck 3 times and went down. The second officer fired at the suspects, killing one of the suspects. The other fled, attempting to "carjack" an occupied vehicle and later held a couple hostage for 3 hours while he arranged transport out of the area.

The suspect pulled out a .380 caliber pistol and fired two shots at the employees. Suspect was located and was brandishing a knife. He ignored several orders to drop the weapon. Pepper Spray was deployed twice with no impact. He then brandished the knife and lunged at officers. One of the officers fired one shot from his weapon, striking the suspect in the chest.
LEAKE, Martin	1/13/01 2332 hrs	3000 blk SW Nevada	B/M 35	Gun	Officers responded to a DV incident in which the victim reported being held captive in her apartment by her gun/knife-wielding boyfriend. On arrival, officers confronted the suspect outside the building. He ran through the complex and was located (by police dog) in a construction site east of the building. Suspect refused several orders to stop and was eventually cornered. He responded by firing at least two shots at officers. They returned fire.
ROBERTS, Aaron	5/31/01 2313 hrs	23 rd & Union	B/M 26	Car	Officers stopped suspect for erratic driving. During the traffic stop One of the officers was pinned to the car by the suspect grabbing his arm. The suspect then accelerated into the intersection, stopped then put the car in reverse and backed up into large cement planters, throwing the officer from the car. During this time the second officer was able to get into the car and was struggling with the suspect. Fearing he and his partners would be killed, he shot the suspect one time, hitting him in the lower abdomen.
