Acute Potential Health Effects:

Warning: May Be Habit Forming.

Skin: It may cause skin irritation. It may be absorbed through intact skin. Symptoms may parallel that of ingestion.

Eyes: It may cause mild irritation. It may have a strong narcotic effect (pupil contraction) and the eyes may serve as an absorption route to the body in general.

Inhalation: Narcotic. It can cause respiratory tract irritation and sneezing or coughing. It may also have an anesthetic effect. Inhalation of large amounts may produce lung edema, respiratory difficulties, and affect

behavior/central nervous system (affects similar to ingestion).

Ingestion: Toxic! Narcotic. It may cause gastric disturbances such as stomach pain, upset stomach, nausea, vomiting, and constipation. Ingestion of large amounts may affect behavior/central nervous system/peripheral nervous system (central nervous system depression or excitation - general anesthetic, headache, restlessness, skeletal and thoracic muscle rigidity, euphoria, somnolence, convulsions, lightheadedness, drowsiness, fainting, dizziness; flaccid paralysis), respiration(respiratory depressant), eyes (miosis (pupil contraction), blurred vision)and cardiovascular system (hypotension, hypertension, bradycardia, circulatory depression, cardiac arrest). When ingested with a tranquilizer, the following adverse reactions may occur: increased risk of cardiovascular depression chills and/or shivering, restlessness, hallucinatory episodes, mental depression.

Chronic Potential Health Effects:

Ingestion: May be habit forming upon prolonged or repeated ingestion.

Skin and Inhalation: Prolonged or repeated exposure may cause allergic reactions with skin rashes, itching, coughs, stuffy nose, asthma.
