function tests impaired, hepatitis, jaundice, hepatic cellular necrosis), eyes (pupillary dilation, corneal damage), cardiovascular system (tachycardia, increase hypertension), skin (skin rash), respiration (chest pain), metabolism (anorexia/weight loss). It may also cause darkening of the urine.
