Property Inspection Report

As stated in the guidelines of the New Zealand Standard 4306:2005 which covers Residential and Commercial Property Inspections "A Property Report should not be seen as an all-encompassing report dealing with a building from every aspect. Rather it should be seen as a reasonable attempt to identify any significant defects visible at the time of the inspection. Nor is a Property Report a warranty against problems developing with the building after the date of the report." It is outside the scope of this report to investigate, or comment on if the dwelling complies with any Building Code legislations or Local Body bylaws.

Some comments in this report are assumptions based on building experience, date of the construction or the visual appearance and style of the materials. As this is a visual non-invasive survey, the condition of the internal framing is not known. **This is NOT a leaky home/weathertightness report - it is a non-invasive visual report only**.

General Description:

This property is a relatively newer (approx early 1990s) aged home of single level design and traditional construction which is situated on a level corner section.

The house consist of 4 bedrooms ,2 bathrooms ,an open plan Kitchen and dining area located toward the Western sides of the house .There is a separate living area on the North West corner of the house .

A separate toilet is also provided .The laundry is located in the double attached internally accessed garage .

The house is constructed on a concrete floor foundation and the external roof cladding is concrete tiles.

The external wall cladding is brick veneer over a timber frame and some timber stained weatherboards .

The house in general presents well as the interior has been completely upgraded and repainted etc.

The exterior is quite original but in reasonable condition overall .

Any areas of concern will be detailed in the Main Summary below or their respective parts of the Report .

Please note ,this is a vendor or owner instigated Report .

This Report is exactly the same as what a prospective purchaser would receive .

Items which should be attended to as a matter of Importance or are regarded as significant requiring major repairs or upgrading to ensure the dwelling continues to perform as required. Items possibly requiring repairs and or maintenance in the short term.

Items which should be taken note of or brought to the attention of the client due to information or relevant advise in regards the area of concern requiring upgrades or repairs. These are recommendations based on industry and personal experience and if the recommendations are not implemented then there is the possibility of deterioration or damage occurring .

I strongly recommend that it is stated in your contract that the power must be connected before settlement to check all of the above, if any issues arise from this it will be up the current owner to rectify.

Considering the dwelling is relatively new, I do suggest you check all council records to be sure the Code of Compliance Certificate has been signed off with the local council.

Structural defects that require attention:

No structural defects that are of concern to the purchaser, or that would compromise the structural integrity and safety of the dwelling were visible on the day of inspection.

Moisture ingress, or moisture damage found.

No current or previous signs of moisture ingress or moisture damage.

Methodology used for moisture testing:

Survey master moisture meter:

The moisture readings are an indication only and comments in regards the level of the moisture reading are based on the type of house and experience .

Indications of possible moisture Issues will be commented on in the relevant areas of the Report along with recommendations as to what is required to remedy the issue or possible further investigation may be required.

Considering the long periods of hot weather we have had, the moisture meter is unlikely to pick up any high moisture readings, because of this our inspectors at this time of the year take extra special care to look out for any signs of moisture damage or water staining. If there are any areas which need to be monitored through the winter period or require further invasive investigation this will be noted.

External area of the dwelling comments:

It was noted that the spouting is holding water in several places and this can result in overflowing in adverse weather conditions.

Re fixing of the spouting may help to alleviate this.

The balance of the exterior of the dwelling is in a reasonable condition. General ageing evident.

There are no structural issues, no requirement for major replacement of any of the base materials, such as the cladding or roofing material.

Foundation Area comments:

The Concrete floor pad appears to be in a good sound condition.

Externally there are no visible fractures evident.

Internally there does not appear to be any major unevenness or damage felt under the internal linings.

Internal inspection comments:

Some areas at the time of the Inspection were not quite finished however the owner indicated these areas were in the process of completion .

The internal linings are in a good sound condition, with a good cosmetic level apparent. (Includes floor linings).

All wet areas were tested, good or reasonable water pressure was found, no leaks or blockages found, internally or externally, or in the sub-floor area (if it exists).

Power points may be noted in the Report but are not tested.

Any obvious broken faceplates or issues with the power point covers etc will be noted in the report.

The dwelling is insulated in the internal ceiling space as shown in the internal ceiling space

Upgrading of the insulation is recommended as it would no longer comply with modern standards .

Smoke alarms may be noted in the report but are not tested .

We recommend that if there are no smoke alarms fitted in the dwelling that this be addressed, we also recommend that all batteries be changed in the existing smoke alarms installed.

Alterations & Additions Comments:

No obvious alterations or additions to the inspector visually have been carried out.

We suggest that council records are checked to view the original plans of the dwelling to be sure this is the case.

Heating systems:

No heating systems were checked on the day of inspection.

Heating systems are a specialist field which require a specialist to carry out a separate inspection.

Heat pumps:

Heat pumps are installed in this dwelling, we suggest the filters are cleaned regularly and serviced as per manufactures instructions.

Heat pumps are not tested or inspected.

Mains power fuse board is found, in the garage.

Some modern fuses are installed here the rest are older style fuses. Due to the age and condition of the wiring or fuses we recommend a registered electrician further investigate as we do not conduct a full electrical inspection.

Any electrical work which has been carried is signed off by the registered electrician doing the work, a Certificate of Compliance should have been issued for this work which should be lodged at the power board and a copy given to the owners at the time of which the work was carried out.

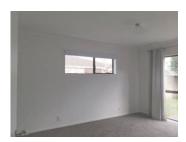
