Annexure Schedule 2

1. **Rights and Powers generally**

- 1.1 The rights and powers set out in the Fifth Schedule to the Land Transfer Regulations 2018 (**Regulations**) are implied to all easements created by this Easement Instrument, except as those rights and powers are varied or substituted in this Schedule.
- 1.2 Where there is a conflict between the provisions of the Regulations, and the modifications in this Easement Instrument, the modifications must prevail.
- 1.3 In respect of any easement no power is implied for the Grantor to determine the Easement for breach of any provision of this Easement Instrument (whether express or implied) or for any other cause. It is the intention of the parties that each Easement will subsist for all time unless it is surrendered.

2. Fifth Schedule Land Transfer Regulations 2018

- 2.1 The maintenance provisions in the Regulations are modified as follows:
 - 2.1.1 The word *"equally"* in clause 11(2) of the Regulations is replaced by *"for a reasonable contribution in proportion to their use"*.
 - 2.1.2 No registered proprietor shall be liable to contribute towards the cost of any work which is in respect of any easement not used by that registered proprietor, or in respect of which such use has not commenced.

1. Class of Easement

- 1.1 For the purposes of Regulation 21 of the Regulations, the classes of easements in clause 2 of the Regulations are extended by reference to the following additional rights:
 - 1.1.1 party wall;
 - 1.1.2 a right to parking; and
 - 1.1.3 overhanging eave and maintenance.

2. Rights and Powers in respect of party wall

- 2.1 In respect of the party wall, **easement facility** means the wall erected on the easement area and includes any extension of the party wall below the surface of the burdened land, the foundations, construction and structure of the party wall, those parts of the connected building necessarily involved and anything in replacement or substitution.
- 2.2 The following additional provisions shall apply to each party wall easement:
 - 2.2.1 The Grantee has the right (in common with the Grantor) to:
 - use, encroach on and enjoy the easement area for the purpose of a party wall;
 - (b) use and enjoy the support, foundations, construction and enclosure of the structure on the burdened land afforded by the party wall in the land upon which it stands, and any extension of the easement facility below the surface of the easement area; and
 - (c) modify the surface of the easement facility on the benefited land within the limits of the easement area provided that any such

modification shall not affect the structural integrity or thermal envelope of the easement facility.

- 2.2.2 The easement facility shall be and shall remain the common property of the Grantor and the Grantee who shall have equal rights to the use, ownership and enjoyment of the easement facility during the term of this easement instrument.
- 2.2.3 Any party intending to demolish the existing easement facility and build an easement facility in substitution, where such demolition is reasonably required for the purposes of any building which that party is erecting or intending to erect, and for the continued support of all other buildings affected, must give the other party not less than six months' notice in writing of such intention. The party giving notice under this clause shall be solely liable for all costs associated with meeting any requirements of the relevant local authority, demolition of the existing easement facility, removal and dumping of debris, and construction of the easement facility in substitution.
- 2.2.4 The party giving notice under clause 2.2.3 must immediately make good any damage done to the burdened land or to any buildings, erections, fences or improvements on the burdened land by restoring the surface of the burdened land or the improvements on the burdened land, as the case may be, as nearly as possible to its former condition.
- 2.2.5 If the easement facility wall needs to be completely rebuilt due to significant damage for which neither party is solely responsible, or for any other reason other than that set out in clause 2.2.3, then the parties shall bear equally the costs referred to in clause 2.2.3 above.
- 2.3 The modification of or construction in substitution for any easement facility already in existence shall be carried out:
 - 2.3.1 in accordance with plans and specifications approved in writing by the Grantor and the Grantee (such approval not to be unreasonably withheld) before any work (including any demolition work) is commenced;
 - 2.3.2 using materials and workmanship of no lesser quality than that of the original easement facility;
 - 2.3.3 in accordance with the requirements of law and the local authority having jurisdiction; and
 - 2.3.4 in such manner as to ensure that the easement facility, any building supported by the easement facility, and any property affected shall not be rendered unstable or unsafe or jeopardised in any manner.

3. Rights and Powers in respect of right to parking

- 3.1 In terms of clause 1 of the Regulations, *easement facility* in relation to a right to parking means the surface of the stipulated area in Schedule A of this Easement Instrument and includes:
 - 3.1.1 the right to repair and maintain the easement facility; and
 - 3.1.2 the right to park and stop motor vehicles on the easement facility.

4. Rights and Powers in respect of overhanging eave and maintenance

- 4.1 In respect of overhanging eave:
 - 4.1.1 **Easement facility** means that portion of the roof of the dwelling on the benefitted land that protrudes into the burdened land, including the eave,

attached guttering and downpipes, and other equipment suitable for that purpose, and anything in replacement or substitution.

- 4.1.2 A right to overhang eave includes the right for the grantee to:
 - (a) at all times use, encroach on, and enjoy the easement area for the purpose of an overhanging eave; and
 - (b) modify the easement facility within the limit of the easement area.
- 4.1.3 The modification, maintenance and repair of the easement facility shall be carried out:
 - (a) in accordance with the requirements of law and the local authority having jurisdiction;
 - (b) in such manner as to ensure that the easement facility, any building supporting the easement facility, and any property affected shall not be rendered unstable or unsafe or jeopardised in any manner.
- 4.1.4 In clause 12(1) of the Regulations, the word "vehicles" is deleted.
- 4.2 In respect of maintenance, **easement facility** means the surface of the easement area on the burdened land.
- 4.3 The right of maintenance includes the right for the Grantee to enter on to the burdened land with any contractors' equipment, tools, materials, ladders and/or scaffolding and remain for a reasonable time to inspect, repair, renew and decorate the building on the benefited land, at the sole cost of the Grantee.
- 4.4 The following provisions shall apply to each right of maintenance easement:
 - 4.4.1 The Grantee has the right to enter onto the burdened land by the nearest practical route to access the easement area at any time on giving reasonable notice (except in an emergency) with any contractors' equipment, tools, scaffolding, ladders, equipment or machinery that is necessary for the purpose of inspecting, repairing, renewing and/or decorating the building on the benefited land, and to remain there for a reasonable period of time for the purposes of carrying out any inspection, repair or restoration work to the Grantee's property adjoining the easement area.
 - 4.4.2 The inspection, repair or restoration work to the Grantee's property adjoining the easement area shall be carried out:
 - (a) in a proper manner;
 - (b) in accordance with the requirements of law in the local authority having jurisdiction;
 - (c) with all reasonable speed; and
 - (d) in such a manner as to cause as little disturbance or nuisance as possible to the Grantor's property.
- 4.5 The general rights and powers in the Regulations are varied to the extent that there is no right for the Grantee to excavate the surface of the burdened land
