SUMMARY

BTW Company Ltd, on behalf of the applicant Alistair Geary, hereby applies for resource consent to subdivide his rural property located on the corner or Lower Taumaha and Geary Roads, Manutahi legally described as Allotment 3-4 DP 5030, into two freehold titles by means of a boundary adjustment. Proposed Lot 2 is to be amalgamated with Lot 5 DP 5030.

The application has been determined as a discretionary activity against the Rules of the South Taranaki District Plan (STDP).

The site consists of an existing dwelling and implement shed. The location of the shed with respect to the proposed new side boundary line has seen the minimum setback rule of 5m for buildings from side boundaries breached by 0.5m, however the effects of this breach are minimal. We request a dispensation to this side boundary breach.

An assessment of the proposal has been made against Section 104, 104B and Part 2 of the Resource Management Act 1991 and against the Rules, Policies and Objectives of the STDP. The potential effects from the subdivision are entirely contained on site, and it is therefore anticipated that this application may be processed on a non-notified basis.

1 INTRODUCTION

1.1 Purpose

The purpose of this report is to seek Resource Consent for a two lot boundary adjustment subdivision over two adjacent allotments held in one Certificate of Title, held by the applicant, within the Hawera Rural Zone. The zoning is identified by Map number 12 within the STDP.

The client wishes to rearrange the internal site boundaries to lie around the existing dwelling and its access way to create a smaller lot for the dwelling and have the balance area for productive farming purposes.

1.3 The Proposal

The subdivision will create one additional title in the Cadastre. The current allotment boundary between Lots 3 & 4 DP 5030 will be removed and new boundaries created around the dwelling house and its access way to create a smaller rural allotment. The balance area will remain for farming purposes. It is intended to amalgamate the balance area with Lot 5 DP 5030, the residue area of CT TN119/45.

Application forms are contained in Appendix A and the current Certificate of Titles are attached in Appendix B.

1.4 Resource Consents Required

The proposal requires Subdivision Resource Consent.

The application <u>does not comply</u> with the rural and subdivision rules and performance standards of the STDP and is therefore considered a *discretionary Activity*. Table D1 and Table D 2 located in Appendix D demonstrates the proposal's compliance and non-compliance with relevant rules within the STDC Rural Environment Area along with supporting comments.

1.5 Technical Studies Undertaken

No technical studies have been undertaken to date.



1.6 Permissions Sought from other Authorities

No permission is sought or required from any other authorities



2 THE SITE AND EXISTING ENVIRONMENT

2.1 Site Description

Set in the rural area of South Taranaki this site occupies the south eastern land of the intersection of Lower Taumaha and Geary Roads. The land, predominantly used for productive farming and agricultural purposes is flat in nature. There is one existing dwelling with a stand-alone accessory shed in close proximity. Additional sheds are located on the property adjacent to existing farm races.

A dwelling and milking shed are located further east along Geary Road within the boundaries of Lot 5 DP 5030 which sits in the same underlying Title. The farm race crosses the boundary between Lots 4 and 5 DP 5030 for farming purposes.

2.2 Land Use Context

The receiving environment is predominantly rural, productive farming is the major use of the land in the area.

The site is adjacent to a coastal protection area. Two existing well sites are located in the area, but the application site is outside the well site buffer zones.

2.3 Services

Overhead power lines run parallel to boundaries and telecom is underground in the road reserve.

Water is obtained from an underground well within the site boundaries and sewage is managed onsite for the existing dwelling.

An existing formed access point services the dwelling and there are alternate access points to allow large and small vehicles access onto the site.

No other services are in the vicinity.

2.4 Landscape, Character and Amenity

The site is relatively flat in nature with mediocre valley in the north eastern corner. This small valley collects surface water and falls into a natural spring.

Sitting in a rural coastal environment, the area is predominantly green land and used as a productive grazing purposes. The land is flat land and generally falls from North to South. The short commute to Hawera or Patea as well as close proximity to Manutahi makes the location of this proposal desirable for a variety of individuals seeking a rural living environment without being isolated.

Assessment of the lot sizes indicates that they are large for productive farming. The site is in close proximity to the Manutahi area, and lot sizes are naturally reduced near a built up area. Being near a built up area is appealing for future owners of smaller allotments in the rural setting.

2.5 Cultural Heritage/Archaeology

A search of the South Taranaki District Council planning maps (STDP Map 12) and New Zealand Archaeological Association site resulted in <u>no</u> Significant Natural Areas, Scheduled Rivers or Streams, Waahi Tapu, Heritage Item or Notable Tree being identified to lie *within* the boundaries of the proposed subdivision.



3 THE PROPOSED SUBDIVISION

3.1 Location

The proposed subdivision is located on the corner of Lower Taumaha and Geary Roads, Manutahi.

3.2 Allotments

A scheme plan (BTW Drawing No 14765-01 Rev 0) is contained in Appendix C. Two lots are proposed as follows:

Proposed Lots 1 and 2 will be created as a result of a boundary adjustment between Lots 3 & 4 DP 5030 with the addition of one extra title as a result of this subdivision. The new boundary line will exclude the current dwelling and its long driveway from the farming purposes of Lot 2.

The new boundary line surrounds the existing dwelling whilst ensuring daylighting angles from the boundaries are met. It also provides extra land to the south west of the dwelling.

These allotments have been designed in a manner that maximises the potential for Lot 2 whilst creating a healthy rural environment that is easily managed and maintained for the dwelling on lot 1.

3.3 Amalgamation Condition

Proposed Lot 2 is to be amalgamated with Lot 5 DP 5030 held within the same underlying Title. As the cowshed, a second dwelling and further sheds are located on this lot, the amalgamation is the most practical approach.

The amalgamation condition reads as follows:

'that one certificate of tittle be issue for Lot 2 hereon and Lot 5 DP 5030 (Residue CT TN119/45).'

3.4 Easements

Proposed easements A-G are required to service both Lots 1 & 2 and these are illustrated on BTW Scheme Plan 13469-01 and attached in Appendix C.

Easement A will provide Lot 2 access rights up the driveway of Lot 1 and onto the land through an existing gate to the west of the dwelling on Lot 1.

Easements B & C follow an existing telecom line across proposed Lot 2 to the dwelling on Lot 1.

Easement D allows existing electricity to pass over Lot 2 to the existing dwelling on Lot 1.

Easements E, F & G provide electricity to a water pump and water back to the dwelling on Lot 1.



3.5 Access

An existing formed vehicle access point off Geary Road will be the major access to Lots 1 & 2. The existing entrance has sufficient sight distances both left and right. It is set back from the intersection with Lower Taumaha Road by approximately 60m.



Figure 3.1: Existing Entrance on Geary Road

The driveway is approximately 140m in length and will have a legal width of 4.5m. Proposed Lot 2 will have a right of way over Lot 1 for access up the driveway by means of easement A (refer section 3.4).



Figure 3.2: Sight visibility from existing access point to Lot 1

Lot 2 has alternate access points along Geary and Lower Taumaha Roads for vehicles as well as access by means of a farm race from Lot 5 DP 5030.

3.6 Services

No new services are required for either new lot as a result of this subdivision.



4 ENVIRONMENTAL EFFECTS

4.1 Introduction

The proposal is classified as a discretionary activity as it does not meet the rules and performance standards for subdivision in the Rural Environment Area due to the reduced setback from the dwelling on Lot 1 to the new boundary.

4.2 STDC Assessment Criteria for Rural Subdivision

4.2.1 Amenity values

STDP policy 2.03.2 a) (i), reads:

'Provide for flexibility in the use, development and subdivision of land while maintaining amenity values; and ensuring that any adverse effects on the surrounding environment are avoided, remedied or mitigated.'

Table D 2 in Appendix D indicates that the proposed subdivision would be in accordance with all of STDC's controlled activity performance standards for subdivision and the provision of services except for minimum setback for a shed from a side boundary. The new boundary follows the existing fence line around the dwelling, and contains sufficient curtilage for rural-residential amenity. The development will be compatible with the receiving environment as it allows for the continuation of productive farming activities in the area. It is considered that any effects on rural amenity would therefore be negligible as a result of the minor non-compliance.

4.2.2 Servicing

The application will have no adverse effect on the provision of services. All work will comply with NZS:4404:2004 specifications. The lot sizes are large enough to accommodate an effluent field, well clear of new boundaries and as a result, it is anticipated that there will be no cross boundary effects, any off-site effects are considered to be no more than minor. Easements are in place to protect services that will cross Lot 2 to service Lot 1.

4.2.3 Effects on Road Safety and Efficiency

Access to the site will be via the existing unsealed access point off Geary Road, The formed right of way will be 4.5m wide.

The creation of a new Title will not create increased vehicular activity, and effects on road safety are considered to be no more than minor.

4.2.4 Positive Effects

The creation of a freehold title which can be on-sold as affordable housing within the rural environment, close to the township of Manutahi.

4.3 Consultation

No consultation has been undertaken as adverse effects are considered to be no more than minor and contained within the proposal boundaries. No recorded archaeological sites are present on application site, therefore consultation with local lwi is not considered necessary.

It is therefore considered appropriate that the application be processed on a non-notified basis.



4.4 Effects Summary

The minimum set back from a building to a side boundary has been breached for the existing implement shed located on site. Although the offset is not met the existing fence acts as the boundary line and is offset at 4.5m. The shading effects on Lot 2 as a result of this activity are no more than minor and will have minimal impact on Lot 2.

All other standards are met.



5 REGULATORY REQUIREMENTS

5.1 Section 104 of the Resource Management Act 1991 Assessment

5.1.1 The Requirements

When considering a resource consent application, Section 104 states that a consent authority 'must, subject to Part 2, have regard to -

- (a) Any actual and potential effects on the environment of allowing the activity; and
- (b) Any relevant provisions of -
 - (i) a national environmental standard
 - (ii) other regulations
 - (iii) a national policy statement
 - (iv) a New Zealand coastal policy statement
 - (v) a regional policy statement or proposed regional policy statement
 - (vi) a plan or proposed plan; and
- (c) Any other matter the consent authority considers relevant and reasonably necessary to determine the application.'

Section 104B states that:

- " After considering an application for a resource consent for a discretionary or non-complying activity, a consent authority
 - (a) May grant or refuse the application; and
 - (b) If it grants the application, may impose conditions under section 108.

It is considered that this application does not meet all relevant standards for a controlled activity and therefore requires to be assessed accordingly under s104B.

5.1.2 Actual and Potential Effects

The adverse effects on the environment were considered against the STDP Subdivision rules and performance standards. These adverse effects are considered to be no more than minor.

5.1.3 The District Plan

The District Plan has classified the subdivision as a discretionary activity as it does not follow the performance standards of the District Plan in a rural area.

The existing implement shed is 4.5m clear of the proposed new boundary adjacent to it. The new boundary is to follow an existing fence line. Effects will be no more than minor as a result of this activity, shading will be of no concern to the neighbouring lot. We request a dispensation to this activity.



5.2 Part 2 Assessment

The matters that Council must have regard to in considering this application under Section 104 of the RMA are all subject to Part 2 (Purpose and Principles) of the Act.

The overriding purpose of the Act is to promote the sustainable management of natural and physical resources.

Section 6 - Matters of National Importance.

Comment: There are no matters of national importance that are relevant to this application.

Section 7 - The following matters under Section 7 are relevant to the determination of the application and particular regard must be had to them:

- b) The efficient use and development of natural and physical resources;
- c) The maintenance and enhancement of amenity values.
- f) Maintenance and enhancement of the quality of the environment.

Comment: The subdivision is in keeping with the surrounding environment. Potable water will be collected onsite and sewage will be managed onsite. Both lots can provide independent stormwater disposal without cross-boundary effects. Overall, amenity values and the quality of the environment would be maintained and enhanced.

Section 8 of Part 2 of the RMA requires that the principles of the Treaty of Waitangi are taken into account.

Comment: There are no waahi tapu sites identified within the boundaries of the site and no natural features on the site that have been statutorily identified as being of importance to tangata whenua. For these reasons no consultation with iwi has been undertaken. The subdivision is not considered to be contrary to the principles of the Treaty of Waitangi.



6 CONCLUSION

This report provides an assessment of Alistair Gearys' application to subdivide his rural property held in one title over three underlying Lots on the corner of Lower Taumaha and Geary Roads, Manutahi. The site is legally described as Lots 3-4 DP 5030. The applicant wishes to subdivide off the existing dwelling from the productive farming area into its individual lot and freehold title by relocating the current boundary line. Proposed Lot 2 and Lot 5 DP 5030 are to be amalgamated into one Certificate of Title

An assessment of the proposal has been made against Section 104, 104B and Part 2 of the Resource Management Act 1991 and against the Rules, Policies and Objectives of the STDP. The potential adverse effects from the subdivision are entirely contained on site, and it is therefore anticipated that this application may be processed on a non-notified basis.

The minimum setback rule for buildings from side boundaries will not be met, however the adverse effects as a result of this are no more than minor. The subdivision will promote the sustainable management of natural and physical resources.

Your application was considered by the Planning Manager under delegated authority on 5 March 2015 and he has resolved as follows:

THAT consent be granted to Alistair Geary to subdivide the property at Lower Taumaha Road, Manutahi (Lots 3-5 DP 5030) into Lot 1 of 4650m² and Lot 2 of 61.85 hectares under Sections 104, 104D and 108 of the Resource Management Act 1991.

THAT consent be granted on Lot 1 above for:

- A yard dispensation for the shed being three metres high at the point 2.5 metres from the eastern (internal) boundary.
- b) A dispensation for the right-of-way not being formed to meet NZS4404:2004 Land Development and Subdivision Engineering specifications.
- c) A dispensation for shared water supply.

For the following reasons:

- 1. The proposal is consistent with other similar activities in the surrounding area.
- 2. The subdivision, subject to consent conditions, would not give rise to any adverse environmental effects that are more than minor.
- 3. There are no external parties affected by the matters of non-compliance associated with Lot 1.

Subject to the following conditions:

1. That the subdivision is undertaken in general accordance with the application submitted to the Council.

- 2. That the proposed water supply easement (over Lot 2 in favour of Lot 1) is granted and reserved and shown on the title plan accordingly.
- 3. That each lot is self-sufficient in terms of stormwater and wastewater disposal and that the provision of these services does not give rise to cross-boundary effects. This includes confirmation provided to the Council by a suitably qualified professional of the location of the septic tank and effluent field system for Lot 1.
- 4. That one certificate of title be issued for Lot 2 hereon and Lot 5 DP 5030 (residue CT TN119/45 subject to the Land Information New Zealand approval (Request 1263907).
- 5. That where required, all necessary easements are shown and registered on the Land Transfer Plan.
- 6. That, where installed, electricity, telecommunication and gas distribution lines are installed underground.

Advice Notes

- 1. Subject to any legal requirements of the Police, Historic Places Act 1993, Antiques Act 1975 and any other governing legislation, should a Waahi Tapu or archaeological site be uncovered during earthworks or other construction work, work in the affected area shall stop immediately the consent holder shall seek advice from Tangata Whenua, the Historic Places Trust and/or the Police (as appropriate) to determine what further actions are appropriate to safeguard the site or its contents before work recommences.
- 2. If in the future, the applicants wish to cancel the water easement, an application would need to be made to the Council on the grounds that an independent water supply can be provided within Lot 1, such as water supplied roof collected tanks.
- 3. Due to the dispensation granted for the right of way not needing to be formed, it is important to outline that it can be used for farm vehicle and residential access at any time. Should there be any cross-owner issues resulting from this arrangement an upgrade may be considered and undertaken completely independent of the Council and the subdivision process.
- 4. The consent holder may wish to voluntarily upgrade any vehicle crossings associated with Lot 2.

Sorry for the delay. This one is a bit confusing for me. I've found Lester's memo to Andrea (attached) and what he asks for is not within the consent conditions; e.g. vehicle crossing upgrade and Stormwater disposal on the ROW.

That then only leaves condition 3 as an engineering issue.

3. That each lot is self-sufficient in terms of stormwater and wastewater disposal and that the provision of these services does not give rise to cross-boundary effects. This includes confirmation provided to the Council by a suitably qualified professional of the location of the septic tank and effluent field system for Lot 1.

Surveyors reply: 3. Each Lot is self-sufficient for stormwater and wastewater. The two photos attached outline the wastewater disposal bed on lot 1 in relation to the new boundaries. *Photos with where the surveyor confirms the location of the services are have also been provided.*

While a plan showing the location of the ST and effluent bed would have been preferable, going back and asking for this would not probably be beneficial as chances are they are contained within lot 1 and the surveyor will see this as unnecessary.

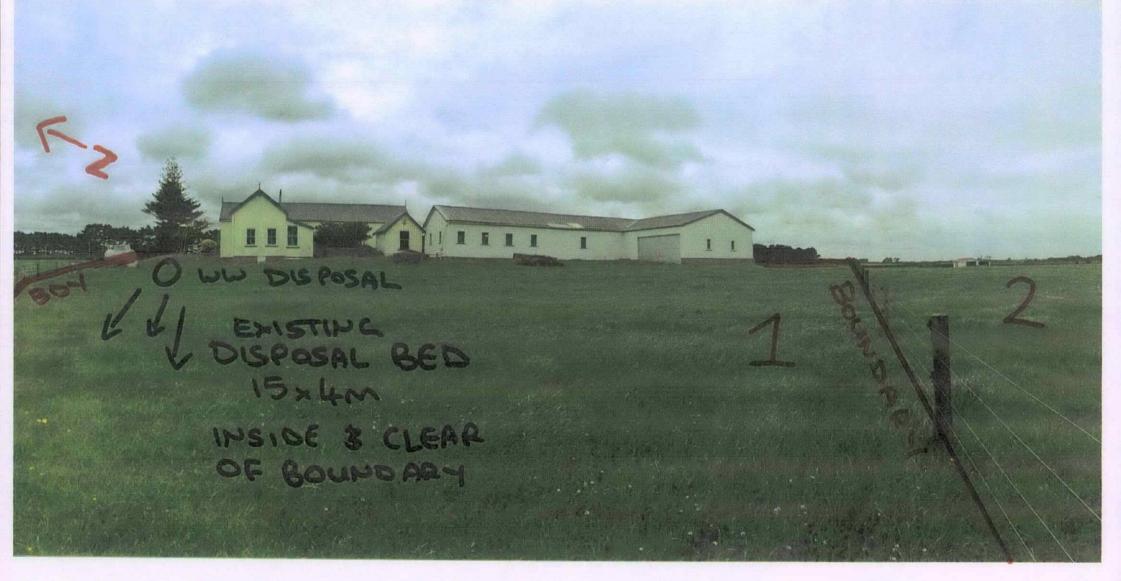

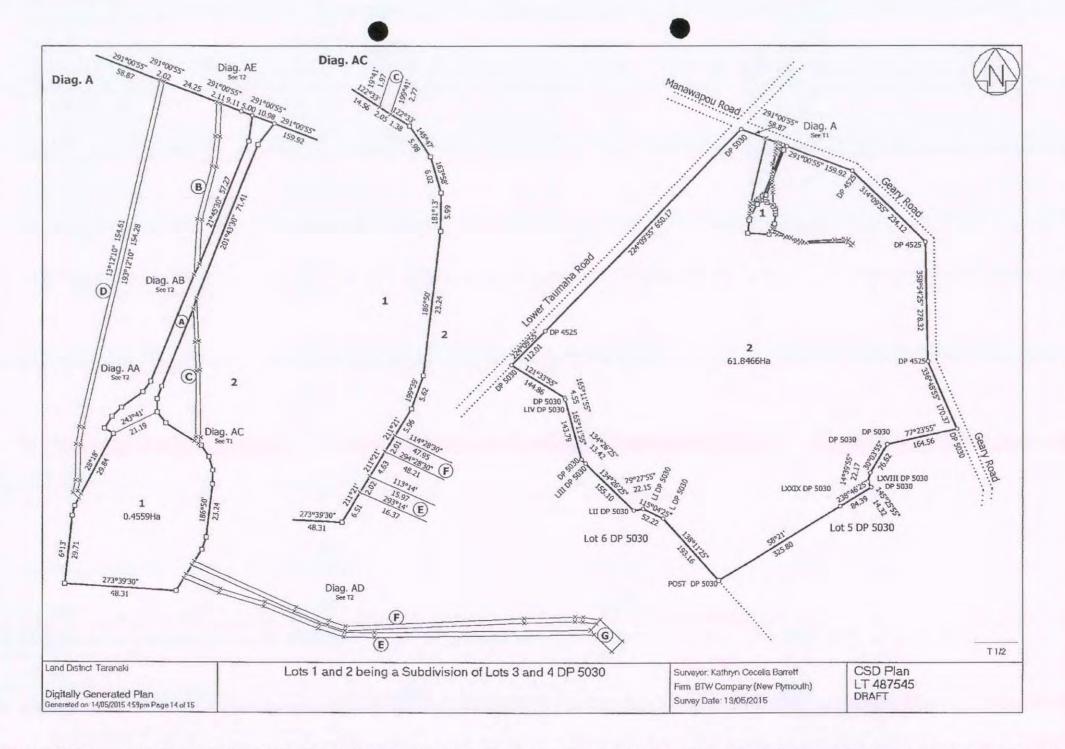

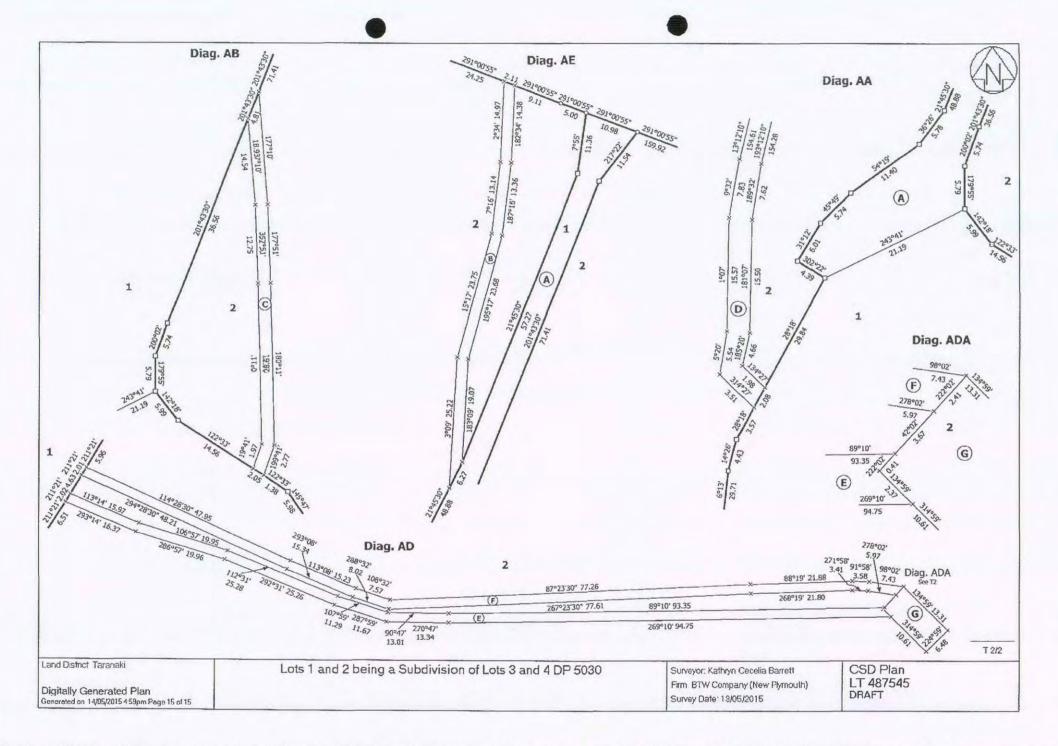

Can you please review this – ensuring that you are content with the conditions. Most of which are taken from Lester's original review. He did want the submission of plans for ROW formation, but given we are granting a dispensation, not required.

I still think that the crossing for LOT 1 shall be upgraded to prevent egress of loose material onto the road. Your thoughts?? Also — I hope my advice note re shared use is sufficient.

I want to give this to Blair tomorrow for approval if possible so I hope you can read this quickly. I am on leave Friday afternoon and all next week.

RECOMMENDATIONS

► THAT consent be granted to Alistair Geary to subdivide the property at Lower Taumaha Road, Manutahi (Lots 3-5 DP 5030) into Lot 1 of 4650m² and Lot 2 of 61.85 hectares under Sections 104, 104D and 108 of the Resource Management Act 1991.

THAT consent be granted on Lot 1 above for:

- a) A yard dispensation for the shed being three metres high at the point 2.5 metres from the eastern (internal) boundary.
- b) A dispensation for the right-of-way not being formed to meet NZS4404:2004 Land Development and Subdivision Engineering specifications.
- c) A dispensation for shared water supply.

For the following reasons:

- 1. The proposal is consistent with other similar activities in the surrounding area.

Advice Notes

- 1. Subject to any legal requirements of the Police, Historic Places Act 1993, Antiques Act 1975 and any other governing legislation, should a Waahi Tapu or archaeological site be uncovered during earthworks or other construction work, work in the affected area shall stop immediately the consent holder shall seek advice from Tangata Whenua, the Historic Places Trust and/or the Police (as appropriate) to determine what further actions are appropriate to safeguard the site or its contents before work recommences.
- If in the future, the applicants wish to cancel the water easement, an application would need to be made to the Council on the grounds that an independent water supply can be provided within Lot 1, such as water supplied roof collected tanks.

Hi Andrea,

Thanks for your time discussing this application on the phone, I hope the purpose is much clearer; I have commented again on the purpose below;

I have removed Lester from CC given he finished yesterday.

Our client wishes to keep the drive as a right of way – the purpose being access to the two sheds next to the farm race south of lot 1. The aerial suggests the race travels north of the sheds to Lower Taumaha Road, this is now no longer the case. The easement heads to an existing gate west of the dwelling which is shown in the attached photo.

As you highlighted if we do not upgrade the right of way to NZS4404 standards the activity class would be discretionary. Given the right of way will have little use (access to sheds the only real requirement) I wish to request for a possible dispensation to the rules for forming a ROW to the standards.

Although difficult to distinguish, the driveway does slope back towards the road and there is approximately 400mm of a grass berm between the edge of metal and fence line (Proposed boundary), this berm, along with the slight

 slope and slight water seepage through metal should mitigate any cross boundary effects in the case of a storm event. No easement for storm water would be necessary.

I could understand the need to upgrade the access point however given Geary Road is a short road rarely used, in one way doesn't seem to practical – I will leave this to or Tracey you to make a best case judgement.

I hope the above clarifies a few things, any further questions give me a call.

Hi Taryn,

Thanks for that information.

I have read through the details and while very light in assessment it will suffice.

Lester Barnes, Council's current Development Control Engineer, has reviewed the site plan and made the following recommendations. Given this ROW fenced on both sides, I do not see the necessity for it to be a ROW and perhaps an access leg would suffice?

Would you like to discuss this point with your client, and advise if you would prefer an access leg over a ROW. I will wait to hear from you before I finalise my report.

Also can you comment on the point of stormwater discharge onto Lot 2 and possible easements.

The proposed ROW is the existing access to an existing dwelling located upon proposed Lot 1. This access is presently fenced on both sides with a post and rail fence, making access from Lot 2 onto the ROW difficult unless some additional work is completed. The ROW is not considered essential and could easily be just the access leg for Lot 1. Therefore conditions for both a ROW and an access leg are included so the applicant can choose to change the application.

Because of the width of the ROW reserve and that the ROW is owned by Lot 1 there will probably be insufficient room within the ROW to dispose of stormwater, and therefore easements to discharge and lay stormwater surface drainage on Lot 2 may be required.

No vehicle access for Lot 2 is required as it will be able to use the ROW access to Lot 1 or an existing access associated with Lot 5 as part of the amalgamation.

Proposed Conditions:

- 1) The ROW shall be formed to the requirements of NZSS 4404, including:
 - a) The submission of plans to the Council for approval, and
 - b) The provision of "As-built" schedules.
- 2) If surface drainage disposal from the ROW is not contained entirely within Lot 1 then easements for the discharging and laying of surface drainage upon Lot 2 shall be required.
- 3) The existing vehicle crossing serving Lot 1 shall be upgraded to the Council's current standards.
- 4) At the time of Section 223 application it is to be demonstrated that the existing sewage management system is located entirely within the boundaries of Lot 1.

EXECUTIVE SUMMARY

The applicant is proposing to subdivide the property into two lots. The subdivision would create one new house lot while the rest of the property would be amalgamated for farming purposes.

An existing shed would not comply with the District Plan's boundary and height setback requirements in relation to the new boundary and the application requires assessment as a Discretionary Activity.

The District Plan requires that all vehicle crossings comply with the Council's specifications. The applicant is requesting a waiver from upgrading the right of way and this requires assessment as a Discretionary Activity.

The existing water line from the natural water spring for Lot 1 would be outside of the property boundaries and is proposed to be covered by an easement. For this reason, the lot would not be self-sufficient as required by the District Plan and this requires assessment as a Discretionary Activity.

Company Compan

There are no external parties affected by the proposal or the matters of noncompliance.

The proposal is consistent with the objectives and policies of the District Plan and the purpose and principles of the Resource Management Act 1991. The consent, if granted with conditions, would not give rise to effects that are more than minor and I recommend that consent be granted.



APPLICATION

The applicant, Alistair Geary is proposing to subdivide the property at Taumaha Road, Manutahi. The property consists of three certificates of title, being Lots 3-5 DP 5030 and the subdivision relates only to Lots 3 and 4. Proposed Lot 1 would be a house lot of 4650m² and Lot 2 of 61.85 hectares. Lot 2 is then to be amalgamated with Lot 5 DP 5030 which is the residue of the original title.

The application is unable to comply with performance standard 3.02.1.5 of the District Plan, relating to bulk and location non-compliance for an existing shed on proposed Lot 1.

The application is also unable to comply with performance standards 8.02.1.2 and 8.02.2.2 relating to independent water supply and the upgrading of the right of way.

Overall the application has been assessed as a Discretionary Activity.

Site & Surrounding Area Description

The rural zoned property has direct frontage onto Geary and Lower Taumaha Roads. The surrounding area is of rural character with established oil and gas related operations within two kilometres of the property (including a production field and landfarming operation). Manutahi, a small community which includes an old pub now operating as a bed and breakfast, business spaces that once operated as a general store and fish and chip shop and residential sized properties, is located approximately one kilometre north of the property.

The coast, to the south, can be seen but the property is not located within the Coastal Protection Area. The back reaches of the property contain remnants of sand dunes and these have been modified to cater for farming in years gone by.

The property as it is currently contains three dwellings, a dairy shed and other farm buildings. Other key features are that a Power Corridor runs through and along the property's rear boundary, an Archaeological Site (Pa Site) and Pipeline Corridor are located on the adjoining property and the Coastal Protection Area is present along the area of the coastline where coastal features are expected (as shown below).

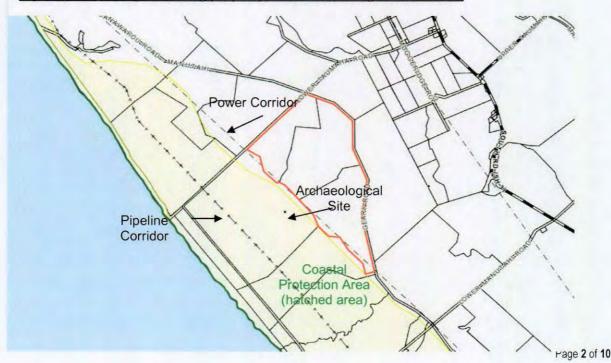


Figure Three – Photo showing shed in relation to new boundary (fence)

Bulk and Location Requirements

The District Plan requires that any building such as a shed or garage, should be located a minimum of five metres from any side boundary and shall be no greater in height at any point than the distance from that point to the nearest boundary.

The three metre high shed on proposed Lot 1 would be approximately 2.5 metres from the new eastern boundary and would therefore not comply with the setback requirements of the District Plan.



The District Plan's objectives and policies are in place to ensure that ongoing development maintains and improves the character of the surrounding rural environment. In particular, objective 2.03.1(b) encourages the protection and enhancement of rural character and amenity values, with provision of access to privacy and open space around buildings.

Due to the existing nature of the building, I consider that the effects of the non-compliance would be retained within the property boundaries. For this reason I consider that there are no external parties affected by the non-compliance beyond those allotments that are within the subdivision.

Utilities and Services

The District Plan requires that where reticulated services are available within 200 metres of the property, allotments must connect unless there is a more sustainable alternative. The Council's Development Control Engineering Team, Lester Barnes and Tracey Mitchell, have assessed the proposal and advised that there are no reticulated services available within 200 metres of the property.

The dwelling on proposed Lot 1 is serviced by water obtained from an underground well within Lot 2 and an existing septic tank with effluent disposal field. At the time of development on proposed Lot 2, similar servicing could be provided. The other two dwellings and dairy shed are located on Lot 5 DP 5030 which is not associated with the subdivision.

The District Plan requires each lot to be independent where services are not available. The existing water supply associated with proposed Lot 1 would be located within Lot 2 and an easement has been proposed to protect this supply. I consider that this is a suitable means of ensuring that this arrangement is protected and that the easement is made a condition of the subdivision, where the easement must be granted and reserved and shown on the survey plan. This would be listed on the Memorandum of Easements.

If in the future, the applicants wish to cancel this easement, an application would need to be made to the Council on grounds that an independent water supply can be achieved within Lot 1.

I consider that the proposed lots are of a suitable size to cater for stormwater disposal within the boundaries of the property without giving rise to any cross boundary effects. As occurs on Lot 1 with existing soak holes, I consider it appropriate that stormwater for Lot 2 is serviced in the same manner at the time of any development and appropriate managed through any building consent application.

The location of the existing septic tank and the associated effluent fields for Lot 1 were not shown at the time the application was made to the Council. To ensure that there are no cross boundary effects, it should be demonstrated that the existing sewer management system is entirely located within the boundaries of Lot 1 and this should form a condition of the consent, if granted.

Policy 2.03.2 of the District Plan seeks to ensure that all activities in the Rural Zone are managed to ensure that any adverse effects on the surrounding environment are avoided, remedied or mitigated. I consider that the proposed application would continue to deliver on this policy

Vehicle Access

It is a requirement of the District Plan that all allotments are provided with vehicle access to a formed legal road.

The application states that the existing vehicle crossing onto Geary Road is well formed and suitable for servicing proposed Lot 1. Lot 2 has alternative access points along Geary and Lower Taumaha Roads for vehicles as well as access by means of a farm race through Lot 5 DP 5030, which Lot 2 is being amalgamated with.

The existing access to Lot 1 is setback from the Lower Taumaha and Geary Roads intersection by approximately 60 metres. The access point at the roadside is of a left and right turn configuration, being approximately 20 metres wide.

The driveway is formed with shell-rock (metal) and is approximately 140 metres in length and would have a legal width of 4.5 metres. The driveway is fenced on both sides with a post and rail fence. Proposed Lot 2 would have a right of way (ROW) over Lot 1 for access for the purpose of accessing farm sheds next to the farm race south of Lot

1. Although difficult to distinguish, the application documents state that the driveway does slope back towards Geary Road and there is approximately 400mm of grass berm between the edge of the metal and the fence line on either side. This, along with the slope and slight water seepage through the metal should mitigate any cross boundary effects in the case of storm events and no easement for stormwater run-off across proposed Lot 2 is deemed necessary.

Taryn Martin of BTW Company Limited has requested a dispensation on behalf of the applicants to avoid forming of the ROW to meet the NZS4404:2004 specifications (NZ Land Development and Subdivision Engineering) as required by the District Plan. Tracey Mitchell has reviewed this matter and advised that given the nature of the subdivision and provided future owners are aware of the shared driveway for both farm vehicle and residential access, the need to upgrade the ROW to meet the specifications can be waived. To deal with this, I consider that an advice note placed on the consent, if granted, which clearly outlines this shared use, would appropriately address this matter.

The vehicle access for the ROW would need to be upgraded to ensure that egress of material onto Geary Road is minimised. This would need to be upgraded to comply with the Council's Rural Property Entrance specifications, which includes two metres (minimum) seal from the edge of the road seal.

Vehicle access for proposed Lot 2 is not required as it would be able to use an existing access associated with Lot 5 DP 5030 as part of the amalgamation.

The District Plan's provisions are in place to ensure that the provision of subdivision occurs in flexible manner while ensuring that the effects on the receiving environment are no more than minor. I have considered that the proposed subdivision is neither contrary to Objective 2.07.1(a) nor is it inconsistent with the underlying Policies for subdivision. The scale and nature of the proposal is well suited to the surrounding rural environment.

The proposal would not compromise the amenity of the rural environment and would not give rise to any adverse environment effects.

Amalgamation Condition

The associated amalgamation proposed should be required as a condition of the consent subject to the Land Information New Zealand approval (Request 1263907).

That one certificate of title be issued for Lot 2 hereon and Lot 5 DP 5030 (residue CT TN119/45).

Part II of the Resource Management Act 1991

Sustainable Management as discussed in Part II of the Resource Management Act 1991 seeks to manage future development that will enable people to provide for their social, economic and cultural wellbeing while ensuring that any adverse effects of activities on the environment are avoided, remedied or mitigated.

Section 6 under Part II of the Act seeks to recognise and provide for the preservation of matters of national importance, which includes the protection from inappropriate subdivision, use and development. Section 8 of the Act requires the Council, in relation to managing the use, development and protection of natural and physical resources to take into account the principles of the Treaty of Waitangi. There are no known Treaty of Waitangi issues relating to this application. In my opinion the proposal is consistent with Part II of the Act.

I consider that the existing environment could receive the requested dispensations without giving rise to any adverse effects that are more than minor given they exist already and the nature of the proposal to separate the dwelling from the remainder of the farm.

While water supply would not be independent, I consider that it would not give rise to adverse effects that are more than minor. An easement, as provided by a condition of consent, would ensure that arrangement was appropriately provided.

While the formation of the ROW would not meet the NZ4404:2004 standards, I consider that it would not give rise to effects that are more than minor.

Section 7 outlines the requirement to ensure the ongoing maintenance and enhancement of amenity values and the quality of the environment. I consider that the proposal would maintain the amenity values and quality of the environment for the reasons outlined within the evaluation section of this report.

There are no known matters of national or cultural importance associated with this property

CONCLUSION

I consider that the proposed subdivision would not compromise the character and amenity of the area. Conditions imposed on the consent would ensure that the proposed subdivision would not result in any actual or potential effects on the environment that would be contrary to the promotion of sustainable management as per the purpose and principles of the Resource Management Act 1991.

From the assessment above, I conclude that the yard and height non-compliances with respect to the existing shed on Lot 1 would not adversely impact on the amenity and character of the surrounding environment and associated activities.

From the assessment above, I conclude that the ROW upgrade non-compliance would not adversely impact on the roading network. The access would be upgrade to comply with the Rural Property Entrance specifications.

I consider that the non-compliance with independent water supply would not give rise to adverse effects that are more than minor. The easement would ensure that the water supply was appropriately provided.

There are no external parties affected by these non-compliance matters.

The proposal is considered to be consistent with the purpose and principles of the Resource Management Act 1991 and the District Plan. The application is therefore recommended for approval.

RECOMMENDATIONS

<u>THAT</u> consent be granted to Alistair Geary to subdivide the property at Lower Taumaha Road, Manutahi (Lots 3-5 DP 5030) into Lot 1 of 4650m² and Lot 2 of 61.85 hectares under Sections 104, 104D and 108 of the Resource Management Act 1991.

THAT consent be granted on Lot 1 above for:

- a) A yard dispensation for the shed being three metres high at the point 2.5 metres from the eastern (internal) boundary.
- b) A dispensation for the right-of-way not being formed to meet NZS4404:2004 Land Development and Subdivision Engineering specifications.
- c) A dispensation for shared water supply.

For the following reasons:

- 1. The proposal is consistent with other similar activities in the surrounding area.
- 2. The subdivision, subject to consent conditions, would not give rise to any adverse environmental effects that are more than minor.
- 3. There are no external parties affected by the matters of non-compliance associated with Lot 1.

Subject to the following conditions:

- 1. That the subdivision is undertaken in general accordance with the application submitted to the Council.
- That the proposed water supply easement (over Lot 2 in favour of Lot 1) is granted and reserved and shown on the title plan accordingly.
- 3. That each lot is self-sufficient in terms of stormwater and wastewater disposal and that the provision of these services does not give rise to cross-boundary effects. This includes confirmation provided to the Council by a suitably qualified professional of the location of the septic tank and effluent field system for Lot 1.
- That one certificate of title be issued for Lot 2 hereon and Lot 5 DP 5030 (residue CT TN119/45 subject to the Land Information New Zealand approval (Request 1263907).
- 5. That where required, all necessary easements are shown and registered on the Land Transfer Plan.
- That, where installed, electricity, telecommunication and gas distribution lines are installed underground.

Advice Notes

- Subject to any legal requirements of the Police, Historic Places Act 1993, Antiques Act 1975 and any other governing legislation, should a Waahi Tapu or archaeological site be uncovered during earthworks or other construction work, work in the affected area shall stop immediately the consent holder shall seek advice from Tangata Whenua, the Historic Places Trust and/or the Police (as appropriate) to determine what further actions are appropriate to safeguard the site or its contents before work recommences.
- 2. If in the future, the applicants wish to cancel the water easement, an application would need to be made to the Council on the grounds that an independent water supply can be provided within Lot 1, such as water supplied roof collected tanks.
- 3. Due to the dispensation granted for the right of way not needing to be formed, it is important to outline that it can be used for farm vehicle and residential access at any time. Should there be any cross-owner issues resulting from this arrangement an upgrade may be considered and undertaken completely independent of the Council and the subdivision process.
- 4. The consent holder may wish to voluntarily upgrade any vehicle crossings associated with Lot 2.

Hi Andrea,

Thanks for your time discussing this application on the phone, I hope the purpose is much clearer; I have commented again on the purpose below;

I have removed Lester from CC given he finished yesterday.

Our client wishes to keep the drive as a right of way – the purpose being access to the two sheds next to the farm race south of lot 1. The aerial suggests the race travels north of the sheds to Lower Taumaha Road, this is now no longer the case. The easement heads to an existing gate west of the dwelling which is shown in the attached photo.

As you highlighted if we do not upgrade the right of way to NZS4404 standards the activity class would be discretionary. Given the right of way will have little use (access to sheds the only real requirement) I wish to request for a possible dispensation to the rules for forming a ROW to the standards.

Although difficult to distinguish, the driveway does slope back towards the road and there is approximately 400mm of a grass berm between the edge of metal and fence line (Proposed boundary), this berm, along with the slight slope and slight water seepage through metal should mitigate any cross boundary effects in the case of a storm event. No easement for storm water would be necessary.

I could understand the need to upgrade the access point however given Geary Road is a short road rarely used, in one way doesn't seem to practical – I will leave this to or Tracey you to make a best case judgement.

I hope the above clarifies a few things, any further questions give me a call.

SUBDIVISION SUMMARY

This consent application is for the subdivision of Lots 3 & 4 DP 5030 into Lot 1 of 4650 m2 and Lot 2 of 61.65 ha. It is proposed that Lot 1 will be the servient tenant for a Right of Way (ROW) with Lot 2, and Lot 2 will be amalgamated with Lot 5 DP 5030

ROADING ISSUES

The proposed ROW is the existing access to an existing dwelling located upon proposed Lot 1. This access is presently fenced on both sides with a post and rail fence, making access from Lot 2 onto the ROW difficult unless some additional work is completed. The ROW is not considered essential and could easily be just the access leg for Lot 1. Therefore conditions for both a ROW and an access leg are included so the applicant can choose to change the application.

Because of the width of the ROW reserve and that the ROW is owned by Lot 1 there will probably be insufficient room within the ROW to dispose of stormwater, and therefore easements to discharge and lay stormwater surface drainage on Lot 2 may be required.

No vehicle access for Lot 2 is required as it will be able to use the ROW access to Lot 1 or an existing access associated with Lot 5 as part of the amalgamation.

SEWER RETICULATION ISSUES

It is stated in the application that sewerage is managed onsite for the existing dwelling. It is assumed that this is an existing septic tank and effluent field that needs to be located entirely within the boundaries of Lot 1.

Any requirements for sewerage disposal for Lot 2 shall be addressed at the time of a building consent application.

WATER RETICULATION ISSUES

Water supply for Lot 1 is from a well located on Lot 2. Easements for the well, pipe lines and electricity are included in the application. The location of the well on Lot 2 (cross boundary effects) is acceptable in term of location the water supply away from the septic tank.

Any requirements for water supply for Lot 2 shall be addressed at the time of a building consent application.

STORMWATER RETICULATION ISSUES

No mention is made within the application on the matter of stormwater disposal from the existing dwelling on Lot 1. It is assumed that there is sufficient land area on Lot 1 for stormwater disposal.

Any requirements for stormwater disposal for Lot 2 shall be addressed at the time of a building consent application.

RECOMMENDED SUBDIVISION CONSENT CONDITIONS

The following consent conditions are recommended:

- 1) The ROW shall be formed to the requirements of NZSS 4404, including:
 - a) The submission of plans to the Council for approval, and
 - b) The provision of "As-built" schedules.
- If surface drainage disposal from the ROW is not contained entirely within Lot 1 then easements for the discharging and laying of surface drainage upon Lot 2 shall be required.
- The existing vehicle crossing serving Lot 1 shall be upgraded to the Council's current standards.
- 4) At the time of Section 223 application it is to be demonstrated that the existing sewage management system is located entirely within the boundaries of Lot 1.

- If the applicant chooses not to create the ROW then conditions1 and 2 will not apply.
- II. If the applicant chooses for Lot 2 to be the servient tenant for the ROW then condition 2 will not apply.
